Major Issues Discussed

Councilman Torrence explained the zoning bill in how it is requesting a conversion of a single-family dwelling unit to 2 dwelling units. It is noted that Councilman Parker noticed that in the title of the bill it states that it says 3 dwelling units instead of 2, which brough conversation of an amendment. There has been an amendment made but the Chair stated it is a technical issue and may not be needed. The Law Department also noted that while their report initially referenced the need for clarification on parking variances, a recent change in the law has eliminated that requirement, rendering the issue moot.
