8	EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, THE CREDIT GRANTED	
9 10	UNDER THIS SECTION IS A FIXED AMOUNT OF \$4,000, TO BE ALLOCATED AND APPLIED OVER A PERIOD OF 5 TAX YEARS AS FOLLOWS:	
11	(I) \$1,000 IN THE 1ST TAX YEAR;	
12	(II) \$900 IN THE 2^{ND} TAX YEAR;	
13	(III) \$800 IN THE 3^{RD} TAX YEAR;	
14	(IV) \$700 IN THE 4^{TH} TAX YEAR; AND	
15	(V) $$600$ in the 5^{th} tax year.	
16	(2) DWELLING WITHIN LOW OR MODERATE INCOME CENSUS TRACT.	
17	(I) FOR APPLICATIONS FILED ON OR AFTER OCTOBER 1, 2015, THE FIXED AMOUNT OF	
18	THE CREDIT IS $$5,000$ FOR A HOMEOWNER WHO PURCHASES A DWELLING LOCATED	
19	WITHIN A LOW OR MODERATE INCOME CENSUS TRACT, AS DESIGNATED FROM TIME	
20	TO TIME BY THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT AND	
21	IN WHICH AT LEAST 51% OF THE PERSONS LIVING IN THE TRACT ARE IN	
22	HOUSEHOLDS EARNING 80% OR LESS OF THE AREA MEDIAN INCOME.	
23	(II) A HOMEOWNER WHO WAS RESIDING WITHIN A LOW OR MODERATE INCOME CENSUS	
24	TRACT, AS DESCRIBED IN SUBPARAGRAPH (I) OF THIS PARAGRAPH, WHEN THE	
25	HOMEOWNER SUBMITTED THE APPLICATION FOR THE CREDIT REMAINS ELIGIBLE	
26	FOR THE HIGHER CREDIT AUTHORIZED BY THIS PARAGRAPH EVEN IF, AFTER THE	
27	DATE OF THE APPLICATION, THE CENSUS TRACT CHANGES AND THE HOMEOWNER	
28	WOULD OTHERWISE BE INELIGIBLE FOR THE HIGHER CREDIT DURING THE 5—YEAR	
29	PERIOD.	
30	(III) THE \$5,000 SHALL BE ALLOCATED AND APPLIED OVER A PERIOD OF 5 TAX YEARS

4	(IV) THE FINANCE DIRECTOR MAY ESTABLISH ADDITIONAL CRITERIA NECESSARY TO			
5	CARRY OUT THIS PARAGRAPH.

7	(E) CREDIT MAY NOT REDUCE CURRENT LIABILITY BELOW THAT FOR PRIOR DWELLING.			
8	A HOMEOWNER MAY NOT RECEIVE A CREDIT UNDER THIS SECTION (OR PORTION OF THE			
9	CREDIT) FOR ANY YEAR IN WHICH APPLICATION OF THE CREDIT (OR PORTION OF THE			
10	CREDIT) WOULD REDUCE THE HOMEOWNER'S PROPERTY TAX LIABILITY BELOW THE			
11	HOMEOWNER'S PROPERTY TAX LIABILITY FOR THE DWELLING PREVIOUSLY OCCUPIED BY

13	(F) DUPLICATION OF CREDITS NOT ALLOWED.			
14	IN ANY YEAR IN WHICH A HOMEOWNER RECEIVES A CREDIT UNDER THIS SUBSECTION			
15	SECTION, THE HOMEOWNER MAY NOT RECEIVE:			
16	(1) THE LOCAL PORTION OF THE CREDIT UNDER STATE TAX-PROPERTY ARTICLE,			
17	§ 9–105 {"Homestead tax credit"}; or			
18	(2) ANY OTHER PROPERTY TAX CREDIT PROVIDED BY THE CITY.			
19	(G) CREDIT NOT TRANSFERABLE.			
20	THE CREDIT GRANTED UNDER THIS SECTION FOR A DWELLING MAY NOT BE TRANSFERRED

22	(I) A PERSON WHO PURCHASES THE DWELLING FROM THE HOMEOWNER RECEIVING THI			
23	CREDIT; OR			
24	(II) A DWELLING THAT IS SUBSEQUENTLY PURCHASED BY THE HOMEOWNER RECEIVING			
25	THE CREDIT.			
26	(H) LOCAL PORTION OF HOMESTEAD CREDIT.			
27	AFTER TERMINATION OF THE CREDIT GRANTED UNDER THIS SECTION, A HOMEOWNER IS			
28	ENTITLED TO THE LOCAL PORTION OF THE CREDIT GRANTED UNDER STATE TAX-PROPERT			
29	ARTICLE, § 9–105 {"HOMESTEAD TAX CREDIT"}, WHICH SHALL BE CALCULATED:

4	THE FINANCE DIRECTOR SHALL REVIEW AND APPROVE APPLICATIONS FOR THE CREDIT
5	GRANTED UNDER THIS SECTION BASED ON:
6	(1) THE AVAILABILITY OF THE FUNDS APPROPRIATED FOR THE CREDIT AND ITS
7	ADMINISTRATION UNDER STATE TAX-PROPERTY ARTICLE, § 9-304(G)(9)(I); AND
8	(2) THE ORDER IN WHICH APPLICATIONS FOR THE CREDIT ARE RECEIVED; AND
9	(J) RULES. REGULATIONS, AND PROCEDURES.
10	THE FINANCE DIRECTOR SHALL ADOPT RULES, REGULATIONS, AND PROCEDURES AS
11	NECESSARY TO CARRY OUT THIS SECTION.
12	(K) REPORTING.
13	THE DEPARTMENT OF FINANCE SHALL EVALUATE THE EFFICACY OF THE CREDIT
14 15	ESTABLISHED BY THIS SECTION AND SUBMIT A REPORT OF ITS FINDINGS AND RECOMMENDATIONS ON OR BEFORE DECEMBER 31, 2018, AND DECEMBER 31, 2020, TO:
16	(1) THE MAYOR AND THE CITY COUNCIL; AND
17	(2) IN ACCORDANCE WITH STATE GOVERNMENT ARTICLE, § 2–1246:
18	(I) THE BALTIMORE CITY HOUSE DELEGATION;
19	(II) THE BALTIMORE CITY SENATORS;
20	(III) THE SENATE BUDGET AND TAXATION COMMITTEE; AND
21	(IV) THE HOUSE COMMITTEE ON WAYS AND MEANS.
22 23	(L) TERMINATION OF PROGRAM.
24	(1) NEW CREDITS MAY NOT BE GRANTED UNDER THIS SECTION FOR ANY TAX YEAR
25	BEGINNING ON OR AFTER JULY 1, 2020.
26	(2) THIS SUBSECTION DOES NOT APPLY TO AN OWNER'S CONTINUED RECEIPT OF AN
27	ANNUAL CREDIT, AS PROVIDED IN SUBSECTION (D) OF THIS SECTION, WITH RESPECT TO
28	A PROPERTY FOR WHICH THE TAX CREDIT WAS INITIALLY GRANTED AND RECEIVED FOR
29	A TAX YEAR ENDING ON OR BEFORE JUNE 30, 2020.
