17	§ 29-1. DEFINITIONS.
18	(A) IN GENERAL.
19	IN THIS SUBTITLE, THE FOLLOWING TERMS HAVE THE MEANINGS INDICATED.
20	(B) COMMISSION.
21	"COMMISSION" MEANS THE BALTIMORE CITY SENIOR COMMISSION.

2	"SENIOR" MEANS AN INDIVIDUAL OVER THE AGE OF 60.
3	§ 29-2. {RESERVED}
4	§ 29-3. PURPOSE.
5 6 7 8 9	THE PURPOSE OF THIS SUBTITLE IS TO ALLOW SENIORS THE OPPORTUNITY TO PROVIDE ADVICE, RECOMMENDATIONS, AND INFORMATION FOR THE MAYOR, THE CITY COUNCIL, AND MUNICIPAL AGENCIES ON THE DEVELOPMENT OF COORDINATED COMMUNITY AND GOVERNMENT POLICIES, PROGRAMS, AND SERVICES THAT SUPPORT SENIORS AND THEIR FAMILIES.
10	§ 29-4. COMMISSION ESTABLISHED.
11	THERE IS A BALTIMORE CITY SENIOR COMMISSION.
12	§ 29-5. COMPOSITION.
13	(A) IN GENERAL.
14	THE COMMISSION COMPRISES 17 VOTING MEMBERS AND 8 NON-VOTING MEMBERS.
15	(B) VOTING MEMBERS.
16 17	(1) The voting members are appointed by the Mayor, in accordance with City Charter Article IV, \S 6, as follows:
18	(I) 1 SENIOR FROM EACH OF THE 14 COUNCIL DISTRICTS; AND
19 20	(II) 3 AT-LARGE SENIORS RECOMMENDED BY THE PRESIDENT OF THE CITY COUNCIL.
21 22	(2) EACH VOTING MEMBER OF THE COMMISSION MUST BE A RESIDENT OF BALTIMORE CITY.
23	(C) AGENCY REPRESENTATIVES.
24 25	EACH OF THE FOLLOWING ENTITIES SHALL DESIGNATE A NON-VOTING MEMBER TO REPRESENT THAT ENTITY:
26	(1) DEPARTMENT OF RECREATION AND PARKS.
27	(2) HEALTH DEPARTMENT.
28	(3) ENOCH PRATT FREE LIBRARY.

1	(4) FAMILY LEAGUE OF BALTIMORE CITY.
2	(5) BALTIMORE CITY COMMUNITY COLLEGE.
3	(6) BALTIMORE COMMISSION ON THE AGING AND RETIREMENT EDUCATION.
4	(D) MAYORAL AND COUNCIL REPRESENTATIVES.
5	(1) 2 NON-VOTING, EX OFFICIO MEMBERS ARE:
6	(I) THE MAYOR; AND
7	(II) THE PRESIDENT OF THE CITY COUNCIL.
8	(2) THE MAYOR OR COUNCIL PRESIDENT MAY DESIGNATE ANOTHER PERSON TO SERVE IN HER OR HIS PLACE.
10	§ 29-6. TERMS, ORGANIZATION, MEETINGS, ETC.
11	(A) TERMS.
12	(1) THE TERM OF A VOTING MEMBER EXPIRES AT THE END OF THE MAYOR'S TERM.
13 14	(2) AT THE END OF A TERM, A VOTING MEMBER CONTINUES TO SERVE UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIES.
15	(B) COMPENSATION
16	MEMBERS OF THE COMMISSION:
17	(1) ARE NOT ENTITLED TO COMPENSATION FOR SERVICE ON THE COMMISSION; BUT
18 19	(2) ARE ENTITLED TO REIMBURSEMENT FOR EXPENSES INCURRED, AS PROVIDED IN THE ORDINANCE OF ESTIMATES.
20	(C) OFFICERS; COMMITTEES.
21	(1) THE MAYOR SHALL DESIGNATE A VOTING MEMBER TO SERVE AS COMMISSION CHAIR.
22	(2) THE CHAIR MAY SELECT OTHER OFFICERS.
23 24	(3) THE CHAIR MAY APPOINT COMMITTEES TO ASSIST THE COMMISSION IN CARRYING OUT ITS FUNCTIONS AND DUTIES.
25	(D) MEETINGS; QUORUM.
26 27 28	(1) THE COMMISSION SHALL MEET ON THE CALL OF THE CHAIR AS FREQUENTLY AS REQUIRED TO PERFORM ITS DUTIES, BUT NOT LESS THAN 6 TIMES NOR MORE THAN 10 TIMES EACH YEAR.

1 2	(2) A MAJORITY OF THE VOTING MEMBERS CONSTITUTES A QUORUM FOR THE TRANSACTION OF BUSINESS.
3 4	(3) AN AFFIRMATIVE VOTE OF AT LEAST A MAJORITY OF A QUORUM IS NEEDED FOR ANY OFFICIAL ACTION.
5	(E) RULES AND REGULATIONS.
6 7	(1) THE COMMISSION MAY ADOPT RULES AND REGULATIONS TO GOVERN ITS MEETINGS AND OPERATIONS.
8 9	(2) A COPY OF ALL RULES AND REGULATIONS MUST BE FILED WITH THE DEPARTMENT OF LEGISLATIVE REFERENCE BEFORE THEY TAKE EFFECT.
10	§ 29-7. COMMISSION DUTIES.
11	THE COMMISSION'S DUTIES INCLUDE:
12 13	(1) DEVELOPING AND MAINTAINING A 3-YEAR PLAN OF ACTION THAT OUTLINES SPECIFIC AREAS FOR COMMISSION STUDY AND RECOMMENDATIONS;
14	(2) REVIEWING ISSUES RELATING TO PROGRAMS AND SERVICES FOR SENIORS;
15 16	(3) IDENTIFYING AND RECOMMENDING PRIORITIES AMONG PROGRAMS AND SERVICES FOR SENIORS;
17	(4) CREATING A FORUM FOR DISCUSSIONS WITH SENIORS AND THEIR FAMILIES;
18	(5) ADVOCATING SERVICES AND PROGRAMS FOR SENIORS;
19 20	(6) MAKING RECOMMENDATIONS FOR PROGRAMS, POLICIES, PROCEDURES, OR LEGISLATION IT DEEMS NECESSARY TO PROMOTE THE WELL-BEING OF SENIORS;
21	(7) WORKING WITH THE PUBLIC AND PRIVATE SECTOR IN A COLLABORATIVE EFFORT TO:
22	(I) BRING FORTH THE CONCERNS OF SENIORS; AND
23 24	(II) EVALUATE AND STRENGTHEN PROGRAMMING THAT WILL ENHANCE THE QUALITY OF LIFE AND SOCIAL INVOLVEMENT OF SENIORS;
25 26	(8) DEVELOPING A COMMUNICATIONS NETWORK TO SHARE INFORMATION ABOUT PUBLIC AND PRIVATE SERVICES FOR SENIORS;
27	(9) SUBMITTING AN ANNUAL REPORT TO THE MAYOR AND THE CITY COUNCIL; AND
28	(10) PERFORMING ANY OTHER DUTIES THAT THE MAYOR REQUESTS.
29	§ 29-8. {RESERVED}

2	AT THE REQUEST OF THE COMMISSION, ALL CITY OFFICIALS AND AGENCIES MUST EXTEND THE
3	SERVICES AND FACILITIES REQUIRED FOR THE PERFORMANCE OF THE COMMISSION'S DUTIES,
4	TO THE EXTENT THAT THOSE OFFICIALS AND AGENCIES ARE ABLE TO DO SO GIVEN THEIR
5	PERSONNEL AND BUDGETS.
6	SECTION 2. AND BE IT FURTHER ORDAINED, That the catchlines contained in this Ordinance
7	are not law and may not be considered to have been enacted as a part of this or any prior
8	Ordinance.
9	SECTION 3. AND BE IT FURTHER ORDAINED , That this Ordinance takes effect on the 30 th day
10	after the date it is enacted.
