AN ORDINANCE CONCERNING

1                           **Supplementary General Fund Operating Appropriation –**  
2                           **Mayoralty: Miscellaneous General Expenses – \$22,400,000**

3   FOR the purpose of providing a Supplementary General Fund Operating Appropriation in the  
4       amount of \$22,400,000.00 to the Mayoralty: Miscellaneous General Expenses - Service 122  
5       (Miscellaneous General Expenses), to provide funding for Fiscal Year 2022 expenses; and  
6       providing for a special effective date.

12                           **Recitals**

13       The revenue appropriated by this Ordinance represents Transfer Tax in excess of the revenue  
14       relied on by the Board of Estimates in determining the tax levy required to balance the budget for  
15       Fiscal Year 2022.

16       This additional revenue could not have been reasonably anticipated when the Ordinance of  
17       Estimates for Fiscal Year 2022 was formulated.

18       This appropriation is made necessary by a material change in circumstances since the  
19       Ordinance of Estimates for Fiscal Year 2022 was formulated or is for a new program that could  
20       not have been reasonably anticipated when that Ordinance of Estimates was formulated.

21       On October 19, 2022, the Board of Estimates recommended this appropriation to the City  
22       Council.

**Council Bill 22-0313**

1       **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That  
2       \$22,400,000.00 shall be made available to the Mayoralty: Miscellaneous General Expenses -  
3       Service 122 (Miscellaneous General Expenses) as a Supplementary General Fund Operating  
4       Appropriation for Fiscal Year 2022, to provide funding for Fiscal Year 2022 expenses. The  
5       source of revenue for this appropriation is Transfer Tax in excess of the amount from this source  
6       that was relied on by the Board of Estimates in determining the tax levy required to balance the  
7       budget for Fiscal Year 2022.

8       **SECTION 2. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the date it is  
9       enacted.


