A BILL ENTITLED

1 AN ORDINANCE concerning

2 **Supplementary General Fund Operating Appropriation –**  
3 **Department of Planning – \$5,107,420**

4 FOR the purpose of providing a Supplementary General Fund Operating Appropriation in the  
5 amount of \$5,107,420 to the Department of Planning – Service 765 (Planning for a  
6 Sustainable Baltimore), to provide funding for food security program expenses resulting from  
7 the COVID-19 pandemic; and providing for a special effective date.

13 **Recitals**

14 The revenue appropriated by this Ordinance represents funds from the Federal Emergency  
15 Management Agency (“FEMA”) in excess of the revenue relied on by the Board of Estimates in  
16 determining the tax levy required to balance the budget for Fiscal Year 2021.

17 This additional revenue could not have been reasonably anticipated when the Ordinance of  
18 Estimates for Fiscal Year 2021 was formulated.

19 This appropriation is made necessary by a material change in circumstances since the  
20 Ordinance of Estimates for Fiscal Year 2021 was formulated or is for a new program that could  
21 not have been reasonably anticipated when that Ordinance of Estimates was formulated.

22 On September 15, 2021, the Board of Estimates recommended this appropriation to the City  
23 Council.

**Council Bill 21-0135**

1       **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That  
2 \$5,107,420 shall be made available to the Department of Planning – Service 765 (Planning for a  
3 Sustainable Baltimore) as a Supplementary General Fund Operating Appropriation for Fiscal  
4 Year 2021, to provide funding for food security program expenses resulting from the COVID-19  
5 pandemic. The source of revenue for this appropriation is funds from FEMA in excess of the  
6 amount from this source that was relied on by the Board of Estimates in determining the tax levy  
7 required to balance the budget for Fiscal Year 2021.

8       **SECTION 2. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the date it is  
9 enacted.
