A RESOLUTION ENTITLED

1 A COUNCIL RESOLUTION concerning

2 **Investigative Hearing – Police/Civilian Interactions - Transparency**

3 FOR the purpose of requesting the Police Commissioner to report to the City Council on the
4 current policy for the documentation and release of information regarding incidents in which
5 there have been confrontations between police officers and civilians resulting in any physical
6 contact.

7 **Recitals**

8 Early last year the City Council adopted a resolution expressing concern over the
9 announcement by Baltimore police officials that the names of police officers who killed or
10 injured citizens in the line of duty would no longer be released, changing a long-standing
11 practice that law enforcement personnel contended put officers at risk and exposed officers to
12 retaliation from disgruntled members of the public.

13 The change in policy met with opposition by some local elected officials and community
14 activists because it did not further a policy of transparent government, facilitate good
15 police/community relations, support the public’s right to know about possible “problem”
16 officers, or do anything to encourage communities to work with police to solve crimes and
17 overcome a “Stop-Snitching” mentality.

18 At the hearing, the Police Commissioner informed the Council that the policy governing the
19 release of names of police involved in incidents that resulted in the death or injury of civilians
20 had been modified. All pertinent information would be released without the name of the officer
21 involved. After internal review, the names of officers found to be at fault would be released, and
22 the names of those exonerated would be disclosed at the discretion of the Commissioner.

23 Recent events surrounding the serious injury to a prominent member of the black community
24 at the hands of law enforcement call into question the efficacy of the current policy – even with
25 modifications. The Christmas-week arrest and injury of an elderly steward of the community
26 known as the “Mayor of Poppleton” resulted in public demonstrations and outcry for full
27 disclosure.

28 A 73-year old man who has barbered the hair of countless politicians and prominent
29 Baltimoreans since 1974, and who has mentored inner city single mothers, and counseled

1 middle-school boys for most of his adult life, was, in his words, ‘stopped for no reason, thrown
2 to the ground, had a foot put to the back of his neck, his arm broken in 2 places, and then placed
3 in handcuffs, an incident that followed the arrest earlier in the month of another community
4 leader across town.

5 In the other incident, occurring in the first week of December, the Union Square Community
6 Association president was arrested after he called police to investigate the alleged sexual assaults
7 of 2 girls who had sought his assistance. The media reported that police said the man interfered
8 with the investigation; the man arrested said the arrest took place after he simply asked the police
9 a question.

10 Both of these police-involved incidents gave rise to public demonstrations because those
11 involved were “pillars” of the community. There were no demonstrations nor calls for an
12 accounting from the officers involved in the other 20-odd police involved shootings of 2009 –
13 not even in the cases of the 7 people who died.

14 It is time for the police to present a uniform, consistent, fair, and transparent policy in the
15 dissemination of information surrounding police/civilian encounters that result in injury to either
16 party, regardless of the prominence of the victim or the discomfiture of the officer.

17 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE,** That the
18 Police Commissioner is requested to report to the City Council on the current policy for the
19 documentation and release of information regarding incidents in which there have been
20 confrontations between police officers and civilians resulting in any physical contact.

21 **AND BE IT FURTHER RESOLVED,** That a copy of this Resolution be sent to the Mayor; the
22 Police Commissioner; the Honorable Members of the Baltimore City Senate and House
23 Delegations to the Maryland General Assembly; the President of the Baltimore NAACP; the
24 President and Members of Ashburton Area, Ash-East Arlington, Auchentoroly, Robert Coleman,
25 Charles Village Community, Coppin Heights Community, Fulton Heights; GMCC, Hampden;
26 Hanlon Park, Matthew Henson, Mondawmin, Panyway, Park Circle Improvement, Penn North,
27 Remington, Woodbrook, Whittier Monroe, and Wyman Park Community Associations; and the
28 Mayor’s Legislative Liaison to the City Council.
