1	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That
2	\$81,393 shall be made available to the Department of Law - Service 862 (Transactions) as a
3	Supplementary General Fund Operating Appropriation for Fiscal Year 2025, to provide funding
4	to balance the Department of Law's Fiscal Year 2025 budget to cover a deficit caused by
5	contractual spending. The source of revenue for this appropriation is General Fund assigned
6	Fund Balance in excess of the amount from this source that was relied on by the Board of
7	Estimates in determining the tax levy required to balance the budget for Fiscal Year 2025.
