To the Budget & Appropriations Committee, Baltimore City Council District representatives, and Mayor Young,

My name is Ari Eckley. I am 25 years old. I have lived in Bolton Hill near the intersection of Eutaw and Laurens for almost my entire life. I have witnessed the city grieve and rebuild too many times. The constant motif I've come to notice is the excess of power afforded to the Baltimore City police force. Another is, to be frank, the de facto segregation of Baltimore by class - which somehow aligns near perfectly with racial stratification. I have watched nearly every single - for lack of a better term - "housing project" in my immediate vicinity be TORN DOWN and replaced with high price point housing and yuppie white families. I know what gentrification is, and I would personally appreciate it stopping. Displacing and persecuting the most vulnerable members of this township is deplorable. This however, is a digression from my more significant point.

When I was fifteen, one of my closest friends was arrested, rough ridden, and detained. That was the day that I realized that the police force in Baltimore City has a significant problem with racial profiling. This was in 2010. When Freddie Gray died due to injuries incurred from a "rough ride," I knew exactly what he had experienced, because my friend had described his experience to me, sparing no details. I'm frankly glad that my friend didn't die the day he was arrested.

I think very often about the fact that, had he not been rich, or perhaps had he been over the age of 18, he wouldn't have lived.

About a year ago, I was walking to my house from the light rail stop on North Ave. I passed by some young boys, they looked to be maybe 13 at the oldest, cleaning car windshields. I then, less than a block away, saw a police officer parked, watching them. I did in fact ask the officer why he was there and what exactly he was doing. I noticed several things. He was respectful to me, and I believe that was because I am white. He also talked around the reason he was there - if memory serves he was called by someone about some "aggressive boys" near the off-ramp.

They were children. Someone called a police officer on children. This is what happens when you *over-fund and venerate* the police force. People who feel uncomfortable being reminded of the practical realities of living in Baltimore (i.e., squeegee kids - they aren't the exact same kids that were washing windshields when I was a kid but they're there and always have been for as long as I can remember and I don't think they're the problem with Baltimore City) feel inclined to call the police without discretion.

In the midst of a global health pandemic and public outcry against police brutality, it is inappropriate to propose increases to the Baltimore Police Department budget. I urge you to reallocate the Baltimore City Expense Budget, divest interest from the Baltimore Police Department, and invest in social services and education programs, effective for FY 2021.

The majority of the citizens of Baltimore do not intrinsically trust our police force. Investment in programs such as the Affordable Housing Trust Fund, Baltimore Children and Youth Fund, Safe Streets Baltimore, the Office of Employment and Development, the Department of Recreation & Parks, or the Department of Health will have a measurable and lasting impact on public health and safety in a way that excessive measures to fund police never could.
