AN ORDINANCE CONCERNING

**Supplementary General Fund Operating Appropriation –
MR-Civic Promotion – \$297,500**

FOR the purpose of providing a Supplementary General Fund Operating Appropriation in the amount of \$297,500 to the MR-Civic Promotion – Program 590 (Civic Promotion), to provide funding for support of the 2006 National Baptist Convention; and providing for a special effective date.

Recitals

The revenue appropriated by this Ordinance represents funds from the FY 2005 Fiscal Fund Balance in excess of the revenue relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2006.

This additional revenue could not have been reasonably anticipated when the Ordinance of Estimates for Fiscal Year 2006 was formulated.

This appropriation is made necessary by a material change in circumstances since the Ordinance of Estimates for Fiscal Year 2006 was formulated or is for a new program that could not have been reasonably anticipated when that Ordinance of Estimates was formulated.

On March 29, 2006, the Board of Estimates recommended this appropriation to the City Council.

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That \$297,500 shall be made available to the MR-Civic Promotion – Program 590 (Civic Promotion) as a Supplementary General Fund Operating Appropriation for Fiscal Year 2006, to provide
