16	determining the tax levy required to balance the budget for Fiscal Year 2007.		
17	This additional revenue could not have been reasonably anticipated when the Ordinance of		
18	Estimates for Fiscal Year 2007 was formulated.		
19	This appropriation is made necessary by a material change in circumstances since the		
20	Ordinance of Estimates for Fiscal Year 2007 was formulated or is for a new program that could		
21	not have been reasonably anticipated when that Ordinance of Estimates was formulated.		
22	On July 19, 2006, the Board of Estimates recommended this appropriation to the City		
23	Council.

The source of revenue for this appropriation is from the Mayor and City Council Real Property Fund in excess of the amount from this source that was relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2007.
