### **AN ORDINANCE CONCERNING**

#### Rezoning - 200 North Central Avenue and 249 Aisquith Street

- 2 FOR the purpose of changing the zoning for the property properties known as 200 North Central Avenue (Block 1320, Lot 001), (Block 1320, Lot 001) and 249 Aisquith Street (Block 1320, 3 Lot 001A), as outlined in red on the accompanying plat, from the EC-2 Zoning District to the 4

12 SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That Sheet 56 of the Zoning District Maps is amended by changing from the EC-2 Zoning District to 13 the C-2 Zoning District the property properties known as 200 North Central Avenue 14 15

- (Block 1320, Lot 001), (Block 1320, Lot 001) and 249 Aisquith Street (Block 1320, Lot 001A),
- 16 as outlined in red on the plat accompanying this Ordinance.

SECTION 2. AND BE IT FURTHER ORDAINED, That as evidence of the authenticity of the 17 18 accompanying plat and in order to give notice to the agencies that administer the City Zoning Ordinance: (i) when the City Council passes this Ordinance, the President of the City Council 19 shall sign the plat; (ii) when the Mayor approves this Ordinance, the Mayor shall sign the plat; 20 and (iii) the Director of Finance then shall transmit a copy of this Ordinance and the plat to the 21 Board of Municipal and Zoning Appeals, the Planning Commission, the Commissioner of 22 23 Housing and Community Development, the Supervisor of Assessments for Baltimore City, and the Zoning Administrator. 24
