3	For the purpose of amending the Urban Renewal Plan for Broadway East to reauthorize the
4	acquisition of properties within the Project Area, to remove certain properties from the list in
5	Appendix A, and to correct and clarify certain language; waiving certain content and
6	procedural requirements; making the provisions of this Ordinance severable; providing for
7	the application of this Ordinance in conjunction with certain other ordinances; and providing
8	for a special effective date.

14	Recitals
15 16	The Urban Renewal Plan for Broadway East was originally approved by the Mayor and City Council of Baltimore by Ordinance 88-156 and last amended by Ordinance 02-457.
10	Council of Baltimore by Ordinance 66-150 and last amended by Ordinance 62-457.
17	An amendment to the Urban Renewal Plan for Broadway East is necessary to reauthorize the
18	Plan's powers of acquisition and condemnation so that these actions may legally continue, in
19	compliance with § 12-105.1 of the Real Property Article of the Annotated Code of Maryland, to
20	remove certain properties from the list in Appendix A, and to correct and clarify certain
21	language.
22	Under Article 13, § 2-6 of the Baltimore City Code, no substantial change may be made in
23	any approved renewal plan unless the change is approved in the same manner as that required for
24	the approval of a renewal plan.
25	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the
26	following changes in the Urban Renewal Plan for Broadway East are approved:

20	as rear or side yard space for adjacent property. The acquisition of properties
21	adjacent to or abutting streets and alleys being closed will also include all rights,
22	title, and interest or any private rights of use in and to the adjacent streets, rights-
23	of-way, or alleys as shown lying within the perimeter of the Land

5	SECTION 2. AND BE IT FURTHER ORDAINED, That the Urban Renewal Plan for Broadway
6	East, as amended by this Ordinance and identified as "Urban Renewal Plan, Broadway East,
7	revised to include Amendment 3, dated February 28, 2011", is approved. The Department of
8	Planning shall file a copy of the amended Urban Renewal Plan with the Department of
9	Legislative Reference as a permanent public record, available for public inspection and
10	information.
11	SECTION 3. AND BE IT FURTHER ORDAINED, That if the amended Urban Renewal Plan
12	approved by this Ordinance in any way fails to meet the statutory requirements for the content of
13	a renewal plan or for the procedures for the preparation, adoption, and approval of a renewal
14	plan, those requirements are waived and the amended Urban Renewal Plan approved by this
15	Ordinance is exempted from them.
16	SECTION 4. AND BE IT FURTHER ORDAINED, That if any provision of this Ordinance or the
17	application of this Ordinance to any person or circumstance is held invalid for any reason, the
18	invalidity does not affect any other provision or any other application of this Ordinance, and for
19	this purpose the provisions of this Ordinance are declared severable.
20	SECTION 5. AND BE IT FURTHER ORDAINED, That if a provision of this Ordinance concerns
21	the same subject as a provision of any zoning, building, electrical, plumbing, health, fire, or
22	safety law or regulation, the applicable provisions shall be construed to give effect to each.
23	However, if the provisions are found to be in irreconcilable conflict, the one that establishes the
24	higher standard for the protection of the public health and safety prevails. If a provision of this
25	Ordinance is found to be in conflict with an existing provision of any other law or regulation that
26	establishes a lower standard for the protection of the public health and safety, the provision of
27	this Ordinance prevails and the other conflicting provision is repealed to the extent of the
28	conflict.
