Re: Bill; 11-657 {"Corrective Bill 2011 – General"}

Bill 11-657, as its title indicates, is a periodic corrective bill intended to "correc[t] ... technical errors and omissions in the City Code; repea[l] ... obsolete or otherwise unnecessary provisions; [and] correc[t], clarif[y], and confor[m related] language".

For each correction made, a "Comment" is appended to explain the reason for that correction. In all cases, care has been taken to assure that the change is technical in nature only and does not implicate policy decisions of the Mayor and City Council.

Since the Bill's introduction, a few additional provisions in need of correction have come to light. Attached to this letter, therefore, are proposed amendments to Bill 11-657 that would include these additional corrections. Again, "Comments" are appended to explain each amendment.


The Department of Legislative Reference recommends the passage of Bill 11-657, with the attached proposed amendments.

AMENDMENTS TO COUNCIL BILL 11-657 (First ReaderCopy)

Amendment No. 1

On page 1, in lines 10 and 15, on page 2, in line 33, on page 3, in lines 8 and 20, in each instance, strike "Ord. 11-xxx" and substitute "Ord. 11-419".

Amendment No. 2

On page 1, in line 8, after "IBC", insert "§ 117.5,"; and, on page 2, after line 30, insert:

"Chapter 1. Administration

Section 117 Emergency and Corrective Measures

117.5 Liability for costs of emergency work. Liability for expenses incurred in the course of performing emergency work and the procedure for collecting resultant debts and liens are as provided in [§ 117] § 118 of this Code.

On page 1, after line 25, insert:

On page 2, in line 18, after the last comma, insert "and"; and, on the same page, in line 19, strike "and (o-2)(3)(ii),"; and, in the same line, after "7(a)(2nd par),", insert "9(o-2)(3)(ii),"; and, on page 8, strike lines 30 through 38, in their entireties; and, on page 9, after line 14, insert.

"§ 9. Class C membership.

(0-2) Line-of-duty death benefit.

(3) Death without beneficiaries or estate.

The amounts that would have been paid under this subsection (o-2). excluding membership contribution accounts, with interest, forever remain assets of the System if:
