14	The revenue appropriated by this Ordinance represents funds from the Fiscal 2006 Fund	
15	Balance in excess of the revenue relied on by the Board of Estimates in determining the tax levy	
16	required to balance the budget for Fiscal Year 2007.	
17	This additional revenue could not have been reasonably anticipated when the Ordinance of	
18	Estimates for Fiscal Year 2007 was formulated.	
19	This appropriation is made necessary by a material change in circumstances since the	
20	Ordinance of Estimates for Fiscal Year 2007 was formulated or is for a new program that could	
21	not have been reasonably anticipated when that Ordinance of Estimates was formulated.	
22	The purpose of this Ordinance is to make available \$440,000 to the MR-Art and Culture -	
23	Program 493 (Art and Culture Grants) in order to provide funding to the Jewish Museum of	
24	Maryland, Inc. The Jewish Museum of Maryland, Inc., may use the funds solely for restoration	
25	of the Lloyd Street Synagogue historic site.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That \$440,000 shall be made available to the MR-Art and Culture – Program 493 (Art and Culture Grants) as a Supplementary General Fund Operating Appropriation for Fiscal Year 2007, to provide funding to the Jewish Museum of Maryland, Inc., for restoration work to be performed at the Lloyd Street Synagogue/Jewish Museum historic site. The source of revenue for this appropriation is from the Fiscal 2006 Fund Balance in excess of the amount from this source that was relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2007.
