1 AN ORDINANCE concerning

Historical and Architectural Preservation – 50th Anniversary Reauthorization

3 FOR the purpose of reconstituting and reauthorizing the Commission for Historical and
4 Architectural Preservation; restating and clarifying the Commission's powers, duties, and
5 functions; substituting a new, short-lived "Potential-Landmark List" for the current "Special
6 List"; modifying the processes for designating Historical and Architectural Preservation
7 Districts, Landmarks, and Potential Landmarks; modifying the procedures for protecting the
8 exteriors, interiors, and appurtenant property of structures located within an Historical
9 District or included on the Landmark List or Potential-Landmark List; modifying the
10 provisions that require review of proposed alterations to "municipal structures"; providing for
11 the establishment and maintenance of an Inventory of Historical Places, to serve primarily as
12 a non-regulatory research and documentation instrument; modifying the procedures for
13 reviewing and criteria for approving proposed alterations to protected structures; authorizing
14 the Commission to delegate to its professional staff the review and approval of minor,
15 compliant alterations; defining various terms; correcting, clarifying, and conforming related
16 provisions; repealing obsolete provisions; and generally relating to the designation and
17 preservation of historically and architecturally significant property.

28 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That:**

29 (a) City Code Article 6 {"Historical and Architectural Preservation"}, Subtitles 1 through
30 5, are repealed, and

31 (b) new Subtitles 1 through 9 are added to Article 6, to read as follows:

33 **Article 6. Historical and Architectural Preservation**

34 **SUBTITLE 1. DEFINITIONS; GENERAL PROVISIONS**

1 **§ 1-1. DEFINITIONS.**

2 (A) *IN GENERAL.*

3 IN THIS ARTICLE, THE FOLLOWING TERMS HAVE THE MEANINGS INDICATED.

4 (B) *BUILDING OFFICIAL.*

5 “BUILDING OFFICIAL” HAS THE MEANING STATED IN § 103.1 OF THE BALTIMORE CITY
6 BUILDING CODE.

7 (C) *COMMISSION; CHAP.*

8 “COMMISSION” OR “CHAP” MEANS THE COMMISSION FOR HISTORICAL AND
9 ARCHITECTURAL PRESERVATION ESTABLISHED UNDER THIS ARTICLE.

10 (D) *DEMOLITION.*

11 “DEMOLITION” INCLUDES “DEMOLITION BY NEGLECT”, WHICH MEANS NEGLECT IN THE
12 MAINTENANCE OR REPAIR OF A STRUCTURE, RESULTING IN ANY OF THE FOLLOWING
13 CONDITIONS:

- 14 (1) THE DETERIORATION OF ANY ARCHITECTURAL FEATURE SO AS TO CREATE OR
15 PERMIT THE CREATION OF A HAZARDOUS OR UNSAFE CONDITION;
- 16 (2) THE DETERIORATION OF WALLS OR OTHER VERTICAL SUPPORTS;
- 17 (3) THE DETERIORATION OF ROOFS OR OTHER HORIZONTAL MEMBERS;
- 18 (4) THE DETERIORATION OF CHIMNEYS;
- 19 (5) THE DETERIORATION OR CRUMBLING OF PLASTER OR MORTAR; OR
- 20 (6) THE INEFFECTIVE WATERPROOFING OF WALLS, ROOFS, AND FOUNDATIONS,
21 INCLUDING BROKEN WINDOWS AND DOORS.

22 (E) *EXECUTIVE DIRECTOR; DIRECTOR.*

23 “EXECUTIVE DIRECTOR” OR “DIRECTOR” MEANS THE EXECUTIVE DIRECTOR OF THE
24 COMMISSION FOR HISTORICAL AND ARCHITECTURAL PRESERVATION OR THE DIRECTOR’S
25 DESIGNEE.

26 (F) *HISTORICAL AND ARCHITECTURAL PRESERVATION DISTRICT; PRESERVATION DISTRICT;
27 DISTRICT.*

28 “HISTORICAL AND ARCHITECTURAL PRESERVATION DISTRICT”, “PRESERVATION
29 DISTRICT”, OR “DISTRICT” MEANS AN AREA DESIGNATED AS AN HISTORICAL AND
30 ARCHITECTURAL PRESERVATION DISTRICT UNDER SUBTITLE 3 {“DESIGNATION OF
31 DISTRICTS”}, OF THIS ARTICLE.

1 (G) *INCLUDES; INCLUDING.*

2 “INCLUDES” OR “INCLUDING” MEANS BY WAY OF ILLUSTRATION AND NOT BY WAY OF
3 LIMITATION.

4 (H) *LANDMARK.*

5 “LANDMARK” MEANS A PROPERTY LISTED ON A LANDMARK LIST.

6 (I) *LANDMARK LIST.*

7 “LANDMARK LIST” MEANS EITHER OR BOTH OF THE FOLLOWING, AS ESTABLISHED AND
8 MAINTAINED UNDER SUBTITLE 4 {“DESIGNATION OF LANDMARKS”}, OF THIS ARTICLE:

9 (1) THE LANDMARK LIST: EXTERIORS; AND

10 (2) THE LANDMARK LIST: PUBLIC INTERIORS.

11 (J) *PERSON.*

12 (1) *IN GENERAL.*

13 “PERSON” MEANS:

14 (I) AN INDIVIDUAL;

15 (II) A PARTNERSHIP, FIRM, ASSOCIATION, CORPORATION, OR OTHER ENTITY OF ANY
16 KIND; OR

17 (III) A RECEIVER, TRUSTEE, GUARDIAN, PERSONAL REPRESENTATIVE, FIDUCIARY,
18 OR REPRESENTATIVE OF ANY KIND.

19 (2) *INCLUSIONS.*

20 “PERSON” INCLUDES, EXCEPT AS USED IN § 9-4 {“CRIMINAL PENALTIES”} OF THIS
21 ARTICLE, A GOVERNMENTAL ENTITY OR AN INSTRUMENTALITY OR UNIT OF A
22 GOVERNMENTAL ENTITY.

23 (K) *POTENTIAL LANDMARK.*

24 “POTENTIAL LANDMARK” MEANS A PROPERTY LISTED ON A POTENTIAL-LANDMARK LIST.

25 (L) *POTENTIAL-LANDMARK LIST.*

26 “POTENTIAL-LANDMARK LIST” MEANS EITHER OR BOTH OF THE FOLLOWING, AS
27 ESTABLISHED AND MAINTAINED UNDER SUBTITLE 5 {“DESIGNATION OF POTENTIAL
28 LANDMARKS”}, OF THIS ARTICLE:

1 (1) THE POTENTIAL-LANDMARK LIST: EXTERIORS; AND

2 (2) THE POTENTIAL-LANDMARK LIST: PUBLIC INTERIORS.

3 (M) *PUBLIC INTERIOR.*

4 ““PUBLIC INTERIOR” MEANS ANY PART OF A STRUCTURE’S INTERIOR THAT IS DETERMINED
5 BY THE COMMISSION TO BE:

6 (1) CUSTOMARILY OPEN OR ACCESSIBLE TO THE PUBLIC; AND

7 (2) OF HISTORICAL OR ARCHITECTURAL SIGNIFICANCE.

8 (N) *REGULATED ALTERATION.*

9 “REGULATED ALTERATION” MEANS ANY ADDITION, ALTERATION OR OTHER ACTION
10 DESCRIBED IN § 8-2(A) {“BUILDING PERMIT REQUIRED: EXTERIOR STRUCTURES”} OR
11 § 8-2(B) {“BUILDING PERMIT REQUIRED: PUBLIC INTERIORS”}, AS THE CASE MAY BE, OF
12 THIS ARTICLE.

13 (O) *STRUCTURE.*

14 “STRUCTURE” MEANS ANY CREATION OF MAN OR NATURE.

15 **§ 1-2. RULES OF CONSTRUCTION.**

16 (A) *IN GENERAL.*

17 IN INTERPRETING AND APPLYING THIS ARTICLE, THE FOLLOWING RULES OF CONSTRUCTION
18 APPLY.

19 (B) *CAPTIONS OR HEADINGS.*

20 THE CAPTIONS OR HEADINGS OF THE VARIOUS SECTIONS AND SUBSECTIONS:

21 (1) ARE FOR CONVENIENCE OF REFERENCE ONLY, INTENDED TO SUMMARIZE THE
22 STATUTORY PROVISIONS THAT FOLLOW; AND

23 (2) ARE NOT LAW AND ARE NOT TO BE TAKEN AS AFFECTING THE MEANING OR EFFECT
24 OF THE LAW.

25 (C) *GENDER.*

26 WORDS DENOTING ONE GENDER INCLUDE AND APPLY TO THE OTHER GENDERS AS WELL.

1 (D) *MANDATORY, PROHIBITORY, AND PERMISSIVE TERMS.*

2 (1) *MANDATORY TERMS.*

3 “MUST” AND “SHALL” ARE EACH MANDATORY TERMS USED TO EXPRESS A
4 REQUIREMENT OR TO IMPOSE A DUTY.

5 (2) *PROHIBITORY TERMS.*

6 “MUST NOT”, “MAY NOT”, AND “NO ... MAY” ARE EACH MANDATORY NEGATIVE TERMS
7 USED TO ESTABLISH A PROHIBITION.

8 (3) *PERMISSIVE TERMS.*

9 “MAY” IS PERMISSIVE.

10 (E) *NUMBER.*

11 THE SINGULAR INCLUDES THE PLURAL AND VICE VERSA.

12 (F) *REFERENCES TO OTHER LAWS.*

13 WHENEVER A PROVISION OF THIS ARTICLE REFERS TO ANY PART OF THE CITY CODE OR TO
14 ANY OTHER LAW, THE REFERENCE APPLIES TO ANY SUBSEQUENT AMENDMENT OF THE LAW
15 REFERRED TO, UNLESS THE REFERRING PROVISION EXPRESSLY PROVIDES OTHERWISE.

16 (G) *SEVERABILITY.*

17 ALL PROVISIONS OF THIS ARTICLE ARE SEVERABLE. IF A COURT DETERMINES THAT A
18 WORD, PHRASE, CLAUSE, SENTENCE, PARAGRAPH, SUBSECTION, SECTION, OR OTHER
19 PROVISION IS INVALID OR THAT THE APPLICATION OF ANY PART OF THE PROVISION TO ANY
20 PERSON OR CIRCUMSTANCES IS INVALID, THE REMAINING PROVISIONS AND THE
21 APPLICATION OF THOSE PROVISIONS TO OTHER PERSONS OR CIRCUMSTANCES ARE NOT
22 AFFECTED BY THAT DECISION.

23 (H) *TIME COMPUTATIONS.*

24 (1) *COMPUTATION OF TIME AFTER AN ACT, EVENT, OR DEFAULT.*

25 (I) IN COMPUTING ANY PERIOD OF TIME PRESCRIBED BY THIS ARTICLE, OR BY A RULE
26 OR REGULATION ADOPTED UNDER THIS ARTICLE, THE DAY OF THE ACT, EVENT, OR
27 DEFAULT AFTER WHICH THE DESIGNATED PERIOD OF TIME BEGINS TO RUN IS NOT
28 INCLUDED.

29 (II) IF THE PERIOD OF TIME ALLOWED IS MORE THAN 7 DAYS, INTERMEDIATE
30 SATURDAYS, SUNDAYS, AND LEGAL HOLIDAYS ARE COUNTED.

31 (III) IF THE PERIOD OF TIME ALLOWED IS 7 DAYS OR LESS, INTERMEDIATE SATURDAYS,
32 SUNDAYS, AND LEGAL HOLIDAYS ARE NOT COUNTED.

1 (IV) THE LAST DAY OF THE PERIOD SO COMPUTED IS INCLUDED UNLESS IT IS A
2 SATURDAY, SUNDAY, OR LEGAL HOLIDAY, IN WHICH EVENT THE PERIOD RUNS
3 UNTIL THE END OF THE NEXT DAY THAT IS NOT A SATURDAY, SUNDAY, OR LEGAL
4 HOLIDAY.

5 (2) *COMPUTATION OF TIME BEFORE A DAY, ACT, OR EVENT.*

6 (I) IN DETERMINING THE LATEST DAY FOR PERFORMING AN ACT THAT THIS ARTICLE,
7 OR A RULE OR REGULATION ADOPTED UNDER THIS ARTICLE, REQUIRES TO BE
8 PERFORMED A PRESCRIBED NUMBER OF DAYS BEFORE A CERTAIN DAY, ACT, OR
9 EVENT, ALL DAYS PRECEDING THAT DAY, INCLUDING INTERVENING SATURDAYS,
10 SUNDAYS, AND LEGAL HOLIDAYS, ARE COUNTED IN THE NUMBER OF DAYS SO
11 PRESCRIBED.

12 (II) THE LATEST DAY IS INCLUDED IN THE DETERMINATION UNLESS IT IS A SATURDAY,
13 SUNDAY, OR LEGAL HOLIDAY, IN WHICH EVENT THE LATEST DAY IS THE FIRST
14 PRECEDING DAY THAT IS NOT A SATURDAY, SUNDAY, OR LEGAL HOLIDAY.

15 **§ 1-3. {RESERVED}**

16 **§ 1-4. PURPOSE OF ARTICLE.**

17 (A) *AREAS AND STRUCTURES TO BE PRESERVED.*

18 (1) BALTIMORE CITY CONTAINS A NUMBER OF SIGNIFICANT AREAS WITHIN WHICH ARE
19 LOCATED VARIOUS BUILDINGS AND OTHER STRUCTURES THAT CONTRIBUTE TO THE
20 HISTORICAL OR ARCHITECTURAL SIGNIFICANCE OF THE AREA. THE PRESERVATION OF
21 THESE AREAS IS APPROPRIATE AND NECESSARY FOR THE EDUCATIONAL, CULTURAL,
22 ECONOMIC, AND GENERAL WELFARE OF THE PUBLIC.

23 (2) BALTIMORE CITY CONTAINS AN EVEN GREATER NUMBER OF INDIVIDUALLY
24 SIGNIFICANT BUILDINGS AND OTHER STRUCTURES THAT HAVE SPECIAL HISTORICAL OR
25 ARCHITECTURAL SIGNIFICANCE. THE PRESERVATION OF THESE INDIVIDUAL
26 STRUCTURES IS EQUALLY APPROPRIATE AND NECESSARY FOR THE EDUCATIONAL,
27 CULTURAL, ECONOMIC, AND GENERAL WELFARE OF THE PUBLIC.

28 (B) *NEED FOR CONTROLS OR RESTRICTIONS.*

29 TO PRESERVE THESE SIGNIFICANT AREAS AND INDIVIDUAL STRUCTURES, IT IS NECESSARY
30 TO IMPOSE CONTROLS AND RESTRICTIONS ON OR IN CONNECTION WITH THEM.

31 (C) *CREATION OF CHAP.*

32 FOR THESE PURPOSES, THE MAYOR AND CITY COUNCIL OF BALTIMORE HAS ENACTED THIS
33 ARTICLE, ESTABLISHING THE COMMISSION FOR HISTORICAL AND ARCHITECTURAL
34 PRESERVATION AND VESTING IT WITH THE POWERS AND DUTIES NEEDED TO ADMINISTER
35 AND ENFORCE THE PROVISIONS OF THIS ARTICLE.

SUBTITLE 2. COMMISSION FOR HISTORICAL AND ARCHITECTURAL PRESERVATION

§ 2-1. CHAP ESTABLISHED.

THERE IS A COMMISSION FOR HISTORICAL AND ARCHITECTURAL PRESERVATION, CONSTITUTED AS AN INDEPENDENT UNIT OF THE DEPARTMENT OF PLANNING.

§ 2-2. COMPOSITION.

(A) *GENERAL.*

THE COMMISSION FOR HISTORICAL AND ARCHITECTURAL PRESERVATION COMPRISES 13 MEMBERS.

(B) *APPOINTED MEMBERS.*

11 MEMBERS ARE APPOINTED BY THE MAYOR, IN ACCORDANCE WITH CITY CHARTER ARTICLE IV, § 6, AS FOLLOWS:

- (1) 1 MEMBER TO BE NOMINATED BY THE GREATER BALTIMORE COMMITTEE;
- (2) 1 MEMBER TO BE NOMINATED BY BALTIMORE HERITAGE;
- (3) 1 MEMBER TO BE NOMINATED BY THE BOARD OF DIRECTORS OF PRESERVATION MARYLAND;
- (4) 1 MEMBER TO BE NOMINATED BY THE BOARD OF THE BALTIMORE CITY HISTORICAL SOCIETY, INC.; AND
- (5) 7 MEMBERS APPOINTED AT-LARGE.

(C) *CITY REPRESENTATIVES.*

- (1) 1 MEMBER IS A COUNCILMEMBER, TO BE DESIGNATED BY THE COUNCIL PRESIDENT.
- (2) 1 MEMBER IS THE COMMISSIONER OF HOUSING AND COMMUNITY DEVELOPMENT OR THE COMMISSIONER'S DESIGNEE.

§ 2-3. QUALIFICATIONS.

(A) *GENERAL.*

EACH MEMBER:

- (1) MUST BE A RESIDENT OF BALTIMORE CITY; AND
- (2) MUST DEMONSTRATE A SPECIAL INTEREST, KNOWLEDGE, OR TRAINING IN SUCH FIELDS AS HISTORY, ARCHITECTURE, PRESERVATION, AFRICAN-AMERICAN HISTORY, OR URBAN DESIGN.

1 (B) *APPOINTED MEMBERS.*

2 OF THE 11 MEMBERS APPOINTED BY THE MAYOR UNDER § 2-2(B) {"COMPOSITION:
3 APPOINTED MEMBERS"} OF THIS SUBTITLE:

4 (1) AT LEAST 1 MEMBER MUST BE AN HISTORIAN KNOWLEDGEABLE IN THE
5 ARCHITECTURE, HISTORY, AND CULTURE OF BALTIMORE CITY;

6 (2) AT LEAST 1 MEMBER MUST BE AN HISTORIAN KNOWLEDGEABLE IN THE AFRICAN-
7 AMERICAN HISTORY AND CULTURE OF BALTIMORE CITY;

8 (3) AT LEAST 2 MEMBERS MUST BE LICENSED ARCHITECTS KNOWLEDGEABLE IN
9 ARCHITECTURAL PRESERVATION;

10 (4) AT LEAST 1 MEMBER MUST BE A LICENSED REAL ESTATE BROKER DOING BUSINESS
11 IN BALTIMORE CITY;

12 (5) AT LEAST 1 MEMBER MUST OWN AND OCCUPY A CONTRIBUTING RESIDENCE WITHIN
13 AN HISTORICAL AND ARCHITECTURAL PRESERVATION DISTRICT;

14 (6) AT LEAST 1 MEMBER MUST OWN AND OPERATE A CONTRIBUTING COMMERCIAL
15 PROPERTY WITHIN AN HISTORICAL AND ARCHITECTURAL PRESERVATION
16 DISTRICT; AND

17 (7) EACH OF AT LEAST 2 DIFFERENT MEMBERS MUST DEMONSTRATE A SPECIAL
18 INTEREST, KNOWLEDGE, OR TRAINING IN 1 OF THE FOLLOWING FIELDS, NOT
19 OTHERWISE WITHIN THE SPECIAL INTEREST, KNOWLEDGE, OR TRAINING OF THE
20 OTHER MEMBER:
21 (I) LANDSCAPE ARCHITECTURE;
22 (II) ARCHEOLOGY; AND
23 (III) CONSTRUCTION OR ENGINEERING.

24 **§ 2-4. TERM OF APPOINTED MEMBERS.**

25 (A) *REGULAR TERMS.*

26 (1) EACH OF THE 11 MEMBERS APPOINTED UNDER § 2-2(B) {"COMPOSITION: APPOINTED
27 MEMBERS"} OF THIS SUBTITLE SERVES FOR A TERM CONCURRENT WITH THE MAYOR'S
28 TERM OF OFFICE AND UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIES.

29 (2) THE COUNCILMEMBER DESIGNATED UNDER § 2-2(C)(1) {"COMPOSITION: CITY
30 REPRESENTATIVES"} OF THIS SUBTITLE SERVES A TERM CONCURRENT WITH THAT
31 COUNCILMEMBER'S SERVICE ON THE COUNCIL.

32 (B) *FILLING VACANCY.*

33 A MEMBER APPOINTED TO FILL A VACANCY IN AN UNEXPIRED TERM SERVES FOR THE
34 REMAINDER OF THAT TERM.

(C) *TERM LIMITS.*

A MEMBER MAY NOT BE APPOINTED UNDER § 2-2(B) OR (C)(1) OF THIS SUBTITLE TO SERVE MORE THAN 2 CONSECUTIVE TERMS.

(D) *REMOVAL ON FAILURE TO ATTEND MEETINGS.*

(1) ANY MEMBER WHO, DURING ANY PERIOD OF 12 CONSECUTIVE MONTHS, FAILS TO ATTEND 6 REGULARLY SCHEDULED MONTHLY MEETINGS OF THE COMMISSION IS CONSIDERED TO HAVE RESIGNED.

(2) THE CHAIR OF THE COMMISSION MUST FORWARD THE MEMBER'S NAME TO THE MEMBER'S APPOINTING AUTHORITY AS SOON AS PRACTICABLE FOLLOWING THE 6TH UNATTENDED MEETING.

(3) THE APPOINTING AUTHORITY MUST THEN APPOINT A SUCCESSOR FOR THE REST OF THE TERM.

§ 2-5. OFFICERS; COMPENSATION.

(A) *CHAIR AND VICE-CHAIR.*

(1) THE MAYOR DESIGNATES ONE OF THE COMMISSION MEMBERS TO SERVE AS THE COMMISSION'S CHAIR.

(2) THE COMMISSION ELECTS ONE OF THE COMMISSION MEMBERS TO SERVE AS THE COMMISSION'S VICE-CHAIR.

(B) *COMPENSATION.*

THE MEMBERS OF THE COMMISSION:

(1) SERVE WITHOUT COMPENSATION; BUT

(2) ARE ENTITLED TO REIMBURSEMENT OF REASONABLE EXPENSES INCURRED, AS PROVIDED IN THE ORDINANCE OF ESTIMATES.

§ 2-6. EXECUTIVE DIRECTOR.

(A) *APPOINTMENT.*

(1) THE EXECUTIVE DIRECTOR FOR HISTORICAL AND ARCHITECTURAL PRESERVATION IS APPOINTED BY THE COMMISSION.

(3) IF THE LIST IS NOT SATISFACTORY TO THE COMMISSION, THE DIRECTOR OF PLANNING MUST PROVIDE A NEW LIST UNTIL A SATISFACTORY LIST OF CANDIDATES IS SUBMITTED

(B) *QUALIFICATIONS.*

§ 2-7. STAFF AND CONSULTANTS.

(1) THE DEPARTMENT OF PLANNING SERVES AS STAFF TO THE COMMISSION.

(2) STAFF SERVING IN THE PLANNING DEPARTMENT'S HISTORICAL AND ARCHITECTURAL PRESERVATION DIVISION MUST MEET THE QUALIFICATIONS OF A POSITION DESCRIPTION THAT CONFORMS TO THE "PROFESSIONAL QUALIFICATIONS STANDARDS" OF THE SECRETARY OF THE INTERIOR'S "STANDARDS AND GUIDELINES FOR ARCHEOLOGY AND HISTORIC PRESERVATION".

(B) *CONSULTANTS.*

THE COMMISSION MAY EMPLOY CONSULTANTS AND OTHER PERSONNEL NECESSARY OR APPROPRIATE FOR THE PROPER PERFORMANCE OF ITS DUTIES, AS PROVIDED IN THE ORDINANCE OF ESTIMATES.

34 (IV) REVIEWING AND DETERMINING THE APPROPRIATENESS OF PROPOSED
35 ALTERATIONS TO OR AFFECTING PROTECTED PROPERTIES, AS PROVIDED IN

(VII) GENERAL ADMINISTRATION AND ENFORCEMENT OF THE PROVISIONS OF THIS ARTICLE AND OF ANY OTHER DUTIES IMPOSED ON THE COMMISSION BY LAW.

(B) *GRANTS, LOANS, ETC.*

THE COMMISSION MAY, ON BEHALF OF THE MAYOR AND CITY COUNCIL OF BALTIMORE AND WITH THE PRIOR APPROVAL OF THE BOARD OF ESTIMATES, CONTRACT WITH OR ACCEPT ANY GRANT, LOAN, OR AID OF ANY KIND FROM ANY FEDERAL, STATE, OR PRIVATE SOURCE, TO BE EXPENDED FOR THE PURPOSES CONTEMPLATED BY THIS ARTICLE, INCLUDING THE PURPOSES LISTED IN SUBSECTION (A)(2) OF THIS SECTION.

(C) PROCEEDS FROM RESALE OF PROPERTIES.

IF PERMITTED BY THE CITY CHARTER, SUMS RECEIVED FROM THE RESALE OF PROPERTIES ACQUIRED AND RESTORED BY OR ON BEHALF OF THE COMMISSION MAY BE RETAINED BY THE COMMISSION FOR THE ACQUISITION AND RESTORATION OF ADDITIONAL PROPERTIES.

§ 2-10. INCENTIVE IMPROVEMENT PROGRAM.

(A) *PROGRAM ESTABLISHED.*

(C) *LIMITATIONS.*

IN NO EVENT MAY THE COMMISSION AUTHORIZE ANY REIMBURSEMENT UNDER THE PROGRAM UNTIL ALL OF THE WORK TO BE DONE AND THE ESTIMATED COST OF THAT WORK HAS BEEN APPROVED BY THE COMMISSION.

1 (D) *COMMISSION DISCRETION.*

2 IN ALL CASES, THE COMMISSION RETAINS FULL DISCRETION TO DETERMINE THE SCOPE,

35 FOR OBTAINING ADDITIONAL INFORMATION ON THE PROPOSAL AND UPDATED

(C) *TIMING OF HEARING.*

§ 5-5. PROTECTIONS PENDING DECISION.

FROM THE TIME THE SIGN IS POSTED UNTIL THE COMMISSION MAKES ITS FINAL DECISION, THE STRUCTURE IS SUBJECT TO THE REQUIREMENTS, PROCEDURES, AND PROTECTIONS OF SUBTITLE 8 {"ALTERATIONS, ETC., TO OR AFFECTING PROPERTIES"} OF THIS ARTICLE.

§ 5-6. EXPIRATION OF DESIGNATION.

(2) IF A PROPOSED LANDMARK ORDINANCE IS INTRODUCED INTO THE CITY COUNCIL BEFORE THAT 180TH DAY BUT HAS NOT YET BEEN ENACTED, 1 YEAR FROM THE DATE OF THE PROPOSED ORDINANCE'S INTRODUCTION.

§ 5-7. LIMITATIONS ON RE-PROPOSAL.

(A) *SCOPE.*

THIS SECTION APPLIES TO:

(1) ANY PROPERTY FOR WHICH NOTICE OF ITS PROPOSED ADDITION TO THE POTENTIAL-LANDMARK LIST WAS POSTED UNDER § 5-4 {"PROCEDURE TO DESIGNATE"} OF THIS ARTICLE, BUT FOR WHICH NO FINAL DECISION TO INCLUDE IT ON THE LIST WAS RENDERED WITHIN THE PERIOD REQUIRED BY THAT SECTION; OR

(2) ANY PROPERTY THAT WAS INCLUDED ON THE POTENTIAL-LANDMARK LIST, BUT WHOSE DESIGNATION HAS EXPIRED BY OPERATION OF § 5-6 {"EXPIRATION OF DESIGNATION"} OF THIS ARTICLE.

15 MEMBERS OF THE CITY COUNCIL; OR

17 AUTHORIZING THE COMMISSION TO DO SO.

1 § 6-2. PURPOSE OF INVENTORY.

2 THE PRIMARY PURPOSE OF THE INVENTORY IS TO SERVE AS A RESEARCH AND
3 DOCUMENTATION INSTRUMENT THAT INFORMS AND PROVIDES GUIDANCE TO THE
4 DEPARTMENT OF PLANNING AND THE COMMISSION FOR HISTORICAL AND ARCHITECTURAL
5 PRESERVATION.

6 § 6-3. NON-REGULATORY NATURE OF INVENTORY.

7 (A) *GENERAL.*

8 EXCEPT ONLY AS OTHERWISE EXPRESSLY PROVIDED IN THIS ARTICLE, THE INVENTORY IS
9 NOT A REGULATORY INSTRUMENT.

10 (B) *NO DETERMINATION OF ELIGIBILITY FOR DESIGNATION.*

11 INCLUSION OF AN AREA OR STRUCTURE IN THE INVENTORY IS NOT A DETERMINATION OF
12 ELIGIBILITY FOR DESIGNATION AS A PRESERVATION DISTRICT, LANDMARK, OR POTENTIAL
13 LANDMARK.

14 SUBTITLE 7. SUBDIVISION OF DESIGNATED PROPERTIES

15 § 7-1. SCOPE OF SUBTITLE.

16 THIS SUBTITLE APPLIES TO ANY LAND OR OTHER PROPERTY WITHIN THE BOUNDARIES OF A
17 STRUCTURE ON THE LANDMARK LIST: EXTERIORS OR THE POTENTIAL-LANDMARK LIST:
18 EXTERIORS.

19 § 7-2. EFFECT OF SUBDIVISION.

20 IF ANY LAND OR OTHER PROPERTY SUBJECT TO THIS SUBTITLE IS SUBDIVIDED, ALL LOTS,
21 PLATS, SITES, OR OTHER DIVISIONS LAND RESULTING FROM THE SUBDIVISION ARE
22 AUTOMATICALLY CONSIDERED TO RETAIN THE SAME LANDMARK OR POTENTIAL-LANDMARK
23 DESIGNATION AND PROTECTION AS THE ORIGINAL SITE HAD BEFORE ITS SUBDIVISION.

24 § 7-3. PLANNING COMMISSION TO NOTIFY CHAP OF SUBDIVISION.

25 AS SOON AS POSSIBLE AFTER A FINAL SUBDIVISION PLAN HAS BEEN RECORDED FOR ANY LAND
26 OR OTHER PROPERTY SUBJECT TO THIS SUBTITLE:

27 (1) THE PLANNING COMMISSION MUST SUBMIT A COPY OF THE APPROVED PLAN TO THE
28 COMMISSION FOR HISTORICAL AND ARCHITECTURAL PRESERVATION; AND

29 (2) THE COMMISSION FOR HISTORICAL AND ARCHITECTURAL PRESERVATION MUST:

30 (I) UPDATE ITS RECORDS ACCORDINGLY; AND

31 (II) REQUEST THE DEPARTMENT OF LEGISLATIVE REFERENCE TO INSERT AN
32 EDITOR'S NOTE TO THE APPROPRIATE SECTION OF SUBTITLE 13 ET SEQ . OF
33 THIS ARTICLE TO INDICATE ANY CHANGE IN THE RELEVANT DESCRIPTION.

SUBTITLE 8. ALTERATIONS, ETC., TO OR AFFECTING PROPERTIES

§ 8-1. RELATED RULES AND REGULATIONS.

(A) *GENERAL.*

THE RULES AND REGULATIONS ADOPTED BY THE COMMISSION UNDER THIS ARTICLE:

- (1) MUST INCLUDE DESIGN GUIDELINES FOR UNDERTAKING REGULATED ALTERATIONS; AND
- (2) MAY INCLUDE PROVISIONS DELEGATING TO THE EXECUTIVE DIRECTOR OR OTHER COMMISSION STAFF THE AUTHORITY TO REVIEW AND APPROVE REGULATED ALTERATIONS THAT INVOLVE ONLY MINOR WORK, AS DEFINED IN SUBSECTION (B) OF THIS SECTION.

(B) "MINOR WORK" DEFINED..

“MINOR WORK” MEANS WORK THAT:

- (1) DOES NOT SIGNIFICANTLY CHANGE THE OVERALL APPEARANCE OF OR REMOVE HISTORIC FABRIC; AND
- (2) CLEARLY MEETS THE APPLICABLE DESIGN GUIDELINES ADOPTED BY THE COMMISSION UNDER THIS ARTICLE.

§ 8-2. BUILDING PERMIT REQUIRED.

(A) EXTERIOR STRUCTURES.

NO PERSON MAY UNDERTAKE, CAUSE, OR ALLOW ANY OF THE FOLLOWING REGULATED ALTERATIONS FOR OR WITH RESPECT TO ANY STRUCTURE LOCATED WITHIN AN HISTORICAL AND ARCHITECTURAL PRESERVATION DISTRICT OR INCLUDED ON THE LANDMARK LIST: EXTERIORS OR THE POTENTIAL-LANDMARK LIST: EXTERIORS WITHOUT FIRST OBTAINING A PERMIT TO DO SO FROM THE BUILDING OFFICIAL:

- (1) ANY RECONSTRUCTION, ALTERATION, OR REMOVAL OF ANY EXTERIOR ARCHITECTURAL FEATURE;
- (2) ANY CHANGE IN AN EXTERIOR COLOR, WHETHER BY PAINTING OR OTHER MEANS;
- (3) ANY EXTERIOR EXCAVATION;
- (4) THE CONSTRUCTION OR ERECTION OF ANY EXTERIOR BUILDING, FENCE, WALL, OR OTHER STRUCTURE OF ANY KIND; OR
- (5) ANY EXTERIOR DEMOLITION.

1 (B) *PUBLIC INTERIORS.*

2 NO PERSON MAY UNDERTAKE, CAUSE, OR ALLOW ANY OF THE FOLLOWING REGULATED
3 ALTERATIONS FOR OR WITH RESPECT TO ANY STRUCTURE ON THE LANDMARK LIST:
4 PUBLIC INTERIORS OR THE POTENTIAL-LANDMARK LIST: PUBLIC INTERIORS WITHOUT
5 FIRST OBTAINING A PERMIT TO DO SO FROM THE BUILDING OFFICIAL:

6 (1) ANY RECONSTRUCTION, ALTERATION, OR REMOVAL OF ANY INTERIOR
7 ARCHITECTURAL FEATURE, AS DEFINED IN SUBSECTION (C) OF THIS SECTION;
8
9 (2) ANY CHANGE IN AN INTERIOR COLOR, WHETHER BY PAINTING OR OTHER MEANS;
10
11 (3) ANY INTERIOR EXCAVATION;
12
13 (4) THE CONSTRUCTION OR ERECTION OF ANY INTERIOR WALL OR OTHER STRUCTURE
14 OF ANY KIND; OR
15
16 (5) ANY INTERIOR DEMOLITION.

17 (C) *"INTERIOR ARCHITECTURAL FEATURE" DEFINED.*

18 (1) *IN GENERAL.*

19 IN THIS SECTION, "INTERIOR ARCHITECTURAL FEATURE" MEANS THE ARCHITECTURAL
20 STYLE, DESIGN, GENERAL ARRANGEMENT, AND COMPONENTS OF A DESIGNATED
21 INTERIOR.
22

23 (2) *INCLUSIONS.*

24 "INTERIOR ARCHITECTURAL FEATURE" INCLUDES THE KIND, COLOR, AND TEXTURE OF
25 THE BUILDING MATERIAL AND THE TYPE AND STYLE OF WINDOWS, DOORS, LIGHTS,
26 SIGNS, PLAQUES, DECORATIVE FINISHES, MURALS, ART WORK, FLOOR PLAN, AND OTHER
27 FIXTURES APPURTENANT TO THE INTERIOR.

28 **§ 8-3. {RESERVED}**

29 **§ 8-4. CHAP TO REVIEW.**

30 (A) *REFERRAL BY BUILDING OFFICIAL.*

31 WITHIN 2 DAYS OF RECEIVING A PERMIT APPLICATION FOR OR INVOLVING A REGULATED
32 ALTERATION, THE BUILDING OFFICIAL MUST FORWARD THE APPLICATION, TOGETHER WITH
33 ALL ACCOMPANYING PLANS AND SPECIFICATIONS, TO THE COMMISSION.

34 (B) *PLANS, ETC., TO BE AVAILABLE.*

35 (1) ON REQUEST OF THE COMMISSION OR ITS STAFF, THE APPLICANT MUST SUBMIT TO THE
36 COMMISSION ANY ADDITIONAL PLANS, ELEVATIONS, AND OTHER RELATED
37 INFORMATION NEEDED TO DETERMINE THE APPROPRIATENESS OF THE PROPOSED
38 REGULATED ALTERATION.

1 (2) THE COMMISSION MAY NOT MAKE ANY DETERMINATION CONCERNING THE PROPOSED
2 REGULATED ALTERATION UNTIL IT IS SATISFIED THAT:

3 (I) THE PERMIT APPLICATION IS COMPLETE; AND

4 (II) THE COMMISSION HAS RECEIVED ALL OTHER NEEDED DOCUMENTS AND
5 INFORMATION, AS REQUESTED.

6 (C) *CHAP APPROVAL PREREQUISITE FOR PERMIT.*

7 THE BUILDING OFFICIAL MAY NOT ISSUE A PERMIT FOR ANY REGULATED ALTERATION
8 UNLESS THE COMMISSION FIRST ISSUES AN AUTHORIZATION TO PROCEED.

9 § 8-5. PUBLIC HEARING.

10 (A) *POSTING NOTICE.*

11 IF AN AUTHORIZATION TO PROCEED IS NOT ISSUED WITHIN 11 DAYS OF THE COMMISSION'S
12 HAVING RECEIVED A COMPLETED APPLICATION, THE EXECUTIVE DIRECTOR MUST CAUSE A
13 SIGN TO BE CONSPICUOUSLY POSTED ON THE STRUCTURE INVOLVED, GIVING NOTICE OF:

14 (1) THE TYPE OF ALTERATIONS PROPOSED; AND

15 (2) THE DATE, TIME, AND PLACE OF A PUBLIC HEARING TO BE HELD BY THE
16 COMMISSION ON THE PROPOSAL.

17 (B) *HEARING.*

18 THE PUBLIC HEARING MUST BE HELD:

19 (I) AT THE NEXT REGULAR COMMISSION MEETING SCHEDULED FOR A DATE THAT IS NO
20 SOONER THAN 10 DAYS NOR LATER THAN 45 DAYS FROM THE TIME THE SIGN IS
21 POSTED; OR

22 (II) IF NO REGULAR MEETING HAS BEEN SCHEDULED FOR THAT PERIOD, AT A SPECIAL
23 MEETING CALLED FOR A DATE THAT IS NO SOONER THAN 10 DAYS NOR LATER THAN
24 20 DAYS FROM THE TIME THE SIGN IS POSTED.

25 § 8-6. CHAP DETERMINATION.

26 (A) *IN GENERAL.*

27 WITHIN 21 DAYS AFTER THE PUBLIC HEARING CONCLUDES, OR WITHIN ANY ADDITIONAL
28 TIME THAT THE APPLICANT APPROVES IN WRITING, THE COMMISSION MUST DETERMINE
29 WHETHER TO APPROVE OR DENY THE ISSUANCE OF AN AUTHORIZATION TO PROCEED.

30 (B) *CRITERIA FOR AUTHORIZATION TO PROCEED.*

31 THE COMMISSION MAY APPROVE ISSUANCE OF AN AUTHORIZATION TO PROCEED ONLY IF
32 IT DETERMINES THAT:

 - 11 (II) DENIAL OF AN AUTHORIZATION TO PROCEED WOULD RESULT IN
12 SUBSTANTIAL HARDSHIP TO THE APPLICANT.

13 (C) *FACTORS TO BE CONSIDERED.*

14 IN PASSING ON APPROPRIATENESS, THE COMMISSION MUST CONSIDER, AMONG OTHER
15 PERTINENT FACTORS:

- 16 (1) THE STRUCTURE'S HISTORIC OR ARCHITECTURAL SIGNIFICANCE;
- 17 (2) THE LOCATION AND VISIBILITY OF THE PROPOSED ALTERATION; AND
- 18 (3) THE HISTORIC OR ARCHITECTURAL SIGNIFICANCE, ARCHITECTURAL STYLE,
19 GENERAL DESIGN, ARRANGEMENT, TEXTURE, MATERIAL, AND COLOR OF
20 ARCHITECTURAL FEATURES OF OTHER STRUCTURES IN THE IMMEDIATE
21 NEIGHBORHOOD.

22 **§ 8-7. {RESERVED}**

23 **§ 8-8. ISSUANCE OF AUTHORIZATION TO PROCEED.**

24 (A) *ISSUANCE.*

25 IF THE COMMISSION APPROVES THE ISSUANCE OF AN AUTHORIZATION TO PROCEED, THE
26 EXECUTIVE DIRECTOR MUST PROMPTLY ISSUE THE AUTHORIZATION TO PROCEED AND
27 FORWARD IT TO THE BUILDING OFFICIAL, ALONG WITH THE RELATED APPLICATION, PLANS,
28 AND SPECIFICATIONS.

29 (B) *CONTENTS OF AUTHORIZATION TO PROCEED.*

30 THE AUTHORIZATION TO PROCEED MUST CONTAIN:

- 31 (1) A DESCRIPTION OF THE REGULATED ALTERATION BEING APPROVED;
- 32 (2) A REFERENCE TO WHETHER THE APPROVAL IS PREMISED ON:

(I) A FINDING THAT THE ALTERATION IS COMPLIANT WITH THE DESIGN GUIDELINES AND IS OTHERWISE APPROPRIATE (AS REQUIRED BY § 8-6(B)(1) OF THIS SUBTITLE); OR

(II) A FINDING THAT THE ALTERATION IS NONCOMPLIANT OR OTHERWISE INAPPROPRIATE, BUT:

(A) IT IS WITHOUT SUBSTANTIAL DETRIMENT TO THE PUBLIC WELFARE AND WITHOUT SUBSTANTIAL DEROGATION OF THIS ARTICLE (AS REQUIRED BY § 8-6(B)(2)(I) OF THIS SUBTITLE); AND

(B) DENIAL WOULD RESULT IN SUBSTANTIAL HARSHSHIP TO THE APPLICANT (AS REQUIRED BY § 8-6(B)(2)(II) OF THIS SUBTITLE);

§ 8-9. DENIAL OF AUTHORIZATION TO PROCEED – DISTRICTS AND LANDMARKS.

IN THE CASE OF A STRUCTURE LOCATED WITHIN A PRESERVATION DISTRICT OR INCLUDED ON THE LANDMARK LIST, IF THE COMMISSION DETERMINES THAT AN AUTHORIZATION TO PROCEED SHOULD NOT BE ISSUED, THE COMMISSION MUST PROMPTLY NOTIFY THE APPLICANT AND THE BUILDING OFFICIAL IN WRITING OF:

- (1) THE REASON FOR THAT DETERMINATION; AND
- (2) ANY RECOMMENDATIONS THAT THE COMMISSION MIGHT HAVE ABOUT THE PROPOSED ALTERATION.

§ 8-10. DENIAL OF AUTHORIZATION TO PROCEED – POTENTIAL LANDMARKS.

(A) *COMMISSION TO NOTIFY BUILDING OFFICIAL.*

IN THE CASE OF A STRUCTURE ON THE POTENTIAL-LANDMARK LIST, IF THE COMMISSION DETERMINES THAT THE PROPOSED REGULATED ALTERATION IS INAPPROPRIATE, THE COMMISSION MUST NOTIFY THE BUILDING OFFICIAL IN WRITING TO POSTPONE ISSUANCE OF THE PERMIT.

(B) *BUILDING OFFICIAL TO POSTPONE.*

IF THE BUILDING OFFICIAL IS SO NOTIFIED, THE BUILDING OFFICIAL MUST POSTPONE ISSUANCE OF THE PERMIT UNTIL THE FIRST TO OCCUR OF:

(1) 180 DAYS FROM THE DATE OF THE NOTIFICATION TO POSTPONE; OR

(2) A SUBSEQUENT NOTIFICATION BY THE COMMISSION TO ISSUE THE PERMIT.

(C) COMMISSION TO CONSULT WITH APPLICANT AND OTHERS:

DURING THE PERIOD OF POSTPONEMENT, THE COMMISSION MUST MEET WITH THE APPLICANT AND MAY CONSULT WITH CIVIC GROUPS, PUBLIC AGENCIES, AND INTERESTED PERSONS TO ASCERTAIN WHAT THE CITY CAN DO TO PRESERVE THE STRUCTURE.

§ 8-11. BUILDING OFFICIAL BOUND BY COMMISSION DECISION.

THE BUILDING OFFICIAL IS BOUND BY THE COMMISSION'S DETERMINATIONS UNDER THIS SUBTITLE AND MUST APPROVE, IF OTHERWISE IN CONFORMANCE WITH THE BUILDING, FIRE, AND RELATED CODES ARTICLE, OR DISAPPROVE THE APPLICATION FOR THE PROPOSED ALTERATION IN ACCORDANCE WITH THOSE DETERMINATIONS.

§ 8-12. *{RESERVED}*

§ 8-13. MUNICIPAL STRUCTURES.

(A) *“MUNICIPAL STRUCTURE” DEFINED.*

IN THIS SECTION, “MUNICIPAL STRUCTURE” MEANS ANY STRUCTURE THAT:

(1) IS OWNED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE; AND

(2) EITHER:

(I) HAS BEEN OR IS BEING USED FOR A MUNICIPAL FUNCTION, INCLUDING OFFICES AND OTHER WORK PLACES, SCHOOLS, FIRE STATIONS, POLICE STATIONS, MONUMENTS, WATER AND WASTE WATER FACILITIES, AND THE LIKE;

(II) HAS BEEN OR IS BEING AGGREGATED BY OR FOR THE CITY FOR
REDEVELOPMENT UNDER AUTHORITY OF A MASTER PLAN OR URBAN
RENEWAL PLAN; OR

(III) MEETS ANY OTHER CRITERIA ADOPTED BY COMMISSION RULE OR REGULATION FOR STRUCTURES REQUIRING REVIEW UNDER THIS SECTION.

(B) *SUBMISSION OF PLANS TO COMMISSION.*

BEFORE ANY CITY ACTION IS TAKEN TO APPROVE OR OTHERWISE AUTHORIZE THE RECONSTRUCTION, EXTERIOR ALTERATION, INTERIOR ALTERATION OF AN AREA CUSTOMARILY OPEN OR ACCESSIBLE TO THE PUBLIC, OR DEMOLITION OF ANY MUNICIPAL

1 STRUCTURE, THE AGENCY RESPONSIBLE FOR PREPARING THE PLANS MUST REFER THE
2 PLANS TO THE COMMISSION FOR A REPORT.

3 (C) *ACTION BY COMMISSION.*

4 (1) THE COMMISSION'S REPORT MUST BE SUBMITTED TO THE MAYOR AND TO THE
5 RESPONSIBLE AGENCY WITHIN 45 DAYS AFTER THE REFERRAL.

6 (2) IF THE COMMISSION DOES NOT REPORT WITHIN THIS 45-DAY PERIOD, THE MAYOR MAY
7 CONCLUDE THAT THE COMMISSION DOES NOT OBJECT TO THE APPROVAL OR
8 AUTHORIZATION OF THE PLANS.

9 **§ 8-14. {RESERVED}**

10 **§ 8-15. PERMISSIBLE MAINTENANCE AND REPAIR.**

11 (A) *NO CHANGE IN DESIGN, ETC.*

12 NOTHING IN THIS ARTICLE PREVENTS THE ORDINARY MAINTENANCE OR REPAIR OF AN
13 ARCHITECTURAL FEATURE WITHIN ANY PRESERVATION DISTRICT OR ON ANY LANDMARK
14 OR POTENTIAL LANDMARK, IF THE MAINTENANCE OR REPAIR INVOLVES NO CHANGE IN
15 DESIGN, MATERIAL, COLOR, OR APPEARANCE OF THE STRUCTURE.

16 (B) *PUBLIC SAFETY NEEDS.*

17 NOTHING IN THIS ARTICLE PREVENTS THE CONSTRUCTION, RECONSTRUCTION,
18 ALTERATION, OR DEMOLITION OF ANY FEATURE THAT THE BUILDING OFFICIAL CERTIFIES
19 AS BEING REQUIRED FOR PUBLIC SAFETY BECAUSE OF AN UNSAFE OR DANGEROUS
20 CONDITION.

21 **SUBTITLE 9. JUDICIAL REVIEW AND ENFORCEMENT**

22 **§ 9-1. JUDICIAL AND APPELLATE REVIEW.**

23 (A) *JUDICIAL REVIEW.*

24 WITHIN 30 DAYS AFTER THE BUILDING OFFICIAL HAS APPROVED, DISAPPROVED, OR
25 DELAYED AN APPLICATION FOR A PERMIT, A PERSON AGRIEVED BY ANY DECISION OF THE
26 COMMISSION MAY SEEK JUDICIAL REVIEW OF THAT DECISION BY PETITION TO THE CIRCUIT
27 COURT FOR BALTIMORE CITY IN ACCORDANCE WITH THE MARYLAND RULES OF
28 PROCEDURE.

29 (B) *APPELLATE REVIEW.*

30 A PARTY TO THE JUDICIAL REVIEW MAY APPEAL THE COURT'S FINAL DECISION TO THE
31 COURT OF SPECIAL APPEALS IN ACCORDANCE WITH THE MARYLAND RULES OF
32 PROCEDURE.

33 **§§ 9-2 TO 9-5. {RESERVED}**

1 **§ 9-6. ENFORCEMENT GENERALLY.**

2 (A) *UNLAWFUL ACTS.*

3 IT IS UNLAWFUL FOR ANY PERSON TO BE IN CONFLICT WITH OR IN VIOLATION OF ANY
4 PROVISION OF THIS ARTICLE OR OF ANY RULE, REGULATION, DECISION, PERMIT, NOTICE, OR
5 ORDER ISSUED UNDER THIS ARTICLE.

6 (B) *ENFORCEMENT AND PENALTIES.*

7 THIS ARTICLE AND THE RULES, REGULATIONS, DECISIONS, PERMITS, NOTICES, AND ORDERS
8 ISSUED UNDER THIS ARTICLE MAY BE ENFORCED BY THE BUILDING OFFICIAL AND
9 PENALTIES MAY BE IMPOSED FOR VIOLATIONS OF THEIR PROVISIONS AS PROVIDED IN
10 CHAPTER 1 {"SCOPE AND ADMINISTRATION"} OF THE BALTIMORE CITY BUILDING CODE
11 FOR THE ENFORCEMENT OF AND THE IMPOSITION OF VIOLATION PENALTIES UNDER THAT
12 CODE.

13 **§ 9-7. INJUNCTIONS.**

22 OR DEMOLISHED IN VIOLATION OF THIS ARTICLE.

23 **§ 9-8. CRIMINAL PENALTIES.**

(c) *Certain structures in [historic] preservation district.*

In any [Historic] HISTORICAL and Architectural Preservation District, a 1-story accessory building may be restored as a 2-story single-family dwelling if:

- (1) it can be proved that the accessory building was formerly of 2-story construction; and
- (2) all other requirements of this section are met.

Title 14. Conditional Uses

Subtitle 3. Additional Considerations for Certain Uses

§ 14-317. Antenna towers, microwave relay towers, etc., for communications.

(a) *Referral for review by Preservation Division.*

For the placement or erection of antenna towers, microwave relay towers, and similar installations for communications transmission or receiving, the Zoning Administrator must, within 10 working days of receiving the application, refer the application and all accompanying documents to the Historical and Architectural Preservation Division of the Department of Planning for review.

(b) *Division report.*

(1) Within 10 working days after the referral, the Historical and Architectural Preservation Division must report to the Board whether the proposed location of the installation is:

(i) on a [Baltimore City] PROPERTY [Landmark List property or] THAT IS LOCATED within [a Baltimore City] AN Historical and Architectural Preservation District OR INCLUDED ON THE CITY'S LANDMARK LIST OR POTENTIAL-LANDMARK LIST;

(ii) on a property or within a district listed on the Maryland [Inventory] REGISTER of Historic Properties; or

(iii) on a property or within a district listed on the National Register of Historic Places.

(2) If the proposed location meets one or more of these criteria, the Division must report to the Board, within 45 days after the referral:

(i) whether the installation will have an adverse effect on the property or district; and

(ii) if so, whether and how that adverse effect can be adequately mitigated.

(c) *Board action.*

The Board may act on the application:

- (1) after receipt and consideration of the report and recommendations of the Historical and Architectural Preservation Division; or
- (2) without the report and recommendations of the Division if the Division fails to submit its report within the period specified in subsection (b)(2) of this section.

(d) *Required findings.*

To approve an application, the Board must find, and require as a condition of approval, that:

- (1) the proposed location does not meet any of the criteria listed in subsection (b)(1) of this section; or
- (2) if it does meet one or more of these criteria:
 - (i) the installation will not have an adverse effect on the property or the district; or
 - (ii) the applicant will adequately mitigate any adverse effect, as specified in the Division's report and recommendations or, absent a timely report from the Division, as specified in the Board's decision.

§ 7-3. Procedure for change.

(a) *Referral to [Department and CHAP] AGENCIES.*

Whenever [an ordinance or resolution] A BILL is introduced in the City Council [of Baltimore] to NAME OR [change the name of] RENAME any public street, avenue, or other thoroughfare [within the corporate limits of] IN Baltimore City, [or to name any street, avenue, or other thoroughfare within said corporate limits,] the [same] BILL shall at once be referred to the Department of [Public Works] TRANSPORTATION and to the [Commission for] DEPARTMENT OF PLANNING'S Historical and Architectural Preservation DIVISION for a written report as to the advisability of the [passage of such ordinance or the adoption of such resolution] PROPOSED NAME.

(b) *Reports required for action.*

The Department of Transportation and the [Commission] HISTORICAL AND ARCHITECTURAL PRESERVATION DIVISION [are hereby authorized and directed to make

1 such] SHALL SUBMIT THEIR reports as soon as practicable, and no further action [shall]
2 MAY be taken by the City Council on [such ordinance or resolution] THE BILL pending the
3 receipt of [such] THOSE reports.

4 (c) *Guidelines.*

17 (b) *Historical and architectural preservation.*

18 For any parking project on or proposed for a site that is [in] LOCATED WITHIN an
19 Historical and Architectural Preservation District or that is on [a] THE Landmark List or
20 [Special] POTENTIAL-LANDMARK List, the Authority must comply with all requirements
21 of City Code Article 6 {"Historical and Architectural Preservation"}.

22 **SECTION 3. AND BE IT FURTHER ORDAINED**, That the catchlines contained in this Ordinance
23 are not law and may not be considered to have been enacted as a part of this or any prior
24 Ordinance.

25 **SECTION 4. AND BE IT FURTHER ORDAINED**, That, as of the effective date of this Ordinance:

26 (a) the Special List: Exteriors and the Special List: Public Interiors then maintained by
27 the Commission for Historical and Architectural Preservation automatically become
28 the Potential-Landmark List: Exteriors and the Potential-List: Public Interiors,
29 respectively, established by this Ordinance;

30 (b) all structures then listed on either Special List automatically become subject to the
31 provisions of this Ordinance governing the corresponding Potential-Landmark List;

33 (c) for purposes of computing the potential automatic expiration of these newly
34 designated Potential-Landmarks, the 180-day time period specified in City Code
