AN ORDINANCE CONCERNING

Zoning – Health-Care Facilities – Conditional Use Home for the 1 Rehabilitation of Non-bedridden Alcoholics and Substance Abusers -2 14 South Broadway 3 4 FOR the purpose of permitting, subject to certain conditions, the establishment, maintenance, and operation of a home for the rehabilitation of non-bedridden alcoholics and substance abusers 5 on the property known as 14 South Broadway, as outlined in red on the accompanying plat. 6 7 By authority of 8 Article - Zoning Section(s) 6-309(7) and 14-102 9 and 10 Article - Health 11 Section 3-102 12 Baltimore City Revised Code 13 (Edition 2000) 14

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That permission is granted for the establishment, maintenance, and operation of a home for the rehabilitation of non-bedridden alcoholics and substance abusers on the property known as 14 South Broadway, as outlined in red on the plat accompanying this Ordinance, in accordance with Baltimore City Zoning Code §§ 6-309(7) and 14-102 and Health Code §3-102, subject to the following conditions:

- 1. The maximum number of beds is 10.
- 2. There will be 1 residential counselor on the property.

4 5	SECTION 2. AND BE IT FURTHER ORDAINED , That the rear setback requirements are waived, in accordance with Baltimore City Zoning Code, § 15-101.
6 7 8 9 10 11 12	SECTION 3. AND BE IT FURTHER ORDAINED, That as evidence of the authenticity of the accompanying plat and in order to give notice to the agencies that administer the City Zoning Ordinance: (i) when the City Council passes this Ordinance, the President of the City Council shall sign the plat; (ii) when the Mayor approves this Ordinance, the Mayor shall sign the plat; and (iii) the Director of Finance then shall transmit a copy of this Ordinance and the plat to the Board of Municipal and Zoning Appeals, the Planning Commission, the Commissioner of Housing and Community Development, the Supervisor of Assessments for Baltimore City, and the Zoning Administrator.
