AN ORDINANCE CONCERNING

**South Baltimore Gateway Community Impact District Management
Authority – Board of Directors**

FOR the purpose of altering certain membership requirements for the Board of Directors for the South Baltimore Gateway Community Impact District Management Authority; amending certain term limits for certain members of the Board of Directors; and providing for a special effective date.

BY repealing and reordaining, with amendments

Article 14 - Special Benefits Districts
Sections 19-6(d)(2) and (f)(2)
Baltimore City Code
(Edition 2000)

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the Laws of Baltimore City read as follows:

Baltimore City Code

Article 14. Special Benefits Districts

Subtitle 19. South Baltimore Gateway Community Impact District


