BACKGROUND

The American Rescue Plan Act (ARPA)

The Mayor's Office of Recovery Programs (MORP) was established in July 2021 to administer the \$641.1 million in one-time funding allocated to the City of Baltimore through the Coronavirus State and Local Fiscal Recovery Funds (SLFRF) program authorized by the American Rescue Plan Act (ARPA). Funding was obligated to city agencies, quasi-government agencies, and nonprofits responding to the COVID-19 pandemic and its adverse economic effects using guiding principles that focused on impact, transparency, equity, accountability, and responsibility.

3rd Quarter Hearing Summary – ARPA Overview

MORP obligated 100% of the APRA funds prior deadline of December 31, 2024. All funded projects are being monitored by MORP to ensure funds are expended by the deadline of December 31, 2026. MORP is closely monitoring capital projects that may be impacted by implemented or proposed tariffs that may increase costs, disrupt supply chains, and cause delays.

During the presentation MORP highlighted organizations expending less than 50% of their obligated funds. In the most recent agency report only five agencies have less than 50% spent, however, all projects are underway.

Following the Q3 briefing, MORP submitted committee requests that showed how the city structured their investment decisions through a racial and economic equity lens. Baltimore was recognized as the third highest performing jurisdiction to advance racial and economic equity. Additionally, MORP provided a comprehensive list of all staff in ARPA funded positions. The list updated as of March 2025 showed that only 6 formerly ARPA funded positions were absorbed into the General Fund in FY 2026. There are several other ARPA positions funded only until December 31, 2025, with a few of those positions moving to another grant source. The majority of ARPA funded positions listed are funded until December 31, 2026.

ARPA Recovery Reports

MORP must prepare and submit an annual Recovery Plan and quarterly reports to the U.S. Department of Treasury. In addition, each month, MORP prepares and submits a report to the Baltimore City Council in accordance with Council Bill 21-0121. Opioid Restitution Fund

Although LO25-0002 is specifically related to the ARPA funding, MORP provided a brief update on the Opioid Restitution Fund at the previous legislative oversight hearing.

The Executive Order Issued by Mayor Scott on August 29, 2024, established the City's approach to managing opioid restitution funds. As of June 2025, the City has reached settlements totaling more than \$402.5 million (before legal fees and repayment of litigation costs). MORP is administering the funds, while Baltimore City's Mayor's Office of Overdose Response (BCMOOR) is responsible for the City's strategic response to the overdose epidemic.ⁱⁱⁱ

During the 3rd Quarter Hearing, MORP reported that only 11.4% of their FY 2025 Supplemental for Opioid Administration was expended. Additionally, they reported that the FY 2025 Supplemental for the 22 Named Entities of \$10 million, only 1.7% was expended and they are anticipating carryover into the next fiscal year. MORP is working towards the goal of having signed grant agreements with the named entities by July 1, 2025. Following the Q3 briefing, MORP submitted committee request detailing funding going out to all the named entities in the initial disbursement in FY 2025 of \$14,643,000 and the anticipated disbursement to multiple agencies in FY 2026 of \$36,726,794.

ADDITIONAL INFORMATION

Fiscal Note:

The legislative oversight hearing on ARPA has no estimated financial impact. However, the details below provide an overview of MORP's operating budget.

In Fiscal 2022, the Mayor's Office of Recovery Programs was established for the purposes of administering funding received by the City for the American Rescue Plan Act (ARPA). ARPA provided \$641,170,126 in one-time funds in response to the COVID-19 health emergency and its negative economic impacts. These funds are not reflected in the FY 26 operating budget for MORP.

As of June 2025, MORP reports that they have expended \$473.4 million, which is 73.8% of ARPA funding. All funds must be expended by December 31, 2026.

The approved FY 2026 Budget for the Mayor's Office of Recovery Programs consists only of special revenue from the Opioid Restitution Funds^{iv}:



Major Issues Discussed

Chair McCray opened the hearing, introduce LO25-0002 and the MORP office presenting.

• Chair noted that technical difficulties may cause a streaming issue, however, hearing is recorded and will be available on Charm TV.

Deputy City Administrator Shamiah Kerney gave a presentation for the Mayor's Office of Recovery Programs regarding the ARPA funding [See PowerPoint in Bill File].

- Highlighted projects with expenditures below 50% and plans on spending projects down before the deadline of December 31, 2026.
- (Noted an error on the Baltimore City Board of School Commissioner's slide should be 42% expended instead of 37%)

Concluding the presentation, Chair McCray asked the following questions:

What deliverables will be completed by next quarter's report under MOPI given \$500K obligated in December 2024 for MOPI for the 6 additional staff. DCA responded with some of the strategic plans that included:

- Updating agency performance plans
- Creating a dashboard that would provide metrics on performance planning
- In-depth conversations with agencies (CitiStat) launching 7 new CitiStat Programs
- Developing a data dictionary
- Developing the Annual Plan produced by CitiStat

How many of the CitiStat programs will start launching. DCA noted that launches for these programs have already begun, and a schedule is available. Chair McCray requested that Council be provided with that schedule.

Councilman Gray had a following question regarding the sideway repairs. For clarification purposes can citizens still put in requests for these reconstructions or fixes or is there already a list. DCA noted there is already a listing. Josh Wilson, Project Manager confirmed that DOT selects the locations for both ADA ramps and for sidewalks – this is based on criteria outline in the Complete Streets Manual. The Manual outlines priority for safety, quality, service requests, and community input. Councilman Gray requests a comprehensive list and breakdown of district for ADA ramps and Sidewalks.

Chair McCray thanked the agency and recessed the hearing.
