A BILL ENTITLED

1 AN ORDINANCE concerning

2 **Supplementary General Fund Operating Appropriation –**  
3 **Police Department – \$6,500,000**

4 FOR the purpose of providing a Supplementary General Fund Operating Appropriation in the  
5 amount of \$6,500,000 to the Police Department - Service 622 (Police Patrol), to provide  
6 funding for premium pay expenses resulting from the COVID-19 pandemic; and providing  
7 for a special effective date.

13 **Recitals**

14 The revenue appropriated by this Ordinance represents funds from Speed Camera Fines in  
15 excess of the revenue relied on by the Board of Estimates in determining the tax levy required to  
16 balance the budget for Fiscal Year 2021.

17 This additional revenue could not have been reasonably anticipated when the Ordinance of  
18 Estimates for Fiscal Year 2021 was formulated.

19 This appropriation is made necessary by a material change in circumstances since the  
20 Ordinance of Estimates for Fiscal Year 2021 was formulated or is for a new program that could  
21 not have been reasonably anticipated when that Ordinance of Estimates was formulated.

22 On September 15, 2021, the Board of Estimates recommended this appropriation to the City  
23 Council.

**Council Bill 21-0151**

1       **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That  
2 \$6,500,000 shall be made available to the Police Department - Service 622 (Police Patrol) as a  
3 Supplementary General Fund Operating Appropriation for Fiscal Year 2021, to provide funding  
4 for premium pay expenses resulting from the COVID-19 pandemic. The source of revenue for  
5 this appropriation is funds from Speed Camera Fines in excess of the amount from this source  
6 that was relied on by the Board of Estimates in determining the tax levy required to balance the  
7 budget for Fiscal Year 2021.

8       **SECTION 2. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the date it is  
9 enacted.
