11	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the		
12	Mayor and City Council finds that the existing disparity study remains a valid factual predicate		
13	for the Minority and Women's Business Program and provides sufficient legal justification for		
14	continuing the Program during the interim extension period enacted by this Ordinance.		
15	SECTION 2. AND BE IT FURTHER ORDAINED, That the Laws of Baltimore City read as

21	This subtitle automatically expires on [December 31, 2006] JUNE 30, 2007, unless the City		
22	Council, after causing an appropriate study to be undertaken, conducting public hearings, and		
23	hearing testimonial evidence, finds that the purposes identified in this subtitle have not yet		
24	been achieved, in which case this subtitle may be extended for 5 more years.
