1 AN ORDINANCE concerning

2 **Planned Unit Development – Amendment 2 –**
3 **New East Baltimore Community**

4 FOR the purpose of repealing Ordinance 11-418 (Amendment 1 of the New East Baltimore
5 Community Planned Unit Development) and approving certain amendments to the
6 Development Plan of the New East Baltimore Community Planned Unit Development.

12 **Recitals**

13 By Ordinance 05-160, as amended by Ordinance 11-418, the Mayor and City Council (i)
14 approved the application of East Baltimore Development, Inc., to have certain property
15 consisting of 33.98 acres, more or less, designated as a Business Planned Unit Development and
16 (ii) approved the Development Plan submitted by the applicant.

17 The Mayor and City Council and East Baltimore Development, Inc., are either the developer,
18 contract purchaser, potential owner, or owner of the properties shown on the Development Plan.
19 They wish to amend the Development Plan, as previously approved by the Mayor and City
20 Council, to repeal Ordinance 11-418 (Amendment 1 of the New East Baltimore Community
21 Planned Unit Development) and to amend the boundaries of the Planned Unit Development and
22 the Development Plan.

EXPLANATION: CAPITALS indicate matter added to existing law.
[Brackets] indicate matter deleted from existing law.

Council Bill 13-0271

1 On January 13, 2013, representatives of East Baltimore Development, Inc., met with the
2 Department of Planning for a preliminary conference to explain the scope and nature of the
3 proposed amendments to the Development Plan.

4 The representatives of East Baltimore Development, Inc., have now applied to the Baltimore
5 City Council for approval of these amendments, and they have submitted amendments to the
6 Development Plan intended to satisfy the requirements of Title 9, Subtitles 1 and 4 of the
7 Baltimore City Zoning Code.

8 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That
9 Ordinance 11-418 is repealed.

10 **SECTION 2. AND BE IT FURTHER ORDAINED,** That the boundaries of the New East Baltimore
11 Community Planned Unit Development are amended to include those properties listed on Exhibit
12 1, which is attached to and made a part of this Ordinance, together with the adjoining roads,
13 highways, alleys, rights-of-way, and other similar property (collectively the "Property").

14 **SECTION 3. AND BE IT FURTHER ORDAINED,** That the Mayor and City Council approves the
15 amendments to the Development Plan submitted by the Developer, as attached to and made part
16 of this Ordinance, including Sheet 1, "Existing Conditions", dated September 10, 2013; Sheet 2,
17 "Development Plan", dated September 10, 2013; Sheet 3, "Massing Plan", dated September 10,
18 2013; and Sheet 4, "Forest Conservation Master Plan", dated September 10, 2013.

19 **SECTION 4. AND BE IT FURTHER ORDAINED,** That all plans for the construction of permanent
20 improvements on the property are subject to final design approval by the Planning Commission
21 to insure that the plans are consistent with the Development Plan and this Ordinance.

22 **SECTION 5. AND BE IT FURTHER ORDAINED,** That as evidence of the authenticity of the
23 accompanying amended Development Plan and in order to give notice to the agencies that
24 administer the City Zoning Ordinance: (i) when the City Council passes this Ordinance, the
25 President of the City Council shall sign the amended Development Plan; (ii) when the Mayor
26 approves this Ordinance, the Mayor shall sign the amended Development Plan; and (iii) the
27 Director of Finance then shall transmit a copy of this Ordinance and the amended Development
28 Plan to the Board of Municipal and Zoning Appeals, the Planning Commission, the
29 Commissioner of Housing and Community Development, the Supervisor of Assessments for
30 Baltimore City, and the Zoning Administrator.

31 **SECTION 6. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the 30th day
32 after the date it is enacted.
