3	FOR the purpose of providing a Supplementary Special Revenue General Fund Operating
4	Appropriation in the amount of \$33,361,780 to the Fire Department – Service 602 (Fire
5	Suppression and Emergency Rescue), to provide funding for overtime due to sworn vacancies
6	and unbudgeted EMS contractual services; and providing for a special effective date.

12	Recitals
13	The revenue appropriated by this Ordinance represents \$33,361,780 in excess of the revenue
14	relied on by the Board of Estimates in determining the tax levy required to balance the budget for
15	Fiscal Year 2024.
16	This additional revenue could not have been reasonably anticipated when the Ordinance of
17	Estimates for Fiscal Year 2024 was formulated.
18	The source of this additional revenue is Cash Investment Earnings. This appropriation is
19	made necessary by a material change in circumstances since the Ordinance of Estimates for
20	Fiscal Year 2024 was formulated or is for a new program that could not have been reasonably
21	anticipated when that Ordinance of Estimates was formulated.
22	On February 5, 2025, the Board of Estimates recommended this appropriation to the City
23	Council.

1	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That
2	\$33,361,780 shall be made available to the Fire Department – Service 602 (Fire Suppression and
3	Emergency Rescue) as a Supplementary Special Revenue General Fund Operating Appropriation
4	for Fiscal Year 2024, to provide funding for overtime due to sworn vacancies and unbudgeted
5	EMS contractual services. The source of revenue for this appropriation is Cash Investment
6	Earnings in excess of the amount from this source that was relied on by the Board of Estimates in
7	determining the tax levy required to balance the budget for Fiscal Year 2024.
8	SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is
9	enacted.
