1 A COUNCIL RESOLUTION concerning

2 **Revisiting the Journey Home – Revisions to Baltimore City's 10-Year Plan to End**
3 **Homelessness**

4 FOR the purpose of calling on the City and external agencies concerned with homelessness in
5 Baltimore to appear before the City Council to discuss the status of and proposals for any
6 revisions to Baltimore City's 10-Year Plan to End Homelessness.

7 **Recitals**

8 In January 2008, Baltimore embarked on a decade long effort to end homelessness with the
9 adoption of "The Journey Home: Baltimore City's 10-Year Plan to End Homelessness". This
10 plan, formulated with input from more than 150 stakeholders, has guided Baltimore's approach
11 to homelessness over the last 5 years and has allowed the City to coordinate its efforts with a
12 broad array of public and private entities to make real progress on homelessness.

13 Now, halfway through the Plan's intended period, it is appropriate to review what progress
14 has been made towards the Plan's goals, and to evaluate where changed circumstances may
15 require changes in approach. However, a plan arrived at through such extensive consultations,
16 and which seeks to coordinate the efforts of so many actors, should not be altered lightly. Any
17 proposed changes should be thoroughly vetted and subjected to the same careful consideration that
18 went into the original plan.

19 Public hearings before the City Council that all stakeholders have an opportunity to
20 participate in would be an appropriate starting place for any proposed changes. The Council
21 should also have an opportunity to examine and comment on the final form of any changes
22 before they go into effect.

23 The city-wide coordination of efforts to address homelessness, as represented by the 10-Year
24 Plan, is simply too important to neglect in proposing changes. It is therefore essential that every
25 effort be made to build a genuine consensus throughout the community about what elements of
26 the Plan are succeeding, and what elements may need to be updated to build on these successes.

27 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE,** That the
28 Council calls on the City and external agencies concerned with homelessness in Baltimore to
