3. Mr. Greenberg talked briefly about his background and talked about some of the goals and mission of the Commission.
4. Committee members stated some concerns, asked Mr. Greenberg questions and etc. Some highlights from same were:
 - o Special interest is in transportation:
 1. Does the Commission provide any services for transportation?
 - o Comment: Racism is a public health issue
 - o Comment: People with disabilities often are left out of conversations
 - o Question: What do you think is the role of the Commission for helping people with disabilities and their role in "Black Lives Matter?"
 - o Comment: Economic Opportunities – We need to have a conversation about this topic!
 - o Request: Hope that the Commission will work closely with Cedric McCray from the Office of Equity and Civil Rights
5. Several committee members thanked Mr. Greenberg for his willingness to serve on the Commission. Vote taken.
