1 A COUNCIL RESOLUTION concerning

2 **Teaching Non-Violent Conflict Resolution in City Schools**

3 FOR the purpose of calling on Baltimore City Public Schools to take steps to systematically
4 integrate lessons in non-violent conflict resolution into its K-12 curriculum to help provide
5 our children with the conflict resolution skills they will need to succeed in life.

6 **Recitals**

7 Perhaps the most crucial role that schools play is to help provide our children with the tools
8 they will need to succeed in life. Teaching academic subjects such as math and science is the
9 most prominent way that schools provide these tools, but they also provide crucial lessons about
10 maintaining health, interacting with a variety of people, and how to work as part of a team,
11 amongst many others.

12 Integrating lessons in non-violent conflict resolution into this varied curriculum could give
13 our children another set of much needed tools.

14 Conflict is an inevitable part of living in any society, but how to handle it is a skill that must
15 be taught and practiced like any other in order to be mastered. Children are not born knowing
16 how to resolve conflicts, and unfortunately the world we live in often provides more poor
17 examples of how to handle conflict than positive ones. This leaves too many children without a
18 real chance to develop the conflict resolution tools that they need.

19 Schools can fill this gap by providing lessons in non-violent conflict resolution as a
20 consistent part of their K-12 curriculum. The school environment provides many opportunities
21 to teach and practice non-violent conflict resolution skills. These opportunities need to be
22 seized in a thoughtful and systematic way through the adoption of a formal conflict resolution
23 curriculum.

24 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE,** That the
25 Council calls on Baltimore City Public Schools to take steps to systematically integrate lessons in
26 non-violent conflict resolution into its K-12 curriculum to help provide our children with the
27 conflict resolution skills they will need to succeed in life.
