### 6 **Legislative Findings**

7 **WHEREAS**, it is estimated that the City's required annual contribution to the Fire and Police  
8 Employees' Retirement System ("F&P") for FY2011, before accounting for the cost of F&P's  
9 variable post-retirement benefit increases, will be \$101 million.

10 **WHEREAS**, the City's required annual contribution to F&P has risen approximately 270%  
11 from \$27.3 million in FY2001 to a budgeted \$101 million in FY2011. Expressed as a percentage  
12 of the City's general fund operating budget, this equals an increase from 1.3% of budget in  
13 FY2001 to 4.6% of budget in FY2011.

14 **WHEREAS**, while the City's covered fire and police payroll used for calculating the City's  
15 annual F&P contribution during the 10-year period starting with FY2001 and ending with  
16 FY2011 increased from approximately \$181.4 million to \$280.2 million, or 54%, the City's  
17 required annual contribution to F&P during the same period rose from approximately \$27.3  
18 million to a budgeted \$101 million, or 270%.

19 **WHEREAS**, Article 22 of the City Code currently includes a variable post-retirement benefit  
20 formula that provides increases to F&P retirees and beneficiaries in years in which the system  
21 achieves positive investment performance, but makes no provision for negative investment  
22 performance years.

23 **WHEREAS**, the current formula results in a diminished asset base under which the F&P  
24 cannot fully benefit from good investment performance since it must share a portion of investment  
25 earnings with retirees in good years but must bear the total impact of investment losses in bad  
26 years.

27 **WHEREAS**, it is now estimated that the annual F&P contribution needed to maintain the  
28 current variable post-retirement benefit increase structure is an additional \$64 million on top of  
29 the budgeted \$101 million required annual contribution, which would bring to \$165 million the  
30 total annual contribution to F&P by the City for FY2011.

31 **WHEREAS**, in its FY2011 budget the City projects a \$121 million budget gap which is  
32 presently projected to be closed only after reducing basic services, closing facilities, and  
33 furloughing and laying off employees or by raising City taxes.

34 **WHEREAS**, the City's Fiscal 2011 Preliminary Budget Plan reports that "The major driver of  
35 cost growth is the City's pension contributions. Because of poor investment performance in  
36 Fiscal 2009, the pension funds need an additional \$28 million from the General and Motor  
37 Vehicle funds to remain financially sound. Without legislation to reform the variable benefit  
38 provision of the Fire and Police Retirement System, this cost grows by another \$64 million".

39 **WHEREAS**, a task force of the Greater Baltimore Committee recently issued its summary  
40 report on the sustainability of F&P and found that current contributions to fund the F&P are  
41 inadequate to fully cover its existing and anticipated liabilities, that the funded ratio of the F&P

1 based on a June 30, 2009 market value is only 58.2%, and that the F&P underfunding problem  
2 “threatens the City’s fiscal stability and could result in a reduction in City services, increased  
3 taxes, and a decline of the City’s bond rating – a combination of adverse circumstances that  
4 would result in immediate and long term financial burdens on the City and its citizens”.

5 **WHEREAS**, an independent actuary and an independent financial consultant have confirmed  
6 that the F&P, as presently constituted, is unsustainable given the City’s structural budgetary  
7 deficit constraints and have recommended changing F&P’s benefit structure in order to reduce  
8 the F&P’s present and future actuarial liability and the City’s concomitant annual contribution to  
9 the F&P.

10 **WHEREAS**, the City Council has given careful consideration to recommendations put forward  
11 by the union representatives of F&P members regarding the sustainability of F&P and the  
12 contractual rights of its members.

13 **WHEREAS**, the City Council has concluded that it is necessary and reasonable to implement  
14 the recommendations of the independent actuary and financial consultant by modifying the  
15 current F&P benefit structure in order to restore the actuarial soundness of F&P in a manner that  
16 minimizes diminution of benefits to F&P members.

17 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE**, That the  
18 Laws of Baltimore City read as follows:

19 **Baltimore City Code**

20 **Article 22. Retirement Systems**

21 **Subtitle – Fire and Police Employees’ Retirement System**

22 **§ 30. Definitions.**

23 In this subtitle, unless a different meaning is plainly required by the context, the following  
24 words and phrases have the meanings indicated:

25 (9) [“Regular interest” for the Annuity Savings Fund shall mean interest at 5½% per annum  
26 compounded annually. “Regular interest” for the Annuity Reserve Fund and the Pension  
27 Reserve Fund shall mean interest at 7% per annum compounded annually. For valuation  
28 purposes, regular interest shall mean 8¼% prior to commencement of benefit payments  
29 and 6-8/10% after commencement of benefit payments. “Regular interest” for the  
30 purposes of determining actuarial equivalents shall mean interest at 5% per annum  
31 compounded annually.] “REGULAR INTEREST” MEANS INTEREST COMPOUNDED  
32 ANNUALLY FOR THE RESERVES AND ITEMS LISTED AT THE FOLLOWING RATES:

33 (I) THE ANNUITY SAVINGS RESERVE: 3.0%.

34 (II) FOR VALUATION PURPOSES: 8.0%

35 (III) FOR DETERMINING ACTUARIAL EQUIVALENTS: 5.0%.

36 (11) (A) “Average final compensation” [shall mean] MEANS the MEMBER’S average annual  
37 EARNABLE compensation[, pay or salary earnable by a member] for the [3 consecutive

1 years] 36 CONSECUTIVE MONTHS of service as an employee during which his OR HER  
2 earnable compensation was highest[, ] or, if he OR SHE had less than [3 years] 36  
3 CONSECUTIVE MONTHS of service, then the average annual EARNABLE compensation[,  
4 pay or salary earnable by him] during his OR HER total years of service.

5 (B) "EARNABLE COMPENSATION" MEANS THE ANNUAL SALARY AUTHORIZED FOR THE  
6 MEMBER. IT DOES NOT INCLUDE OVERTIME PAY, DIFFERENTIAL PAY, OUT-OF-TITLE  
7 PAY, ENVIRONMENTAL PAY, HAZARDOUS DUTY PAY, PAY FOR CONVERSION OF LEAVE  
8 OR OTHER FRINGE BENEFITS, OR ANY LIKE ADDITIONAL PAYMENTS.

9 (C) [Provided, however, for] FOR members who [retire] RETIRED on or after July 1, 1986,  
10 and before July 1, 1988, "average final compensation" [shall mean] MEANS the  
11 average annual compensation, pay, or salary earnable by a member for the 2  
12 consecutive years of service as an employee during which his OR HER earnable  
13 compensation was highest, [provided] IF the member had at least 2 years of service in  
14 that grade, or if he OR SHE had less than 2 years of service, then the average annual  
15 compensation, pay, or salary earnable by him OR HER during his OR HER actual year(s)  
16 of service.

17 (D) [Provided further, however, for] FOR members who:

18 (i) [retire] RETIRED on or after July 1, 1988, AND ON OR BEFORE JUNE 30, 2010,  
19 OR

20 (ii) RETIRE ON OR AFTER JULY 1, 2010, AND WHO, AS OF JUNE 30, 2010, MEET THE  
21 APPLICABLE AGE AND SERVICE REQUIREMENTS FOR A NORMAL SERVICE  
22 RETIREMENT UNDER § 34(A-1)(1) OR HAVE ACQUIRED 15 OR MORE YEARS OF  
23 CONTINUOUS SERVICE AS A CONTRIBUTING MEMBER OF THIS SYSTEM,

24 "average final compensation" [shall mean] MEANS the average annual EARNABLE  
25 compensation[, pay or salary earnable by a member] for the 18 consecutive months of  
26 service as an employee during which his OR HER earnable compensation was highest.

27 (E) In no event [shall] MAY the retirement benefits of a member[, ] RETIRED UNDER  
28 § 30(11)(D)(II) as a result of the [implementation] APPLICATION of the definition of  
29 "average final compensation" [enacted by Ordinance 88-123], effective July 1, [1988]  
30 2010, be less than the benefit [said] THE member would have been entitled to prior to  
31 July 1, [1988] 2010. [In no event shall the retirement benefits of a member, as a  
32 result of the implementation of the definition of "average final compensation"  
33 enacted by Ordinance 91-086, effective July 1, 1991, be less than the benefit said  
34 member would have been entitled to prior to July 1, 1991. "Earnable" shall include  
35 all usual compensation, in whatever manner paid, such as lodging, subsistence, etc.  
36 In cases where compensation is not all paid in money, the Board of Trustees shall fix  
37 the value of that part of the compensation not paid in money.]

### 38 § 32. Service creditable.

39 (f) *Military service credit.*

40 (1) Notwithstanding any other provision of this subtitle, upon proper application to the  
41 [Retirement] System, credit for military service, as defined in § 32(e) of this subtitle,

1 FOR BENEFIT PURPOSES AND FOR PURPOSES OF ELIGIBILITY FOR A NORMAL SERVICE  
2 RETIREMENT UNDER § 34(A-1), DROP UNDER § 36B, OR DROP 2 UNDER § 36C, shall  
3 be granted to any member of this system who has served in the military prior to  
4 employment with the City, [provided said] IF THAT member has acquired at least 10  
5 years of service and attained the age of 50, or [shall have] HAS acquired 20 years of  
6 service.

7 (2) [However, a] A member [shall] MAY not be awarded credit UNDER THIS SUBSECTION  
8 if he OR SHE has received credit for a period of military service under another  
9 retirement system[,] for which retirement benefits have been or will be received by  
10 him OR HER[; ]. [however] HOWEVER, this exclusion does not apply to any such  
11 credit provided through Federal Old-Age and Survivors Insurance (Social Security),  
12 or to any benefits provided under Title [3] 32 or Title 10, Chapter [67] 1223,  
13 [§§ 1331 through 1337] §§ 12731 THROUGH 12741 of the U.S. Code.

14 (3) [In addition, the] THE military service credit [herein] provided UNDER THIS  
15 SUBSECTION [shall] MAY not exceed 3 years.

16 (4) The City shall make all necessary contributions [to the pension and annuity funds] for  
17 the funding of military service credit. [The provisions of this section shall apply to  
18 all retirees and beneficiaries of the Retirement System who are receiving periodically  
19 paid benefits on the effective date of this ordinance, regardless of their date of  
20 retirement, provided that at the time of retirement the retiree met the age and service  
21 requirements stated above.]

### 22 § 33. Administration.

#### 23 (b) *Members.*

24 The Board consists of [9] 11 trustees, as follows:

25 (1) The Comptroller of the City of Baltimore, ex-officio.

26 (2) The Police Commissioner, ex officio. The Police Commissioner may designate a  
27 representative to attend any meeting of the Board of Trustees in his or her place.  
28 This representative must be a [member of the Police Command Staff II with  
29 administrative responsibilities] DEPUTY POLICE COMMISSIONER and must be a  
30 member of this system. This representative has the authority to act in the  
31 Commissioner's place.

32 (3) The Chief of the Fire Department, ex officio. The Chief of the Fire Department  
33 may designate a representative to attend any meeting of the Board of Trustees in  
34 his or her place. This representative must be [an Assistant Chief of the Fire  
35 Department with administrative responsibilities] THE DEPARTMENT'S CHIEF OF  
36 STAFF OR THE DEPARTMENT'S DEPUTY CHIEF FOR FINANCE AND  
37 ADMINISTRATION and must be a member of this system. This representative has  
38 the authority to act in the Chief's place.

39 (4) THE DIRECTOR OF FINANCE, EX OFFICIO. THE DIRECTOR OF FINANCE MAY  
40 DESIGNATE A REPRESENTATIVE TO ATTEND ANY MEETING OF THE BOARD OF  
41 TRUSTEES IN HIS OR HER PLACE. THIS REPRESENTATIVE MUST BE EITHER THE

1 DEPUTY DIRECTOR OF FINANCE OR THE BUDGET DIRECTOR. THIS  
2 REPRESENTATIVE HAS THE AUTHORITY TO ACT IN THE DIRECTOR OF FINANCE'S  
3 PLACE.

4 (5) (i) [(4)] [2 citizens] 3 RESIDENTS AND REGISTERED VOTERS of the City of  
5 Baltimore [who are not employees within the meaning of this subtitle, 1 of  
6 whom shall be a responsible officer of a bank authorized to do business within  
7 the State of Maryland, or a person with similar experience], to be appointed  
8 by the Mayor with the consent of the City Council, as provided in CITY  
9 CHARTER Article IV, § 6 [of the City Charter], EACH to serve for [terms] A  
10 TERM of 4 years [each] CONCURRENT WITH THE MAYOR'S TERM OF OFFICE.  
11 [each, provided, however, that immediately following July 1, 1962, the Mayor  
12 shall appoint 1 trustee to serve until July 1, 1963, and 1 trustee to serve until  
13 July 1, 1965, such trustees to take office at appointments.] 1 OF THESE 3  
14 TRUSTEES SHALL BE APPOINTED BY THE MAYOR FROM A LIST OF 3  
15 RECOMMENDED CANDIDATES SUBMITTED BY THE PRESIDENT OF THE CITY

17 (ii) THESE TRUSTEES SHALL POSSESS COMMERCIAL BANKING, INVESTMENT  
18 BANKING, ACCOUNTING, ACTUARIAL, AUDITING, INVESTMENT MANAGEMENT,  
19 INVESTMENT CONSULTING, OR FINANCIAL LEGAL EXPERTISE.

20 (iii) AS OF THEIR APPOINTMENT AND DURING THEIR ENTIRE TERM OF OFFICE, THESE  
21 TRUSTEES:

22 A. MAY NOT BE AN EMPLOYEE OR OFFICIAL OF THE CITY; AND

23 B. MAY NOT ENGAGE IN ANY OF THE FOLLOWING ACTIVITIES OR HOLD ANY  
24 OF THE FOLLOWING INTERESTS, AS THESE ACTIVITIES OR INTERESTS  
25 ARE DEFINED IN CITY CODE ARTICLE 8 {"ETHICS"}:

26 1. DOING BUSINESS WITH ANY SYSTEM, PLAN, OR TRUST  
27 ADMINISTERED BY THE CITY'S DEFERRED COMPENSATION  
28 PLAN, BY THE BOARD OF TRUSTEES OF THIS SYSTEM, OR BY THE  
29 BOARD OF TRUSTEES OF THE CITY'S EMPLOYEES' RETIREMENT  
30 SYSTEM (COLLECTIVELY, THE "CITY BENEFIT PLANS");

31 2. BEING EMPLOYED BY OR HAVING A FINANCIAL INTEREST IN ANY  
32 PERSON OR ENTITY DOING BUSINESS OR SEEKING TO DO  
33 BUSINESS WITH ANY CITY BENEFIT PLAN; OR

34 3. ENGAGING IN ANY ACTIVITY THAT REQUIRES REGISTRATION AS  
35 A LOBBYIST WITH THE CITY ETHICS BOARD.

36 (6) [(5)] 2 members of the system, one of whom shall be an employee of the Fire  
37 Department, the other an employee of the Police Department, to be elected by the  
38 membership of the respective departments to which each belongs under [such]  
39 THE rules and regulations [as may be] adopted by the Board of Trustees to govern  
40 [such] THE election, to serve for a term of 4 years, STAGGERED AS PROVIDED FOR  
41 THE TRUSTEES FIRST ELECTED. [; provided, however, that the term of office of the  
42 first 2 trustees so elected shall begin immediately following their election and

1 shall expire July 1, 1964, and July 1, 1966, respectively; and provided further,  
2 that for] FOR the purposes of this [subsection (b)] PARAGRAPH (6), members of the  
3 system who are not employed by the Fire Department or the Police Department  
4 [shall be] ARE eligible to participate as voters and as candidates in elections of the  
5 Board of Trustees. School crossing guards, meter monitors, and police personnel  
6 employed at the [Baltimore-Washington] BALTIMORE / WASHINGTON  
7 International THURGOOD MARSHALL Airport shall participate in the Police  
8 Department elections. Fire personnel employed at the [Baltimore-Washington]  
9 BALTIMORE / WASHINGTON International THURGOOD MARSHALL Airport shall  
10 participate in the Fire Department elections. For other categories of members of  
11 the system who are not employees of the Fire Department or the Police  
12 Department, the Board of Trustees shall determine in which departmental election  
13 they shall participate.

14 (7) [(5-1)] 2 retirees of the system, 1 of whom shall be a Fire Department retiree, and  
15 the other a Police Department retiree, to be elected by the retirees of the  
16 respective department to which each belonged, [said] THESE elections to be held  
17 concurrently with the election for the employees representative of each respective  
18 department, under [such] THE rules and regulations [as may be] adopted by the  
19 Board of Trustees to govern [such] THE election, to serve for a term of 4 years[; ].  
20 [provided, however, that for] FOR the purposes of this [subsection (b)]  
21 PARAGRAPH (7), retirees of the system who are not employed by the Fire  
22 Department or the Police Department [shall be] ARE eligible to participate as  
23 voters and as candidates in elections of the Board of Trustees. Retired school  
24 crossing guards, retired meter monitors, and police personnel retired from  
25 employment at the [Baltimore-Washington] BALTIMORE / WASHINGTON  
26 International THURGOOD MARSHALL Airport shall participate in the Police  
27 Department elections. Fire personnel retired from employment at the  
28 [Baltimore-Washington] BALTIMORE / WASHINGTON International THURGOOD  
29 MARSHALL Airport shall participate in the Fire Department elections. For other  
30 categories of retirees in the system who were not employees of the Fire  
31 Department or the Police Department, the Board of Trustees shall determine in  
32 which departmental election they shall participate.

33 (8) NOTWITHSTANDING CITY CHARTER ARTICLE IV, §8 , REQUIRING MINORITY PARTY  
34 REPRESENTATION, THE ELECTION OR APPOINTMENT OF TRUSTEES UNDER THIS  
35 SUBSECTION SHALL BE MADE WITHOUT REGARD TO POLITICAL AFFILIATION,  
36 INCLUDING THOSE TRUSTEES HOLDING THEIR POSITIONS EX OFFICIO.

37 **§ 34. Benefits.**

38 (A-1) [(a)] *Normal service retirement benefits.*

39 (1) *Age and service requirements FOR RETIREMENTS ON OR BEFORE JUNE 30, 2010.*

40 A member may retire with a normal service retirement ON OR BEFORE JUNE 30, 2010,  
41 if, on his or her last day of City employment, the member meets the following age  
42 and service requirements:

43 (i) for an employee who became a member of this system on or before June 30,  
44 2003, and who retired on or after June 30, 1989:

1 (A) age 50, regardless of years of service; or

2 (B) regardless of age, 20 years of service; and

3 (ii) for an employee who became a member of this system on or after July 1,  
4 2003:

5 (A) age 50, with at least 10 years of service as a contributing member of  
6 this system; or

7 (B) regardless of age, 20 years of service, at least 10 years of which were  
8 as a contributing member of this system.

9 (2) *AGE AND SERVICE REQUIREMENTS FOR RETIREMENTS ON OR AFTER JULY 1, 2010.*

10 A MEMBER MAY RETIRE WITH A NORMAL SERVICE RETIREMENT ON OR AFTER JULY 1,  
11 2010, IF HE OR SHE SATISFIES ITEM (I), (II), OR (III) THAT FOLLOWS:

12 (I) AS OF JUNE 30, 2010, HE OR SHE HAS MET THE APPLICABLE AGE OR SERVICE  
13 REQUIREMENTS SET FORTH IN PARAGRAPH (1) OF THIS SUBSECTION.

14 (II) AS OF JUNE 30, 2010, HE OR SHE HAS ACQUIRED 15 OR MORE YEARS OF  
15 CONTINUOUS SERVICE AS A CONTRIBUTING MEMBER OF THIS SYSTEM AND, ON  
16 THE LAST DAY OF HIS OR HER CITY EMPLOYMENT, HE OR SHE HAS MET THE  
17 APPLICABLE AGE OR SERVICE REQUIREMENTS SET FORTH IN PARAGRAPH (1) OF  
18 THIS SUBSECTION.

19 (III) ON THE LAST DAY OF HIS OR HER CITY EMPLOYMENT, HE OR SHE HAS EITHER:

20 (A) ACQUIRED 25 OR MORE YEARS OF CONTINUOUS SERVICE AS A  
21 CONTRIBUTING MEMBER OF THIS SYSTEM; OR

22 (B) 1. ATTAINED AGE 55; AND

23 2. ACQUIRED 15 OR MORE YEARS OF CONTINUOUS SERVICE AS A  
24 CONTRIBUTING MEMBER OF THIS SYSTEM.

25 (A-2) *EARLY SERVICE RETIREMENT BENEFITS – AGE AND SERVICE REQUIREMENTS.*

26 (1) ON OR AFTER JULY 1, 2010, A MEMBER OF THIS SYSTEM ON JUNE 30, 2010, WHO DOES  
27 NOT SATISFY THE CONDITIONS OF EITHER PARAGRAPH (2)(I) OR PARAGRAPH (2)(II) OF  
28 SUBSECTION (A-1) OF THIS SECTION MAY RETIRE WITH AN EARLY SERVICE RETIREMENT  
29 WHEN HE OR SHE FIRST MEETS THE APPLICABLE AGE OR SERVICE REQUIREMENTS FOR A  
30 NORMAL SERVICE RETIREMENT UNDER SUBSECTION (A-1)(1) OF THIS SECTION.

31 (2) THE BENEFIT COMMENCEMENT DATE OF AN EARLY SERVICE RETIREMENT IS ANY DATE  
32 ELECTED BY THE MEMBER IN ACCORDANCE WITH SUBSECTION (A-3) OF THIS SECTION  
33 AND THAT IS:

1 (A) ON OR AFTER THE DATE THE MEMBER FIRST MEETS THE APPLICABLE AGE OR  
2 SERVICE REQUIREMENTS FOR A NORMAL SERVICE RETIREMENT UNDER  
3 SUBSECTION (A-1)(1) OF THIS SECTION; AND

4 (B) BEFORE THE DATE AS OF WHICH THE MEMBER WOULD HAVE FIRST MET THE  
5 AGE AND SERVICE REQUIREMENTS FOR A NORMAL SERVICE RETIREMENT  
6 UNDER SUBSECTION (A-1)(2)(III) OF THIS SECTION HAD HE OR SHE CONTINUED  
7 EMPLOYMENT WITH THE CITY.

8 (A-3) [(2)] *Application.*

9 To retire under [this] subsection (A-1) OR (A-2) OF THIS SECTION, the member must:

10 (i) apply to the Board of Trustees, on a form approved by the Board;

11 (ii) set forth the date he or she wants to retire; and

12 (iii) submit the application to the Board no less than 30 days nor more than 90 days  
13 before the date of retirement.

14 (B-1) [(b)] *Allowance on service retirement.*

15 Upon retirement from service a member shall receive a service retirement allowance as  
16 follows:

17 (1) For any member who retires on or before June 30, 1989, the service retirement  
18 allowance shall consist of:

19 (A) an annuity which shall be the actuarial equivalent of his accumulated  
20 contributions at the time of his retirement; and

21 (B) for each year of service, in addition to his annuity, a pension, which shall  
22 be equal to 1/100 of his average final compensation for each of the first 25  
23 years of service, less any prior service, and 1/120 of his average final  
24 compensation for each year after the first 25 years of service less any prior  
25 service; and

26 (C) if he has been credited with prior service, a supplemental pension which  
27 shall be equal to 1/50 of his average final compensation multiplied by the  
28 number of years of such prior service; and

29 (D) if at the time of retirement the annuity determined in accordance with  
30 [§ 34(b)(1)(A)] § 34(B-1)(1)(A) resulting from the member's contributions  
31 for service is less than the pension resulting from the member's years of  
32 service determined in accordance with [§ 34(b)(1)(B)] § 34(B-1)(1)(B), a  
33 supplemental pension equal to the difference between the two shall be  
34 payable.

35 (E) The additional annuity provided as the result of voluntary contributions  
36 permitted under § 36(b)(10) shall be payable and shall not be used in

1 determining this supplemental pension, if any, payable under this  
2 subdivision.

3 (2) For any member who retires on or after July 1, 1989, and on or before June 30,  
4 1991, the service retirement allowance shall consist of:

5 (A) an annuity which shall be the actuarial equivalent of his accumulated  
6 contributions at the time of his retirement; and

7 (B) a pension which, together with his annuity, shall be equal to:
