Dear Honorable President and Members of the City Council:

I am pleased to inform your Honorable Body that I have signed into law this day the following bills:

Bill 21-0076 - An Ordinance concerning - Zoning – Conditional Use Conversion of a Single-Family Dwelling Unit to 2 Dwelling Units in the R-8 Zoning District – Variances -1049 Brantley Avenue - For the purpose of permitting, subject to certain conditions, the conversion of a single-family dwelling unit to 2 dwelling units in the R-8 Zoning District on the property known as I049 Brantley Avenue (Block 0115, Lot 069), as outlined in red on the accompanying plat; and granting variances from certain bulk (lot area size) and off-street parking requirements.

Bill 21-0103 - An Ordinance concerning - Suicide Prevention Coordinator – Establishment - For the purpose of establishing the position of Suicide Prevention Coordinator within the Health Department; and providing for the duties of the Suicide Prevention Coordinator.

Bill 21-0104 - An Ordinance concerning - Baltimore City Workgroup on Women in Public Safety - For the purpose of establishing the Baltimore City Workgroup on Women in Public Safety; providing for the composition and staffing of the Workgroup; requiring the Workgroup to study certain matters related to the recruitment, hiring, training, retention, mentorship, and promotions of women in Baltimore City public safety agencies; requiring the Workgroup to report its findings and recommendations to the Mayor and City Council on or before a certain date; providing for a special effective date; providing for the termination of this Ordinance; and generally relating to the advancement of women in public safety professions.

Bill 21-0041 - An Ordinance concerning - Board of Estimates – Clerk to the Board of Estimates - For the purpose of designating the Comptroller or the Comptroller’s designee to be the clerk of the Board of Estimates.

Bill No. 21-0185 - By Councilmember Torrence
