1 AN ORDINANCE concerning

2 **Supplementary General Fund Operating Appropriation –**
3 **Police Department – \$90,000**

4 FOR the purpose of providing a Supplementary General Fund Operating Appropriation in the
5 amount of \$90,000 to the Police Department – Program 200 (Administrative Direction and
6 Control), to provide funding for Civil Service Exam Preparation Classes; and providing for a
7 special effective date.

13 **Recitals**

14 The revenue appropriated by this Ordinance represents funds from the Fiscal 2007 Fund
15 Balance in excess of the revenue relied on by the Board of Estimates in determining the tax levy
16 required to balance the budget for Fiscal Year 2008.

17 This additional revenue could not have been reasonably anticipated when the Ordinance of
18 Estimates for Fiscal Year 2008 was formulated.

19 This appropriation is made necessary by a material change in circumstances since the
20 Ordinance of Estimates for Fiscal Year 2008 was formulated or is for a new program that could
21 not have been reasonably anticipated when that Ordinance of Estimates was formulated.

22 On September 26, 2007, the Board of Estimates recommended this appropriation to the City
23 Council.

24 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That**
25 **\$90,000 shall be made available to the Police Department – Program 200 (Administrative**
26 **Direction and Control) as a Supplementary General Fund Operating Appropriation for Fiscal**
27 **Year 2008, to provide funding for Civil Service Exam Preparation Classes. The source of**

1 revenue for this appropriation is funds from the Fiscal 2007 Fund Balance in excess of the
