13	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the

5 6	SECTION 2. AND BE IT FURTHER ORDAINED, That the increase in benefits established by this Ordinance applies to:			
7 8	(a) all persons who, in accordance with City Code Article 22, § 34, retire on a 100% line-of-duty disability after the effective date of this Ordinance, and			
9 10 11 12	(b) all persons who, on the effective date of this Ordinance, are currently receiving a 100% line-of-duty disability retirement benefit under Article 22, § 34, which persons shall begin receiving their increased benefits prospectively from the effective date of this Ordinance.

AND BE IT FURTHER ORDAINED, That as of the date of enactment of this Ordinance, any member currently receiving a 100% line-of-duty disability retirement benefit under Article 22, § 34, who has not received in annuity payments an amount equal to the total of her or his accumulated contributions as of her or his retirement date, shall receive a lump-sum refund of any remaining unpaid accumulated contributions.			
18 19 20	SECTION 3. AND BE IT FURTHER ORDAINED , That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.			
21 22	SECTION 4. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is enacted.
