**AN ORDINANCE CONCERNING**

1                                   **Bond Fund Capital Appropriation Transfer –**  
2                                   **Department of Public Works (Account #9916-197-317) to**  
3                                   **the Baltimore City Public Schools (Account #9932-418-122) – \$1,700,000**

4 FOR the purpose of transferring a Bond Fund Capital Appropriation in the amount of \$1,700,000  
5 from Department of Public Works (Account #9916-197-317) to the Baltimore City Public  
6 Schools (Account #9932-418-122); and providing for a special effective date.

12                                   **Recitals**

13     Article VI, § 9(a)(2) of the City Charter provides that, on recommendation of the Board of  
14     Estimates, the City Council by ordinance may authorize the transfer of an appropriation  
15     contained in the Ordinance of Estimates from one municipal agency to another municipal  
16     agency.

17     The sum of \$1,700,000, as appropriated to the Department of Public Works (Account #9916-  
18     197-317) in the Fiscal 2006 Ordinance of Estimates, is not needed for the purpose for which it  
19     was appropriated and, therefore, is available for transfer to another agency.

20     On June 29, 2005, the Board of Estimates recommended the transfer authorized by this  
21     Ordinance.

1        **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That the  
 2        sum of \$1,700,000, contained in the Fiscal 2006 Ordinance of Estimates as a Bond Fund Capital  
 3        Appropriation, is transferred from Department of Public Works (Account #9916-197-317) to the  
 4        Baltimore City Public Schools (Account #9932-418-122).

5        **SECTION 2. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the date it  
 6        is enacted.
