3 the Maryland Building Performance Standards (effective March 25, 2019), the International
4 Building Code (2018 Edition), the National Electrical Code (2017 Edition), the International
5 Fuel Gas Code (2018 Edition), the International Mechanical Code (2018 Edition), the
6 International Plumbing Code (2018 Edition), the International Property Maintenance Code
7 (2018 Edition), the International Fire Code (2018 Edition), the International Energy
8 Conservation Code (2018 Edition), the International Residential Code for One- and Two-
9 Family Dwellings (2018 Edition), the International Green Conservation Code (2012 Edition),
10 and the International Swimming Pool and Spa Code (2018 Edition), all as supplemented,

12 and effective date of these new standards and codes; conforming, correcting, and clarifying

1 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE**, That the
2 Laws of Baltimore City read as follows:

3 **ARTICLE – BUILDING, FIRE, AND RELATED CODES**

4 **PART I. MARYLAND BUILDING PERFORMANCE STANDARDS**

5 **§ 1-101. State action.**

6 (a) *In general.*

7 The Maryland Building Performance Standards are adopted and, from time to time,
8 amended by the [State] MARYLAND Department of [Housing and Community
9 Development] LABOR under State Public Safety Article, Title 12, Subtitle 5.

10 (b) *Contents.*

11 As amended effective [January 1, 2015,] MARCH 25, 2019, these Standards consist of:

- 12 (1) the International Building Code ([2015] 2018 Edition), with certain State
13 modifications {[COMAR 05.02.07.04A and B] COMAR 09.12.51.04A AND B};
- 14 (2) the International Residential Code for One- and Two-Family Dwellings ([2015]
15 2018 Edition), with certain State modifications {[COMAR 05.02.07.04A and C]
16 COMAR 09.12.51.04A AND C}; and
- 17
18 (3) the International Energy Conservation Code (2015 Edition), with certain State
19 modifications {[COMAR 05.02.07.04A and D] COMAR 09.12.51.04A AND D}.

20 **§ 1-102. City adoption.**

21 The Maryland Building Performance Standards are adopted as part of the Building, Fire, and
22 Related Codes of Baltimore City, subject to the following modifications:

- 23 (1) in the International Building Code ([2015] 2018 Edition):
- 24 (i) incorporate the State modifications indicated in the appropriate chapter,
25 section, or other provision of Part II below; and
- 26 (ii) add the Baltimore City modifications indicated in the appropriate chapter,
27 section, or other provision of Part II below;
- 28 (2) in the International Residential Code for One- and Two-Family Dwellings ([2015]
29 2018 Edition):
- 30 (i) incorporate the State modifications indicated in the appropriate chapter,
31 section, or other provision of Part X below; and
- 32 (ii) add the Baltimore City modifications indicated in the appropriate chapter,
33 section, or other provision of Part X below; and

PART II. INTERNATIONAL BUILDING CODE

§ 2-101. City adoption.

(a) *In general.*

The International Building Code ([2015] 2018 Edition) is adopted as part of the Building, Fire, and Related Codes of Baltimore City, subject to the additions, deletions, amendments, and other modifications contained in this Part II.

(b) *Codification.*

Unless otherwise specified, chapter and section numbers in this Part II refer to the chapter and section numbers of the International Building Code.

§ 2-102. Maryland Building Performance Standards.

The Maryland Building Performance Standards contain certain State modifications to the International Building Code. The State modifications that Baltimore City has adopted are repeated in this Part II, for the user's convenience, in the appropriate chapter, section, or other provision. These State modifications are labeled "MBPS Modification".

§ 2-103. City modifications.

The additions, deletions, amendments, and other modifications adopted by the City are as follows:

Chapter 1 Scope and Administration

{**MBPS Modification – Note to Chapter 1:** Local jurisdictions are responsible for the implementation and enforcement of the Maryland Building Performance Standards. Refer to each local jurisdiction for local amendments to Chapter 1 of the IBC. Each local jurisdiction having authority shall establish ... implementation and enforcement procedures that include: (a) review and acceptance of appropriate plans; (b) issuance of building permits; (c) inspection of the work authorized by the building permits; and (d) issuance of use and occupancy certificates.}

Section 101 General

101.1 Title. The regulations contained in this Code constitute and are known as the "Baltimore City Building Code". The Baltimore City Building Code, together with the standards and codes listed in § 101.4 {"Referenced codes"} of this Chapter, as supplemented, amended, or otherwise modified by these provisions, collectively constitute and are known as the "Building, Fire, and Related Codes of Baltimore City".

101.1.1 References to "this Code". Throughout this Part II, all references to "this Code" refer to the Building, Fire, and Related Codes of Baltimore City.

1 101.2 Scope. *{As in IBC}*

2 **Exception 1: {Per MBPS Modification}** Detached 1- and 2-family dwellings and
3 multiple single-family dwellings (townhouses) not more than 3 stories above grade
4 plane in height with a separate means of egress and their accessory structures
5 must comply with the International Residential Code.

6 **Exception 2: {Per MBPS Modification}** Existing buildings undergoing repair,
7 alterations, or additions, and change of occupancy must comply with the Maryland
8 Building Rehabilitation Code, set forth in COMAR [05.16] 09.12.58. **{NOTE: THE**
9 **MARYLAND BUILDING REHABILITATION CODE COMPRISES THE 2015 INTERNATIONAL**
10 **EXISTING BUILDING CODE, WITH STATE MODIFICATIONS).**

11 **EXCEPTION 3: {PER MBPS MODIFICATION} MAINTENANCE OF RESIDENTIAL**
12 **STRUCTURES AND PREMISES MUST COMPLY WITH THE MINIMUM LIVABILITY CODE, AS**
13 **SET FORTH IN COMAR 09.12.54.**

14 **101.2.1 Appendices.** The appendices to the International Building Code apply as
15 follows:

16 **101.2.1.1 Appendices adopted.** The [provisions of the] following appendices are
17 **adopted, WITH OR WITHOUT LOCAL MODIFICATIONS,** as part of this Code:

- 18 1. Appendix C: “Group U – Agricultural Buildings”.
- 19 2. Appendix D: “Downtown Fire District”.
- 20 3. Appendix F: “Rodent Proofing”.
- 21 4. Appendix H: “Signs”.
- 22 5. Appendix I: “Patio Covers”.

24 **101.2.1.2 Appendices not adopted.** The following appendices are not adopted as

3 **101.3 Intent.** *{As in IBC}*

4 **101.4 Referenced codes.** The standards and codes listed in this § 101.4, as modified by
5 these provisions and as referred to elsewhere in this Code, are part of the requirements of this
6 Code to the extent prescribed by the reference.

7 **101.4.1 Electrical.** The National Electrical Code ([2014] 2017 Edition), as modified in
8 Part III of this Code, applies to the installation of electrical systems, including their
9 alteration, repair, replacement, equipment, appliances, fixtures, fittings, and
10 appurtenances.

11 **101.4.2 Gas.** The International Fuel Gas Code ([2015] 2018 Edition), as modified in
12 Part IV of this Code, applies to the installation of gas piping from the point of delivery, to
13 gas appliances, and to related accessories as covered in this Code. These requirements
14 apply to gas piping systems extending from the point of delivery to the inlet connections
15 of appliances and the installation and operation of residential and commercial gas
16 appliances, and related accessories.

17 **101.4.3 Mechanical.** The International Mechanical Code ([2015] 2018 Edition), as
18 modified in Part V of this Code, applies to the installation, alterations, repairs, and
19 replacement of mechanical systems, including equipment, appliances, fixtures, fittings,
20 and appurtenances, including ventilating, heating, cooling, air-conditioning and
21 refrigeration systems, incinerators, and other energy-related systems.

22 **101.4.4 Plumbing.** The International Plumbing Code ([2015] 2018 Edition), as
23 modified in Part VI of this Code, applies to the installation, alteration, repair, and
24 replacement, use, or maintenance of or addition to plumbing systems, including
25 equipment, appliances, fixtures, fittings, and appurtenances.

26 **101.4.5 Property maintenance.** The International Property Maintenance Code ([2015]
27 2018 Edition), as modified in Part VII of this Code, applies to existing structures and
28 premises; equipment and facilities; light, ventilation, space heating, sanitation, life, and
29 fire safety hazards; responsibilities of owners, operators, and occupants; and occupancy
30 of existing premises and structures.

31 **101.4.6 Fire prevention.** The International Fire Code ([2015] 2018 Edition), as
32 modified in Part VIII of this Code, applies to matters affecting or relating to prevention
33 of structures, processes, and premises from the hazard of fire and explosion arising from
34 the storage, handling or use of structures, materials, or devices; from conditions
35 hazardous to life, property, or public welfare in the occupancy of structures or premises;
36 and from the construction, extension, repair, alteration or removal of fire suppression,
37 automatic sprinkler systems and alarm systems or fire hazards in the structure or on the
38 premises from occupancy or operation.

39 **101.4.7 Energy.** The International Energy Conservation Code ([2015] 2018 Edition), as
40 modified in Parts IX-A and IX-B of this Code, applies to all matters governing the design
41 and construction of buildings for energy efficiency.

1 **101.4.8 Residential.** The International Residential Code for One- and Two-Family
2 Dwellings ([2015] 2018 Edition), as modified in Part X of this Code, applies to detached
3 1- and 2-family dwellings and multiple single-family dwellings (townhouses), not more
4 than 3 stories above grade plane in height, and their accessory structures.

5 **101.4.9 Green Construction.** The International Green Construction Code Construction
6 (2012 Edition), as modified in Part XI of this Code, applies to construction requirements
7 intended to reduce the negative impacts and increase the positive impacts of the built
8 environment on the natural environment and building occupants.

9 **101.4.10 Swimming Pool and Spa.** The International Swimming Pool and Spa Code
10 ([2015] 2018 Edition), as modified in Part XII of this Code, applies to the construction,
11 alteration, movement, renovation, replacement, repair and maintenance of aquatic
12 recreation facilities, pools and spas.

13 **101.5 References to former Codes.** All references in a violation, condemnation, or other
14 notice, in a citation, or in the Baltimore City Code to any former version of the Building
15 Code or to any provision of that Code are considered to refer to the comparable or otherwise
16 applicable provisions of this Code.

17 **Section 102 Applicability**

18 **102.1 to 102.5 {As in IBC}**

19 **102.6 Existing conditions.** The legal occupancy of any structure existing on the date of
20 adoption of this Code is permitted to continue without change, except as otherwise
21 specifically provided in this Code, the International Property Maintenance Code, or the
22 International Fire Code.

23 **102.6.1 to 106.1.2 {As in IBC}**

24 **102.7 Structures owned by City.** This Code does not apply to any structure (other than a
25 building) that is owned by the City, to the extent that the structure:

- 26 1. is located on, over, or under a street, alley, or other public way or land, and
- 27 2. is designed, constructed, controlled, and maintained by and under the authority and
28 supervision of the Director of Public Works, the Director of General Services, or the
29 Director of Transportation, whichever has jurisdiction, or an authorized
30 representative of the applicable Director.

31 **102.8 Public service structures on streets.** This Code does not apply to any pole, conduit,
32 tunnel, pipe line, manhole, or other similar surface or subsurface structure, including its
33 equipment, that is owned and controlled by a public service corporation, to the extent that:

- 34 1. the structure is located on, over, or under a street, alley, or other public way or land,
- 35 2. its construction is authorized by the City, and

3. its installation is regulated and supervised by the Director of Public Works, the Director of General Services, or the Director of Transportation, whichever has jurisdiction, or an authorized representative of the applicable Director.

102.9 Property owned or leased by United States or Maryland. Except as specified in § 102.9.1, land owned by the United States or by the State of Maryland, including any structure owned by either and located on the land, is exempt from this Code.

102.9.1 Exceptions. The following are not exempt from this Code:

1. land or structures leased by the United States or the State of Maryland from a private owner,
2. land or structures leased by a private owner from the United States or the State of Maryland, and
3. land or structures held by the United States or the State of Maryland pursuant to the foreclosure of a residential mortgage.

102.10 Waterways. Other than work done by the United States or the State of Maryland, all construction done along the shoreline and waterways within the City must:

1. comply with this Code, and
2. be approved by:
 - a. the Department of Public Works,
 - b. the Department of General Services,
 - c. the Department of Transportation,
 - d. the Department of Planning,
 - e. the Fire Department,
 - f. the Maryland Department of the Environment, and
 - g. the U.S. Army Corps of Engineers.

102.11 Railroad facilities. Railroad facilities within a railroad right-of-way are exempt from the provisions of this Code, except for those provisions that relate to sanitary maintenance. However, privately owned structures within a right-of-way are not exempt unless they are ancillary to the railroad.

102.12 Moved structures. Structures that are moved into or within Baltimore City:

1. must comply with the provisions of this Code for new structures, and
2. may not be used or occupied, in whole or in part, until the Building Official approves an occupancy permit for the structure.

1 **102.13 to 102.14 {Reserved}**

2 **102.15 Compliance with Code required.** No structure, premises, land, or equipment may
3 be constructed, altered, added to, repaired, rehabilitated, demolished, moved, located, used,
4 occupied, or maintained in violation of this Code.

5 **102.15.1 Construction of structure.** When constructed, every structure must be located
6 so that it does not create a violation of this Code.

7 **102.15.2 Relocation, etc., of lot lines, etc.** No lot or property line may be moved or
8 relocated and no lot or parcel of land may be subdivided in any way that creates a
9 violation of this Code for any structure.

10 **102.16 Compliance with other laws.** To the extent applicable, all work must also comply
11 with:

- 12 1. the Critical Area Management Program of Baltimore City,
- 13 2. the Baltimore City Forest and Tree Conservation Program,
- 14 3. the Baltimore City Sustainability Plan,
- 15 4. the Zoning Code of Baltimore City,
- 16 5. City Code Article 6 {"Historical and Architectural Preservation"},
- 17 6. any applicable Urban Renewal Plan,
- 18 7. the Department of Public Works' rules and regulations governing:
 - 19 a. stormwater management,
 - 20 b. soil erosion and sediment control, and
 - 21 c. discharges to the storm drain system,
- 22 8. the Department of Transportation's rules and regulations governing:
 - 23 a. encroachments into the public right-of-way,
 - 24 b. developer's agreements, and
 - 25 c. blasting,
- 26 9. the Federal Americans with Disabilities Act,
- 27 10. the Maryland Accessibility Code,
- 28 11. the Floodplain Management Code, and

1 12. all other applicable laws, rules, and regulations of the United States, the State of
2 Maryland, and the City of Baltimore.

3 **Section 103 Department of Building Safety**

4 **103.1 Enforcement agency.** This Code is administered and enforced by the Baltimore City
5 Department of Housing and Community Development and its Commissioner. Accordingly,
6 in this Code:

- 7 1. “Department of Building Safety” or “Department” means the Baltimore City
8 Department of Housing and Community Development, and
- 9 2. “Building Official”, means the Commissioner of Housing and Community
10 Development or an authorized representative of the Commissioner.

11 **103.2 Appointment.** *{Not Adopted}*

12 **103.3 Deputies.** *{Not Adopted}*

13 **103.4 Employee restrictions.** An officer or employee of the Department may not:

- 14 1. engage in or directly or indirectly be connected with the furnishing of labor,
15 materials, or appliances or the preparation of plans or specifications for the
16 construction, alteration, addition, repair, rehabilitation, demolition, moving,
17 or maintenance of a structure, unless the officer or employee is the owner of
18 the structure, or
- 19 2. engage in any work that conflicts with his or her official duties or with the
20 interests of the Department.

21 **Section 104 Duties and Powers of Building Official**

22 **104.1 General.** Except as otherwise specifically provided by law, the Building Official:

- 23 1. administers and enforces all provisions of this Code and the provisions of all other
24 ordinances, laws, or regulations relating to the matters provided for in this Code,
25 and
- 26 2. may act on any question relative to the manner of and the materials to be used in
27 the construction, alteration, addition, repair, rehabilitation, demolition, moving,
28 location, use, occupancy, and maintenance of all structures and in the installation
29 of equipment.

30 **104.1.1 Interpretations, rules, and regulations.** The Building Official may:

- 31 1. render interpretations of this Code, and
- 32 2. adopt rules and regulations to carry out this Code.

1 **104.1.2 Filing rules and regulations.** A copy of all rules and regulations adopted under
2 this Code must be filed with the Department of Legislative Reference.

3 **104.2 Applications and permits. {As in IBC}**

4 **104.2.1 Determination of substantially improved or substantially damaged existing**
5 **structures in flood hazard areas.** For applications for reconstruction, rehabilitation,
6 repair, alteration, addition, or other improvement of existing structures located in flood
7 hazard areas, the Building Official shall determine if the proposed work constitutes
8 “substantial improvement” or repair of “substantial damage”, as defined in the Floodplain
9 Management Code. If the Building Official determines that the proposed work does
10 constitute “substantial improvement” or repair of “substantial damage”, the Building
11 Official shall require the structure to meet the requirements of the Floodplain
12 Management Code. **FOR APPLICATIONS FOR RECONSTRUCTION, REHABILITATION,**
13 **ADDITION, OR OTHER IMPROVEMENT OF AN EXISTING STRUCTURE IN A FLOOD HAZARD**
14 **AREA, THE BUILDING OFFICIAL MUST EXAMINE THE CONSTRUCTION DOCUMENTS AND**
15 **PREPARE FINDINGS WITH REGARD TO WHETHER THE STRUCTURE HAS SUSTAINED**
16 **“SUBSTANTIAL DAMAGE” AND WHETHER THE PROPOSED IMPROVEMENT IS A**
17 **“SUBSTANTIAL IMPROVEMENT”, AS THESE TERMS ARE DEFINED IN AND CALCULATED**
18 **UNDER THE FLOODPLAIN MANAGEMENT CODE. THE BUILDING OFFICIAL MUST SUBMIT**
19 **THESE FINDINGS TO THE FLOODPLAIN MANAGER FOR A DETERMINATION OF “SUBSTANTIAL**
20 **IMPROVEMENT”. APPLICATIONS DETERMINED BY THE FLOODPLAIN MANAGER TO**
21 **CONSTITUTE A “SUBSTANTIAL IMPROVEMENT” REQUIRE FULL COMPLIANCE WITH THE**
22 **REQUIREMENTS OF THE FLOODPLAIN MANAGEMENT CODE.**

23 **104.3 to 104.5 {As in IBC}**

24 **104.6 Right of entry.** In the performance of his or her duties, the Building Official may
25 enter any land, structure, or premises in the City to enforce this Code, at any reasonable time
26 or, in an emergency that might endanger public health or safety, at any time.

27 **104.6.1 Entry without notice or warrant.** Neither a search warrant nor prior notice is
28 needed in any of the following circumstances:

- 29 1. if entry is by permission or at the request of an occupant of the land, structure, or
30 premises or a person with apparent right of possession,
- 31 2. if the land, structure, or premises is open and accessible to members of the
32 general public,
- 33 3. if the Building Official reasonably believes that an imminent danger to health or
34 safety exists or might exist, or
- 35 4. immediately after an accident or disaster that causes the Building Official to
36 believe that immediate entry is necessary for investigative purposes or to protect
37 property or public health or safety.

38 **104.6.2 Authority to seek warrant.** Where appropriate, the Building Official may seek
39 a search warrant to enter any land, structure, or premises in the City to make an
40 inspection or to take any other authorized action to administer and enforce:

- 1 1. this Code (including the standards and codes incorporated in it), or
- 2 2. any of the following (collectively “related laws”):
 - 3 a. the Health Code of Baltimore City,
 - 4 b. the Zoning Code of Baltimore City,
 - 5 c. an Urban Renewal Plan,
 - 6 d. City Code Article 6 {“Historical and Architectural Preservation”}, or
 - 7 e. any other related statute, ordinance, rule, or regulation for the protection
 - 8 of the health and safety of the residents of Baltimore City.

9 **104.6.3 Warrant after prior notice.** Before the Building Official may apply for a
10 warrant to make a routine inspection or spot check to determine if a violation exists, the
11 Building Official must give prior notice of his or her intent to the occupant or other
12 person with apparent right of possession or, in the case of an unoccupied structure or
13 premises, to the owner, the owner’s agent, or other person in apparent control of the
14 structure or premises.

15 **104.6.3.1 Contents of notice.** The notice must:

- 16 1. state the date and time at which the Building Official will be present to make
- 17 the inspection or spot check, and
- 18 2. inform the person notified that he or she may reschedule the inspection or spot
- 19 check to a reasonable date and time by contacting the Building Official before
- 20 the stated date.

21 **104.6.3.2 Service of notice – Occupied property.** If the structure or premises is
22 occupied, the notice must be either:

- 23 1. mailed or delivered to the occupant or person with apparent right of
- 24 possession, or
- 25 2. posted conspicuously at or near the entrance to the structure or premises.

26 **104.6.3.3 Service of notice – Unoccupied property.** If the structure or premises is
27 unoccupied, the notice must be mailed or delivered to the last-known address of the
28 owner, agent, or other person in apparent control.

29 **104.6.3.4 Obtaining warrant.** After notice has been given, if the person notified
30 fails to arrange for, denies, or unduly delays the entry, the Building Official may
31 apply to a court of competent jurisdiction for a search warrant to authorize entry for
32 the inspection or spot check.

1 **104.6.3.5 Probable cause.** Probable cause for a search warrant under this § 104.6.3
2 exists if:

- 3 1. the notice required by this § 104.6.3 has been given, and
- 4 2. the inspection is:
 - 5 a. a spot check made at random or restricted to a few sample structures
6 or premises in a designated area to determine if a building-by-building
7 survey is necessary,
 - 8 b. a routine inspection based on a general administrative plan for the
9 enforcement of this Code or any related law, or
 - 10 c. a routine inspection to determine compliance with a notice or order
11 issued under § 123 {"Notices"} of this Code.

12 **104.6.4 Warrant without prior notice.** The Building Official may apply for a search
13 warrant to enter a structure or premises without giving the prior notice otherwise required
14 by § 104.6.3, if there is probable cause to believe that a violation of this Code or a related
15 law exists in the structure or on the premises.

16 **104.6.4.1 Probable cause.** Probable cause for a search warrant under this § 104.6.4
17 includes, among other appropriate circumstances, the following:

- 18 1. the inspection is to identify lead-based hazards in a dwelling unit that is the
19 last-reported address of a child who, by notice from a health care provider or
20 the State Department of the Environment to the Building Official or the
21 Health Commissioner, is reported to have been diagnosed with a venous
22 blood-lead level of [15] 5 micrograms per deciliter or more, or
- 23 2. untreated lead-based paint hazards have been found in a unit of a multiple-
24 family dwelling in which a child who has been diagnosed with a venous
25 blood-lead level of [15] 5 micrograms per deciliter or more resides and entry
26 is needed to other units of the dwelling to determine compliance with law.

27 **104.6.5 Application for warrant.** The application for a search warrant must be:

- 28 1. signed and sworn to by the Building Official, and
- 29 2. accompanied by an affidavit containing facts within the personal knowledge of
30 the affiant:
 - 31 a. that probable cause for issuance of a search warrant exists, and
 - 32 b. in cases where prior notice is required, that notice has been given and
33 entry has not been arranged for or has been denied or unduly delayed by
34 the person notified.

1 **104.6.6 Contents of warrant.** The search warrant must name or describe, with
2 reasonable particularity:

- 3 1. the place to be inspected,

7 within 15 days of the date the warrant was issued. At the end of that 15-day period, the

10 entrance to a dwelling for the purpose of enforcing this Code or any related law may
11 obtain or furnish evidence of, or testify to, any offense other than violations of this
12 Code or of any related law.

13 **104.6.8.1 Exception.** The limitations of § 104.6.8 do not apply to:

- 14 1. a felony, or
- 15 2. a misdemeanor involving an act of violence and committed in the inspector's
16 presence.

19 **104.9 Approved materials and equipment.** *{As in IBC}*

26 **104.11 Alternative materials and methods.** The provisions of this Code are not intended
27 to prevent the installation of any material or to prohibit any method of construction not
28 specifically prescribed by this Code, as long as that alternative has been approved. An
29 alternative material or method of construction may be approved if the Building Official finds
30 in writing that, for the purpose intended:

- 31 1. the proposed alternative is satisfactory and complies with the intent of this Code, and
- 32 2. the material, method, or work offered is at least the equivalent of that prescribed

13 **105.1.1 Annual permit. {As in IBC}**

14 **105.1.2 Annual permit records. {As in IBC}**

15 **105.1.3 By whom application to be made.** Except as otherwise specified in Chapter
16 27 {"Electrical"}, Chapter 28 {"Mechanical Systems"}, and Chapter 29 {"Plumbing
17 Systems"}, the application for a permit must be made as follows:

- 18 1. for a demolition or moving permit, by the owner of the property to be
19 demolished or moved,
- 20 2. for a permit to remove formstone, paint, or other material from exterior
21 surfaces, by the licensed contractor employed to do the proposed work,
- 22 3. for a permit to do work involving underpinning or a retaining foundation
23 wall, by the licensed contractor employed to do the proposed work, and
- 24 4. for all other permits, by:
- 25 a. the owner or lessee of the structure,
- 26 b. the agent of the owner or lessee, or
- 27 c. the licensed engineer or architect employed in connection
28 with the proposed work.

29 **105.1.4 Work done without permit.** A person who does any work without a permit,
30 or outside or beyond the scope of a permit, or in a manner inconsistent with plans or
31 drawings approved as part of a permit application, or after a permit is revoked for any

1 reason, must obtain a permit for that work, even if already completed, and pay the
2 appropriate permit fee and penalty surcharge.

3 **105.1.5 Special professional services.** In addition to and without limiting any other
4 requirements of or authority granted by this Code, the Building Official may require, as
5 a term or condition of a permit, that a registered design professional or other licensed
6 specialist or expert perform specific work or sign and seal specific plans, computations,
7 specifications, or statements.

8 **105.2 Work exempt from permit.** An exemption from the permit requirements of this
9 Code does not authorize any work to be done in a manner that violates a provision of this
10 Code or of any other law. Permits are not required for the following:

10 **105.3 Application for permit.** To obtain a permit, the applicant must first file an
11 application on the form provided by the Building Official for that purpose. The application
12 must:

- 13 1. identify and describe the work to be covered under the permit,
- 14 2. describe the land on which the proposed work is to be done by legal description,
15 street address, or similar description that will readily identify and definitely locate
16 the proposed building or work,
- 17 3. indicate the use and occupancy for which the proposed work is intended,
- 18 4. specify the gross floor area, as defined in Baltimore City Zoning Code § 1-306(j)
19 {“Floor Area: Gross (GFA)”}, involved in the proposed work,
- 20 5. specify the number of dwelling units, if any, involved in the proposed work,
- 21 6. be accompanied by the construction documents and other information required
22 by § 107 {“Submittal Documents”} of this Code, and
- 23 7. if the property is located within an Historical and Architectural Preservation District
24 or included on the City’s Landmark List or Potential-Landmark List, be forwarded to
25 the Commission for Historical and Architectural Preservation, for review and action
26 under City Code Article 6 {“Historical and Architectural Preservation”}, Subtitle 8
27 {“Alterations, etc., to or Affecting Properties”},
- 28 8. state the valuation of the proposed work,
- 29 9. if the proposed work will replace any existing structure, be accompanied by

19 Official must reject the application in writing, stating the reasons for the rejection. If
20 the Building Official is satisfied that the application and the proposed work conform
21 to the requirements of this Code and all other applicable laws, the Building Official
22 must issue the permit as soon as practicable.

23 **105.3.1.2 Referral to assess need for traffic mitigation.** Within 15 business days
24 of receiving a completed application, the Building Official must refer the application
25 and all accompanying documents to the Director of Transportation, for review and
26 action under Chapter 38 {"Traffic Impact and Mitigation"} of this Code, if:

- 27 1. traffic mitigation requirements for the proposed work have not already been
28 complied with in accordance with this Code or the Baltimore City Zoning

- 30 2. the proposed work:

The bond must be in an amount of at least \$10,000.

105.5 **Expiration; extension; reinstatement for final inspection.** Unless an extension is granted, every permit expires and becomes invalid on the expiration date specified on the permit or, if earlier, as provided in this § 105.5.

105.5.1 **Expiration – General.** Except as specified in § 105.5.2, a permit expires if:

1. the work authorized by the permit is not begun on the site within 180 days after the permit is issued, or
2. the work authorized by the permit is abandoned or suspended on the site for 180 days or more.

105.5.2 **Expiration – Condemnation, demolition.** A permit issued to comply with a condemnation notice served under § 123 {"Notices"} of this Code or to comply with a demolition order issued under § 116 {"Unsafe Structures"} of this Code expires if:

1. the work authorized by the permit is not begun on the site within 30 days after the permit is issued, or
2. the work authorized by the permit is not completed within 90 days after the permit is issued.

105.5.3 *{Reserved}*

105.5.4 **Extensions – General.** On a timely written application and for justifiable cause demonstrated, the Building Official may grant 1 or more extensions. Except as specified in § 105.5.5:

1. the application for an extension must be made within 60 days after the permit expires, and
2. each extension is limited to a period of not more than 180 days, unless otherwise authorized by the Building Official.

105.5.5 **Extensions – Condemnation, demolition.** For a permit issued to comply with a condemnation notice or a demolition order:

1. the application for an extension must be made before the permit expires, and
2. each extension must be limited to a period of not more than 90 days.

11 issued under this Code if:

- 12 1. the work is being done in violation of the permit, of this Code, or of any other
13 applicable law or regulation, [or]
- 14 2. the permit was issued:
 - 15 a. in error or on the basis of incorrect, inaccurate, or incomplete information, or
 - 16 b. in violation of this Code or of any other law or regulation[.]; OR
- 17 3. ANY FEDERAL, STATE, OR CITY AGENCY SUSPENDS OR REVOKES ANY LICENSE OR TAKES
18 ANY OTHER ACTION THAT DIMINISHES THE ABILITY TO USE ANY PORTION OF THE PROPERTY
19 IN ANY WAY FOR WHICH THE PERMIT WAS GRANTED UNDER THIS CODE.

20 **105.7 Placement of permit.** *{As in IBC}*

21 **105.8 Separate structures.** Whenever work is being done on two or more independent
22 structures on the same property, a separate permit is required for each independent structure.

23 **105.9 Special requirements for demolition or moving.**

24 **105.9.1 Pre-permit requirements.** A permit may not be granted for demolishing or
25 moving a structure unless the applicant complies with the following.

26 **105.9.1.1 Inspector consultation.** The applicant must have attended an on-site,
27 pre-demolition or pre-moving inspector consultation to discuss and confirm:

- 28 1. appropriate hosing/wetting requirements and procedures,
- 29 2. notification requirements, and
- 30 3. any other matters the Building Official requires.

31 **105.9.1.2 Written notice to adjoining owners, etc.** The applicant must have given
32 written notice to:

- 1 1. the owners of all properties that [immediately adjoin the property] ARE

6 **105.9.1.2.1 Contents of notice.** The written notice must:

- 7 1. indicate the intent to demolish or move the structure,
- 8 2. specify when the work is expected to begin,
- 9 3. identify the contractor scheduled to perform the demolition or

- 11 4. provide the full name, phone number, address, and (if available) email
12 address of an agent of the contractor who can be reached at all times in
13 case of an emergency.

14 **105.9.2 Pre-demolition, moving requirements.** Before beginning any demolition or 15 moving operations, the permit holder must comply with the following.

16 **105.9.2.1 Posted notice.** Public notice of the demolition or moving must be posted 17 on the premises at least 5 days before the scheduled action, but not more than 10 days 18 before the scheduled action.

19 **105.9.2.1.1 Sign requisites – General.** The sign must be:

- 20 1. at least 4 feet wide and 3 feet high,
- 21 2. written in black lettering, at least 2 inches high, on a yellow background,
- 22 3. conspicuously posted, clearly visible and legible to the public, and with
23 the bottom of the sign not less than 5 feet nor more than 10 feet above
24 ground level, and
- 25 4. maintained in good condition until the time of the demolition or moving.

26 **105.9.2.1.2 Sign requisites – Multiple structures.** If the demolition or moving 27 involves 2 or more structures on the same or adjoining properties:

- 28 1. 1 sign meeting the specifications of § 105.9.2.1.1 must be conspicuously
29 posted, clearly visible and legible to the public, and with the bottom of
30 the sign not less than 5 feet nor more than 10 feet above ground level, and
- 31 2. each individual structure must be posted with a sign that is:
 - 32 a. at least 17 inches wide and 11 inches high,

105.9.3 Inspector presence. At least 24 hours before beginning the demolition or moving operation, the contractor must contact the Building Official to schedule the presence of an inspector at the beginning of the demolition or moving operation.

105.9.4 Failure to comply. Failure to comply with the requirements of this § 105.9 may result in revocation of the permit.

105.10 Required corrections. The issuance of a permit does not prevent the Building Official from later requiring the correction of errors in any plans, drawings, work, or operations.

105.13 Inspection registration permits. An inspection registration permit issued by the Building Official is required before any person may use any land or structure for:

4 building operation is not valid unless the fees prescribed in this Code have been paid, nor is
5 any amendment or extension to a permit valid unless the prescribed additional fee has been
6 paid. Payment must be made before issuance of the permit, amendment, or extension.

7 **109.2 Other fees.** The payment of the fee for all work done concurrently or in connection
8 with the work contemplated by a permit does not relieve the applicant or permit holder from
9 the payment of other fees prescribed by law for water taps, sewer connections, electrical
10 permits, signs and display structures, marquees, or other appurtenant structures, or fees for
11 inspections, occupancy permits, or other privileges or requirements, whether within or
12 without the jurisdiction of the Department.

13 **109.3 Minimum fees and service charges.** Fees or service charges for the various permits,
14 certificates, inspections, tests, or other services provided under this Code are as specified in
15 this § 109. Unless otherwise specified, the minimum fee or service charge is \$25. All fees
16 are to be rounded to the nearest dollar.

17 **109.4 Refunds; credits.**

18 **109.4.1 General.** No fee or other service charge paid for any application, permit,
19 certificate, inspection, test, or other service may be refunded, in whole or in part, except
20 as provided in this § 109.4.

21 **109.4.2 Limitations.** Except as provided in § 109.4.3:

- 22 1. if no work has been done nor any privilege enjoyed under a permit, certificate,
23 inspection, test, or other service, a refund may be granted of not more than 50%
24 of the fee or service charge paid; and
- 25 2. in no event may any refund be granted on any fee or charge of less than \$1,000.

26 **109.4.3 Administrative error.** If the Building Official revokes a permit because of an
27 administrative error that, through no fault of the applicant, was made in issuing the
28 permit, the applicant is entitled to:

- 29 1. apply for and receive a full refund of the fee paid for the revoked permit, or
- 30 2. request that the fee paid for the revoked permit be applied and credited to
31 the fee due for a new permit to replace the one revoked.

32 **109.5 Service charges.**

33 **109.5.1 Duplicate or additional documents.** The charges for copies or duplicates of
34 permits, certificates, and other documents are:

- 35 1. for photocopies of documents other than approved plans, \$1 for the 1st page and
36 50¢ for each additional page,

109.5.8 Inspection fees.

3. during the suspension or after the revocation of a permit for that work.

109.5.9.1 **Amount – In general.** Except as otherwise specified in this § 109.5.9, the amount of the surcharge is the greater of \$1,000 or 50% of the permit fee.

109.5.9.2 **Amount – Demolition work.** For demolition work done without the proper permit or in violation of the terms of a permit, the surcharge is 50¢ for each cubic foot of the structure before the demolition.

109.5.9.3 **Reductions.** The Building Official may reduce the amount of a surcharge imposed by this § 109.5.9:

1. on written application and justifiable cause demonstrated, and
2. in accordance with applicable standards and criteria contained in the rules and regulations adopted under this Code.

109.5.9.4 **Surcharge in addition to other fines, etc.** A surcharge imposed by this § 109.5.9 is in addition to any other fine or penalty imposed under this Code or any other law or regulation.

109.5.9.5 UNPAID SURCHARGE. AN UNPAID SURCHARGE SHALL BE COLLECTED AND A LIEN PLACED IN THE MANNER SET FORTH IN § 118 OF THIS CODE.

34 Fund and accounted for in a revenue account entitled "Homeless Relief Assistance", with the
35 legislative intent that an equivalent amount be appropriated in the future for the relief of the
36 homeless.

38 **110.1 to 110.2** *{As in IBC}*

39 **110.3 Required inspections.** *{As in IBC}*

1 **110.3.1 to 110.3.2** *{As in IBC}*

2 **110.3.3 Lowest floor elevation.** In a flood hazard area, on placement of the lowest
3 floor, including the basement, and before undertaking any further vertical construction,
4 the elevation certificate required by the Floodplain Management Code must be submitted
5 to the Building Official.

6 **110.3.4 to [110.3.9] 110.3.10** *{As in IBC}*

7 **[110.3.11] [110.3.10] Final inspection.** The final inspection must be made after all work
8 required by the building permit is completed.

9 **[110.3.11.1] [110.3.10.1] Flood hazard documentation.** For structures in a flood
10 hazard area, documentation of the elevation of the lowest floor, as required by the
11 Floodplain Management Code, must be submitted to the Building Official before the
12 final inspection.

13 **110.4 to 110.6** *{As in IBC}*

14 **Section 111 Occupancy Permit; Certificate of Completion**

15 **111.1 to 111.4** *{As in IBC. But Note: The “certificate of occupancy” to which the IBC*
16 *refers is known in Baltimore City as an “occupancy permit”}.*

17 **111.5 Certificate of completion.** Within 10 days of written application, the Building
18 Official will issue a certificate of completion if all work authorized by a building permit
19 has been satisfactorily completed in compliance with this Code. The certificate certifies the
20 satisfactory completion of the work and the purpose for which the structure may be used in
21 its several parts.

22 **Section 112 Service Utilities** *{As in IBC}*

23 **Section 113 Board of Appeals** *{Not Adopted}*

24 **Section 114 Violations**

25 **114.1 Unlawful acts.** It is unlawful for any person to:

- 26
- 27 1. construct, alter, add to, repair, rehabilitate, demolish, move, locate, use, occupy, or
28 maintain any structure, premises, land, or equipment contrary to or in conflict with
29 or in violation of:
- 30 a. any provision of this Code,
- 31 b. any provision of City Code Article 6 {“Historical and Architectural
32 Preservation”}, or
- 33 c. any provision of any rule, regulation, decision, permit, notice, or order issued
34 under this Code or under City Code Article 6 by the Building Official, by the
35 Commission for Architectural and Historical Preservation, or by any other
36 person, board, department, bureau, commission, or agency with jurisdiction,

- 1 2. otherwise fail to comply with any provision of this Code, of City Code Article 6, or
2 of any rule, regulation, decision, permit, notice, or order issued under this Code or
3 City Code Article 6, or
- 4 3. cause any of these acts or omissions to be done.

5 **114.2 Violation notice or order.** Except as otherwise provided in this Code, the Building
6 Official may serve a violation notice or order on any person legally responsible for the
7 construction, alteration, addition, repair, rehabilitation, demolition, moving, location, use,
8 occupancy, or maintenance of any structure, premises, land, or equipment in violation of any
9 provision of:

- 10 1. this Code, or
- 11 2. a plan approved under this Code, or
- 12 3. a permit or certificate issued under this Code.

13 **114.2.1 Tenor of notice or order.** The notice or order may direct:

- 14 1. the discontinuance of the illegal action or condition, and
- 15 2. the abatement of the violation, which may include restoration to the prior
16 condition.

17 **114.3 Enforcement generally.** If a violation is not promptly discontinued or abated, or if
18 the violation notice or order is not complied with promptly, the Building Official may
19 institute or cause to be instituted any appropriate legal proceedings.

20 **114.3.1 Types of proceedings.** Enforcement proceedings may include:

- 21 1. injunctive or other equity proceedings, including:
 - 22 a. an action initiated by a code-enforcement-injunction citation under
23 City Code Article 19, § 71-3 {"Code enforcement injunction"}, or
 - 24 b. an action for appointment of a receiver under § 121 {"Vacant Building
25 Receiver"} of this Code,
- 26 2. criminal prosecution, including a prosecution initiated by a prepayable criminal
27 citation under City Code Article 19, § 71-2 {"Prepayable criminal citations"}, and
- 28 3. administrative proceedings, including one initiated by an environmental citation
29 under City Code Article 1, § 40-14 {"Violations to which subtitle applies"}.

30 **114.3.2 Remedies not exclusive.** In pursuing a violation, the Building Official may use
31 any 1 or more available remedies or enforcement actions. The initiation of any 1 remedy
32 or enforcement action does not preclude pursuing any other remedy or enforcement
33 action authorized by law. Neither damages, irreparable injury, nor the lack of an
34 adequate remedy at law is a prerequisite to enforcement in equity.

1 **114.3.3 When prior notice not required.** A violation notice or order is not a
2 prerequisite to enforcement action in the following situations:

- 3 1. when seeking a temporary restraining order or injunction in an emergency,
- 4 2. when seeking equitable relief for a pattern or practice of noncompliance,
- 5 3. for work being done without a permit or in violation of a stop-work order,
- 6 4. for a violation that remains unabated after a prior prosecution for that violation,
- 7 5. for a prepayable criminal citation that is issued under City Code Article 19,
8 Subtitle 71 {"Special Enforcement Officers"} and for which prior notice
9 is waived under Article 19, § 71-2 {"Prepayable criminal citations"},
- 10 6. for an environmental citation that is issued under City Code Article 1, Subtitle 40
11 {"Environmental Control Board"},
- 12 7. for occupying or causing to be occupied a building that is subject to a violation
13 notice issued under § 116 {"Unsafe Structures"} or § 120 {"Condemnation
14 Proceedings"}, and
- 15 8. in any other case specifically authorized by this Code.

16 **114.4 Violation a misdemeanor.** A person is guilty of a misdemeanor and, on conviction,
17 subject to the penalties specified in this § 114.4, if the person:

- 18 1. violates a provision of this Code,
- 19 2. fails to comply with any requirement of this Code or of a regulation, order, decision,
20 permit, or notice issued under this Code, or
- 21 3. constructs, alters, adds to, repairs, rehabilitates, demolishes, moves, locates, uses,
22 occupies, or maintains any structure, premises, land, or equipment in violation of an
23 approved plan or directive of the Building Official or of a permit or certificate issued
24 under this Code.

25 **114.4.1 Notice required.** Except as otherwise specifically authorized by law, criminal
26 proceedings may not be initiated unless the Building Official issues a notice of violation
27 and allows a period within which to abate the violation.

28 **114.4.2 Each day a separate offense.** Each day that a violation continues is a separate
29 offense. Proof that a violation exists on any date after issuance of a violation notice is
30 prima facie evidence that the violation has continued unabated throughout the intervening
31 period.

32 **114.4.3 Penalties.** The penalty for each offense is as follows:

- 33 1. for work done without a permit or in violation of a stop-work order, a fine of not
34 more than \$500 or imprisonment for not more than 90 days or both fine and
35 imprisonment, and

1 2. for all other violations, a fine of not more than \$500.

2 **114.5 Civil penalties and costs.** In equity proceedings instituted under this Code:

- 3 1. a violation for which equitable relief is sought is subject to a civil fine of not more
4 than \$500 for each day that the violation continues unabated,
- 5 2. the defendant is liable for the plaintiff's enforcement costs and reasonable attorneys'
6 fees, at the rate established by the Court of Appeals, whether or not the attorney is a
7 salaried employee of the plaintiff, and
- 8 3. judgment may be sought for outstanding liens imposed by the City on property
9 subject to the proceeding and owned by the defendant.

10 **114.6 Additional legal action.** The imposition of penalties does not preclude the City
11 Solicitor from instituting appropriate legal proceedings to:

- 12 1. prevent unlawful construction,
- 13 2. restrain, correct, or abate a violation,
- 14 3. prevent illegal occupancy of a structure or premises, or
- 15 4. stop an illegal act, conduct, business, or use of a structure on or about any premises.

16 **114.7 to 114.10 {Reserved}**

17 **114.11 Revoking or withholding violator's permits.**

18 **114.11.1 Scope.** This § 114.11 applies whenever the Building Official finds that an
19 owner, an owner's agent, a contractor, or an architect, engineer, or other design
20 professional:

- 21 1. has violated a provision of this Code, of a permit, or of the rules and regulations
22 of any department or agency of the City in connection with the construction,
23 alteration, addition, repair, rehabilitation, demolition, moving, location, use,
24 occupancy, or maintenance of any structure, premises, land, or equipment; **OR**
- 25 2. **HAS FAILED TO PAY ANY OUTSTANDING CITATION ISSUED OR FEE IMPOSED UNDER**
26 **THIS CODE.**

27 **114.11.2 Actions authorized.** In any situation described in § 114.11.1, the Building
28 Official may:

- 29 1. revoke, without prior notice, any existing permit that has been granted:
- 30 a. to the owner, the owner's agent, the contractor, or the architect, engineer,
31 or other design professional, or

- 1 b. for work in connection with which the design professional is employed,
2 and
- 3 2. refuse to grant, for a period of up to 5 years, any further permits:
- 4 a. to the owner, the owner's agent, the contractor, or the architect, engineer,
5 or other design professional,
- 6 b. for work in connection with which the design professional is employed, or
- 7 c. for work on the property with respect to which the violation occurred.

8 **114.12 to 114.13 {Reserved}**

9 **114.14 Work without permit.** Any person who does work without a permit, outside or
10 beyond the scope of a permit, or in a manner inconsistent with plans or drawings approved as
11 part of a permit application:

- 12 1. is in violation of this Code and subject to enforcement action without notice,
- 13 2. must immediately stop any work in progress,
- 14 3. must obtain a permit, paying all associated fees and penalties, whether the work
15 is in progress or completed, and
- 16 4. must restore the structure to its original condition, unless:
- 17 a. the work otherwise conforms to the relevant requirements of law, and
- 18 b. the Building Official, in his or her discretion, allows the work to
19 remain or continue.

20 **114.15 to 114.20 {Reserved}**

21 **114.21 Responsibility of owners and operators.** Except as otherwise specifically provided
22 in § 114.21.1, the owner and the operator of any property subject to this Code are each:

- 23 1. responsible for compliance with all provisions of this Code in all matters pertaining
24 directly or indirectly to that property, and
- 25 2. liable for all violations of this Code in connection with any land, structure, matter,
26 or thing owned or controlled by them.

27 **114.21.1 Exceptions.** Only the owner is responsible for compliance with a provision
28 requiring an owner's signature. Except as specified in § 114.21.2, an owner or operator
29 is not responsible for compliance with a provision of this Code that is specifically
30 designated as the responsibility of the occupant, unless that owner or operator is also an
31 occupant.

32 **114.21.2 Liability for sanitary maintenance.**

33

Council Bill 20-0505

1 **a. Secondary liability.** If, after a notice, order, or citation, a tenant fails to correct a
2 violation of Property Maintenance Code § 305 {"Exterior Sanitary Maintenance –
3 General"} or § 306 {"Exterior Sanitary Maintenance – Trash, Garbage, and
4 Debris"} for which occupants are responsible under Property Maintenance Code
5 § 308 {"Occupants’ Sanitary Responsibilities"}, the owner and operator of the
6 property are secondarily liable.

7 **b. Liability – Failure to register property.** The owner of a property is responsible
8 for exterior sanitary maintenance if:

- 9 1. the owner fails to register or license the property as required by City Code
10 Article 13, Subtitle 4 {"Registration of Non-Owner-Occupied Dwellings,
11 etc."} or Subtitle 5 {"Licensing of Rental Dwellings"}, or
12 2. reasonable attempts at telephone contact, using information in a current
13 registration statement, do not lead within 2 business days to current
14 occupant information.

15 **c. Liability – Third environmental citation.** The owner of a property is
16 responsible for exterior sanitary maintenance if:

- 17 1. within the previous 12 months, two or more environmental citations
18 were issued under City Code Article 1, Subtitle 40 {"Environmental
19 Control Board"}, for violations of this Code that were the responsibility
20 of an occupant of the property under Property Maintenance Code § 308
21 {"Occupants’ Sanitary Responsibilities"}, and
22 2. notification of each citation has been sent to the owner by regular mail.

23 **114.21.2.1 Notice to owner, operator.** Before an owner or operator may be charged
24 under § 114.21.2a {"Secondary liability"}, he or she must be served with a violation
25 notice under § 123.4 {"Violation notices"}. A violation notice under § 123.4 is not
26 necessary to charge an owner under §§ 114.21.2b {"Liability – Failure to Register
27 Property"} or 114.21.2c {"Liability – Third environmental citation"}.

28 **114.21.2.2 Recovery of expenses.** If an owner or operator incurs expenses in
29 correcting the violation, the owner or operator:

- 30 1. may bring legal action to recover those expenses from the tenant, and
31 2. has all the rights and remedies available under the law for nonpayment.

32 **114.22 Responsibility of others.** In addition to the owner or operator of the property
33 involved, any other person who violates any provision of this Code is liable for the violation
34 and, on conviction, is subject to all penalties provided in this Code for the violation.

35 **114.23 Responsibility of transferee.** This § 114.23 applies whenever any property is
36 transferred by sale, assignment, ground rent lease, or otherwise, with or without
37 consideration ("transfer"). Except as provided in § 114.25 {"Responsibility of mortgagee"},
38 this § 114.23 does not apply to a mortgagee or to the holder of a note secured by a deed of
39 trust.

1 **114.23.1 Duty before transfer.** Before any transfer of property, the transferee must
2 obtain a copy of a violation report for the property.

3 **114.23.2 Primary liability of transferee.** On transfer of the property, if any violation
4 or condemnation notices lie against the property and are included in the violation report,
5 the transferee:

- 6 1. becomes primarily liable for those notices the same as if the notices had been
7 addressed to the transferee,
- 8 2. must abate the violation, and
- 9 3. is liable in accordance with § 117 {"Emergency and Corrective Measures"}
10 of this Code for any expenses incurred by the City in abating the violation or
11 condemnation notice, if the transferee failed to request a violation report as
12 required by § 114.23.1.

13 **114.23.3 Reliance on violation report.** A transferee is not liable for abatement
14 expenses incurred by the City if, before the transfer, the transferee requested a violation
15 report and the report does not show the violation.

16 **114.24 Responsibility of officers, directors, etc., of corporations, partnerships, etc.**

17 Whenever a corporation, joint stock company, partnership, association, limited liability
18 company, or other entity violates any provision of this Code, every officer, director, trustee,
19 partner, member, or agent of that entity who has authorized or done any of the acts
20 constituting the violation, in whole or in part, or who has failed to act or acquiesced in any
21 failure to act constituting the violation, in whole or in part, is individually guilty of a
22 misdemeanor and, on conviction, is subject to the penalties provided in this § 114.

23 **114.25 Responsibility of mortgagee.** A person that acquires an interest in property by way
24 of a mortgage or deed of trust ("lender") is liable to the same extent as an owner/transferee
25 for a violation or condemnation notice pertaining to a vacant unsafe structure, if:

- 26 1. the person with primary responsibility fails to comply with the notice,
- 27 2. the lender has been notified by certified mail of the violation or condemnation notice,
28 and
- 29 3. within 180 days after the receipt of the notice:
 - 30 a. ratification of a foreclosure sale of the property has not occurred, or
 - 31 b. the lender has not released its mortgage or deed of trust.

32 **114.25.1 Bankruptcy toll.** The 180-day period referred to in § 114.25(3) is tolled by
33 any period during which the lender's right to foreclose is stayed by a pending proceeding
34 under the federal Bankruptcy Code.

35 **114.25.2 Defense.** During any enforcement proceeding instituted against a lender under
36 this section, it is a defense that the lender did not have the right to institute foreclosure
37 proceedings.

1 **114.25.3 During pendency of foreclosure.** During the pendency of a foreclosure, the
2 lender is responsible for maintaining the property free from high vegetation, free from
3 accumulation of trash and debris, and otherwise in full compliance with the requirements
4 of this Code.

5 **114.26 Responsibility of buyer on foreclosure.** On foreclosure or sale in lieu of
6 foreclosure, the buyer:

- 7 1. acquires ownership responsibility when the sale is ratified, and
- 8 2. takes title subject to any outstanding notices.

9 **Section 115 Stop-Work Order**

10 **115.1 Authority.** *{As in IBC}*

11 **115.2 Issuance.** The stop-work order must be in writing and state the reason for the order.
12 It must be posted on the property. On posting, the cited work must immediately cease.
13 Written notice of the stop-work order must be sent by first class and certified mail to the
14 owner of the property involved.

15 **115.3 Unlawful continuance.** *{As in IBC}*

16 **115.4 Removal, etc., of posted notice.** Until the Building Official so authorizes, no person
17 may remove, deface, damage, or change any notice, poster, or sign placed under this section
18 on any land, structure, or other object.

19 **Section 116 Unsafe Structures**

20 **116.1 General.** Any structure or part of a structure found to be unsafe or unfit for human
21 habitation or other authorized use must be rehabilitated or, as permitted or required by the
22 Building Official, demolished.

23 **116.1.1 Scope.** A structure may be unsafe or unfit for human habitation or other
24 authorized use because of:

- 25 1. conditions constituting a fire hazard or conditions of damage, decay, dilapidation,
26 obsolescence, abandonment, vacancy (as described in § 116.4), insanitation, or
27 vermin or rodent infestation that constitute a hazard to the health, welfare, or
28 safety of occupants or the public,
- 29 2. lack of sanitation, illumination, ventilation, heating, plumbing, exitways, fire
30 protection, utilities, or other facilities adequate to protect the health, welfare, or
31 safety of occupants or the public, or
- 32 3. conditions that are so unsafe, insanitary, overcrowded, improper in use or
33 occupancy, or otherwise dangerous to life, health, welfare, or safety as to create a
34 hazard to occupants or the public.

1 **116.2 Occupied unsafe structures.** Whenever the Building Official or the Commissioner
2 of Health finds all or any part of an occupied structure to be unsafe or unfit for human
3 habitation or other authorized use:

- 4 1. either the Building Official or Commissioner of Health may:
 - 5 a. post an order requiring the structure or affected part to be vacated, and
 - 6 b. take necessary steps to remove occupants who fail or refuse to vacate,
- 7 2. once vacated, the structure or affected part may not be reoccupied until:
 - 8 a. it is rehabilitated to comply with all applicable codes and ordinances, and
 - 9 b. the Building Official has issued an occupancy permit, and
- 10 3. pending rehabilitation, the structure must be kept secure against casual entry and the
11 premises kept free of occupants, litter, high grass, and weeds.

12 **116.3 Temporarily unoccupied structures.** Any structure or part of a structure that has
13 been left unoccupied without removing appliances or portable equipment or furniture and
14 without disconnecting utility service must be safeguarded by closing and securely locking all
15 windows, doors, and other openings.

16 **116.4 Vacant structures.** Every vacant structure, as defined in this § 116.4, is declared to
17 be a fire hazard and a nuisance per se, and must be safeguarded and otherwise maintained as
18 required in this § 116.4.

19 **116.4.1 Definitions.**

20 **116.4.1.1 General.** In this § 116.4, the following terms have the meanings indicated.

21 **116.4.1.2 Vacant structure.** “Vacant structure” means [an unoccupied] A structure
22 OR DISTINGUISHABLE PART OF A STRUCTURE that is:

23 1. UNOCCUPIED, AND

24 2. EITHER:

25 A. [1.] unsafe or unfit for human habitation or other authorized use, or

26 B. [2.] a nuisance property.

27 **116.4.1.3 Nuisance property.** “Nuisance property” means:

- 28 1. an unoccupied structure for which 2 or more final, non-appealable Building
29 Code, Fire Code, or Property Maintenance Code violations remained unabated
30 for 10 days or more beyond the date by which the violation notice, citation, or
31 order required the violation to be corrected; or

Council Bill 20-0505

2. the exterior premises of an unoccupied structure for which, at any time within the preceding 12 months, on 6 or more separate occasions, final, no-longer appealable violation notices, citations, or orders were served to correct violations of Property Maintenance Code, § 305 {"Exterior Sanitary Maintenance – General"} or § 306 {"Exterior Sanitary Maintenance – Trash, Garbage, and Debris"}.

116.4.1.3.1 Registered interest holders.

116.4.1.3.1.1 Registration authorized. A holder of an interest in a structure by way of a mortgage or deed of trust may register that interest in the Housing Commissioner’s Registry of Non-Owner-Occupied Dwellings, Rooming Houses, and Vacant Structures (City Code Article 13, Subtitle 4).

116.4.1.3.1.2 Notice required to registrants. Before declaring an unoccupied structure to be a nuisance property, the Building Official must send a notice, by first-class mail or email, to any interest holder that is registered for that structure under City Code Article 13, Subtitle 4 {"Registration of Non-Owner-Occupied Dwellings, Rooming Houses, and Vacant Structures"}.

116.4.1.3.1.3 Tenor of notice. The notice shall provide the interest holder with the opportunity to avoid a declaration of public nuisance if, within 30 days of the mailing, the interest holder:

1. abates all outstanding violations; and
2. submits a reasonable plan to the Building Commissioner for regular maintenance of the property.

116.4.1.3.2 Official’s corrective actions do not constitute abatement.

Actions taken by the Building Official to clean, secure, or repair a property do not preclude the Building Official’s determination that the property is a nuisance property.

116.4.2 Determination of vacancy, noncompliance. A determination of vacancy and a determination of noncompliance with a notice or order issued under this section may be based on observation that a structure:

1. contains, at any level, any open window or door, any opening caused by damage or decay, or any other opening that is unprotected from intruders,
2. has boarded windows or doors, or
3. lacks intact doors, windows, window sashes, walls, or roof surfaces to protect against the elements.

116.4.3 Required safeguarding. Every vacant structure must be cleaned, closed, and safeguarded as follows:

- 1 2. Before the structure is closed and secured, all litter, trash, and other debris must
2 be removed from the premises.
- 3 2. All windows, doors, and other openings must be closed, securely locked, and, if
4 readily accessible, boarded up with substantial material, including masonry,
5 approved by the Building Official. The Building Official may require windows
6 facing streets to be boarded with lexan, vinyl, or similar material, protected by
7 security grills, or both.
- 8 3. As long as the structure remains unrehabilitated:
 - 9 a. it must be kept boarded,
 - 10 b. the premises must be conspicuously posted against trespass, and
 - 11 c. the premises must be kept free of occupants, litter, trash, debris,
12 high grass, and weeds at all times.
- 13 4. Boarding, posting, and cleaning, however, do not relieve the owner of
14 responsibility to demolish or to repair and maintain the property in conformity
15 with this Code.
- 16 5. THE BUILDING OFFICIAL MAY POST A SIGN TO INFORM THE PUBLIC THAT THE
17 STRUCTURE IS A VACANT STRUCTURE AND TO PROVIDE ADDITIONAL INFORMATION
18 ABOUT THE STRUCTURE'S STATUS.
- 19 6. [5.] The structure may not be reoccupied until the Building Official has issued
20 an occupancy permit.

21 **116.4.4 Emergency condition.** A vacant structure that is not kept boarded and free
22 from accumulations of debris and high vegetation or that, in the opinion of the Building
23 Official, is so dangerously unsound or so deteriorated that rehabilitation is not feasible,
24 constitutes an emergency condition that imminently threatens the public health and safety
25 and requires immediate resolution.

26 **116.4.5 Rodenticide procedure.** See § 3314 of this Code.

27 **116.4.6 Notice to Public Works.** Whenever the Building Official determines a structure
28 to be vacant, the Building Official must promptly notify the Director of Public Works of
29 that determination. On receipt of the notice, the Director of Public Works must proceed
30 to cut off water service, as provided in City Code Article 24, § 2-3 {"Cut-off for
31 nonpayment"}.

32 **116.5 Rehabilitation, demolition, and stabilization.** Except as otherwise authorized or
33 required under this section, a structure found to be unsafe or unfit for human habitation or
34 other authorized use must be rehabilitated and an occupancy permit obtained.

35 **116.5.1 Permitted demolition.** On timely appeal of an order to rehabilitate, the
36 Building Official may permit an owner to demolish an unsafe structure instead of
37 rehabilitating it if, in the Building Official's opinion, demolition is not detrimental to the
38 immediate neighborhood.

1 **116.5.2 Required demolition.** The Building Official may order the immediate
2 demolition of any unsafe structure that, in the Building Official’s opinion, is either so
3 dangerously unsound or so deteriorated that rehabilitation is not feasible.

4 **116.5.2.1 Appeal.** The recipient of an order to demolish an unsafe structure may
5 request administrative review of the order under § 128 {“Administrative and Judicial
6 Review”} of this Code.

7 **116.5.2.2 Rescission of demolition order.** The Building Official may rescind or
8 modify a demolition order if the owner demonstrates the financial ability and
9 requisite expertise to rehabilitate the structure within a reasonable time, as
10 determined by the Building Official, and agrees to comply with a specified timetable.
11 Failure to comply with an agreed timetable reinstates the demolition order.

12 **116.5.3 Stabilization.** The Building Official may permit or order an interim
13 stabilization of an unsafe structure pending its rehabilitation.

14 **116.5.4 Reoccupancy of rehabilitated structure.** A structure declared unsafe or unfit
15 for occupancy may not be reoccupied until the Building Official has:

- 16 1. abated the violation notice or order, and
- 17 2. issued an occupancy permit.

18 **116.6 Vacant lot maintenance.** When a structure has been demolished under this § 116,
19 the premises must be made to conform to the provisions of this Code and of the regulations
20 adopted under this Code.

21 **116.7 Remedial action by Building Official.** The Building Official may take action under
22 this § 116.7 whenever the owner, agent, or person in control cannot be found or fails to
23 comply with a notice or order served under this Code:

- 24 1. to repair, rehabilitate, stabilize, or demolish an unsafe structure,
- 25 2. to clean, close, board, **FENCE**, or otherwise safeguard a vacant
26 structure or **LOT**, or
- 27 3. to remove high grass and weeds or litter, trash, and debris from
28 the premises of a vacant structure **OR LOT**.

29 **116.7.1 Actions authorized.** The Building Official may proceed to:

- 30 1. have a receiver appointed, or
- 31 2. complete all or any part of the required work through officers,
32 agents, employees, or contractors.

33 **116.7.2 Entry to property.** Before taking any remedial action, the Building Official
34 may enter the premises, without additional notice, to determine the extent of deterioration
35 and the feasibility of rehabilitation.

1 **116.7.3 When additional notice not required.** Boarding, cleaning, **FENCING**, and
2 otherwise safeguarding a vacant structure **OR LOT** that is subject to an expired violation
3 notice is an emergency action that requires no additional prior notice.

4 **116.7.4 Remedies nonexclusive.** Remedial action under this § 116 does not preclude
5 any other enforcement action authorized by this Code.

6 **116.8 {Reserved}**

7 **116.9 “Abandoned” property.** If a property is cited as “vacant” or “unfit for human
8 habitation” on a violation notice issued under this § 116, the property is considered to be
9 cited as “abandoned” or to be in need of substantial repair within the meaning of the State
10 Tax-Property Article, Title 14, Subtitle 8.

11 **116.10 Effect of designation.** On issuance of a violation notice that designates a structure
12 to be a vacant structure, the structure is deemed to be condemned.

13 **Section 117 Emergency and Corrective Measures**

14 **117.1 Power of Building Official in emergencies.** In an emergency where life, health,
15 safety, or property is in immediate danger, the Building Official may immediately take any
16 action necessary to protect the endangered life, health, safety, or property, without complying
17 with the notice provisions of this Code.

18 **117.2 Photographs of dangerous conditions.** In all emergencies, if it is practical and if
19 enough time is available to do so, the Building Official must cause the dangerous or unsafe
20 condition that created the emergency to be photographed before any demolition or other
21 work or operation is begun to eliminate the dangerous or unsafe condition.

22 **117.3 Closing streets.** When necessary for the public safety, the Building Official may
23 temporarily close adjacent structures and request the Director of Transportation to close
24 adjacent sidewalks, streets, and other public ways and prohibit them from being used. The
25 Building Official may temporarily close adjacent sidewalks, streets, and other public ways
26 only pursuant to an agreement with the Department of Transportation.

27 **117.4 Labor and material for emergency work.** In an emergency where life, health,
28 safety, or property is in immediate danger and it is necessary to perform any work or
29 operation to protect that life, health, safety, or property, the Building Official may employ
30 the persons and buy the materials needed to perform the work or operation as expeditiously
31 as possible.

32 **117.5 Liability for costs of emergency work.** Liability for expenses incurred in the course
33 of performing emergency work and the procedure for collecting resultant debts and liens are
34 as provided in § 118 {“Liability for Expenses...”} of this Code.

35 **Section 118 Liability for Expenses and Collection of Debts and Liens**

36 **118.1 Scope.** This § 118 applies to all cases where:

- 1 1. the Building Official enforces any provision of this Code, including but not limited
2 to:
 - 3 a. the elimination of any safety, health, or fire hazard,
 - 4 b. the elimination of any nuisance, blight, or insanitary condition,
 - 5 c. the removal of any abandoned or illegally constructed structure or other
6 object, or
 - 7 d. the taking of any corrective action in emergencies or otherwise, and
- 8 2. in connection with those efforts, the Building Official or any department, agency,
9 unit, or body corporate and politic of this State, including the Maryland Stadium
10 Authority:
 - 11 a. furnishes or causes to be furnished any labor, supervision, equipment, or
12 materials, or
 - 13 b. performs or causes to be performed any inspection, work, or operation to
14 eliminate the hazard or condition or to remove the structure or other object.

15 **118.2 Liability and lien for expenses.** In the cases described in § 118.1, the entire amount
16 of the Building Official's expenditures and of the expenditures incurred by any department,
17 agency, unit, or body corporate and politic of this State, including the Maryland Stadium
18 Authority, together with all incidental costs and all accrued penalties:

- 19 1. are a personal debt owed to the City jointly and severally by every person made liable
20 under this Code, and
- 21 2. are a lien in favor of the City on the land and improvements in respect to which the
22 expenditures were made.

23 **118.3 When debts and liens become effective.** All debts become due and owing to the
24 City immediately when the work is completed or the expenditure made. All liens become
25 effective immediately after the Building Official notifies the Bureau of Liens that appropriate
26 notice has been given or that a structure has been posted in accordance with this Code.

27 **118.4 Collection of debts and liens.** All debts due and liens incurred under this § 118:

- 28 1. are collectible from any assets of the persons made liable under this Code,
29 including a former owner, and
- 30 2. may be collected and enforced in the same way that the City collects and
31 enforces other debts due to it or liens in its favor.

32 **118.5 Priority over other liens and encumbrances.** All debts and liens incurred under this
33 § 118 have priority over all other liens and encumbrances, except taxes or other government
34 assessments.

35 **Section 119 {Reserved}**

1 Section 120 Condemnation Proceedings

2 **120.1 In general.** If any land, structure, or equipment becomes unsafe or dangerous to
3 public health or safety, the Building Official may condemn the land, structure, or equipment
4 as provided in this § 120 and issue a condemnation notice as provided in § 123 {"Notices"}
5 of this Code. The issuance of a violation notice is not a prerequisite for the condemnation of
6 real property.

7 **120.2 Posting notice.** If the Building Official condemns any land, structure, or equipment,
8 the Building Official must cause a notice to be conspicuously displayed on the condemned
9 land, structure, or equipment.

10 **120.2.1 Contents.** The notice must:

- 11 1. be at least 24 inches wide 8 inches high,
- 12 2. be signed by the Building Official, and
- 13 3. advise the public that:
 - 14 a. the particular land, structure, or equipment has been condemned as
 - 15 being unsafe or dangerous for occupancy or use, and
 - 16 b. the public is warned to keep away.

17 **120.2.2 Emergencies.** In case of an emergency where life or property may be in
18 immediate danger, the Building Official need not post the property and may proceed in
19 accordance with § 117 {"Emergency and Corrective Measures"} of this Code.

20 **120.3 Vacating condemned property.** A notice posted under § 120.2 is deemed to be
21 sufficient warning to all occupants of the condemned property to leave immediately. If any
22 occupant fails to vacate the property immediately after the notice is posted, the Building
23 Official may take whatever action is proper and expedient to remove that occupant.

24 **120.4 Receiver of condemned property.** After a property is condemned, the Building
25 Official may:

- 26 1. take any action authorized under § 120.7, or
- 27 2. in accordance with § 121 {"Vacant Building Receiver"} of this Code, apply to
28 court for the appointment of a receiver.

29 **120.5 Status of condemned property.** After property has been condemned and posted in
30 accordance with this § 120, that property remains condemned and may not be occupied or
31 used again until the Building Official declares the property safe for occupancy or use and has
32 removed the condemnation.

33 **120.6 Order to demolish.** If, in the Building Official's opinion, a structure is so
34 dangerously unsound or so deteriorated that rehabilitation is not feasible, the condemnation
35 notice may order the owner to demolish the structure immediately.

1 **120.7 Removal of unsafe conditions.** Anytime after property has been posted in
2 accordance with this § 120, the Building Official may demolish, move, alter, repair,
3 rehabilitate, rebuild, reconstruct, or take any other appropriate action to eliminate or make
4 safe and secure any dangerous or unsafe condition. Before doing so, however, the Building
5 Official must provide the notice required by § 105.9 {"Special requirements for demolition
6 or moving"} of this Code.

7 **120.8 Condemnation of electrical work.** If any electrical wiring or equipment that has
8 been the subject of a condemnation notice is not made safe within the time required by the
9 condemnation notice, the wiring or equipment must be put out of service by cutting off all
10 electric current to it and by sealing all switches that operate in connection with the wiring or
11 equipment.

12 **120.8.1 Emergency action.** In case of an emergency where life or property is in
13 immediate danger, the Building Official may order all electric current serving the wiring
14 or equipment to be cut off and all switches that control the wiring or equipment to be
15 sealed. The Building Official's orders must be complied with immediately, regardless of
16 any other provisions of this Code that might apply.

17 **120.8.2 Permission needed to reactivate.** Whenever electric current has been cut off or
18 switches have been sealed under this § 120.8, the electric current may not be cut in and
19 the seals may not be broken, except by an authorized agent of the Building Official, after
20 all requirements of the Building Official have been complied with and the Building
21 Official has issued a certificate of approval.

22 **120.9 Condemnation of mechanical work.** If any mechanical equipment that has been the
23 subject of a condemnation notice is not made safe within the time required by the
24 condemnation notice, the mechanical equipment must be put out of service and sealed.

25 **120.9.1 Emergency action.** In case of an emergency where life or property is in
26 immediate danger, the Building Official may order the mechanical equipment to be put
27 out of service and sealed. The orders of the Building Official must be complied with
28 immediately, regardless of any other provisions of this Code that might apply.

29 **120.9.2 Permission needed to reactivate.** Whenever mechanical equipment has been
30 put out of service and sealed under this § 120.9, the mechanical equipment may not be
31 put back in service and the seals may not be broken, except by an authorized agent of the
32 Building Official, after all requirements of the Building Official have been complied with
33 and the Building Official has issued a certificate of approval.

34 Section 121 Vacant Building Receiver

35 **121.1 Scope.** This § 121 applies to a vacant structure, as defined in [§ 116.4 {"Unsafe
36 vacant structures"}] § 116.4.1.2 {"DEFINITIONS: VACANT STRUCTURE"} for which a notice or
37 order to rehabilitate or to demolish is outstanding.

38 **121.2 In general.** The Building Official may petition the court for appointment of a
39 receiver to rehabilitate a vacant property, to demolish it, or to sell it to a qualified buyer.
40 Except as otherwise provided in this § 121, the receiver may be any person.

41 **121.3 Contents of petition.** The petition for appointment of a receiver must include:

- 1 1. a copy of the original violation notice or order, and
- 2 2. a verified pleading that:
 - 3 a. avers that the required rehabilitation or demolition has not been completed,
 - 4 and
 - 5 b. identifies and states the qualifications of the proposed receiver, if other than
 - 6 the Building Official.

7 **121.4 Named respondents.** The petition for appointment of receiver must name as
8 respondents:

- 9 1. the owner of the property,
- 10 2. any lien holder of record, and
- 11 3. the plaintiff in any proceeding that was timely filed under State Tax-Property Article
12 § 14-833 {"Foreclosing right of redemption"} and for which the time for securing a
13 decree of foreclosure has not yet expired.

14 **121.4.1 Effect of failure to name plaintiff.** Failure to name a person described in
15 § 121.4(3) does not prevent the action from going forward, but does prevent the
16 receiver's lien for expenses incurred in rehabilitating, demolishing, or selling the vacant
17 building from having priority over that person's lien interest.

18 **121.5 Filing with Bureau of Liens.** A notice of the proceeding, together with a copy of the
19 violation notice or order, must be filed with the Bureau of Liens. The Bureau must include a
20 record of these in its lien reports, and the property cannot be transferred without the prior
21 approval of the [court] BUILDING OFFICIAL.

22 **121.6 Notice to judgment creditors and lien holders.** After filing the petition and before a
23 receiver is appointed, the Building Official must give notice of the pendency and nature of
24 the proceedings by regular and certified mail to the last-known addresses of all judgment
25 creditors and lien holders with a recorded interest in the property.

26 **Exceptions:**

- 27 1. This notice is not required for respondents named under § 121.4 {"Named
28 respondents"} of this Code.
- 29 2. The Building Official is not required to send notices to any creditor or lien holder
30 whose interest in the property is unrecorded.

31 **121.6.1 Intervention.** Within 30 days of the date on which the notice was mailed, a
32 judgment creditor or lien holder with a recorded interest in the property may apply to
33 intervene in the proceeding and to be appointed receiver. A creditor or lien holder whose
34 interest is not recorded does not have standing to intervene in the proceeding and is not
35 eligible to be appointed receiver.

1 **121.6.2 Effect of failure to give notice.** Failure to give any required notice to any
2 interested person under this § 121 does not prevent the action from going forward, but
3 does prevent the receiver's lien for expenses incurred in rehabilitating, demolishing, or
4 selling the vacant building from having priority over that person's lien interest.

5 **121.7 Appointment of owner, etc., instead of receiver.** Instead of appointing a receiver to
6 rehabilitate or sell a vacant building, the court may permit an owner, mortgagee, or other
7 person with an interest in the property to rehabilitate or demolish it, if that person:

- 8 1. demonstrates ability to complete the rehabilitation or demolition within a reasonable
9 time,
- 10 2. agrees to comply with a specified schedule for rehabilitation or demolition, and
- 11 3. posts bond, in an amount determined by the court, as security for performance of the
12 required work in compliance with the specified schedule.

13 **121.7.1 Application to dismiss owner.** If it appears to the petitioner that the person
14 appointed is not proceeding with due diligence or in compliance with the court-ordered
15 schedule, the petitioner may apply to the court for immediate revocation of that person's
16 appointment and for appointment of a receiver. The bond posted under this section must
17 then be applied to the subsequently appointed receiver's expenses in rehabilitating,
18 demolishing, or selling the vacant building.

19 **121.8 Appointment of receiver.** If no qualified person with an ownership interest requests
20 appointment to rehabilitate or demolish the property, or if an appointee is dismissed, the
21 court must then appoint a receiver of the property for the purpose of rehabilitating and
22 managing the property, demolishing the property, or selling it to a qualified buyer.

23 **121.8.1 Parties divested of authority.** On appointment of a receiver to rehabilitate,
24 demolish, or sell the property, all parties are divested of any authority to act in
25 furtherance of those goals.

26 **121.8.2 Penalties.** Any party who takes any step to rehabilitate, demolish, or sell the
27 property is subject to the penalties for contempt.

28 **121.8.3 Receiver not responsible to maintain or protect the property.** A receiver
29 appointed to rehabilitate, demolish, or sell a vacant building has no duty to, and is not
30 personally liable for failing to, maintain the property or protect the property from
31 casualty or loss.

32 **121.9 Powers of receiver appointed to rehabilitate or demolish.** A receiver appointed to
33 rehabilitate or demolish a vacant building, in addition to all necessary and customary powers,
34 has the right of possession with authority to:

- 35 1. contract for necessary labor and supplies for rehabilitation or demolition,
- 36 2. borrow money for rehabilitation or demolition from an approved lending institution
37 or through a government agency or program, using the receiver's lien against the
38 property as security,

Council Bill 20-0505

- 1 3. manage the property after rehabilitation, with all the powers of a landlord, for a
2 period of up to 2 years and apply the rent received to current operating expenses and
3 to repayment of outstanding rehabilitation expenses, and
- 4 4. foreclose on the receiver's lien or accept a deed in lieu of foreclosure.

5 **121.10 Powers of receiver appointed to sell.** A receiver appointed to sell a vacant
6 building, in addition to all necessary and customary powers, may sell the property [to the
7 high bidder] at public auction OR PRIVATE SALE, following the provisions that apply to a
8 receiver appointed under Rule 3-722 {"Receivers"} and Title 14, Chapter 300 {"Judicial
9 Sales"} of the Maryland Rules. [If the property fails to sell at public auction, the receiver
10 may sell the property in a private sale.]

11 **121.10.1 Notice of auction.** In the notice of public auction, it is sufficient to describe
12 the property by a street address and by reference to the liber and folio number of the title
13 deed recorded in the land records of Baltimore City.

14 **121.10.2 Buyer qualifications.** Before any sale, the applicants to bid in a public sale or
15 the proposed buyer in a private sale must demonstrate the ability and experience needed
16 to rehabilitate the property within a reasonable time.

17 **121.10.2.1 Application fee.** The receiver may charge a reasonable fee to applicants
18 in connection with the application to bid at a public sale or in connection with the
19 solicitation of offers for a private sale.

20 **121.10.3 Application of sale proceeds.** After deducting the expenses of the sale, the
21 amount of outstanding taxes and other government assessments, and the amount of the
22 receiver's lien, the receiver must apply any remaining proceeds of the sale, first to the
23 petitioner's costs and expenses, including reasonable attorney's fees, and then to the liens
24 against the property in order of priority.

25 **121.10.4 TAX SALE REDEMPTION.** A RECEIVER MAY REDEEM A TAX SALE CERTIFICATE
26 AT ANY TIME AFTER THE RECEIVER'S APPOINTMENT BY COURT.

27 **121.11 Tenure of receiver appointed to rehabilitate.** The tenure of a receiver appointed
28 to rehabilitate a vacant building may extend no longer than 2 years after rehabilitation.
29 Anytime after rehabilitation, any party to the receivership may file a motion to dismiss the
30 receiver on payment of the receiver's outstanding costs, fees, and expenses.

31 **121.12 Final accounting.** At the end of the receiver's tenure, the receiver must file a final
32 accounting with the court.

33 **121.13 Receiver's lien for costs, etc.** Any costs or fees incurred by the receiver are a lien
34 against the property in accordance with § 118 {"Liability for Expenses ..."} of this Code.
35 The receiver's lien has priority over all other liens and encumbrances, except taxes or other
36 government assessments. The receiver must allow the petitioner's costs and expenses,
37 including reasonable attorney's fees, to be paid to the extent that the proceeds of the sale
38 permit.

1 **121.13.1 Foreclosure of lien.** A receiver may foreclose on the lien by a sale of the
2 property at public auction, following 1 public notice and notice to interested parties in the
3 manner of a mortgage foreclosure. After deducting the expenses of the sale, the receiver
4 must apply the proceeds of the sale to the liens against the property, in order of priority.
5 In lieu of foreclosure, and only if the receiver has rehabilitated the property, an owner
6 may pay the receiver's costs, fees, including attorney's fees, and expenses or may
7 transfer all ownership in the property to either the receiver or an agreed-on third party for
8 an amount agreed to by all parties to the receivership as being the property's fair market
9 value.

10 **121.14 Transfer on sale.** Following court ratification of a sale, the receiver must sign a
11 deed conveying title to the buyer, free and clear of all liens, judgments, and other
12 encumbrances. On court ratification of the sale, any secured interest of a lien holder or
13 judgment creditor automatically attaches to the proceeds from the sale, to the extent those
14 proceeds are available under § 121.10.3 {"Application of sale proceeds"}.

15 **121.15 Dismissal.** On sale of the property, the receiver must:

- 16 1. file with the court a final accounting, and
- 17 2. at the same time, file a motion with the court to dismiss the action.

18 **Section 122 {Reserved}**

19 **Section 123 Notices**

20 **123.1 In general.** All notices under this Code must be issued in accordance with this
21 § 123. However, nothing in this Code may be construed to excuse or relieve any person
22 from complying with all provisions of this Code at all times, regardless of whether any
23 notice or order has been issued by the Building Official in any particular case.

24 **123.2 Classification.** Notices issued under this Code are classified as either:

- 25 1. condemnation notices, or
- 26 2. violation notices.

28 **123.3 Contents – Condemnation notices.** Except as specified in § 123.3.1, every
29 condemnation notice must set forth:

- 30 1. the location of the condemned structure or equipment,
- 31 2. the reason the structure or equipment is condemned,
- 32 3. a reference to applicable provisions of this Code,
- 33 4. a warning against entering or using the condemned structure or equipment,
- 34 5. the right of the person to whom the notice is directed to request a hearing
35 within 10 days of the date on which the notice was served, and

- 1 6. unless to be contained in a follow-up or subsequent notice:
 - 2 a. a statement of the requirements that must be complied with to rectify
 - 3 the unsafe condition,
 - 4 b. the time within which the unsafe condition must be rectified, and
 - 5 c. the Building Official’s authority under § 123.8 {“Failure to comply
 - 6 with notice or citation”} to take action at the owner’s expense.

7 **123.3.1 Follow-up notices.** A follow-up or other subsequent notice involving the same
8 condemnation need not repeat the information contained in a prior notice as long as the
9 subsequent notice identifies the prior notice.

10 **123.4 Violation notices.** Except as specified in § 123.4.1, every violation notice must set
11 forth:

- 12 1. the location and character of the violation,
- 13 2. a reference to applicable provisions of this Code,
- 14 3. the right of the person to whom the notice is directed to request a hearing within
- 15 10 days of the date on which the notice was served, and
- 16 4. unless to be contained in a follow-up or subsequent notice:
 - 17 a. a statement of the requirements that must be complied with to rectify
 - 18 the violation,
 - 19 b. the time within which the violation must be rectified, and
 - 20 c. the Building Official’s authority under § 123.8 {“Failure to comply
 - 21 with notice or citation”} to take action at the owner’s expense.

22 **123.4.1 Follow-up notices.** A follow-up or other subsequent notice involving the same
23 violation need not repeat the information contained in a prior notice as long as the
24 subsequent notice identifies the prior notice.

25 **123.5 When notices to be issued.** Except as otherwise specified in this Code, notices must
26 be issued in all cases where legal proceedings might be necessary to enforce this Code.

27 **123.5.1 Condemnation notices.** For any land, structure, or equipment being
28 condemned, the condemnation notice must be issued to the owner of the land, structure,
29 or equipment.

30 **123.5.2 Violation notices.** For violations, the violation notice must be issued to the
31 person who committed or otherwise is responsible for the violation.

32 **123.6 Service of notice – General.** Except as otherwise specified in § 123.7 {“Service of
33 notice – Posting”}, all notices issued by the Building Official must be served on the person
34 that the notice is intended for or on any authorized agent or representative of that person.

1 **123.6.1 More than 1 person responsible.** If more than 1 person is responsible for the
2 violation or responsible for complying with this Code, as in a case of property owned by
3 more than 1 person, notice may be served on any 1 of those persons or on any authorized
4 agent or representative of any of them.

5 **123.6.2 Method of service.** A notice is properly served if:

- 6 1. served personally on the owner, agent, person in control, former owner,
7 or other person responsible for the property,
- 8 2. hand delivered to that person’s home, business, or tax record address, or
- 9 3. sent by certified or registered mail to that person’s home, business, or
10 tax record address.

11 **123.6.3 Authorized server.** Service under § 123.6.2(1) or (2) must be made by:

- 12 1. a member of the Baltimore City Police Department, or
- 13 2. an official or employee of the City or the State of Maryland.

14 **123.7 Service of notice – Posting.** Adequate and sufficient notice may be made by posting
15 a copy of the notice on the property in question if:

- 16 1. the identity or whereabouts of the owner, agent, person in control, former owner,
17 or other person responsible for the property is unknown, or
- 18 2. notice mailed under § 123.6 is returned unclaimed or refused or is designated
19 undeliverable by the post office for any other reason, and neither of the following
20 sources can provide a more accurate address:
 - 21 a. the tax records of the Bureau of Treasury Management, Collections Division,
22 and
 - 23 b. the property registration files of the Department of Housing and Community
24 Development.

25 **123.8 Failure to comply with notice or citation.** If any person fails to comply with a
26 violation notice, condemnation notice, or citation, the Building Official:

- 27 1. may enforce the violation notice or condemnation notice by issuance of an
28 environmental citation as authorized by City Code Article 1, Subtitle 40
29 {“Environmental Control Board”},
- 30 2. may take whatever action is necessary and proper, including the institution of legal
31 proceedings, to compel compliance with the notice or citation or to enforce the
32 penalty provisions of this Code, and
- 33 3. subject to the notice requirements of § 123.8.1, may proceed to repair, rebuild,
34 demolish, or take any other action necessary to eliminate, in whole or in part, or make

1 safe any nuisance, blight, health hazard, or dangerous, insanitary, or unsafe condition
2 that is the subject of the violation notice, condemnation notice, or citation.

3 **123.8.1 Notice of intent to repair, etc.** Except as provided in § 123.8.2, before the
4 Building Official proceeds to repair, rebuild, demolish, or take any other action to
5 eliminate or make safe any nuisance, blight, health hazard, or dangerous, insanitary, or
6 unsafe condition, a notice must be posted on the front of the structure stating that the
7 violation has not been rectified and that the Building Official intends to undertake the
8 necessary work and charge the expenses of that work to 1 or more of the owner, agent,
9 person in control, or former owner of the premises, as the case may be. This notice must
10 also be mailed or delivered to the home, business, or tax record address of the owner,
11 agent, person in control, former owner, or other person responsible for the property, as
12 the case may be, or their respective agents.

13 **123.8.2 Exception.** The notice required by §123.8.1 need not be given:

- 14 1. in the case of an emergency,
- 15 2. as provided in § 116.7 {"Remedial action by Building Official"} of this Code
16 for unsafe structures, or
- 17 3. if the initial or any other prior notice or order issued by the Building Official
18 informed the recipient of the Building Official's authority to take corrective
19 action and of the recipient's right to request administrative review.

20 **123.8.3 Actions not an abatement, etc.** Actions taken by the Building Official under
21 this § 123.8 do not constitute an abatement or cancellation of the underlying notice or
22 citation.

23 **123.9 Extension of time limit on notices.** The Building Official may extend the time
24 within which to comply with a condemnation notice or violation notice if, in the Building
25 Official's judgment, more time is needed to comply.

26 **123.10 Removal or defacement of posted notices.** No person may remove, deface,
27 damage, or change any notice, poster, or sign placed under this Code on any land, structure,
28 or other object, until the Building Official authorizes its removal.

29 **123.11 Notices for property owned by the City.** If the land, structure, or other object in
30 violation of this Code is owned by the City, the Building Official must notify:

- 31 1. the head of the bureau, department, commission, or other agency having jurisdiction
32 over that land, structure, or other object, and
- 33 2. the Councilmember in whose district that land, structure, or other object lies.

34 Section 124 Violation Reports

35 **124.1 Building Official to issue.** On application to the Department or to the Bureau of
36 Liens, the Building Official must issue a violation report for a particular property. The report
37 must:

- 1 1. state whether any violation or condemnation notices are open for that property, and
- 2 2. if any are open, include a true copy of each notice.

4 **Section 128 Administrative and Judicial Review**

6 **128.1 Right of review.** If any person is aggrieved by any notice, order, permit, penalty
7 assessment, or other act of the Building Official, the person may apply in writing to the
8 Building Official for a review.

9 **128.2 Application – General.** The application for review must:

- 10 1. be made within 10 days of the action for which review is sought,
- 11 2. set forth in full the reasons for the review, and
- 12 3. either be:
 - 13 a. mailed to the Building Official by certified or registered mail, return receipt
14 requested, or
 - 15 b. delivered to the Building Official’s office and stamped received by the office.

16 **128.3 Application – Emergencies.** In the case of an emergency that presents substantial
17 and imminent danger to life, property, or the general public welfare, the time for requesting
18 review may be shortened or eliminated, as specified in the applicable notice, order, permit,
19 penalty assessment, or other act.

20 **128.4 When review to be held.** The requested review must be held within a reasonable
21 time. If a notice, order, permit, penalty assessment, or other act requires action within 10
22 days or less and an application for review is made before the notice, order permit, penalty
23 assessment, or time for other act expires, the Building Official must promptly schedule a
24 hearing, to be conducted in accordance with § 128.5 {“Hearings”}.

25 **128.5 Hearings.** All hearings must be conducted in accordance with this § 128.5.

26 **128.5.1 Hearings to be public.** All hearings must be open to the public.

27 **128.5.2 Notification of complainants.** Before a hearing, the Building Official must
28 notify all persons who the Building Official knows are interested in the hearing of its
29 scheduled date, time, place, and purpose.

30 **128.5.3 Time and place for hearings.** Hearings must be held:

- 31 1. at the time the Building Official designates, and
- 32 2. in the office of the Building Official or at any other place the Building Official
33 designates.

1 **128.5.3.1 Postponements.** The Building Official may postpone a hearing only for
2 good cause shown.

3 **128.5.4 Hearing officer or panel.** A hearing officer or 3-person panel designated by the

5 permit, penalty assessment, or other act being appealed may not serve as the hearing
6 officer or as a member of the panel.

7 **128.5.5 Rules for conducting hearings.**

8 **128.5.5.1 Building Official.** The Building Official may adopt general rules and
9 regulations for the proper conduct of hearings.

10 **128.5.5.2 Hearing officer or panel.** The hearing officer or panel may set
11 requirements to ensure a fair and expeditious hearing. The requirements set:

- 12 1. may include the holding of a pre-hearing conference, the briefing of certain
13 issues, deadlines for the filing of motions, and other scheduling matters, but
- 14 2. may not be inconsistent with the general rules and regulations adopted by the
15 Building Official.

16 **128.5.6 Decision.** Within 30 days after a hearing is completed, the hearing officer or
17 panel must render a decision.

18 **128.5.6.1 Form and contents.** The decision must:

- 19 1. be in writing, and
- 20 2. contain separate statements of:
 - 21 a. the findings of fact,
 - 22 b. the conclusions of law, applying the relevant provisions of law to
23 the findings of fact, and
 - 24 c. the decision or order.

25 **128.5.6.2 Distribution.** A copy of the decision must be mailed or delivered to
26 each party or that party's attorney of record.

27 **128.5.6.3 Final administrative decision.** A decision issued under this § 128 is a
28 final administrative decision.

29 **128.5.7 Records.** The Department must keep a complete record of all papers filed in
30 connection with any hearing, together with a copy of the written decision.

31 **128.5.8 Transcript.** The costs of preparing a hearing transcript must be paid by the
32 party requesting the transcript.

201.5.1 Computation of time after an act, event, or default. In computing a period of time that begins to run after an act, event, or default:

1. the day of the act, event, or default after which the designated period of time begins to run is not included,
2. if the period of time allowed is more than 7 days, intermediate Saturdays, Sundays, and legal holidays are counted,
3. if the period of time allowed is 7 days or less, intermediate Saturdays, Sundays, and legal holidays are not counted, and
4. the last day of the period so computed is included unless it is a Saturday, Sunday, or legal holiday, in which event the period runs until the end of the next day that is not a Saturday, Sunday, or legal holiday.

201.5.2 Computation of time before a day, act, or event. In determining the latest day for performing an act that is required by this Code to be performed a prescribed number of days before a certain day, act, or event:

1. all days preceding that day, act, or event, including intervening Saturdays, Sundays, and legal holidays, are counted in the number of days so prescribed, and
2. the latest day is included in the determination unless it is a Saturday, Sunday, or legal holiday, in which event the latest day is the first preceding day that is not a Saturday, Sunday, or legal holiday.

16 otherwise, the Department of Building Safety, as further defined in § 103.1
17 {“Enforcement agency”}.

18 **202.2.18 Department of Building Safety.** “Department of Building Safety” has the
19 meaning stated in § 103.1 {“Enforcement agency”}.

20 **202.2.19 Design flood.** “Design flood” has the meaning stated in City Code Article 7
21 {“Natural Resources”}, § 1-2 {“Definitions – “Accessory structure” to “Floodplain

[308.6 Institutional Group I-4, day care facilities. This group includes buildings and structures occupied by persons of any age who receive custodial care on less than a 24-hour basis by individuals other than parents, guardians, or relatives by blood, marriage, or adoption, and in a place other than home of the person cared for. A facility like this with 8 or fewer persons is classified as a Group R-3 or must comply with the International Residential Code in accordance with § 101.2 {"Scope"} of this Code. Places of worship during religious functions are not included.]

[308.6.1 Adult day care facility. A facility that provides accommodation on less than a 24-hour basis for more than 8 unrelated adults and provides supervision and personal care services is classified as Group I-4.]

[Exception: A facility where occupants are capable of responding to an emergency situation without physical assistance from the staff is classified as Group R-3.]

[308.6.2 Child day care facility. A facility that provides supervision and personal care on less than a 24-hour basis for more than 8 children who are 2½ years of age or less is classified as Group I-4.]

Chapter 27 Electrical

Section 2701 General

2701.1 Scope. This Chapter governs the electrical components, equipment, and systems used in structures covered by this Code. Electrical components, equipment, and systems must be designed and constructed in accordance with the National Electrical Code (“NEC”).

2701.2 Electric equipment standards. Only electrical materials, appliances, or equipment approved by the Building Official may be installed. The Building Official must approve all materials, appliances, and equipment that are listed and labeled by the Underwriters' Laboratories, Incorporated, or by any other independent testing organization that the Building Official approves, except for any materials, appliances, or equipment that other provisions of this Code preclude from being installed. In investigating new materials, appliances, and equipment, the Building Official must consider the factors listed in NEC § 110.3 {“Examination, Identification, Installation, and Use of Equipment”}.

Section 2702 Emergency and Standby Power Systems *{As in IBC}*

Section 2703 Permit and Certificate of Inspection

2703.1 Applications. The application for an electrical permit must bear the name and address of the insured, licensed electrician responsible for all work to be done under the permit.

2703.2 Permits for maintenance work. Any person who employs 1 or more licensed maintenance electricians or licensed master electricians for maintenance of approved installations in or on a structure or premises owned or operated by the person must:

1. obtain individual permits for the maintenance work, or
2. apply for and obtain a semiannual permit for all maintenance work to be performed by these licensed electricians.

2703.3 Semiannual records. The person to whom a semiannual permit is issued must keep a detailed record of all maintenance work done under the permit. These records must be:

1. available at all times for inspection by the Building Official, or
2. if the Building Official so specifies, filed with the Building Official.

1 **2703.4 Certificates.** An electrical certificate is required before electric service may be

- 14 2. be put out of service and either sealed or removed.

15 **Section 2706 Permits**

16 **2706.1 Permit required.** Unless specifically excepted by this Building, Fire, and Related

18 a permit for that work.

19 **2706.2 To whom issued.** A permit may be issued only:

- 20 1. to a master electrician licensed to do business in the City,
- 21 2. to a master restricted electrician licensed to do business in the City,
- 22 3. to a restricted electrician licensed to do business in the City, or
- 23 4. to a maintenance electrician licensed to do business in the City.

24 **Section 2707 Licensing Requirements**

2. the International Fuel Gas Code ([2015] 2018 Edition), as modified by Part IV of this Code.

2801.2 Scope – Chimneys, fireplaces, barbecues. Masonry chimneys, fireplaces, and barbecues must comply with:

1. Chapter 21 {“Masonry”} of this Code, and
2. the International Mechanical Code ([2015] 2018 Edition), as modified by Part V of this Code.

Section 2802 Permits

2802.1 Permit required. Unless specifically excepted by this Building, Fire, and Related Codes Article, no heating, ventilation, air-conditioning, or refrigeration (“HVACR”) work may be undertaken before the Building Official has issued a permit for that work.

2802.2 Applications. The application for an HVACR work permit must bear the name and address of the insured, licensed HVACR contractor responsible for all work to be done under the permit.

2802.3 To whom issued. A permit may be issued only:

1. to a master HVACR contractor licensed to do business in the City,
2. to a master restricted HVACR contractor licensed to do business in the City,
3. to a limited HVACR contractor licensed to do business in the City,
4. to a journeyman HVACR contractor licensed to do business in the City, or
5. to a journeyman restricted HVACR contractor licensed to do business in the City.

2 **Section 2903 Permits**

3 **2903.1 Permit required.** Unless specifically excepted by these plumbing regulations, no
4 plumbing work may be undertaken before the Building Official has issued a permit for that
5 work.

6 **2903.2 Applications.** The application for a plumbing work permit must bear the name and
7 address of the insured, licensed master plumber responsible for all work to be done under the
8 permit.

9 **2903.3 To whom issued.** A permit may be issued only:

- 10 1. to a master plumber licensed to do business in the City,
- 11 2. to a master gas fitter licensed to do business in the City, or
- 12 3. for on-site utility facilities, to an on-site utility contractor licensed to do business in
13 the City.

14 **2903.4 Insurance.** The Building Official may not issue a permit to any master plumber
15 unless the master plumber has provided the Building Official with certification of insurance,
16 as required by State law.

17 **2903.5 Emergency work.** When emergency work needs to be done to rectify a possible
18 health hazard or other hazardous condition, the work may be undertaken, even before a
19 permit is issued, by:

- 20 1. a master plumber, or
- 21 2. within the scope of his or her license:
 - 22 a. an on-site utility contractor, or
 - 23 b. a gas fitter.

24 **2903.5.1 Notice and subsequent permit.** A master plumber, contractor, or gas fitter
25 who performs emergency work under this section must:

- 26 1. promptly notify the proper City authorities of the emergency, and
- 27 2. within a reasonable time, obtain a permit for the work.

28 **Section 2904 {Reserved}**

29 **Section 2905 Licensing Requirements**

30 **2905.1 Licenses and supervision required.** Except as otherwise provided in this section,
31 no person may provide plumbing services or otherwise engage in any plumbing work unless:

- 1 1. the person is licensed to do so in accordance with State law, and
2 2. the services and work are done by or under the direct supervision of
3 an insured, licensed master plumber.

4 **2905.1.1 On-site utilities work.** On-site utility work, as defined in City Code Article
5 13, § 18-1, may be done by or under the direct supervision of an on-site utility contractor
6 licensed by the City.

7 **2905.1.2 Gas-fitting work.** A licensed gas fitter may perform any gas-fitting work that
8 falls within the scope of his or her license.

9 **2905.2 Limits on plumber's, etc., liability.** The liability of the surety on any bond given
10 under this Chapter and the liability of any master plumber or on-site utility contractor for
11 materials furnished or work done under this Code does not extend to defects in materials or
12 workmanship discovered more than 1 year after completion of the work.

13 **2905.2.1 Plumber's, etc., responsibility for certain defects.** The surety and the master
14 plumber or on-site utility contractor are responsible to the City to correct all defects that
15 are discovered during the 1-year period after completion of the work and about which
16 they were promptly notified in writing.

17 **2905.2.2 Owner remains responsible.** Notwithstanding the limited liabilities of the
18 surety and the master plumber or on-site utility contractor, the owner of the property is
19 responsible at all times to the City to correct any defects in the plumbing installations in
20 or on his or her property.

21 **2905.2.3 Use of license by others prohibited.** A master plumber, on-site utility
22 contractor, or gas fitter may not allow his or her name to be used by any other person for
23 obtaining permits or for doing business or work under his or her license.

Chapter 30
Elevators and Conveying Systems

3001.1 Scope. {As in IBC}

3001.2 EMERGENCY ELEVATOR COMMUNICATION SYSTEMS FOR THE DEAF, HARD OF HEARING, AND SPEECH IMPAIRED. AN EMERGENCY TWO-WAY COMMUNICATION SYSTEM SHALL BE PROVIDED THAT:

1. IS A VISUAL, TEXT-BASED, AND VIDEO-BASED 24/7 LIVE INTERACTIVE SYSTEM,
2. IS FULLY ACCESSIBLE BY THE DEAF, HARD OF HEARING, AND SPEECH IMPAIRED, AND INCLUDES VOICE-ONLY OPTIONS FOR HEARING INDIVIDUALS,
3. HAS THE ABILITY TO COMMUNICATE WITH EMERGENCY PERSONNEL UTILIZING EXISTING VIDEO CONFERENCING TECHNOLOGY, CHAT/TEXT SOFTWARE OR OTHER APPROVED TECHNOLOGY, AND
4. COMPLIES WITH ALL APPLICABLE REQUIREMENTS OF THE MARYLAND ACCESSIBILITY CODE (COMAR 09.12.53).

3001.3 [3001.2] Referenced standards. Except as otherwise provided for in this Code, the design, construction, installation, alteration, repair, and maintenance of elevators, conveying systems, and their components conform to ASME A17.1/CSA B44, ASME A17.7/CSA B44.7, ASME A90.1, ASME B20.1, ANSI MH29.1, ALI ALCTV, and, for construction in flood hazard areas, ASCE 24.

3 SECTION 3112 [472] GREENHOUSES

4 [3112.1 General. The provisions of this section shall apply to greenhouses that are designed
5 and used for the cultivation, maintenance, or protection of plants.]

6 3112.1 [427.1] General. Structures with glazed surfaces that are used for [only] horticulture
7 are classified as greenhouses. These structures must be independent and separated from
8 other buildings on the same lot. All greenhouses must conform to the requirements of this
9 Code for exits and for materials.

10 3112.1.1 [427.2] Commercial greenhouses. Commercial greenhouses are classified as
11 Group S-2, Low Hazard Storage Buildings, and must comply with § 503 {"General
12 Building Height and Area Limitations"} and [with] Tables 601 {"Fire-Resistant Rating
13 Requirements for Building Elements"} and 602 {"Fire-Resistant Rating Requirements
14 for Exterior Walls"} OF THIS CODE.

15 3112.1.2 [427.3] Residential greenhouses. Greenhouses that are located on a lot zoned
16 for residential use are classified as Group U, Utility and Miscellaneous Structures.

17 3112.1.2.1 [427.3.1] Height. Residential greenhouses may not exceed 20 feet (6.10
18 m) above grade.

19 3112.1.2.2. [427.3.2] Size. The floor area of a residential greenhouse must conform
20 to the requirements of the Baltimore City Zoning Code.

21 3112.1.2.3 [427.3.3] Location. Residential greenhouses must be located at least 36
22 inches (914 mm) from any property line or other structure.

23 3112.2 ACCESSIBILITY. GREENHOUSES MUST BE ACCESSIBLE IN ACCORDANCE WITH THE
24 MARYLAND ACCESSIBILITY CODE, COMAR 09.12.53.

25 3112.3 STRUCTURAL DESIGN. GREENHOUSES MUST COMPLY WITH THE STRUCTURAL DESIGN
26 REQUIREMENTS FOR GREENHOUSES IN CHAPTER 16 {"STRUCTURAL DESIGN"} OF THIS CODE.

27 3112.4 GLASS AND GLAZING. GLASS AND GLAZING USED IN GREENHOUSES MUST COMPLY
28 WITH § 2405 {"SLOPED GLAZING AND SKYLIGHTS"} OF THIS CODE.

29 3112.5 LIGHT-TRANSMITTING PLASTICS. LIGHT-TRANSMITTING PLASTICS ARE PERMITTED
30 IN LIEU OF PLAIN GLASS IN GREENHOUSES AND MUST COMPLY WITH § 2606 "LIGHT-
31 TRANSMITTING PLASTICS"} OF THIS CODE.

32 3112.6 MEMBRANE STRUCTURES. GREENHOUSES THAT ARE MEMBRANE STRUCTURES MUST
33 COMPLY WITH § 3102 {"MEMBRANE STRUCTURES"} OF THIS CODE.

34 3112.6.1 PLASTIC FILM. PLASTIC FILMS USED IN GREENHOUSES MUST COMPLY WITH
35 § 3102.3 {"TYPE OF CONSTRUCTION"} OF THIS CODE.

SECTION 3113 RELOCATABLE BUILDINGS {AS IN IBC}

SECTIONS 3114 TO 3115 {RESERVED}

Section 3116 [3112] Parking Lots, Driveways, and Other Paved Surfaces

3116.1 [3112.1] Section inapplicable to special-event parking. This [§ 3112] § 3116 does not apply to special-event parking lots operating under and in compliance with City Code Article 15, Subtitle 13 {“Parking facilities – Special-Event Parking Lots”} as long as the lot complies with all other requirements applicable to the lot’s principal occupancy, use, or structure.

3116.2 [3112.2] Driveway entrances. All driveway entrances located on a public right-of-way must be constructed in accordance with the rules, regulations, and permit requirements of the Department of Transportation.

3116.3 [3112.3] Surface paving. Parking lots, parking pads, driveways, and private roads must be paved with asphalt, brick, concrete, macadam, or stone block. Permeable paving systems may be utilized in accordance with the rules and regulations of the Department of Public Works. All paving must be able to support the design loads for the proposed vehicular traffic.

3116.4 [3112.4] Parking spaces. The size, layout, and arrangement of parking spaces must comply with:

1. the Baltimore City Zoning Code,
2. the Maryland State Accessibility Code, and
3. the rules and regulations of the City Planning Commission.

3116.5 [3112.5] Curbs or bumpers. Curbs or bumpers must be installed for all parking spaces. Each curb or bumper must be:

1. made of concrete, wood, or an approved metal wheel stop,
2. at least 6 inches (152 mm) high and 8 inches (203 mm) wide,
3. securely fixed in place, and
4. located:
 - a. at least 4 feet (1.22 m) from the parking lot perimeter, or
 - b. for parking spaces that are parallel to the perimeter of the parking lot, at least 2 feet (0.61 m) from the perimeter.

3116.6 [3112.6] Surface drainage. Storm drainage off paved surface areas, such as parking lots, playgrounds, and plazas, must be properly conveyed to paved alleys, paved streets, or other approved water courses.

1 **3116.6.1 [3112.6.1] Limitations.** No drainage may be discharged:

- 2 1. so as to run or flow over any sidewalk or footway, except at a driveway
- 3 with a depressed curb, or
- 4 2. across any adjoining property.

5 **3116.6.2 [3112.6.2] Methods.** Drainage must be piped to a storm drain, to the street or

6 alley, to a paved swale, or to another approved water course. The installation of piping,

7 connections to storm drains, etc., must be made in accordance with the plumbing

8 regulations of Chapter 29 {"Plumbing Systems"} of this Code.

9 Section **3117 [3113] Piers and Marinas**

10 **3117.1 [3113.1] General.** All piers, marinas, and related structures constructed or

11 demolished along the shoreline of the City must comply with the requirements of this

12 **[§ 3113] § 3117**, in addition to all other applicable provisions of this Code.

13 **3117.2 [3113.2] Plans and specifications.** All proposed work for piers and marinas

14 requires plans and specifications that illustrate, describe, and specify the proposed work in

15 sufficient detail and clarity.

16 **3117.3 [3113.3] Approvals.** Before a building permit may be issued for the construction or

17 demolition of a pier, marina, or related structure, the work must be approved by:

- 18 1. the U.S. Army Corps of Engineers (Baltimore District),
- 19 2. the State of Maryland,
- 20 3. the Division of Construction and Buildings Inspection,
- 21 4. the Baltimore City Fire Department,
- 22 5. the Baltimore City Department of Transportation, and
- 23 6. the Baltimore City Department of Public Works.

24 **3117.4 [3113.4] Design.** All shoreline and offshore free-standing piers, with or without

25 buildings, must be designed in accordance with:

- 26 1. the design manuals of the Federal Emergency Management Agency, and
- 27 2. the requirements of this Code.

28 **3117.5 [3113.5] Structural design for piers.** Minimum live load requirements are as

29 follows:

- 30 1. for static or fixed piers or marinas for light duty uses, 60 pounds per square foot, and
- 31 2. for heavy duty live loads and for structures constructed on piers, as required by
- 32 Chapter 16 {"Structural Design"} of this Code.

1 **3117.6 [3113.6] Structures on piers.** Every structure that is constructed on a pier, wharf,
2 dock, bulkhead, breakwater, piles, or other similar structure must comply with this **[§ 3113]**
3 **§ 3117** and all other applicable provisions of this Code and other law.

4 **Section 3118 [3114] Fences**

5 **3118.1 [3114.1] Location.** A fence may be built only on the property of the owner of the
6 fence. However, if the owners of adjoining property agree to build a fence on the property
7 line between them, they may do so if they both submit, with the application for the permit, a
8 written statement of their agreement.

9 **3118.2 [3114.2] Height.** Except as otherwise specified in this **[§ 3114.2] § 3118.2**, the
10 height of a fence may not exceed 42 inches (1067 mm), measured on the high side.

11 **3118.2.1 [3114.2.1] Enclosing dwellings.** Fences enclosing dwellings may be as high
12 as, but may not exceed, 6 feet (1.83 m) if located in side or rear yards.

13 **3118.2.2 [3114.2.2] Enclosing certain other buildings.** Fences enclosing buildings
14 used for public assembly, private assembly, institutions, offices, commercial storage, or
15 industrial occupancies may be as high as, but may not exceed, 8 feet (2.44 m).

16 **3118.2.3 [3114.2.3] Special purposes.** For special purposes like protection around
17 dangerous places, highly hazardous operations, **IN CONJUNCTION WITH ELECTRIC**
18 **SECURITY FENCES**, or **PROTECTION AROUND** athletic fields, and in similar cases where a
19 high fence is necessary for the safety of the public, fences may be higher than 8 feet
20 (2.44 m) to the extent specially authorized by the Building Official.

21 **3118.3 [3114.3] Construction.** Fences may be built of any material or construction that is
22 permitted in this Code for exposed structures. However, all fences must be designed and
23 constructed, in accordance with the applicable structural provisions of this Code, to resist
24 from any direction a horizontal force of 20 pounds per square foot, applied normal to and
25 over either the gross area of the fence or the net area of the fence plus 50% of the gross area,
26 whichever is less.

27 **3118.3.1 [3114.3.1] Wood fences.** The posts for wood fences must be:

- 28 1. locust, heart cedar, or any other wood that will resist decay underground,
- 29 2. any wood that has been treated in accordance with this Code, or
- 30 3. any good timber set in concrete.

31 **3118.3.2 [3114.3.2] Wire fences.** Wire fences must be constructed with wire mesh
32 substantially fabricated and constructed so as to resist a nominal horizontal load of 500
33 pounds without deflecting more than 6 inches (152 mm). The posts for wire fences must
34 be metal posts set in concrete, properly designed masonry posts, or wood posts of the
35 type required for wood fences.

1 **3118.3.3 [3114.3.3] Metal fences.** Metal fences must be of a substantial design and
2 construction approved by the Building Official. The posts for metal fences must be
3 concrete, masonry, or metal set in concrete or masonry.

4 **3118.3.4 [3114.3.4] Masonry fences.** Masonry fences must be of reinforced concrete or
5 other masonry and must be designed and constructed in accordance with the requirements
6 governing reinforced concrete or freestanding masonry walls. All masonry fences must
7 extend at least 2 feet (0.61 m) into the ground.

8 **3118.3.5 [3114.3.5] Combination fences.** Fences that consist of 2 or more kinds of
9 materials may be built as long as all applicable requirements of this Code for those
10 materials and construction are met. The total aggregate height of a combination fence
11 must be used in determining the height limitations for that fence.

12 **3118.4 [3114.4] Sharp points, projections, etc.** No fence may have any projecting sharp
13 points, jagged edges, or other projections that can injure persons or animals coming in
14 contact with the fence.

15 **3118.4.1 [3114.4.1] Fence tops.** No fence less than 3 feet 6 inches (1.07 m) high may
16 have any sharp pickets or vertical pointed objects at the top. Barbed wire or other
17 approved retarding material or construction may be placed on the top of any fence that is
18 more than 6 feet 9 inches (2.06 m) high, unless the barbed wire or other retarding
19 material will create a highly hazardous condition.

20 **3118.4.2 [3114.4.2] Razor wire.** Razor wire may not be used anywhere in any fence.

21 **3118.4.3 ELECTRIC SECURITY FENCES. AN ELECTRIC SECURITY FENCES IS PERMITTED:**

22 1. ONLY IN A C-3, C-4, OR INDUSTRIAL ZONING DISTRICT, AS IDENTIFIED IN CITY
23 CODE ARTICLE 32 {"ZONING"}; AND

24 2. ONLY AS LONG AS LONG AS THE FENCE:

25 A. DOES NOT ABUT ANY RESIDENTIALLY ZONED PARCEL; AND

26 B. IS INSTALLED IN CONJUNCTION WITH AN EXTERIOR, NON-ELECTRIC
27 BARRIER FENCE.

28 **3118.5 [3114.5] Maintenance.** Every fence must be maintained in good repair by its owner.
29 The Building Official may determine the sufficiency of any fence and the amount and
30 character of repairs required to make it safe.

31 **3118.6 [3114.6] Nonconforming fences.** Any existing fence that was compliant when
32 erected but does not comply with the requirements of this [§ 3114] § 3118 is permitted to
33 continue to exist and be repaired at any time, unless the fence has deteriorated more than
34 50%. All nonconforming fences that have deteriorated more than 50% or beyond repair must
35 be removed or reconstructed in accordance with the requirements of this Code.

1 **Section 3119 [3115] Radio and Television Antennas**

2 **3119.1 [3115.1] Aircraft warning lights.** Radio and television antennas located on a high
3 rise building or on a high terrain feature must comply with Federal Aviation Administration
4 requirements for aircraft warning lights.

5 **Section 3120 [3116] Lightning Protection**

6 **3120.1 [3116.1] General.** Lightning protection for buildings and structures must comply
7 with NFPA 780.

Chapter 32 Encroachments into the Public Right-of-Way

Section 3201 General

3201.1 Scope. *{As in IBC}*

3201.2 Measurement. *{As in IBC}*

3201.3 Other laws. This Chapter does not permit anything that is otherwise prohibited or regulated by any law governing the use of public property.

3201.3.1 Permission needed for encroachments. No person may use, encroach on, or connect to any street, highway, alley, or other public right-of-way for any purpose unless that person first obtains permission to do so by:

1. an ordinance of the Mayor and City Council,
2. a minor privilege permit issued by or under the authority of the Board of Estimates, or
3. an appropriate permit issued by the Department of Transportation.

3201.4 Drainage generally. Drainage may not be discharged from private property on to the public right-of-way except through piping to a storm drain, to a street or alley, or to some other water course approved by the Department of Public Works. Drainage may not be discharged to flow over the surface of any public sidewalk.

Section 3202 Encroachments

3202.1 Encroachment below grade. *{As in IBC}*

3202.2 Encroachment above grade and below 8' in height. *{As in IBC}*

3202.2.1 Steps. Steps may not project more than any 1 or another of the following distances:

1. 1/4 of the width of a public sidewalk on which the steps are located,
2. 4 feet (1219 mm) into a public sidewalk, or
3. any distance that leaves a clear public sidewalk of less than 4 feet (1219 mm).

3202.2.2 Architectural features. *{As in IBC}*

3202.2.3 Awnings. *{As in IBC}*

3202.3 Encroachment 8' or more above grade. *{As in IBC}*

3202.4 Temporary encroachments. *{As in IBC}*

1 **3202.5 Unauthorized encroachment.** In this § 3202.5, “unauthorized encroachment”
2 means any building, structure, projection, object, or other thing that has been placed,
3 constructed, or installed on or connected to a public right-of-way without appropriate
4 permission, as outlined in § 3201.3.1 {“Permission needed...”}.

5 **3202.5.1 Removal of unauthorized encroachments.** On notice from the Building
6 Official or the Director of Transportation, the owner of any unauthorized encroachment
7 must immediately:

- 8 1. remove the encroachment, or
- 9 2. obtain appropriate permission for its continuation.

Chapter 33 Safeguards During Construction

Section 3301 General

3301.1 to 3301.2 *{As in IBC}*

3301.3 Prohibited hours. No site work, demolition work, pile driving work, or construction work is permitted between 7:00 p.m. and 7:00 a.m., if that work or any part of a premises in or on which the work is to be done is within 300 feet (91.44 m) of any dwelling.

3301.3.1 Exception. This § 3301.3 does not apply to an emergency operation that has been specifically approved by the Building Official.

Section 3302 Construction Safeguards

3302.1 Remodeling and additions. Required exits, existing structural elements, fire protection devices, and sanitary safeguards must be maintained at all times during remodeling, alterations, repairs, or additions to any building or structure.

Exceptions:

1. When these required elements or devices are themselves being remodeled, altered, or repaired, adequate substitute provisions must be made.
2. These requirements do not apply if the existing building is not occupied.

3302.2 Waste and debris. All sites for new construction or for remodeling, alterations, repairs, or additions, and all abutting sidewalks, gutters, and alleys, must be properly maintained and kept free of accumulated trash, garbage, waste, or debris, including construction waste or debris, and of any object or condition that constitutes a nuisance. Removal of all trash, garbage, waste, and debris must be done in a manner that prevents injury or damage to persons, adjoining properties, and public rights-of-way.

3302.3 Fire safety during construction. *{As in IBC}*

Section 3303 Demolition

3303.1 to 3303.3 *{As in IBC}*

3303.4 Filling required. Except as otherwise specified in this § 3303.4, where a structure has been demolished or removed, the vacant area must be filled **WITH APPROVED MATERIAL** and maintained to the existing grade or otherwise in accordance with City law and seeded.

3303.4.1 Cellar floors. All basement and cellar floors must be removed or completely broken up before any filling materials are used.

3303.4.2 Exception. The Building Official may waive the filling requirements of this § 3303.4 for up to 3 months if:

- 1 1. the Building Official receives satisfactory evidence that construction of a new
2 building or structure will begin on the site within 3 months of the demolition or
3 removal, and
- 4 2. the site is protected with barriers that comply with § 3306.5 {"Barriers"} of
5 this Code.

6 **3303.5 to 3303.7** *{As in IBC}*

7 **3303.8 Notice to adjoining owners and others.** A permit to demolish a structure may not
8 be issued unless:

- 9 1. all notices required by §§ 105.9 {"Special requirements for demolition or
10 moving"} and 3307.1 {"Protection required"} of this Code have been given, and
- 11 2. copies of the notices are submitted with the permit application.

12 **3303.9 Demolition contractor's license.** Except as otherwise specified in this § 3303.9, no
13 person may engage in the demolition of any structure without first obtaining a demolition
14 contractor's license from the Building Official.

15 **3303.9.1 Prerequisites.** Every contractor applying for a new license or for the renewal
16 of a license must:

- 17 1. provide the Building Official with the full name, phone number, address,
18 and (if available) email address of the contractor's business, and
- 19 2. provide the Building Official with a copy of a liability insurance policy
20 that complies with § 3303.10 of this Code.

21 **3303.9.2 Term; fees.** A demolition contractor's license expires on December 31 of each
22 year. The license may be renewed annually, on or before December 31, on payment of
23 the renewal fee. The license fees are as set by the Building Official with the approval of
24 the Board of Estimates.

25 **3303.9.3 Change of name or address.** A licensee must immediately notify the Building
26 Official of any change in the name, phone number, address, or email address of the
27 licensee's business.

28 **3303.9.4 Use of license by other.** A licensee may not allow his or her name to be used
29 by another person for the purpose of obtaining permits or for doing any demolition work
30 under the licensee's license.

31 **3303.9.5 Exception.** The Building Official may waive the requirements of this § 3303.9
32 if the structure to be demolished is a miscellaneous structure as described in § 312
33 {"Utility, Miscellaneous Group U"} of this Code.

34 **3303.9.6 Enforcement.** A violation notice is not a prerequisite to the enforcement of
35 this § 3303.9 by any appropriate legal proceeding. Penalties will be assessed in
36 accordance with § 114 {"Violations"} of this Code.

1 **3303.9.7 Debarment on conviction.** Any person convicted of a violation of this
2 § 3303.9 is, in addition to any other penalty that might be imposed:

- 3 1. prohibited from performing demolition work without first obtaining a new
4 license, and
- 5 2. is ineligible to receive a new license for 1 year.

6 **3303.10 Demolition insurance.** The licensee must have an insurance policy that complies
7 with the minimum requirements of this § 3303.10.

8 **3303.10.1 Coverage.** The policy must provide coverage for all operations for which a
9 permit might be sought. The minimum coverage requirements are:

- 10 1. \$500,000 for damages (including damages for care and loss of services) because
11 of bodily injury (including death at any time resulting from bodily injury), per
12 person, per incident,
- 13 2. \$1,000,000 for damages (including damages for care and loss of services) because
14 of bodily injury (including death at any time resulting from bodily injury)
15 sustained by more than 1 person per incident, and
- 16 3. \$250,000 for injury to or destruction of property of others per incident.

17 **3303.10.2 Prohibited exclusions.** The policy may not contain:

- 18 1. any “collapse hazard” exclusion,
- 19 2. any exclusion that would prohibit the contractor from performing the demolition
20 operations in accordance with this Code and the normal procedures of the
21 industry, or
- 22 3. any exclusion that would create an undue risk to the City or to the health, safety,
23 and welfare of the general public.

24 **3303.10.3 Cancellation.** The terms of policy must provide either:

- 25 1. that the policy may not be canceled during the duration of the operations to be
26 performed, or
- 27 2. that the Building Official will be notified in writing, at least 15 days before the
28 policy is canceled.

29 **3303.11 to 3303.12 {Reserved}**

30 **3303.13 Demolition permits.** Each application for a demolition permit must:

- 31 1. comply with § 105 {“Permits”} of this Code,

1 2. except as provided in § 3303.13.1, be accompanied by a certificate of
2 insurance that evidences compliance with § 3303.10, and

3 3. be accompanied by an affidavit to the Building Official that all contracts
4 and other arrangements complying with this Code have been made.

5 **3303.13.1 Alternative certificate of continuing insurance.** Instead of providing a
6 separate certificate for each permit, a contractor may provide one general certificate of
7 continuing insurance, as long as the certificate evidences:

8 1. the required coverage for all work to be performed by the contractor, and

9 2. the insurer's obligation to notify the Building Official, in writing, at
10 least 15 days before the policy is canceled.

11 **3303.14 to 3303.15 {Reserved}**

12 **3303.16 Methods of demolition.** The following methods must be used for the demolition
13 of a structure:

14 1. The demolition must be performed in approximately the reverse order in which
15 the structure was erected. Where unusual conditions exist, the Building Official
16 may authorize a different method.

17 2. Structural elements must be carefully disassembled to avoid collapse.

18 3. Heavy pieces of stone or other heavy and bulky materials or equipment must be
19 carefully handled in accordance with this Code.

20 4. DEMOTION MUST BE HALTED WHEN WINDS EXCEED 20 MPH.

21 5. WETTING IS PROHIBITED DURING PERIODS OF PROLONGED FREEZING TEMPERATURES.

22 **3303.17 Use of explosives.** The use of explosives is generally prohibited. Explosives for
23 demolition by implosion may be used by special permit from the Building Official.

24 **3303.18 Partial Demolition.** Building elements that become exposed as result of a partial
25 demolition must be properly finished, braced, or otherwise made safe.

26 **3303.19 to 3303.20 {Reserved}**

27 **3303.21 Removal of debris.** The requirements of this section are in addition to those of
28 § 3302.2 {"Waste and debris"}.

29 **3303.21.1 General requirements.** Debris on upper floors must be lowered to ground
30 level:

31 1. in receptacles, by elevators or hoists, or

32 2. in tight and completely enclosed chutes.

1 **3303.21.2 Chute requirements.** No chute used for this purpose may extend in an
2 unbroken line that is more than 25 feet (7.62 m) without suitable barriers to prevent
3 debris from falling too fast. Each chute must be equipped with a proper gate or stop at
4 the bottom to control the flow of materials from the chute.

5 **3303.22 {Reserved}**

6 **3303.23 Disposition of recyclable debris.** Whenever recyclable debris to be cleared from a
7 site exceeds 5 tons, at least 30% of that recyclable debris must be immediately transported to
8 a licensed recycling facility.

9 **3303.23.1 “Recyclable debris” defined.** In this section, “recyclable debris” means
10 materials that:

- 11 1. if not recycled, would become solid waste for disposal in a solid waste
12 acceptance facility, and
- 13 2. may be collected, separated, or processed and returned to the marketplace in
14 the form of raw materials or products.

15 **3303.24 to 3303.25 {Reserved}**

16 **3303.26 Correction of injurious conditions.** This section applies to any demolition
17 contractor who:

- 18 1. performs any demolition work that creates a condition that violates this Code or a
19 condition that might be injurious to the general public or adjoining to adjoining
20 properties, and
- 21 2. refuses or fails to correct the condition in the manner and time required by this Code.

22 **3303.26.1 Correction by Building Official.** If the contractor refuses or fails to correct
23 the condition or if an emergency occurs as a result of the condition, the Building Official
24 may correct the condition or perform any other operations necessary to bring the
25 demolition operations into compliance with this Code. All work the Building Official
26 performs under this section is at the expense of the contractor.

27 **3303.26.2 Contractor not relieved of responsibility.** The Building Official’s
28 performance of any work under this section does not relieve the contractor from
29 responsibility for all work performed by the contractor. Any remedies or penalties
30 provided in this section are in addition to any other remedies or penalties provided by
31 law.

32 **3303.27 Limits of liability.** The liability of any contractor for materials furnished or work
33 done under this Code and the liability of the contractor’s surety does not extend to defects in
34 materials or workmanship discovered more than 12 months after the completion of the work.
35 The contractor and surety are responsible to the City to correct all defects discovered during
36 this 12-month period and about which they were notified in writing.

1 **3303.28 Owner's responsibility.** Notwithstanding the limited liabilities of the contractor
2 and the surety, the owner of the property is responsible at all times to the City to correct any
3 defects in the operations performed on his or her property.

4 **3303.29 Penalty for violation.** On a contractor's refusal or failure to correct any violation,
5 the contractor's license and all outstanding work permits are automatically suspended. The
6 suspension continues until the violation is corrected.

7 **Section 3304 Site Work** *{As in IBC}*

8 **Section 3305 Sanitary** *{As in IBC}*

9 **Section 3306 Protection of Pedestrians** *{As in IBC}*

10 **Section 3307 Protection of Adjoining Property**

11 **3307.1 Protection required.** *{As in IBC}*

12 **3307.2 Shared elements – General.** Repairs to elements shared by a demolished or moved
13 structure and an adjoining structure must comply with all applicable provisions of this Code.

14 **3307.3 Shared elements – Walls.** Party walls must be repaired and finished by the owner
15 of the demolished or moved structure. The repairs must include:

- 16 1. restoration or replacement of any flashing on adjoining property that has
17 been broken or damaged during the operations,
- 18 2. removal of all plaster from the exposed side of the wall, and
- 19 3. cleaning and finishing the wall with approved waterproof material.

20 **Sections 3308 to 3313** *{As in IBC}*

21 **SECTION 3314 FIRE WATCH DURING CONSTRUCTION** *{AS IN IBC}*

22 **SECTIONS 3315 TO 3317** *{RESERVED}*

23 **Section 3318 [3314] Rodenticide Procedure**

24 **3318.1 [3314.1] Certification required.** Before any structure may be demolished, moved
25 to another site, or substantially rehabilitated, the applicant for a permit must provide
26 certification from a pesticide applicator licensed by the State of Maryland that all areas of the
27 structure and its lot are free from rodent infestation. A certification of treatment and
28 abatement of all infestation must accompany the permit application.

29 **3318.2 [3314.2] Treatment required.** Structures or lots found to be infested must be
30 treated by a licensed pesticide applicator before demolition, moving, or rehabilitation

1 **Section 3319 [3315] Unsafe Walls**

2 **3319.1 [3315.1] Presumption.** For purposes of this [§ 3315] § 3319, any load-bearing wall
3 that is cracked or bowed and any 4-inch load-bearing wall is considered a structurally unsafe
4 wall unless certified to be safe by a professional structural engineer licensed in Maryland.

5 **3319.2 [3315.2] Removal or correction required.** Any structurally unsafe wall that
6 remains after the demolition or moving of a structure must be:

- 7 1. removed and replaced as required by all applicable sections of this Code, or
- 8
- 9 2. in the case of a party wall, corrected as provided in [§ 3315.3] § 3319.3.

10 **3319.3 [3315.3] Party walls.** If the structurally unsafe wall that remains is a party wall, the
11 owner of the structure being demolished or removed must:

- 12 1. remove all or any part of the wall that the Building Official considers dangerous, and
- 13 2. reconstruct and do all other necessary work to properly enclose the adjoining
14 structure.

15 **Section 3320 [3316] Operations Not to Cause Nuisance**

16 **3320.1 [3316.1] Scope.** This section applies to all operations that involve:

- 17 1. moving or demolishing any structure, or
- 18 2. removing any machinery or equipment from any structure to be moved or
19 demolished.

20 **3320.2 [3316.2] Work to avoid nuisance.** All operations of the sort described in [§ 3316.1]
21 § 3320.1 must be conducted so that:

- 22 1. no material, object, or thing is allowed to fall in or on any structure or premises
23 or any alley or other public way,
- 24 2. all materials, objects, and things are well wetted down or otherwise treated as
25 needed to prevent dust or other airborne debris, and
- 26 3. no nuisance is otherwise created in the vicinity of the operations.

27 **3320.3 [3316.3] Stop-work order.** If any operation violates these requirements, the
28 Building Official must issue a stop-work order. Work may resume only after the violation
29 has been corrected and measures taken to prevent a recurrence.

Chapter 36 “Visitability” Requirements for Publicly Assisted Dwellings

Section 3601 Scope

3601.1 General. This Chapter applies to every single-family dwelling, whether detached, semi-detached, or attached, and to all ground-floor dwelling units of any 2-family dwelling or of any multiple-family dwelling that contains 4 or fewer dwelling units, that:

1. is newly constructed on a vacant lot, and
2. receives funding or other assistance from the City or any City agency (including the Housing Authority of Baltimore City) by any one of the following methods:
 - a. a building contract or similar agreement that involves any Federal, State, or City funds,
 - b. acquisition, by gift, purchase, lease, or otherwise, of any real property for less than its appraised value, as determined by a certified appraiser,
 - c. preferential tax treatment, such as payments in lieu of taxes, tax increment financing, or similar benefit,
 - d. bond proceeds or issuance assistance, a loan, or similar financial benefit,
 - e. receipt under City authority of Federal or State construction funds, including Community Development Block Grant funds, and
 - f. except as otherwise specified in this section, receipt of any other form of funding or financial benefit from the City or a City agency.

3601.2 Exclusions. This Chapter does not apply to:

1. additions to or remodelings of existing buildings, or
2. new construction for which City funding or assistance is limited to either or both:
 - a. a property tax credit under City Code Article 28, § 10-5 {“Newly constructed buildings”}, and
 - b. waiver of a City lien on property where the lien exceeds the value of the property.

Section 3602 Accessible Entry

3602.1 Requirements. Every dwelling that is subject to this Chapter must provide at least 1 entrance that:

1. is accessible to, and usable by, a person with a mobility disability,

- 1 2. does not include steps,
- 2 3. has a level change (including any level change at threshold) that does not
- 3 exceed ½ inch and, if the level change exceeds ¼ inch, is beveled, and
- 4 4. is located on a continuous unobstructed path that, through the use as
- 5 necessary or appropriate of curb ramps, parking access aisles, walks, ramps,
- 6 elevators, lifts, and the like:
 - 7 a. connects the lot entrance to the dwelling entrance, and
 - 8 b. can be negotiated by a person with a disability who uses a wheelchair,
 - 9 by a person with a disability who does not require use of a wheelchair,
 - 10 and by a person without a disability.

11 **Section 3603 Accessible Interior**

12 **3603.1 “Entry level” defined.** In this § 3603, “entry level” means the level at which an
13 accessible entrance is provided under § 3602.1 {“Requirements”}.

14 **3603.2 Interior doors.** On the entry level of the dwelling, each door designed to allow
15 passage must have an unobstructed opening of at least 32 inches when the door is open at a
16 90-degree angle.

17 **3603.3 Environmental controls.**

18 **3603.3.1 “Environmental control” defined.** In this § 3603.3, “environmental control”
19 means any switch or device that controls or regulates lights, temperature, fuses, fans,
20 doors, security systems, or similar features included in the construction of the dwelling
21 unit.

22 **3603.3.2 Requirements.** On the entry level of the dwelling, each environmental control
23 must be located:

- 24 1. no higher than 48 inches above the floor and no lower than 15 inches above the
25 floor, and
- 26 2. if an environmental control is located directly above a counter, sink, or appliance,
27 no higher than 3 inches above the counter, sink, or appliance.

28 **3603.4 Habitable space.** The entry level of the dwelling must contain at least 1 interior
29 room that:

- 30 1. has an area of not less than 108 sq. ft., and
- 31 2. contains no side or dimension narrower than 9 feet.

32 **3603.5 Bathroom.** The entry level of the dwelling must contain at least 1 bathroom that
33 contains:

- 1 1. a toilet,
- 2 2. a sink,
- 3 3. reinforced walls at the toilet, to allow for future installation of grab bars, and
- 4 4. the following minimum dimensions:
 - 5 a. 30"-by-48" of clear floor space outside of the door swing,
 - 6 b. 30"-by-48" of clear floor space parallel to and centered on the sink, and
 - 7 c. 48"-by-56" of clear floor space at the toilet for a side approach.

8 **Section 3604 Waivers**

9 **3604.1 General.** The Building Official may grant a waiver from one or more of the
10 requirements of this Chapter if:

- 11 1. the cost of grading the terrain to meet the requirement is disproportionately expensive
12 in relation to the value of the dwelling,
- 13 2. the width of the lot is less than 16 feet, or
- 14 3. compliance with the requirement is precluded or limited because of the lot's location
15 in a Federal, State, or City historic district.

16 **3604.1.1 "Disproportionately expensive" defined.** For purposes of this section,
17 "disproportionately expensive" means that the cost of grading the terrain to meet the
18 requirement exceeds 5% of the fair market value of the unimproved property.

19 **Section 3605 Relationship to Other Laws**

20 **3605.1 Federal and state laws.** Federal and state laws also govern multiple-family
21 dwellings and public accommodations. Newly constructed multiple-family dwellings may
22 also be subject to the federal Americans with Disabilities Act and the federal Fair Housing
23 Act and their respective guidelines.

24 **3605.2 City law.** This Chapter applies to some dwellings that are not covered by federal or
25 state law, such as newly-constructed single-family dwellings.

26 **3605.3 More restrictive law controls.** To the extent that the provisions of this Chapter are
27 not identical to federal or state laws, the more restrictive law controls.

1 **Chapter 38**
2 **Traffic Impact and Mitigation**

3 **Section 3801 Definitions**

4 **3801.1 General.** In this Chapter, the following terms have the meanings indicated.

5 **3801.1.1 Director.** “Director” means the Director of the Department of Transportation
6 or the Director’s designee.

7 **3801.1.2 Gross floor area.** “Gross floor area” means the area specified in Baltimore
8 City Zoning Code § 1-306(j) {“Floor area: Gross (GFA)”}.

9 **3801.1.3 Change in occupancy.** “Change in occupancy” has the meaning stated in
10 Baltimore City Building Code § 202.2.9.

11 **3801.1.4 Traffic-Mitigation Zone.** “Traffic-Mitigation Zone” or “Zone” means a
12 geographic area designated by this Chapter for heightened review of the potential impact
13 of development on the area’s transportation network.

14 **Section 3802 Scope of Chapter**

15 **3802.1 {Reserved}**

16 **3802.2 Outside a Traffic-Mitigation Zone.** A traffic-impact study is required for any
17 proposed work outside of a Traffic-Mitigation Zone if the proposed work involves any 1 of
18 the following:

- 19 1. an impact area that includes an intersection performing at Level of Service D or
20 worse,
- 21 2. 50 or more dwelling units, or
- 22 3. a gross floor area that equals or exceeds:
- 23 a. for a warehouse use, 100,000 sq. ft., or
- 24 b. for any other use or combination of uses, 50,000 sq. ft.

25 **3802.2.1 Determination of impact area.** For purposes of this § 3802.2, an impact area
26 must include the entire area located ½ mile or less from any point on the development’s
27 property line, unless the Director, in accordance with the rules and regulations adopted
28 under this Chapter, determines that extraordinary circumstances exist that require that a
29 larger impact area of up to 1 mile from the development’s property line be considered.

30 **3802.3 Within a Traffic-Mitigation Zone.** A Traffic-Mitigation Fee is required for any
31 proposed new construction or change in occupancy within a Traffic-Mitigation Zone if the
32 proposed work involves any 1 of the following:

- 1 1. 10 or more dwelling units, or
- 2 2. a gross floor area that equals or exceeds:
 - 3 a. for a warehouse use, 100,000 sq. ft., or
 - 4 b. for any other use or combination of uses, 50,000 sq. ft.

5 **3802.4 DoT initial determination.** Within 20 business days after an application has been
6 referred to the Director of Transportation under § 105.3.1.2 {"Referral to assess need for
7 traffic-mitigation"} of this Code, the Director must review the application and notify the
8 referring official and the applicant:

- 9 1. whether and, if so, what additional information is needed to evaluate the application,
10 or
- 11 2. if no additional information is needed:
 - 12 a. whether the proposed project is in a Traffic-Mitigation Zone, and if so,
13 whether the developer of a project must pay a Traffic-Mitigation Fee under
14 § 3806 {"Traffic-Mitigation Fee"} of this Chapter,
 - 15 b. whether, under the criteria set forth in this § 3802, a traffic-impact study
16 will be required, and
 - 17 c. if a traffic-impact study will be required, the estimated expenses for
18 undertaking or contracting for the study.

19 Section 3803 DoT Rules and Regulations

20 **3803.1 In general.** The Department of Transportation must adopt rules and regulations to
21 carry out this Chapter.

22 **3803.2 Contents.** These rules and regulations:

- 23 1. must include:
 - 24 a. procedures for determining the number of trips to be attributable to projects
25 in a particular Traffic-Mitigation Zone or Subzone,
 - 26 b. procedures for determining what constitute extraordinary circumstances
27 requiring that an impact area of up to a 1 mile radius be considered for
28 purposes of § 3802.2 {"Outside Traffic-Mitigation Zone"},
 - 29 c. a schedule of the fees that an applicant may be charged under § 3804.3
30 {"Expenses"}, and,
 - 31 d. an accounting method, adopted in accordance with § 3807.5.3 {"Accounting
32 method to be published"}, to identify what specific projects individual fees
33 are obligated to for purposes of a review under § 3807.5.1 {"Review of fee
34 use"},

1 2. may establish:

2 a. usage categories for determining the number of trips generated by differing
3 uses within Traffic-Mitigation Zones, and

4 b. procedures for designating, within Traffic-Mitigation Zones, Subzones with
5 differing trip-generation formulas, and

6 3. may include any other procedures, standards, or requirements consistent with this
7 Chapter.

8 **3803.3 Public review.** All proposed rules and regulations under this Chapter must be
9 published for public comment on the Department of Transportation’s website by the Director
10 for at least 45 days. During the 45-day public comment period the Director must hold 1 or
11 more public hearings on the proposed rules and regulations, at least 1 of which must begin
12 between 6 pm and 8 pm. After this publication and hearing, the Director may modify and
13 adopt rules and regulations by filing a copy of the final rules and regulations with the
14 Director of Legislative Reference.

15 **3803.4 Filing.** A copy of all rules and regulations adopted under this Chapter must be filed
16 with:

17 1. the Building Official,

18 2. the Zoning Administrator,

19 3. the Board of Municipal and Zoning Appeals,

20 4. the Director of Legislative Reference, and

21 5. the Director of Planning.

22 **Section 3804 Traffic-Impact Study**

23 **3804.1 Scope of section.** This § 3804 is applicable to all proposed projects located outside
24 of a Traffic-Mitigation Zone.

25 **3804.2 How conducted.**

26 **3804.2.1 By DoT or consultant.** The Department of Transportation may itself
27 undertake the study or contract with independent consultants for the study, as the
28 Director considers necessary or appropriate.

29 **3804.2.1.1 Consultant conflicts.** For a consultant to be eligible to undertake a
30 Traffic-Impact Study, the consultant must certify to the Director, in the manner
31 prescribed by the Director, that the consultant is free of any conflicts of interest.

32 **3804.2.1.2 Conflict defined.** For purposes of this § 3804.2, a “conflict of interest”
33 is defined as any consultant having materially participated in the development of the
34 application or having worked for the applicant on any application within the prior 24
35 months.

1 **3804.2.2 Scope of study.** The area and scope of each study is to be determined by the
2 Department of Transportation, in accordance with the rules and regulations adopted
3 under § 3803 {"DoT rules and regulations"}.

4 **3804.2.2.1 Minimum area of study.** The area of a study required under this § 3804
5 must not be smaller than the impact area of the project, as determined using the
6 method described in § 3802.2.1 {"Determination of impact area"}.

7 **3804.3 Expenses.** All reasonable expenses incurred in undertaking or contracting for the
8 study must be paid by the applicant, and will be imposed and collected as provided in § 118
9 {"Liability for Expenses..."} of this Code for fees and service charges.

10 **3804.3.1 Initial payment.** Before the study begins, the applicant must pay the expenses
11 estimated under § 3802.4 {"DoT initial determination"}.

12 **3804.3.2 Balance.** After the study is completed, but before any permit may be issued,
13 the applicant must pay any difference between the initial amount paid under § 3804.3.1
14 and the actual expenses incurred for the study.

15 **3804.3.2.1 Refund.** After the study is completed, subject to appropriation by the
16 Board of Estimates, the applicant is entitled to a refund of any payments made under
17 § 3804.3.1 that exceed the actual expenses incurred for the study plus a reasonable
18 service charge.

19 **3804.4 Applicant's option on delay.** If the Traffic-Impact Study is not completed within
20 60 business days after the initial payment is made under § 3804.3.1:

- 21 1. the applicant may proceed to contract for the Traffic-Impact Study with a consultant
22 selected from a list of consultants prequalified by the Department of Public Works'
23 Office of Boards and Commissions; and
- 24 2. subject to appropriation by the Board of Estimates, the applicant is entitled to a full
25 refund of all fees paid to the City for the uncompleted Traffic-Impact Study.

26 **3804.5 Mitigation.** The applicant and the Department of Transportation must negotiate in
27 good faith to determine who must pay for and undertake the actions necessary or appropriate
28 to mitigate the adverse traffic impacts identified in the Traffic-Impact Study. If no
29 agreement is reached, the application is not approved.

30 Section 3805 Traffic-Mitigation Zones

31 **3805.1 Purpose of Zones.** Areas designated as Traffic-Mitigation Zones are areas that have
32 overburdened and interrelated transportation networks and that are anticipated to experience
33 significant development. Heightened review of development that might impact the
34 transportation networks in these areas is therefore necessary.

35 **3805.2 Traffic-Management Plans for Zones.** The Planning Commission may adopt a 10-
36 year traffic-management plan for each Traffic-Mitigation Zone and review and update each
37 plan every 5 years.

1 **3805.2.1 Required plan inclusions.** Each plan must, among other things:

- 2 1. project the number of trips that reasonably might be expected to be generated
3 in the Zone, based on new development (including redevelopment of vacant
4 and underutilized parcels),
- 5 2. identify multimodal transportation solutions to mitigate the likely growth in
6 traffic congestion, and
- 7 3. based on the Director’s recommendations, indicate what projects may be funded,
8 in whole or in part, by Traffic-Mitigation Fees from the Zone.

9 **3805.2.2 Plan exclusions.** The plan may not include Traffic-Mitigation Fee funding for
10 system preservation projects such as street resurfacing, reconstruction, or other projects
11 not required to mitigate the growth in traffic congestion unless the system preservation
12 projects are reasonably necessary to improve safety or capacity.

13 **3805.3 Designated Zones.** There are 5 Traffic-Mitigation Zones in the City of Baltimore.

14 **3805.3.1 Downtown/Midtown Zone.** The area within the following boundaries is the

- 10 (8) Northerly to a point formed by the geometric intersection of the centerline of said The
11 Fallsway and the centerline of Interstate Route 83 Right of Way below; thence running with
12 the centerline of said Interstate Route 83
- 13 (9) Northwesternly direction to the point formed by the geometric intersection of the centerline of
14 said Interstate Route 83 Right of Way and the centerline of said North Calvert Street above;
15 thence running with the centerline of said North Calvert Street to the place of beginning.
16

17 **3805.3.5 Southwest Zone.** The area within the following boundaries is the "Southwest Traffic-Mitigation
18 Zone":
19

20 BEGINNING for the same at the point formed by the intersection of the centerline of West Mulberry
21 (aka US Route 40) and the centerline of North Martin Luther King, Jr. Boulevard, varying in width;
22 thence running with the centerline of said North Martin Luther King, Jr. Boulevard, with meridian
23 reference to the Baltimore City Survey Control System, the following courses:

- 24 (1) Southerly and Southeasterly, passing over West Baltimore Street whereas said North Martin
25 Luther King, Jr. Boulevard becomes South Martin Luther King, Jr. Boulevard, varying in
26 width, to a point formed by the intersection of the centerline of said South Martin Luther
27 King, Jr. Boulevard and the centerline of Russell Street (Baltimore-Washington Parkway, MD
28 I-295), 160 feet wide; thence running with the centerline of said Russell Street
- 29 (2) Southwesterly and Westerly to a point formed by the intersection of the centerline of said
30 Russell Street and the centerline of Interstate Route 95 (John F. Kennedy Memorial
31 Highway), varying in width; thence running with the centerline of said Interstate Route 95
- 32 (3) Westerly to a point formed by the intersection of the centerline of said Interstate Route 95 and
33 the centerline of Washington Boulevard, 49.5 feet wide; thence running with the centerline of

41 thence binding on and running with the north-west boundary line of Lot 1 as shown on said
42 plat
- 43 (6) North 45° 24' 52" East 1,109.33 feet line to a point designated as "509" as shown on said plat
44 and located along the south side of the former bed of Putnam Street, also known as the former
45 bed of The Baltimore and Ohio Railroad Right-of-Way, and currently the south side of CSX
46 Transportation, Inc. property; thence binding on and running with the north-east boundary line
47 of Lot 1 as shown on said plat
- 48 (7) South 44° 31' 29" East to intersect the last line of the second parcel of land conveyed by
49 Carroll Park, LLC, to Washington-Monroe, LLC, by deed dated September 7, 2001 and
50 recorded among said the Land Records in Liber F.M.C. 1719, Folio 30, if projected in a

- 1 Southerly direction; thence binding on and running with said last line of second parcel so
2 projected
- 3 (8) North 44° 42' 07" East, passing over the north side of said CSX Transportation, Inc. property
4 and the south west side of South Monroe Street, 66 feet wide, to the centerline of said South
5 Monroe Street; thence running with the centerline of said South Monroe Street
- 6 (9) Northwesterly and Northerly to a point formed by the intersection of the centerline of said
7 South Monroe Street and the "southern property line" of the B&O Railroad Museum,
8 Incorporated property as described in a deed dated August 14th, 1991, by and between CSX
9 Transportation, Inc. et al to B&O Railroad Museum, Incorporated as recorded among said
10 Land Records in Liber S.E.B. 3638, Folio 208; thence binding and running with the said
11 "southern property line" of the B&O Railroad Museum, Incorporated property
- 12 (10) Northeasterly to a point formed by the intersection of said "southern property line" of the
13 B&O Railroad Museum, Incorporated property and the centerline of South Carey Street, 80
14 feet wide; thence binding on the centerline of said South Carey Street
- 15 (11) Northerly, passing over West Baltimore Street whereas said South Carey Street becomes
16 North Carey Street, 80 feet wide, to a point formed by the intersection of said North Carey
17 Street and aforesaid West Mulberry Street; thence running with the centerline of said West
18 Mulberry Street
- 19 (12) Easterly, to the point of beginning.

20 Section 3806 Traffic-Mitigation Fee

21 **3806.1 Scope of section.** This § 3806 is applicable to all proposed projects located inside of
22 a Traffic-Mitigation Zone.

23 **3806.2 General.** A Traffic-Mitigation Fee is a payment that, by authority of Charter Article
24 II, §§ (40) and (47), must be paid for projects that meet the criteria established in § 3802.3
25 {"Within Traffic-Mitigation Zone"}.

26 **3806.2.1 Application and processing fee.** An application to begin the required Traffic-
27 Mitigation Fee process must be:

- 28 1. made in the form and within the time frame set forth in the rules and regulations
29 adopted under this Chapter; and
- 30 2. accompanied by a processing fee in the amount set by these rules and regulations.

31 **3806.3 Assessment of fee.**

32 **3806.3.1 Trip formula.** The rules and regulations adopted under this Chapter must
33 establish:

- 34 1. procedures for determining the number of trips attributable to various types of
35 projects in a particular Traffic-Mitigation Zone or Subzone; and
- 36 2. adjustment factors for calculating the number of non-single-occupant-vehicle
37 trips attributable to various types of projects.

38 **3806.3.2 Fee Rates.** The fee rate per trip is as set by the Board of Estimates, in
39 consultation with the Director, for each Zone.

1 **3806.3.2.1 Temporary limitation on Fee Rate increases.** For the period beginning
2 when a fee rate is initially set for a Zone, and ending on December 31, 2016, the
3 Board of Estimates may not increase the fee rate for that Zone more often than once
4 every 5 years.

5 **3806.3.3 Fee formula.** The amount of the Traffic-Mitigation Fee assessed on a specific
6 project is determined by multiplying:

- 7 1. the applicable rate per trip, as of the date that the permit is applied for, for the
8 Zone where the project is located, by
- 9 2. the number of trips that the Department of Transportation attributes to the project
10 using the procedure established under § 3806.3.1.

11 **3806.4 Trip-Generation Credits.**

12 **3806.4.1 General.** The Director must issue trip-generation credits to any proposed
13 project that meets the requirements of this § 3806.4. Each credit issued reduces by 1 the
14 number of trips used to calculate the amount of the Traffic-Mitigation Fee under
15 § 3806.3.

16 **3806.4.2 Authorized credits.** Trip-generation credits are authorized as follows.

17 **3806.4.2.1 Negotiated agreement.** The Director may agree to issue trip-generation
18 credits for a proposed project if:

- 19 1. the Mayor and City Council enter into a binding, written mitigation agreement
20 with the developer of the project that requires the performance of specific
21 actions that the Director determines will reduce the number of trips actually
22 generated by the project,
- 23 2. the mitigation agreement requires the developer to require all subsequent
24 purchasers or occupants of the property to abide by the ongoing requirements
25 of the mitigation agreement,
- 26 3. the mitigation agreement includes a mechanism making it binding on all
27 future successors and assigns who may acquire any interest in the property
28 in the future,
- 29 4. the mitigation agreement requires the Director to issue a number of credits
30 equivalent to the number of trips that the director calculates will be avoided
31 through the actions agreed to by the developer, and
- 32 5. the mitigation agreement, together with any adjustment factors calculated
33 using the procedure established under § 3806.3.1(2), does not reduce the total
34 number of trips that would otherwise be used to calculate the
35 Traffic-Mitigation Fee by more than 50%.

1 **3806.4.2.2 Change in occupancy within 1 year.** For the change in occupancy of a
2 structure that has been vacant for less than 1 year before the date of application for a
3 permit, the Director must issue trip-generation credits equivalent to the number of
4 trips attributable to the previous use, as calculated using the procedure established
5 under § 3806.3.1 {“Trip formula”}.

6 **3806.4.3 Buy-out of credits.** An owner or occupier of property that has benefitted from
7 the issuance of trip-generation credits may not change the use of the property in any way
8 that would no longer qualify the property for 1 or more trip-generation credits previously
9 issued unless the owner or occupier first cancels the previously issued credits.

10 **3806.4.3.1 Formula.** To cancel those credits, the owner or occupier must pay to the
11 Director of Finance an amount equal to the greater of:

- 12 1. the number of trip-generation credits being canceled, multiplied by the
13 Traffic-Mitigation Fee rate that was in force for the Zone when the credits
14 were issued, or
- 15 2. the number of trip-generation credits being canceled, multiplied by the
16 Traffic-Mitigation Fee rate that is in force in the Zone when the credits are
17 cancelled.

18 **3806.4.4 Obligation created by acceptance of credits.** The acceptance of trip-
19 generation credits under this § 3806.4 creates a binding obligation on the persons
20 accepting the credits to fulfill the representations and agreements that allowed the credits
21 to be issued. In addition to any other remedy or enforcement action, the Director may
22 enforce these obligations by seeking both legal and equitable remedies.

23 **3806.5 Right-of-way dedication set-off.** If an applicant controls property that the Director
24 determines to be necessary for the construction of a traffic-mitigation project, the Director
25 may accept the dedication of the needed property to the City’s use and issue a set-off credit
26 toward the Traffic-Mitigation Fee assessed on a project in exchange. The total amount of the
27 Traffic-Mitigation Fee to be paid would then be reduced by the appraised value of the
28 property dedicated to City use.

29 **3806.6 Payment of Fees.**

30 **3806.6.1 \$50,000 or less.** If the Traffic-Mitigation Fee assessed for a proposed project
31 is \$50,000 or less, the Fee must be paid to the Director of Finance in full before any
32 permits for the work are issued.

33 **3806.6.2 More than \$50,000.** If the Traffic-Mitigation Fee assessed for a proposed
34 project is more than \$50,000, the Director of Transportation may negotiate installment
35 payments to be made over a period of up to 5 years from the issuance of a building
36 permit for all amounts in excess of \$50,000. The initial payment of at least \$50,000 must
37 be paid to the Director of Finance in full before any permits for the work are issued. Any
38 installment plan under this § 3806.6.2 requires the approval of the Board of Estimates to
39 become effective.

1 **3806.6.2.1 Interest to be charged on installment payments.** If a Traffic-Mitigation
2 Fee is to be paid in installments under an agreement authorized by § 3806.6.2,
3 installment payments must include an additional interest charge at the current City
4 borrowing rate as determined by the Director of Finance.

5 **Section 3807 Use of Fees**

6 **3807.1 Separate revenue accounts.** Traffic-Mitigation Fees collected under this Chapter
7 are to be deposited to the General Fund and accounted for in separate revenue accounts
8 designated to indicate precisely how much revenue is derived from each Traffic-Mitigation
9 Zone.

10 **3807.2 Fees to benefit Zone of origin.** Subject to appropriation, revenue derived from
11 Traffic- Mitigation Fees in each Traffic-Mitigation Zone must be used only for the purposes
12 described in § 3807.3 or for:

- 13 1. designing and constructing projects to benefit the transportation infrastructure of the
14 Zone from which the fees derive, as approved by the Planning Commission in the
15 Traffic-Management Plan adopted under § 3805.2 {"Traffic-Management Plans"}.
- 16 2. designing and constructing projects to benefit the transportation infrastructure of the
17 Zone from which the fees derive, as certified by the Director, if the Planning
18 Commission has not adopted a Traffic-Management Plan under § 3805.2, or
- 19 3. defraying the planning and administrative costs, of no more than 10% of all revenue
20 collected, of implementing this Chapter.

21 **3807.3 Fees may defray cost of site access improvements.**

22 **3807.3.1 Site access improvements.** Subject to the approval of the Board of Estimates,
23 the Director may permit up to 33% of the Traffic Mitigation Fee, after deduction of
24 credits, paid by an applicant to be used for minor site access improvements, including
25 turning lanes, acceleration/deceleration lanes, traffic signals, or similar improvements.

26 **3807.3.2 Use of Fees.** Fees appropriated under this § 3807.3 may be either:

- 27 1. rebated to the applicant pursuant to an agreement requiring the applicant
28 to construct these improvements; or
- 29 2. retained by the City for the purpose of constructing these improvements.

30 **3807.3.2.1 No rebates until remainder of fees paid.** A developer may not receive a
31 rebate of any fees under this § 3807.3.2 until the remaining Traffic-Mitigation Fees
32 have been paid to the City.

33 **3807.4 Annual accounting.** With the assistance of the Department of Finance, the Director
34 must annually produce and provide to the Board of Estimates an accounting that shows:

- 35 1. the cumulative revenue derived from Traffic-Mitigation Fees in each Traffic-
36 Mitigation Zone; and

2. the cumulative expenditures or appropriations for projects that benefit the transportation infrastructure of each Zone.

3807.5 Return of unobligated fees.

3807.5.1 Review of fee use. If an applicant who has paid a Traffic-Mitigation Fee for a project believes that the fee has not been obligated to a specific project within 6 years of final payment, the applicant may request a review of the fee’s use by the Director. The Director must then determine if the fee in question, or any portion of it, has, within 6 years of payment, been obligated to a specific project.

3807.5.2 Refund of unobligated fees. If the Director’s review under § 3807.5.1 determines that a fee has not been entirely obligated to a specific project within 6 years of payment, any unobligated portion of the fee must be refunded to the applicant upon the Board of Estimate’s appropriation of the necessary funds.

3807.5.3 Accounting method to be published. The Director, in consultation with the Department of Finance, must establish a standardized method for determining how specific fees are allocated to particular projects for purposes of a review under § 3807.5.1. This accounting method must be included in the rules and regulations adopted under this Chapter.

Section 3808 Enforcement

3808.1 General. A violation of any provision of this Chapter, of a rule or regulation adopted under this Chapter, or of an agreement entered into under this Chapter constitutes a violation of this Code, subject to the enforcement, penalty, and other provisions of § 114 {“Violations”} and related sections of this Code.

20 Fallsway, the point of beginning.

27 Construction”} and regulated in Tables 601 {“Fire-Resistant Rating Requirements

 - 30 a. fireproof (Type I),
 - 31 b. protected noncombustible (Types IIA and IIB),
 - 32 c. ordinary protected (Type IIIA), or
 - 33 d. heavy timber (Type IV).

1105.3.3 Discharge. No water from any building may be discharged so as to flow over any sidewalk, footway, or adjoining property, except from window sills, copings, or cornices that project no more than 1 foot (305 mm).

Exceptions:

1. Roofs, cornices, copings, or other similar projections that are less than 5 feet (3.03 m), measured horizontally in the line of flow, as long the water is not discharged on any sidewalk, footway, or adjoining property.
2. Awnings or marquees that discharge off the outer edge.

1105.4 Methods of roof drainage.

1105.4.1 Method 1. Drainage may be discharged by piping to a storm drain, to the street or alley, or to an approved water course. The installation of piping, connections to storm drains, etc., must be made in accordance with this Code.

1105.4.2 Method 2. Drainage may be discharged not less than 10 feet (3.05 m) from the building, from other buildings, or from any adjacent property line, as long as the discharge is in a manner that does not allow drainage to cross adjacent property lines or sidewalks.

1105.5 Individual downspouts.

Gutters of buildings on adjoining properties may not be connected with common downspouts or leaders, but each building must have individual downspouts or leaders on its own property. If a building is more than 4 stories or 50 feet (15.24 m) high, its leader and downspouts must be inside the building's exterior walls.

PART VII. INTERNATIONAL PROPERTY MAINTENANCE CODE

§ 7-101. City adoption.

(a) *In general.*

The International Property Maintenance Code ([2015] 2018 Edition) is adopted as part of the Building, Fire, and Related Codes of Baltimore City, subject to the additions, deletions, amendments, and other modifications contained in this Part VII.

(b) *Codification.*

Unless otherwise specified, chapter and section numbers in this Part VII refer to the chapter and section numbers of the International Property Maintenance Code.

§ 7-102. City modifications.

The additions, deletions, amendments, and other modifications adopted by the City are as follows:

Chapter 1 Scope and Administration

Section 101 General

101.1 Title. The regulations contained in this Code constitute and are known as the “Baltimore City Property Maintenance Code”.

101.1.1 References to “this Code”. Throughout this Part VII, all references to “this Code” refer to the Baltimore City Property Maintenance Code.

101.2 to 101.4 *{As in IPMC}*

Section 102 Applicability

102.1 General. *{As in IPMC}*

102.2 Maintenance. Equipment, systems, devices, and safeguards required by this Code or by a previous regulation or code under which the structure or premises was constructed, altered, or repaired must be maintained in good working order.

No owner, operator, or occupant may cause any service, facility, equipment, or utility required under this section to be removed or shut off from or discontinued for any occupied dwelling, except for a temporary interruption necessary while repairs or alterations are in progress.

102.2.2 Code not override of fire and safety systems. The requirements of this Code are not intended to provide the basis for removal or abrogation of fire protection and safety systems and devices in existing structures.

1 **102.2.3 Owner and operator responsible.** Except as otherwise specified, each owner
2 and each operator of a structure or premises is responsible for the maintenance of that
3 structure or premises.

4 **102.3 Application of other codes.** All repairs, additions, or alterations to a structure and all
5 changes of occupancy must be done in accordance with this Code and with the following
6 codes and standards, as modified by Baltimore City:

- 7 1. the International Building Code ([2015] 2018 Edition),
- 8 2. the National Electrical Code ([2014] 2017 Edition),
- 9 3. the International Fuel Gas Code ([2015] 2018 Edition),
- 10 4. the International Mechanical Code ([2015] 2018 Edition),
- 11 5. the International Plumbing Code [2015] 2018 Edition),
- 12 6. the International Fire Code ([2015] 2018 Edition),
- 13 7. the International Energy Conservation Code ([2015] 2018 Edition),
- 14 8. the International Residential Code for One- and Two-Family Dwellings
15 ([2015] 2018 Edition),
- 16 9. the International Green Construction Code (2012 Edition),
- 17 10. the International Swimming Pool and Spa Code ([2015] 2018 Edition), and
- 18 11. the Zoning Code of Baltimore City.

19 **102.4 Existing remedies.** The provisions of this Code may not be construed to abolish or
20 impair existing remedies of the City or its officers or agencies relating to:

- 21 1. enforcement of repair and maintenance standards, or
- 22 2. the removal or demolition of any structure that is dangerous,
23 unsafe, and insanitary.

24 **102.5 Workmanship.** All repairs, maintenance work, alterations, or installations must be
25 executed and installed in a workmanlike manner and installed in accordance with the
26 manufacturer's installation instructions.

29 **Section 103 Department of Property Maintenance Inspection**

30 **103.1 General.** This Code is administered and enforced by the Department of Housing and

27 violation, the Code Official must issue a notice of abatement.

28 **Section 105 Approval**

29 **105.1 Modifications.** *{As in IPMC}*

30 **105.2 Alternative materials and methods.** The provisions of this Code are not intended to
31 prevent the installation of any material or to prohibit any method of construction not
32 specifically prescribed by this Code, as long as that alternative has been approved. An
33 alternative material or method of construction may be approved if the Code Official finds in
34 writing that, for the purposes intended:

18 {"Notices and Orders"} of this Chapter is guilty of a misdemeanor. If the violation is not
19 abated or the notice or order not complied with, the Code Official may institute the
20 appropriate proceeding at law or in equity to restrain, correct, or abate the violation or to
21 require the removal or termination of the unlawful occupancy of the structure in violation of
22 this Code or of the order or direction made under this Code.

202.2.6 Multiple-family dwelling. "Multiple-family dwelling" means a building or a group of buildings on the same lot that contains or is designed or intended to contain:

1. more than 2 dwelling units,

- 1 2. 2 dwelling units and any other residential or commercial occupancy, or
2 3. any combination of 3 or more rooming units and dwelling units.

3 **202.2.7 Must/shall.** “Must” and “shall” are each mandatory terms used to express a

5 **202.2.8 Occupancy.** “Occupancy” has the meaning stated in § 202.2 of the Baltimore
6 City Building Code.

7 **202.2.9 Occupant.** “Occupant” has the meaning stated in § 202.2 of the Baltimore

9 **202.2.10 Operator.** “Operator” has the meaning stated in § 202.2 of the Baltimore
10 City Building Code.

11 **202.2.11 Owner.** “Owner” means any person that:

- 12 1. has a legal or equitable interest in the property,
13 2. is recorded in the land records as holding title to the property, or
14 3. otherwise has control of the property, with or without accompanying
15 possession of the property, including:
16 a. a guardian of the person or estate of an owner,
17 b. a trustee, including a trustee in bankruptcy, of an owner, or
18 c. the personal representative of the estate of an owner.

19 **202.2.12 Person.** “Person” has the meaning stated in § 202.2 of the Baltimore City
20 Building Code.

21 **202.2.13 Premises.** “Premises” means a lot or group of lots, together with all or any
22 part of any structures on the lot or group of lots, considered as a unit devoted to a
23 particular use, including accessory structures and open spaces required or used in
24 connection with that particular use.

25 **202.2.14 Rooming house.** “Rooming house” means a building that:

- 26 1. is not a multiple-family dwelling, and
27 2. contains more than 2 rooming units occupied or designed or intended to be
28 occupied by individuals who, even though they might share common areas
29 and facilities, do not form a single housekeeping unit and do not provide
30 compensation under a single lease for occupancy of the rooming house.

31 **202.2.14.1 Inclusions.** “Rooming house” includes a hotel, motel, bed and breakfast
32 (as defined in Zoning Code § 1-203(f)), or boarding house.

1 **202.2.15 Rooming unit.** “Rooming unit” means any room or group of rooms that form
2 a single habitable unit occupied or designed or intended to be occupied for sleeping or
3 living, but not for cooking purposes.

4 **202.2.16 Strict liability offense.** “Strict liability offense” means an offense in which the
5 prosecution in a legal proceeding is not required to prove knowledge or intent as a part of
6 its case. It is enough to prove that the defendant either did an act that was prohibited or
7 failed to do an act that the defendant was legally required to do.

8 **202.2.17 Structure.** “Structure” has the meaning stated in IPMC § 202 and, unless the
9 context indicates otherwise, includes premises and lands.

10 **202.2.18 Trash.** “Trash” means rubbish, as defined in IPMC § 202.

11 **202.2.19 Workmanlike.** “Workmanlike” means executed in a skilled manner in
12 accordance with the standards of the trade – e.g., generally plumb, level, square, in line,
13 undamaged, and without marring adjacent work.

**Chapter 3
General Requirements**

Section 301 General

301.1 Scope. This Chapter governs the minimum requirements and the responsibilities of persons for repair and maintenance of structures, equipment, and premises.

301.2 Responsibility.

301.2.1 Owners and operators. Except as otherwise specifically provided, the owner and the operator of any premises are responsible for maintaining all structures and exterior property areas in compliance with all requirements of this Chapter.

301.2.2 Occupants – In general. The occupant of any premises:

1. must give the owner and the owner’s agents access to the premises, at all reasonable times, for the purpose of inspecting and making repairs or alterations as necessary to effect compliance with this Code or with any lawful rule or regulation adopted or order issued under this Code,
2. may not obstruct any required means of egress,
3. may not store flammable liquids or gas or unsafe quantities of combustible materials,
4. if in control of the heating facilities, must maintain a sufficiently high temperature in all parts of the unit to prevent damage to the plumbing system, and
5. is responsible for:
 - a. keeping in a clean and sanitary condition the occupant’s unit and any other part of the premises that the occupant occupies or controls, and
 - b. otherwise complying with the requirements specified in § 308 {“Occupants’ Sanitary Responsibility”} of this Chapter.

301.2.3 Occupants – Vandalism. The occupant of a non-owner occupied dwelling may not destroy, deface, damage, impair, or carry away, nor permit any other person on the premises to destroy, deface, damage, impair, or carry away any of the facilities, equipment, appurtenances, or any part of the structure of the dwelling.

301.3 Vacant structures and land. All vacant structures and their premises and all vacant land must be maintained in a clean, sanitary, and safe condition, as provided in this Code.

301.4 Lead-based paint. Lead-paint hazards must be abated in accordance with:

1. the rules and regulations of:
 - a. the Maryland Department of the Environment; and

- 1 b. the Baltimore City Health Department; and
- 2 2. the Department of Public Works' requirements governing discharges into the storm
- 3 water system.

4 **301.4.1 Unoccupied dwelling unit – Scope.** These provisions apply to any dwelling

5 unit that:

- 6 1. is the subject of a notice or order for the treatment of lead paint, and
- 7 2. becomes unoccupied either:
- 8 a. before the notice or order is served, or
- 9 b. while the notice or order is still outstanding.

10 **301.4.2 Unoccupied dwelling unit – Posting property.** If a dwelling unit is or

11 becomes unoccupied, the Health Commissioner immediately must post 1 or more public

12 notices in, on, or around the dwelling unit stating that the dwelling unit may not be

13 reoccupied until the lead paint notice or order has been abated.

14 **301.4.3 Unoccupied dwelling unit – Reoccupancy prohibited.** If a dwelling unit is or

15 becomes unoccupied, the dwelling unit may not be reoccupied until:

- 16 1. the lead paint notice or order has been abated, and
- 17 2. the Health Commissioner has given written approval of reoccupancy.

18 **301.4.4 Unoccupied dwelling unit – Removing notice, etc., prohibited.** Until the

19 Health Commissioner has give written approval of reoccupancy, no person may remove,

20 deface, or otherwise tamper with any notice that has been posted under this section.

21 **301.4.5 Unoccupied dwelling unit – Unauthorized reoccupancy.** If a dwelling unit

22 is reoccupied in violation of this section:

- 23 1. each day that an unauthorized occupancy continues is a separate offense, and
- 24 2. the owner, operator, and unauthorized occupant of the unit are subject to the
- 25 following penalties:
- 26 a. in a criminal prosecution, a criminal fine of up to \$500 for each offense,
- 27 and
- 28 b. in an action seeking equitable relief, a civil fine of up to \$500 for each
- 29 offense.

30 **Section 302 Exterior Property Areas** *{Not Adopted}*

31 **Section 303 Swimming Pools, Spas, and Hot Tubs** *{Not Adopted}*

Section 304 Repair and Maintenance of Structures

304.1 General. The interior and exterior of a structure must be maintained in good repair and in a structurally sound and sanitary condition.

304.1.1 Unsafe conditions. *{Not Adopted}*

304.2 Protective treatment. *{As in IPMC}*

304.3 Premises identification. Premises identification must be provided and maintained for all buildings in accordance with:

1. [ICC International Building Code § 501.2 {"Address identification"}] BALTIMORE CITY BUILDING CODE § 502 {"BUILDING ADDRESS"}, and
2. City Code Article 26, Subtitle 6 {"Building Address Numbers"}.

304.4 Structural members. All interior and exterior structural members must be:

1. maintained in a structurally sound condition and free from deterioration, and
2. capable of safely supporting the imposed dead and live loads.

304.5 Foundation walls. *{As in IPMC}*

304.6 Exterior walls. *{As in IPMC}*

304.7 Roofs and drainage. The roof and flashing must be sound, tight, and without defects that admit rain. Roof drainage must be adequate to prevent dampness or deterioration in the walls or interior portion of the structure. Roof drains, gutters, and downspouts must be provided and maintained in good repair and free from obstructions. Roof water must be discharged away from the foundation and may not be discharged in a manner that creates a public nuisance.

304.8 Decorative features. *{As in IPMC}*

304.9 Overhang extensions. *{As in IPMC}*

304.10 Stairways, floors, decks, etc. Every interior and exterior stairway, floor, deck, porch, and balcony, and all their appurtenances must be:

1. structurally sound,
2. properly anchored and capable of supporting the imposed loads, and
3. maintained in good repair and safe condition.

304.11 Chimneys and towers. *{As in IPMC}*

304.12 Handrails and guards. *{As in IPMC}*

1 **304.13 Window, skylight, and door frames. {As in IPMC}**

2 **304.14 Insect screens. {Not Adopted}**

3 **304.15 Doors.**

4 **304.15.1 General.**

- 5 1. All doors, door assemblies, and hardware must be maintained in good condition.
- 6 2. Except as otherwise required for means of egress doors, locks and latching
7 hardware must be provided at all entrances to dwelling units and rooming units
8 and must tightly secure the doors at those entrances.
- 9 3. Doors must fit properly within their frames.
- 10 4. Except for a building where the entrances are staffed by security personnel or
11 where unobstructed access is provided to the entrance of each unit, in a building
12 that contains 2 or more dwelling units, an electric doorbell must be provided for
13 each dwelling unit in that building.

14 **304.15.2 Interior.** Every interior door must be capable of being opened and closed by
15 being securely attached and properly equipped with properly functioning attachment and
16 latching hardware.

17 **304.16 Basement hatchways. {As in IPMC}**

18 **304.17 Guards for basement windows. {As in IPMC}**

19 **304.18 Building security. {As in IPMC}**

20 **304.19 Gates. {As in IPMC}**

21 **304.20 Interior surfaces.** All interior surfaces, including floors, walls, ceilings, windows,
22 and doors, must be maintained in good, clean, and sanitary condition. Peeling, chipping,
23 flaking, or abraded paint must be repaired, removed, or covered. Cracked or loose plaster,
24 decayed wood, and other defective surface conditions must be corrected. Floors in kitchens,
25 bathrooms, lavatories, toilet rooms, and laundry rooms must be kept impervious to water.

26 **304.21 Grading and drainage.** All premises must be graded and maintained to:

- 27 1. drain away from the foundation of any structure and away from adjoining property,
- 28 2. prevent the erosion of soil, and
- 29 3. prevent the accumulation of stagnant water.

30 **304.22 Sidewalks, driveways, etc.** All sidewalks, walkways, stairs, driveways, parking
31 spaces, and similar areas must be kept in good repair and free from hazardous conditions.

1 **304.23 Exhaust vents.** Pipes, ducts, conductors, fans, or blowers may not be allowed to
2 discharge gases, steam, vapor, hot air, grease, smoke, odors, or other gaseous or particulate
3 wastes directly on any abutting or adjacent public or private property or on any property
4 areas occupied by another in the same building.

5 **304.24 Accessory structures.** All accessory structures, including detached garages, fences,
6 gates, walls, and swimming pools, must be maintained in a structurally sound condition and
7 in good repair.

8 **304.25 Defaced property.** If an exterior surface of a structure has been defaced by
9 carvings, markings, or graffiti, the surface must be restored to an approved state of
10 maintenance and repair.

11 **304.26 Nuisance or hazardous conditions.** All premises must be kept free of any object,
12 material, or condition that constitutes a nuisance or a fire, accident, or health hazard.

13 **304.27 {Reserved}**

14 **304.28 Ratproofing.** All buildings must be ratproofed and maintained in a ratproof
15 condition by the owner or his agent. Ratproofing methods include:

- 16 1. preventing entrance by blocking passages with rat-resistant material, and
- 17 2. paving basements and any other areas that are in contact with the soil.

18 **304.29 Equipment.** All equipment required by the Building, Fire, and Related Codes of
19 Baltimore City must be maintained in good working condition.

20 **304.30 Fire protection.** All required fire protection, including separation between
21 nonresidential and residential occupancies, must be maintained in good repair. All fire doors
22 must be equipped and maintained as required by the Fire Code of Baltimore City.

23 Section 305 Exterior Sanitary Maintenance – General

24 **305.1 General.** All lots and exterior premises, including abutting sidewalks, gutters, and
25 alleys, must be maintained in a clean, safe, and sanitary condition.

26 **305.2 Grass and weeds.**

27 **305.2.1 “Weeds” defined.** In this section, “weeds” includes all plants and vegetation
28 other than:

- 29 1. trees or shrubs, or
- 30 2. cultivated flowers and gardens.

31 **305.2.2 Maintenance requirements.** All abutting sidewalks, gutters, and alleys must be
32 maintained free of grass, weeds, or plant growth in excess of 4 inches (102 mm). All
33 other premises and exterior property must be maintained free of grass, weeds, or plant
34 growth in excess of 8 inches (203 mm). All noxious weeds are prohibited.

1 **305.3 Trees and shrubbery.** All trees and shrubbery that are dangerous to life and property
2 or that create a fire or traffic hazard must be pruned or removed to eliminate the danger or
3 hazard.

4 **305.4 Pest control.** All exterior property areas must be kept free from infestation by
5 insects, rodents, and other pests, from rodent harborage, and from the conditions that attract
6 pests. Where pests are found, they must be promptly exterminated by approved processes
7 that will not be injurious to human health.

8 **305.5 Motor vehicles and trailers.** Except only as otherwise expressly authorized by law,
9 the following rules apply to all motor vehicles and trailers.

10 1. No motor vehicle or trailer may be parked, kept, or stored, whether or not covered,
11 on any exterior premises if:

12 a. it is inoperative, unregistered, or fails to display current registration tags, or

13 b. it is in a state of disassembly or disrepair or in the process of being stripped
14 or dismantled.

15 2. A motor vehicle or trailer may be parked, kept, or stored only on a dustless all-
16 weather surface constructed and maintained in accordance with the Baltimore City
17 Building Code and Baltimore City Zoning Code.

18 3. Painting a motor vehicle or trailer is prohibited unless conducted inside an approved
19 spray booth.

20 **Exception:** On premises with a proper use permit, a vehicle may undergo overhaul,
21 including body work, if that work is performed inside a structure or similarly enclosed
22 area designed and approved for that purpose.

23 **305.5.1 Registered owner responsible.** For a motor vehicle or trailer parked, kept, or
24 stored in violation of § 305.5(1) or (2), the registered owner of the motor vehicle or
25 trailer is responsible for the violation, jointly and severally with the property owner.

26 **305.6 Swimming pools.** Swimming pools must be maintained in a clean, safe, and sanitary
27 condition.

28 **305.7 Outdoor storage.** Outdoor storage must be neat and orderly. All stored objects and
29 materials must be elevated at least 1 foot off the ground to prevent rat harborage, unless
30 elevation is determined unnecessary by the Commissioner.

31 **305.7.1 Caveat.** Nothing in this section authorizes any outdoor storage that is otherwise
32 prohibited by law.

33 **305.8 PLACEMENT OUTDOORS OF UPHOLSTERED FURNITURE.** NO PERSON MAY PLACE, USE,
34 KEEP, STORE, OR MAINTAIN ANY UPHOLSTERED FURNITURE NOT MANUFACTURED FOR
35 OUTDOOR USE, INCLUDING, FOR EXAMPLE, ANY UPHOLSTERED CHAIR, SOFA, OR COUCH, OR
36 ANY MATTRESS, IN ANY OUTSIDE AREA LOCATED:

1 **1. IN ANY FRONT, SIDE, OR REAR YARD, OR**

2 **2. ON ANY COVERED OR UNCOVERED PORCH, PATIO, OR DECK LOCATED IN OR ADJOINING**
3 **ANY FRONT, SIDE, OR REAR YARD.**

4 **305.9 [305.8] Snow and ice on sidewalks.** After any snowfall that results in an
5 accumulation of snow or ice on the ground, the snow and ice must be removed and cleared
6 away from all sidewalks that abut the premises.

7 **305.9.1 [305.8.1] Time for compliance.** The snow and ice must be removed and
8 cleared away:

- 9 1. within 6 hours after the snow has stopped falling; or
- 10 2. if the snow stopped falling between 3 p.m. and 6 a.m., before 11 a.m.

11 **305.9.2 [305.8.2] Manner of compliance.** The snow and ice must be removed and
12 cleared away in a manner that:

- 13 1. leaves a clear path that is at least 2 feet wide; and
- 14 2. does not obstruct the passage of water in the gutters.

15 **Section 306 Exterior Sanitary Maintenance – Trash, Garbage, and Debris**

16 **306.1 Accumulation prohibited.** All premises, including abutting sidewalks, gutters, and
17 alleys, as well as the interior of every structure, must be kept free of any accumulation of
18 trash, garbage, and debris, including any animal waste, construction material, equipment,
19 furniture, appliances, and similar objects and materials.

20 **306.2 Bulk trash.** If discarded or abandoned articles are too large to be disposed of in
21 required receptacles, they must be conveyed to an appropriate landfill or other approved
22 disposal site.

23 **306.3 No deposit on sidewalks, etc.** No trash, garbage, or debris may be deposited on any
24 sidewalk, alley, or street or on any public or private lot, except as specified in §§ 306.4
25 through 306.7 of this Chapter.

26 **306.4 Storage receptacles – Required.** Trash, garbage, or debris may not be stored or
27 placed out for collection except in approved storage receptacles. The owner or operator of
28 every occupied premises must provide a sufficient number of these storage receptacles to
29 receive and store trash, garbage, and debris from individual units between days of collection.
30 The receptacles must be maintained in a location accessible to occupants.

31 **306.5 Storage receptacles – Location.** If, in the opinion of the Code Official, the exterior
32 maintenance of storage receptacles is causing nuisance or blight, the Code Official may
33 require that, between days of collection, the receptacles be stored:

- 34 1. inside the building they serve, or
- 35 2. in the discretion of the Code Official, within a contiguous structure.

1 **306.6 Storage receptacles – Specifications and maintenance.**

2 **306.6.1 Specifications.**

3 **306.6.1.1 General.** Each storage receptacle must:

- 4 1. be made of metal or some other durable material approved by the Code
5 Official,
- 6 2. be watertight, with tight-fitting covers and handles, and
7
- 8 3. either:
 - 9 a. have a capacity of not more than 32 gallons, or
 - 10 b. be a City-owned trash receptacle assigned to the address for the
11 curbside collection of mixed refuse.

12 **306.6.1.2. Exceptions.**

- 13 1. Receptacles used for recycling need not have covers.
- 14 2. Yard waste may be bagged or bundled.

15 **306.6.2. Maintenance.** Each storage receptacle must be:

- 16 1. maintained in good repair, and
- 17 2. kept tightly closed to prevent blight, nuisance, pest infestation, and
18 dispersal of trash, garbage, or debris.

19 **306.7 Placement for collection.** Storage receptacles:

- 20 1. should be placed out for collection no later than 6 a.m. of the day of collection,
- 21 2. may not be placed out on any sidewalk or along an alley earlier than 6 p.m. of
22 the evening before the day of collection, and
- 23 3. if placed on a sidewalk or along an alley, must be returned to the premises no
24 later than 6 a.m. on the day after collection.

25 **306.8 Owner transport.** At any building for which the City does not provide collection
26 services, the owner and operator must collect and transport the building's trash, garbage, and
27 debris to an appropriate landfill or other approved disposal site.

28 **Section 307 Interior Sanitary Maintenance**

29 **307.1 General.** The interior of each unit and the shared, common, or public areas within
30 each building that contains more than one unit must be maintained in a clean and sanitary
31 condition.

1 **307.2 Floor, furniture, etc., surfaces.** Floors, furniture, countertops, and similar surfaces
2 must be clean and free of trash, garbage, and debris, including human and animal waste and
3 any other insanitary matter or cause of nuisance.

4 **307.3 Walls, ceilings, and openings.** Walls, ceilings, windows, and doorways must be
5 clean and free of dirt, grease, soot, and any other insanitary matter or cause of nuisance.

6 **307.4 Trash, etc., receptacles.** Each unit must have a sufficient number of interior
7 receptacles to contain that unit's trash, garbage, and debris.

8 **307.5 Plumbing fixtures.** Plumbing fixtures must be kept clean and free from any foreign
9 object or material that could obstruct a fixture or a line connected to a fixture.

10 **307.6 {Reserved}**

11 **307.7 Pest control.** The interior of every building must be kept free of infestation by
12 insects, rodents, and other pests.

13 Section 308 Occupants' Sanitary Responsibilities.

14 **308.1 General.** An occupant must keep in a clean and sanitary condition the occupant's unit
15 and any other part of the premises that the occupant occupies or controls. However, the
16 owner and operator is responsible for any insanitary condition caused by a sewer back-up or
17 a structural defect.

18 **308.2 Exteriors.** An occupant of a single-unit building and an occupant of a unit with
19 exclusive use of an exterior property area must maintain the exterior areas, including abutting
20 sidewalks, gutters, and alleys, in compliance with § 305 {"Exterior ... maintenance –
21 General"} and § 306 {"Exterior ... maintenance – Trash, garbage..."} of this Chapter.
22 However, the owner and operator are responsible for any insanitary condition caused by a
23 sewer back-up or a structural defect.

24 **308.2.1 Exception – Residential property registration.** The owner of a property is
25 responsible for exterior sanitary maintenance under any of the circumstances described
26 in Building Code § 114.21.2b {"Liability – Failure to register property"}.

27 **308.2.2 Exception – Third environmental citation.** The owner of a property is
28 responsible for exterior sanitary maintenance under the circumstances described in
29 Building Code § 114.21.2c {"Liability – Third environmental citation"}.

30 **308.2.3 EXCEPTION – SECONDARY LIABILITY.** THE OWNER AND OPERATOR OF A
31 PROPERTY ARE RESPONSIBLE FOR EXTERIOR SANITARY MAINTENANCE UNDER ANY OF THE
32 CIRCUMSTANCES DESCRIBED IN BUILDING CODE § 114.21.2A {"SECONDARY LIABILITY"}.

33 **308.3 Interiors.** Except as otherwise specified in § 308.5, an occupant must maintain the
34 interior of the occupant's unit and any other part of the building that the occupant occupies or
35 controls in compliance with § 307 {"Interior ... maintenance"} of this Chapter.

36 **308.4 Pest control – Single-unit building.** An occupant of a single-unit building is
37 responsible for extermination of insects, rodents, or other pests, other than wood-destroying
38 insects.

1 **404.2 Minimum room size.** A habitable room, other than a kitchen, may not be less than
2 7 feet (2134 mm) in any plane dimension.

3 **404.2.1 Kitchens.** A kitchen must contain at least 35 sq. ft (3.25 sq. m.) of floor area,
4 and, if arranged as a corridor the corridor between counter fronts or between a wall and
5 counter fronts must be at least 3 feet (914 mm).

6 **404.3 Minimum ceiling heights.** Habitable spaces hallways, corridors, laundry areas, and
7 bathrooms must have a clear ceiling height of not less than 7 feet (2134 mm) over at least
8 50% of the floor area. Toilet rooms must have a ceiling height of not less than 6½ feet
9 (1981 mm) over at least 50% of the floor area

10 **Exceptions:**

- 11 1. *{Not Adopted}*
- 12 2. Basement rooms that otherwise meet the requirements of this § 404.3 may have
13 a clear height of not less than 6 feet (1829 mm) under beams, girders, ducts, and
14 similar obstructions.
- 15 3. Rooms occupied exclusively for sleeping, study, or similar purposes and having a
16 sloped ceiling over all or part of the room may have a clear ceiling height of not
17 less than 7 feet (2134 mm) over not less than 33⅓% of the required minimum
18 floor area.
- 19 4. As allowed by regulations of the Code Official.

20 **404.3.1 Floor area calculations.** In calculating floor area for purposes of this § 404.3,
21 only those portions of the floor area with a clear height of 5 feet (1524 mm) or more may
22 be included.

23 **404.4 Bedroom requirements.** Every bedroom must comply with the requirements of this
24 § 404.4.

25 **404.4.1 Area for sleeping purposes.** Every bedroom occupied by 1 person must
26 contain at least 70 sq. ft. (6.5 sq. m.) of floor area. Every bedroom occupied by more
27 than one person must contain at least 50 sq. ft. (4.6 sq. m.) of floor area for each occupant
28 of the bedroom.

29 **404.4.2 to 404.4.5** *{As in IPMC}*

30 **404.5 Overcrowding.** Dwelling units may not be occupied by more occupants than
31 permitted by the minimum area requirements of Table 404.5.

32 **404.5.1 Sleeping area.** The minimum occupancy area required by Table 404.5 may not
33 be included as a sleeping area in determining the minimum occupancy area for sleeping
34 purposes. All sleeping areas must comply with § 404.4.

35 **404.5.2 Combined spaces.** Combined living room and dining room spaces must comply
36 with the requirements of Table 404.5 if:

- 1. the total area is equal to that required for separate rooms, and
- 2. the space is located so as to function as a combination living room/dining room.

404.6 Efficiency unit. {Not Adopted}

404.7 Food preparation. A dwelling unit must contain a room or space for the storage, preparation, and cooking of food, including a sink and space and connections for a stove and refrigerator.

404.8 Closets. A dwelling unit must contain at least 1 closet, for storing clothing and other articles, with a floor area of not less than 6 sq. ft. (0.6 sq. m.). A dwelling unit with more than 1 bedroom must contain at least 1 additional closet of the same minimum size.

16 **603.1 General.** All mechanical equipment provided must be properly installed and
17 maintained in a safe condition. In addition, all required mechanical equipment must be
18 maintained in a safe working condition and must be capable of performing its intended
19 function.

§ 8-101. City adoption.

(a) *In general.*

The International Fire Code ([2015] 2018 Edition) is adopted as part of the Building, Fire, and Related Codes of Baltimore City, subject to the additions, deletions, amendments, and other modifications contained in this Part VIII.

(b) *Codification.*

Unless otherwise specified, chapter and section numbers in this Part VIII refer to the chapter and section numbers of the International Fire Code.

§ 8-102. City modifications.

28 necessary or appropriate to enforce this Code. Nothing in this Code prevents the Fire
29 Code Official from instituting or causing to be instituted and fully prosecuting any and all
30 legal or equitable proceedings of any kind necessary or appropriate to compel compliance
31 with this Code, even if criminal proceedings are pending or have been completed.

2 **104.9 Alternative materials and methods.** The provisions of this Code are not intended to
3 prevent the installation of any material or to prohibit any method of construction not

6 finds in writing that, for the purpose intended:

- 7 1. the proposed alternative is satisfactory and complies with the intent of this Code, and
- 8 2. the material, method, or work offered is at least the equivalent of that prescribed
9 in this Code in quality, strength, effectiveness, fire resistance, durability, and safety.

10 **104.10 Fire investigations.** *{As in IFC}*

11 **104.10.1 Fire Investigation Bureau; Fire Marshal.** The Fire Investigation Bureau is
12 continued in the Fire Department. The Bureau consists of members assigned to it by the
13 Chief of the Fire Department. The head of the Bureau is the Fire Marshal of Baltimore
14 City, to be designated by the Chief. The Chief may also designate one or more officers
15 or officials to serve in the absence of the Fire Marshal.

16 **104.10.2 General duties.** The Fire Investigation Bureau investigates fires and related
17 incidents in Baltimore City. The Bureau must keep a complete record of these fires and
18 related incidents, including their cause and origin, and a complete record of its
19 investigations. The Assistant Chief or his or her designee is the custodian of all records
20 of investigations. In addition to the duties specified in this section, the Bureau performs
21 all other duties assigned to it by law or by the Chief of the Fire Department.

22 **104.10.3 Charge of evidence.** In investigating a fire or related incident, the Bureau
23 must take charge immediately of the physical evidence and, to preserve that evidence,
24 take measures to prevent access by any person to the structure or premises until the
25 evidence has been properly processed.

26 **104.10.3.1 Cooperation with other agencies.** The Bureau must notify the persons
27 designated by law to pursue investigations, cooperate with authorities in collecting
28 evidence and in prosecuting offenders, and pursue the investigation to its conclusion.

29 **104.10.3.2 Assistance from other agencies.** Police and other enforcement agencies
30 are authorized to render assistance in the investigation of fires when requested to do
31 so.

32 **104.10.4 Authority of Fire Marshal.** The Fire Marshal has general supervision and
33 control of all fire investigations in the City and of all inquiries to determine their cause
34 and origin, both for the purpose of eliminating that cause and, if arson or incendiaries is
35 suspected, to ascertain the persons responsible.

36 **104.10.5 Penalty for obstructing investigation.** Any person who prevents or obstructs
37 or attempts to prevent or obstruct an investigation is guilty of a misdemeanor and, on
38 conviction, is subject to the penalties specified in **[§ 109] § 110** *{“Violations”}* of this
39 Code.

1 **104.10.6 Subpoena of witness and documents.** In conducting an investigation, the Fire
2 Marshal may subpoena and compel attendance of any person and the production of any
3 documents that, in the judgment of the Fire Marshal, are connected with and necessary to
4 the investigation, and have that person examined on oath or affirmation at the time and
5 place specified in the subpoena. Officers of the Baltimore Police Department may serve
6 the subpoena.

7 **104.10.7 Enforcement of subpoena.** If a person is served with a subpoena and fails to
8 attend and testify, or fails on examination to answer any question, or otherwise fails to
9 comply with the subpoena, the Fire Marshal may apply to a judge of the Circuit Court of
10 Baltimore City to order compliance to the subpoena. If the judge orders compliance, the
11 Fire Marshal must so notify the person named in the subpoena and fix the time and place
12 for his or her further examination. If the person still fails to comply, the person may be
13 arrested and charged with contempt.

15 affirmations. Any false testimony given under oath or affirmation administered by the
16 Fire Marshal, if material and made willfully, is punishable as perjury.

17 **104.10.9 Submission to State's Attorney.** If gross negligence, arson, or incendiaries is
18 reasonably evident in a case, the Fire Marshal must submit all of the Bureau's records on
19 the case to the State's Attorney of Baltimore City.

22 annually review a fee schedule for non-fire suppression services performed by the Fire

28 aggrieved by a Board decision made under **[§ 108.4] § 109.4** of this Code may seek judicial

30 the Maryland Rules of Procedure. A party to the judicial review may appeal the court's final
31 judgment to the Court of Special Appeals in accordance with the Maryland Rules of

3. if the violation affects the immediate safety of the public, request the Baltimore Police Department to arrest those responsible for the violation.

110.5 [109.5] Violation of notices, etc. – Constitutes violation of Code. Every person must fully comply with all provisions of this Code and with all provisions of any notice, order, decision, permit, or regulation issued by the Fire Code Official. Any act contrary to and any failure to comply with any provision or requirement of any notice, order, decision, permit, or regulation of the Fire Code Official constitutes a violation of this Code.

PART XI. INTERNATIONAL GREEN CONSTRUCTION CODE

§ 11-101. City adoption.

(a) *In general.*

The International Green Construction Code (2012 Edition) is adopted as part of the Building, Fire, and Related Codes of Baltimore City, subject to the additions, deletions, amendments, and other modifications contained in this Part XI.

(b) *Codification.*

Unless otherwise specified, chapter and section numbers in this Part XI refer to the chapter and section numbers of the International Green Construction Code.

§ 11-102. City modifications.

The additions, deletions, amendments, and other modifications adopted by the City are as follows:

Chapter 1 Scope and Administration

Section 101 General

101.1 Title. The regulations contained in this Code constitute and are known as the “Baltimore Green Construction Code”.

101.1.1 References to “this Code”. Throughout this Part XI, all references to “this Code” refer to the Baltimore City Green Construction Code.

101.2 Code as an overlay document. This Code is an overlay document to be used in conjunction with the other codes and standards adopted by the City. This Code is not intended to be used as a stand-alone construction regulation document, and permits are not to be issued under this Code. This Code is not intended to abridge or supersede any health, safety, or environmental requirements of any other applicable law, code, or standard.

101.3 Scope and Application. This Code applies to the design, construction, addition, alteration, change of occupancy, relocation, replacement, repair, equipment, building site, maintenance, removal, and demolition of every structure and any appurtenances connected or attached to a structure and to the site on which the structure is located. Occupancy classifications are determined in accordance with the Baltimore City Building Code.

Exceptions: This Code does not apply to:

1. A 1- or 2-family dwelling, including accessory structures, regulated by the International Residential Code for One- and Two-Family Dwellings ([2015] 2018 Edition).
2. A multiple-family dwelling that is no more than 3 stories above grade plane in height and contains no more than 5 dwelling units.

- 1 3. A structure that achieves, as certified by the Green Building Certification
2 Institute, a silver-level or higher rating in the U.S. Green Building Council's
3 LEED (Leadership in Energy and Environmental Design) rating system.

5 height, including their accessory structures and the site or lot on which these
6 buildings are located, that, as certified by a third-party approved by the Code
7 Official, comply with the requirements of the ICC 700 ("National Green Building
8 Standard"), as follows:
 - 9 (i) for energy efficiency category requirements, at the Silver performance
10 level or equivalent, and
 - 11 (ii) for all other ICC 700 categories and chapters, at the Bronze performance
12 level or equivalent.

- 13 5. Group R-2 and R-4 portions of mixed use buildings that, as certified by a third-
14 party approved by the Code Official, comply with the requirements of the ICC
15 700 ("National Green Building Standard"), as follows:
 - 16 (i) for energy efficiency category requirements, at the Silver performance
17 level or equivalent, and
 - 18 (ii) for all other ICC 700 categories and chapters, at the Bronze performance
19 level or equivalent.

- 20 The remainder of the building and the site on which the building is located must
21 comply with the provisions of this Code.

- 22 6. A structure that has been designed and, as verified by the Code Official or an
23 entity approved by the Code Official, constructed in compliance with the
24 Standard for the Design of High-performance Green Buildings, Except Low-rise
25 Residential Buildings", adopted by American Society of Heating, Refrigerating
26 and Air-Conditioning Engineers, Inc. (ASHRAE 189.1).

- 27 7. A structure that, as certified by Enterprise Community Partners, Inc., complies
28 with Enterprise Green Communities Criteria.

- 29 8. A temporary structure approved under Building Code § 3103 {"Temporary
30 Structures"}.

- 31 9. Equipment or systems that are used primarily for industrial or manufacturing
32 purposes.

Chapter 9 Commissioning

Section 901 General

901.1 Scope. This chapter is intended to facilitate the commissioning of buildings constructed in accordance with this Code. Its requirements apply only to equipment and systems that are covered by this Code and are new or being wholly replaced.

Section 902 Approved Agency

902.1 General. The Code Official must determine the required qualifications of an approved agency for purposes of this chapter

902.1.1 Owner's duties. For commissioning required by this Code, the owner must identify the individual or firm who will be performing the commissioning and providing the requisite certifications and verifications.

902.1.2 Approved agency's duties. The approved agency must comply with the commissioning requirements set forth in this Code.

Section 903 Commissioning

903.1 General. Where application is made for construction as described in this section, the registered design professional in responsible charge or the approved agency must perform commissioning during construction as required by Table 903.1. The approved agency must be qualified and must demonstrate competence, to the satisfaction of the Code Official, for the commissioning of the particular type of construction or operation. The registered design professional in responsible charge and the engineer of record involved in the design of the project may act as the approved agency if those persons meet the required qualifications to the satisfaction of the Code Official.

903.1.1 to 903.1.2 *{Not Adopted}*

903.2 Records and commissioning reports. The approved agency must:

1. keep records of the commissioning required by Table 903.1, and
2. furnish commissioning reports to:
 - a. the owner,
 - b. the registered design professional in responsible charge, and
 - c. on request, the Code Official.

903.2.1 Scope of reports. These reports must indicate whether work was or was not completed in conformance to approved construction documents.

903.2.2 Discrepancies. Discrepancies must be brought to the immediate attention of the contractor for correction. If the discrepancies are not corrected, they must be brought to the attention of the owner, the Code Official, and the registered design professional in responsible charge before completion of that phase of the work.

903.3 Preliminary Commissioning Report. Before the final inspection, a Preliminary Commissioning Report must be provided to the owner and, on request, to the Code Official.

903.4 Final Commissioning Report. Within 180 days after issuance of an occupancy permit, a Final Commissioning Report must be provided to the owner and, on request, to the Code Official.

9 to receive an open and interoperable Auto-DR relay or Internet signal. Building HVAC and
10 lighting systems and specific building energy-using components must incorporate
11 preprogrammed demand response strategies that are automated with a demand response
12 automation Internet software client.

13 **Exception:** Auto-DR infrastructure is not required for the following:

- 14 1. Buildings located where the electric utility or Regional Independent System
15 Operator (“RISO”) or Regional Transmission Operator (“RTO”) does not offer a
16 demand response program to buildings regulated by this Code.
- 17 2. Buildings with peak electric demand is no greater than 0.75 times that of the
18 standard reference design.
- 19 3. Buildings that have incorporated onsite renewable energy generation to provide
20 20% or more of the building’s energy demand.

21 **A106.7.2 Software clients.** Demand response automation software clients shall be
22 capable of communicating with a demand response automation server via the Internet or
23 other communication relay.

24 **A106.7.3 Heating, ventilating, and air-conditioning systems.** The Auto-DR strategy
25 for HVAC systems must be capable of reducing the building’s peak cooling or heating
26 HVAC demand by at least 10% when signaled from the electric utility, RISO, or RTO
27 through any combination of the strategies and systemic adjustments, including the
28 following:

- 29 1. space temperature setpoint reset,
- 30 2. increasing chilled water supply temperatures or decreasing hot water supply
31 temperatures,
- 32 3. increasing or decreasing supply air temperatures for variable air volume (“VAV”) systems,
33
- 34 4. limiting capacity of HVAC equipment that has variable or multiple-stage capacity
35 control,
- 36 5. cycling HVAC equipment or turning off noncritical equipment,
- 37 6. disabling HVAC in unoccupied areas,

- 1 7. limiting the capacity of chilled water, hot water, and refrigerant control valves,
- 2 8. limiting the capacity of supply and exhaust fans, without reducing the outdoor air
- 3 supply below the minimum required by Chapter 4 of the International Mechanical
- 4 Code, or the minimum required by ASHRAE 62.1.
- 5 9. limiting the capacity of chilled water or hot water supply pumps, and
- 6 10. anticipatory control strategies to precool or preheat in anticipation of a peak
- 7 event.

8 **Exception:** The Auto-DR strategy is not required for the following buildings and

9 systems:

- 10 1. hospitals and critical emergency response facilities,
- 11 2. life safety ventilation for hazardous materials storage,
- 12 3. building smoke exhaust systems, and
- 13 4. manufacturing process systems.

14 **A106.7.4 Rebound avoidance.** The Auto-DR strategy must include logic to prevent a

15 rebound peak. When the signal for Auto-DR is ended, a gradual return to normal HVAC

16 equipment operations must be part of the Auto-DR strategy, through any combination of

17 strategies and systemic adjustments, including the following:

- 18 1. when close to the unoccupied period, extension of the Auto-DR period by using a
- 19 rebound avoidance, extended Auto-DR control strategy, until initiation of the
- 20 unoccupied period.
- 21 2. rebound avoidance, slow recovery control strategies, gradually increasing or
- 22 decreasing space temperature setpoints or a variance in the timing by cooling or
- 23 heating zone,
- 24 3. rebound avoidance, slow recovery control strategies, gradually increasing or
- 25 decreasing zone supply air temperatures,
- 26 4. rebound avoidance, slow recovery control strategies, gradually increasing or
- 27 decreasing chilled water temperatures or decreasing hot water temperatures,
- 28 5. rebound avoidance, sequential equipment recovery strategies, gradually restoring
- 29 demand limited equipment capacity,
- 30 6. rebound avoidance, sequential equipment recovery strategies, gradually restoring
- 31 equipment that was turned off during the Auto- DR period,
- 32 7. rebound avoidance, slow recovery control strategies, gradually increasing
- 33 capacity for air moving and pumping systems, and

- 1 8. rebound avoidance, sequential equipment recovery or rebound avoidance, slow
 2 recovery control where chilled water or hot water and other capacity control
 3 valves are sequentially or gradually allowed to return to normal operation,
 4 respectively.

5 **A106.7.5 Lighting.** In Group B office spaces, the Auto-DR system must be capable of
 6 reducing total connected power of lighting, as determined in accordance with [§ 405.5]
 7 § 405.3 {“INTERIOR LIGHTING POWER REQUIREMENTS”} of the International Energy
 8 Conservation Code - COMMERCIAL PROVISIONS, by at least 15%.

9 **Exception:** The following buildings and lighting systems need not be addressed by
 10 the Auto-DR system:

- 11 1. buildings or portions of buildings associated with lifeline services,
 12 2. luminaires on emergency circuits,
 13 3. luminaires located in emergency and life safety areas of a building,
 14 4. lighting in buildings that are less than 5,000 square feet (465 m²) in total
 15 building floor area,
 16 5. luminaires within a daylight zone that are dimmable and connected
 17 to automatic daylight controls that comply with [§ 405.2.2.3.2] § 405.2.3
 18 {“DAYLIGHT-RESPONSIVE CONTROLS”} of the International Energy
 19 Conservation Code - COMMERCIAL PROVISIONS, and
 20 6. signage used for emergency, life safety, or traffic control purposes.

PART XII. INTERNATIONAL SWIMMING POOL AND SPA CODE

§ 12-101. City adoption.

(a) *In general.*

The International Swimming Pool and Spa Code ([2015] 2018 Edition) is adopted as part of the Building, Fire, and Related Codes of Baltimore City, subject to the additions, deletions, amendments, and other modifications contained in this Part XII.

(b) *Codification.*

Unless otherwise specified, chapter and section numbers in this Part XII refer to the chapter and section numbers of the International Swimming Pool and Spa Code.

§ 12-102. City modifications.

The additions, deletions, amendments, and other modifications adopted by the City are as follows:

Chapter 1 Scope and Administration

Section 101 General

101.1 Title. The regulations contained in this Code constitute and are known as the “Baltimore City Swimming Pool and Spa Code”.

101.1.1 References to “this Code”. Throughout this Part XII, all references to “this Code” refer to the Baltimore City Swimming Pool and Spa Code.

2 **612.1 DEFINITIONS.** IN THIS CHAPTER, “SPLASH PAD” (ALSO KNOWN AS “SPRAY PAD”,
3 “WET DECK”, OR “INTERACTIVE WATER PLAY FEATURE”) MEANS ANY INDOOR OR OUTDOOR
4 STRUCTURE DESIGNED TO ALLOW FOR PUBLIC RECREATIONAL ACTIVITIES WITH
5 RECIRCULATED, FILTERED, AND TREATED WATER THAT:

- 6 1. INCLUDES SPRAYED, JETTED, OR OTHER WATER SOURCES CONTACTING BATHERS,
7 BUT
- 8 2. DOES NOT INCORPORATE STANDING OR CAPTURED WATER AS PART OF THE BATHER
9 ACTIVITY AREA.

10 **612.2 GENERAL.** CONSTRUCTION AND OPERATION OF ANY SPLASH PAD MUST COMPLY WITH
11 §§ 612.3 THROUGH 612.8.

12 **612.3 SAFETY HAZARDS.** ALL PARTS OF THE SPLASH PAD THAT CAN BE ACCESSED BY SPLASH
13 PAD USERS MUST BE DESIGNED AND CONSTRUCTED TO NOT PRESENT SAFETY HAZARDS TO THE
14 USERS.

15 **612.4 DECKING.** A DECK OF NOT LESS THAN 4 FEET (1296 MM) IN WIDTH MUST BE PROVIDED
16 AROUND THE PERIMETER OF THE SPLASH PAD. THE DECK MUST BE SLOPED AWAY FROM THE
17 SPLASH PAD.

18 **612.5 SPLASH PAN ZONE.** THE SPLASH PAD ZONE MUST COMPLY WITH §§ 612.5.1 THROUGH
19 612.5.3.

20 **612.5.1 SURFACE.** SPLASH PAD ZONE SURFACES MUST HAVE A SLIP-RESISTANT AND
21 CLEANABLE SURFACE. THE MANUFACTURER OF MANUFACTURED ZONE SURFACES MUST
22 CERTIFY THAT THE SURFACING IS SUITABLE FOR AQUATIC AND CHLORINATED
23 ENVIRONMENTS. DIRECT SUCTION OUTLETS FROM A SPLASH PAD ARE PROHIBITED.

24 **612.5.2 SLOPE AND WATER COLLECTION.** SPLASH PAD ZONE SURFACES MUST SLOPE
25 TO ONE OR MORE DRAIN POINTS SO THAT ONLY WATER FROM THE SPLASH PAN ZONE
26 FLOWS BACK TO A GRAVITY FED COLLECTION TANK. THE SLOPE MUST PREVENT THE
27 ACCUMULATION OR POOLING OF WATER AND MAY NOT EXCEED ½ INCH (12.7 MM) PER
28 FOOT. DRAIN OPENINGS IN THE SPLASH PAD ZONE SURFACES THAT CAN BE ACCESSED
29 BY USERS MAY NOT ALLOW A ½ INCH (12.7 MM) DIAMETER DOWEL ROD TO BE INSERTED
30 INTO THE OPENING. DRAIN COVERS IN SPLASH PAD ZONE SURFACES MUST BE FLAT AND
31 FLUSH WITH THE ZONE SURFACE AND MUST REQUIRE TOOLS FOR REMOVAL. THE
32 MANUFACTURER OF THE DRAIN COVER MUST CERTIFY THAT THE COVERS COMPLY WITH
33 THE PHYSICAL TESTING AND FINGER-AND-LIMB ENTRAPMENT REQUIREMENTS OF
34 SECTIONS 3 AND 6, RESPECTIVELY, OF APSP 16.

35 **612.5.3 NOZZLES WITHIN SPLASH PAD ZONES.**

36 **612.5.3.1 GENERAL.** NOZZLES THAT SPRAY WATER FROM THE SPLASH PAD ZONE
37 MUST BE FLUSH WITH THE ZONE SURFACE. OPENINGS IN THE NOZZLES MAY NOT
38 ALLOW A ½ INCH (12.7 MM) DIAMETER DOWEL ROD TO BE INSERTED INTO THE
39 OPENING. THE WATER VELOCITY FROM THE ORIFICE OF ANY WATER NOZZLE MAY NOT
40 EXCEED 20 FEET (6.1 M) PER SECOND.

1 **612.5.3.2 NOZZLES NOT ON WALKING SURFACES.** NOZZLES THAT ARE NOT ON
2 WALKING SURFACES MUST BE DESIGNED TO BE CLEARLY VISIBLE.

3 **612.6 WATER SANITATION.** THE WATER SANITATION MUST CONSIST OF THE EQUIPMENT
4 COVERED IN §§ 612.6.1 THROUGH 612.6.5.

5 **612.6.1 WATER COLLECTION AND TREATMENT TANK.** A SPLASH PAD MUST DRAIN TO
6 A COLLECTION AND TREATMENT TANK. THE INSIDE OF THE TANK MUST BE ACCESSIBLE
7 FOR CLEANING AND INSPECTION. THE ACCESS HATCH OR LID MUST BE LOCKED OR
8 REQUIRE A TOOL TO OPEN. THE TANK CAPACITY MAY NOT BE LESS THAN 1,000 GALLONS
9 OR 10 TIMES THE NUMBER OF GALLONS IN A MINUTE WHEN ALL NOZZLES ARE OPERATING
10 SIMULTANEOUSLY, WHICHEVER IS GREATER. THE VOLUME WATER IN THE TANK, AT THE
11 DESIGN WATER LEVEL, MAY NOT DECREASE MORE THAN 15% OF THAT VOLUME WHEN
12 ALL PUMPS AND DISCHARGE PIPING FILL WITH WATER TO THE DISCHARGE POINTS OF ALL
13 NOZZLES. THE TANKS MUST BE PROVIDED WITH A MEANS TO EMPTY ALL WATER IN THE
14 TANK FOR THE PURPOSES OF SERVICING OR CLEANING.

15 **612.6.2 FILTRATION PUMP.** THE FILTRATION PUMP MUST BE SIZED TO TURNOVER THE
16 SURGE BASIN CAPACITY IN 30 MINUTES OR LESS. THE INTAKE FOR THE PUMP MUST BE
17 LOCATED TO DRAW WATER FROM THE LOWEST ELEVATION IN THE TREATMENT TANK.

18 **612.6.3 SPRAY NOZZLE AND WATER FEATURE DISINFECTION.** SPRAY NOZZLES AND
19 WATER FEATURES MUST BE SUPPLIED BY WATER FROM THE WATER COLLECTION AND
20 TREATMENT TANK THAT IS EQUIPPED WITH FILTRATION AND SANITIZING EQUIPMENT
21 REQUIRED BY CHAPTER 3 AND THIS CHAPTER WHERE SEPARATE WATER FEATURE PUMPS
22 ARE INSTALLED, CONTROLS MUST PREVENT THOSE PUMPS FROM OPERATING WHEN THE
23 FILTRATION PUMP IS NOT OPERATING.

24 **612.6.4 DISINFECTION SYSTEM.** IN ADDITION TO ANY FILTRATION AND SANITIZING
25 EQUIPMENT REQUIREMENTS OF CHAPTER 3 AND THIS CHAPTER, ALL WATER SUPPLIED TO
26 SPRAY NOZZLES OR OTHER WATER THAT CAN BE ACCESSED BY A USER, MUST PASS
27 THROUGH A SECONDARY DISINFECTION SYSTEM BEFORE DISCHARGE TO THE USER. THE
28 SECONDARY DISINFECTION SYSTEM MUST BE LISTED AND LABELED TO NSF 50 AS HAVING
29 A SINGLE-PASS, THREE-LOG REDUCTION OF CRYPTOSPORIDIUM SURROGATE.

30 **612.6.5 MAKE-UP WATER SYSTEM.** THE WATER COLLECTION AND TREATMENT TANK
31 MUST BE PROVIDED WITH A MAKE-UP WATER SYSTEM THAT IS SUPPLIED WITH POTABLE
32 WATER.

33 **612.7 OPERATING INSTRUCTIONS.** IN ADDITION TO THE DOCUMENTATION AND INSTRUCTION
34 REQUIREMENTS OF CHAPTERS 1 AND 3, THE OPERATING INSTRUCTIONS FOR A SPLASH PAD
35 MUST REQUIRE THAT THE CIRCULATION SYSTEM BE OPERATED CONTINUOUSLY FOR NOT LESS
36 THAN 4 TURNOVERS PRIOR TO OPERATION OF THE PUMPS FOR THE SPRAY NOZZLES AND OTHER
37 WATER FEATURES SYSTEMS.

38 **612.8 LIGHTING.** WHERE A SPLASH PAD WILL BE IN OPERATION AT NIGHT OR DURING
39 PERIODS OF INADEQUATE NATURAL LIGHTING, ARTIFICIAL LIGHTING MUST BE PROVIDED IN
40 ACCORDANCE WITH THE SAME REQUIREMENTS FOR POOL DECK AREA LIGHTING IN § 321.2.2.

Part 7. Animated Riding Devices

§ 2-46. Building Code.

The provisions of [§ 428.9] § 432.9 of the Baltimore City Building Code, which relate to the electrical and mechanical requirements for certain circuses and carnivals, apply in all respects to the animated riding devices provided for in this Part 7. However, no other provisions of [§ 428] § 432 of the Building Code apply to animated riding devices.

Part 8. Mobile Riding Units

§ 2-55. Building Code; time limit on operation.

(a) *Building Code.*

Subject to a licensee’s compliance with subsection (b) of this section, the provisions of [§ 428] § 432 {“Circuses and Carnivals”} of the Baltimore City Building Code, which regulates circuses and carnivals, do apply to applications and licenses to operate any type of ride or riding device mounted on mobile equipment.

ARTICLE 32. ZONING

Title 16. Off-Street Parking and Loading

Subtitle 4. Design of Facilities

§ 16-409. Curbing and wheel stops.

Wheel stops or curbing must be provided to prevent vehicles from damaging or encroaching on an adjacent parking or loading space, sidewalk, landscaped area, or parking lot island, fence, wall, or building. Curbing must be at least 6 inches in height, in accordance with Building Code [§ 3112.5] § 3116.5 {"Curbs or bumpers"}.

SECTION 2. AND BE IT FURTHER ORDAINED, That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.

SECTION 3. AND BE IT FURTHER ORDAINED, That this Ordinance and the Building, Fire, and Related Codes adopted by it apply to all building operations for which a permit application is filed on or after the effective date of this Ordinance.

SECTION 4. AND BE IT FURTHER ORDAINED, That, except as expressly provided to the contrary in this Ordinance, any transaction, case, proceeding, investigation, or other matter validly begun before the effective date of this Ordinance and affected by or flowing from any law amended or repealed by this Ordinance, and any right, duty, or interest flowing from any ordinance amended or repealed by this Ordinance, remains valid after the effective date of this Ordinance and may be terminated, completed, enforced, or prosecuted as required or permitted by the prior law as though the amendment or repeal has not occurred. If any change in nomenclature involves a change in name or designation of any City agency or official, the successor agency or official has all the powers and obligations granted the predecessor agency or official.

SECTION 5. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is enacted.
