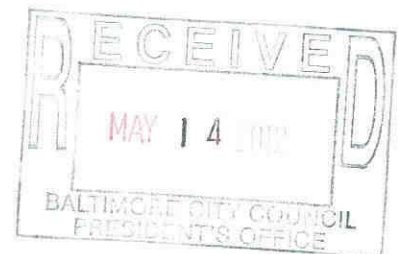

Amendment No. 1

On page 3, in line 13, after "THE FACILITY", insert "(I) IS LOCATED IN A SINGLE-FAMILY DWELLING (WHETHER DETACHED, SEMI-DETACHED, OR ATTACHED), (II)"; and, on the same page, in line 15, before the period, insert ", AND (III) MEETS THE GENERAL REQUIREMENTS, THE BULK REGULATIONS, AND ALL OTHER REQUIREMENTS OF THIS ARTICLE APPLICABLE TO DWELLINGS IN THE ZONING DISTRICT WITHIN WHICH THE FACILITY IS LOCATED".

Amendment No. 2

On page 3, in lines 26 and 27, and lines 33 and 34, on page 4, in lines 11 and 12, lines 18 and 19, and lines 27 and 28, and on page 5, in lines 8 and 9, in each instance, strike "HOUSING 16 OR FEWER PATIENTS".

Amendment No. 3

On page 3, in line 27 and line 34, on page 4, in line 12, line 19, and line 28, and on page 5, in line 9, in each instance, after "FACILITY", insert "(I)"; and, in the same lines, in each instance, after "WITH", insert "§ 1-136(C)(3) {“DWELLING: MULTIPLE-FAMILY DWELLING”},” and, in the same lines, in each instance, before "AND", insert a comma.

Amendment No. 4

On page 3, in line 28 and line 35, on page 4, in line 13, line 20, and line 29, and on page 5, in line 10, in each instance, before the period, insert "AND (II) MEETS THE GENERAL REQUIREMENTS, THE BULK REGULATIONS, AND ALL OTHER REQUIREMENTS OF THIS ARTICLE APPLICABLE TO DWELLINGS IN THE ZONING DISTRICT WITHIN WHICH THE FACILITY IS LOCATED".
