A BILL ENTITLED

1 AN ORDINANCE concerning

2 **Baltimore Development Corporation – Procurement Procedures**

3 FOR the purpose of requiring that the processes for requesting or soliciting quotes, bids, or
4 proposals, or for contracts made or proposed by the Baltimore Development Corporation
5 comport with the procurement requirements imposed on City agencies.

6 BY adding

7 Article 5 - Finance, Property, and Procurement
8 Section(s) 39-1 and 39-2, to be under the new subtitle designation,
9 “Subtitle 39. Baltimore Development Corporation”

12 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That the
13 Laws of Baltimore City read as follows:

14 **Baltimore City Code**

15 **Article 5. Finance, Property, and Procurement**

16 **SUBTITLE 39. PROCUREMENT THROUGH BALTIMORE DEVELOPMENT CORPORATION**

17 **§ 39-1. SCOPE.**

18 THIS SUBTITLE APPLIES TO EVERY REQUEST OR SOLICITATION FOR QUOTES, BIDS, OR
19 PROPOSALS AND TO EVERY CONTRACT FOR THE PURCHASE OF GOODS OR SERVICES OR FOR THE
20 PURCHASE, SALE, DEVELOPMENT, OR REDEVELOPMENT OF PROPERTY THAT IS MADE OR
21 PROPOSED BY THE BALTIMORE DEVELOPMENT CORPORATION OR RECOMMENDED TO THE
22 CITY OR TO OTHERS BY THE BALTIMORE DEVELOPMENT CORPORATION.

EXPLANATION: CAPITALS indicate matter added to existing law.
[Brackets] indicate matter deleted from existing law.

1 **§ 39-2. PROCUREMENT PROCEDURES.**

2 ALL SOLICITATIONS, REQUESTS, AND CONTRACTS SOUGHT OR PROPOSED BY THE BALTIMORE
3 DEVELOPMENT CORPORATION MUST COMPLY WITH THE REQUIREMENTS OF THE FOLLOWING,
4 THE SAME AS IF THE BALTIMORE DEVELOPMENT CORPORATION WERE AN AGENCY OR UNIT OF
5 CITY GOVERNMENT:

- 6 (1) CITY CHARTER ARTICLE VII, § 11 {"PROCUREMENT"};
- 7 (2) SUBTITLES 24 THROUGH 41 OF THIS ARTICLE;
- 8 (3) ANY OTHER FEDERAL, STATE, OR LOCAL LAW GOVERNING PROCUREMENT BY THE CITY
9 AND ITS AGENCIES; AND
- 10 (4) THE RULES AND REGULATIONS OF THE BOARD OF ESTIMATES GOVERNING
11 PROCUREMENT BY THE CITY AND ITS AGENCIES.

12 **SECTION 2. AND BE IT FURTHER ORDAINED,** That the catchlines contained in this Ordinance
13 are not law and may not be considered to have been enacted as a part of this or any prior
14 Ordinance.

15 **SECTION 3. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the 30th day
16 after the date it is enacted.
