AN ORDINANCE CONCERNING

**Zoning – Conditional Use Conversion of a 1-Family Dwelling Unit to a
~~2-Family Dwelling Unit~~ 1-Family Dwelling Unit with 1 Efficiency Unit in the
R-8 Zoning District – Variances – 2642 McElderry Street**

FOR the purpose of permitting, subject to certain conditions, the conversion of a 1-family dwelling unit to a ~~2-family dwelling unit~~ 1-family dwelling unit with 1 efficiency unit in the R-8 Zoning District on the property known as 2642 McElderry Street, as outlined in red on the accompanying plat; and granting variances from certain lot size, rear yard setback, and off-street parking requirements.

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That permission is granted for the conversion of a 1-family dwelling unit to a ~~2-family dwelling unit~~ 1-family dwelling unit with 1 efficiency unit in the R-8 Zoning District on the property known as 2642 McElderry Street, as outlined in red on the plat accompanying this Ordinance, in accordance with Baltimore City Zoning Code §§ ~~3-305(b)(3)~~ 3-305(b) and 14-102, subject to the condition that the building complies with all applicable federal, state, and local licensing and certification requirements.

SECTION 2. AND BE IT FURTHER ORDAINED, That pursuant to the authority granted by Title 15 of the Zoning Code of Baltimore City, specifically by §§ 15-101, 15-202, 15-218, and 15-219, ~~the City Council grants permission is granted~~ for a variance from the required lot size area of 1,500 1,250 square feet for a lot of 1,072.5 square feet, a variance of ~~427.5~~ 177.5 square feet of lot area.

1 **SECTION 3. AND BE IT FURTHER ORDAINED**, That pursuant to the authority granted by Title
2 15 of the Zoning Code of Baltimore City, specifically by §§ 15-101, 15-203, 15-218, and 15-219,
3 ~~the City Council grants permission is granted for~~ a variance from the required rear yard setback
4 of 25 feet to a rear yard setback of 10 feet, a variance of 15 feet.

5 **SECTION 4. AND BE IT FURTHER ORDAINED**, That pursuant to the authority granted by Title
6 15 of the Zoning Code of Baltimore City, specifically by §§ 15-101, 15-208, 15-218, and 15-219,
7 ~~the City Council grants permission is granted for~~ a variance of 0 parking spaces from the
8 requirement of 1 parking space.

9 **SECTION 5. AND BE IT FURTHER ORDAINED**, That as evidence of the authenticity of the
10 accompanying plat and in order to give notice to the agencies that administer the City Zoning
11 Ordinance: (i) when the City Council passes this Ordinance, the President of the City Council
12 shall sign the plat; (ii) when the Mayor approves this Ordinance, the Mayor shall sign the plat;
13 and (iii) the Director of Finance then shall transmit a copy of this Ordinance and the plat to the
14 Board of Municipal and Zoning Appeals, the Planning Commission, the Commissioner of
15 Housing and Community Development, the Supervisor of Assessments for Baltimore City, and
16 the Zoning Administrator.

17 **SECTION 6. AND BE IT FURTHER ORDAINED**, That this Ordinance takes effect on the 30th day
18 after the date it is enacted.
