BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the following amounts or so much thereof as shall be sufficient are hereby appropriated subject to the provisions hereinafter set forth for the purpose of carrying out the programs included in the operating budget and the projects listed in the capital budget from the amounts estimated to be available in the designated funds during the fiscal year ending June 30, 2027.

20 City (or any entity controlled by the City within the meaning of Treas. Reg.
21 Section 1.150-1). The term "obligation" (as such term is defined in Treas. Reg.
22 Section 1.150(b) and as used in this Section) includes general obligation bonds and
23 notes, revenue bonds and notes, leases, conditional purchase agreements and other
24 obligations of the City (or any entity controlled by the City within the meaning of
25 Treas. Reg. Section 1.150-1).
- 26 (c) The maximum anticipated debt expected to be incurred by the City to reimburse the
27 cost of each capital project or program in this Ordinance of Estimates is the applicable
28 appropriation listed in this Ordinance of Estimates from the proceeds of one or more
29 obligations, as such appropriations may be increased or decreased.
