A BILL ENTITLED

1 AN ORDINANCE concerning

2 **Supplementary Special Fund Capital Appropriation –**  
3 **Department of Housing and Community Development – \$8,000,000**

4 FOR the purpose of providing a Supplementary Special Fund Capital Appropriation in the  
5 amount of \$8,000,000 to the Department of Housing and Community Development (Account  
6 #9911-600-858), to provide funding for the acquisition of various parcels of land; and  
7 providing for a special effective date.

13 **Recitals**

14 The revenue appropriated by this Ordinance represents funds from proceeds from the sales of  
15 various City-owned properties for redevelopment in excess of the revenue relied on by the Board  
16 of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2008.

17 This additional revenue could not have been reasonably anticipated when the Ordinance of  
18 Estimates for Fiscal Year 2008 was formulated.

19 This appropriation is made necessary by a material change in circumstances since the  
20 Ordinance of Estimates for Fiscal Year 2008 was formulated or is for a new program that could  
21 not have been reasonably anticipated when that Ordinance of Estimates was formulated.

22 On April 16, 2008, the Board of Estimates recommended this appropriation to the City  
23 Council.

24 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That**  
25 **\$8,000,000 shall be made available to the Department of Housing and Community Development**  
26 **(Account #9911-600-858) as a Supplementary Special Fund Capital Appropriation for Fiscal**  
27 **Year 2008, to provide funding for the acquisition of various parcels of land. The source of**

1 revenue for this appropriation is funds from the proceeds from the sales of various City-owned
