**AN ORDINANCE CONCERNING**

**1                                    Mobile and Other Street Vendors – Licensing and Regulation**

2        FOR the purpose of transferring the powers of the Board of Licenses for Street Vendors to the  
3        Department of General Services; ~~establishing a Street Vendors Advisory Board~~; modifying the  
4        provisions governing the classifications, issuance, terms, and renewal of licenses for street  
5        vendors; providing for all license and other fees to be set by the Board of Estimates;  
6        ~~prohibiting the operation of mobile vendors outside of certain designated zones~~; requiring  
7        posting for public comment, and a hearing, for certain proposed rules and regulations;  
8        providing for the designation and classification of mobile vending zones; prohibiting the  
9        operation of mobile vendors near designated mobile vending zones; placing a restriction on the  
10       maximum length of vehicles used by mobile vendors after certain dates; modifying the  
11       prohibitions on the operation of street vendors in residential areas, near schools, and near  
12       retail establishments selling similar products; allowing for the inclusion of certain mobile  
13       vendors near or in farmers' markets; prohibiting the operation of mobile vendors during certain  
14       hours; prohibiting the operation of street vendors near City markets; requiring certain mobile  
15       vendors to keep detailed logbooks; prohibiting parking of private vehicles in mobile vending  
16       zones; prohibiting the parking of vendor trucks in certain areas; prohibiting smoking in mobile  
17       vending vehicles; defining certain terms; creating certain exceptions; setting certain penalties;  
18       ~~authorizing Special Parking Enforcement Officers to issue environmental citations for~~  
19       ~~violations of the laws, rules, and regulations governing street vendors~~; correcting and  
20       clarifying related provisions; providing for a special effective date; and generally relating to  
21       the licensing and regulation of street vendors.

### 33 **Recitals**

34 **WHEREAS**, The mobile vending industry has the potential to create new employment  
35 opportunities, small business growth and favorable conditions for culinary entrepreneurs in  
36 Baltimore and its neighborhoods.

37 **WHEREAS**, The mobile vending industry has become increasingly widespread, popular and  
38 profitable in urban settings such as Boston, Los Angeles, New York, Houston, Philadelphia, San  
39 Francisco, Atlanta, Seattle, Miami, Austin, Portland, and Washington D.C.

40 **WHEREAS**, Cities around the country have, made incremental strides in regulating the  
41 complexities of the mobile vendor industry, including efforts to find solutions to challenges created  
42 by the industry, such as issues around parking, traffic, and waste disposal.

1 WHEREAS, The City of Baltimore has strong interest in preparing for the expansion of the  
2 mobile vending industry and in supporting programs to promote healthier food vendors.

3 WHEREAS, In 2011, the City of Baltimore outlined the following guiding principles for mobile  
4 vending: safeguarding public safety and health, respecting ingress and egress to established  
5 businesses, addressing pedestrian, traffic, and parking concerns, and promoting entrepreneurship  
6 and a vibrant business climate for food truck vendors and local restaurants.

7 NOW, THEREFORE,

8 SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the  
9 Laws of Baltimore City read as follows:

14 § 17-1. Definitions.

15 (a) In general.

16 In this subtitle, the following terms have the meanings indicated.

21 “Downtown area” means:

23 Luther King, Jr. Boulevard; binding on the west side of said Martin Luther King, Jr. Boulevard and  
24 running in a northerly direction to a point of intersection with the north side of W. Franklin Street;  
25 thence running easterly along W. Franklin Street to the northeast corner of W. Franklin and N. Paca  
26 Streets; binding on the west side of N. Paca Street running northerly to the northwest corner of Druid  
27 Hill Avenue and N. Paca Street; thence binding on the northern right-of-way line of Druid Hill Avenue  
28 running easterly crossing N. Eutaw Street in a straight line and continuing along the northern  
29 right-of-way line of Centre Street easterly to intersect the eastern right-of-way line of the Fallsway;  
30 thence binding on the eastern right-of-way line of the Fallsway running southerly to intersect the  
31 southern curbline of E. Fayette Street following the southern right-of-way of E. Fayette Street to the  
32 westerly right-of-way line of the Jones Falls Boulevard to intersect the southern right-of-way line of  
33 Pratt Street thence westerly to the point of beginning.]

8 “ICE CREAM TRUCK” MEANS A VENDOR WHO EARNS SUBSTANTIALLY ALL OF ITS REVENUE  
9 FROM THE SALE OF ICE CREAM, OR SIMILAR FROZEN FOOD CONFECTIONS, FROM A VEHICLE.

11 (1) *IN GENERAL.*

12 “MOBILE VENDOR” MEANS ANY PERSON THAT SELLS, DISTRIBUTES, OR OFFERS TO SELL  
13 OR DISTRIBUTE FOOD PRODUCTS, OTHER MERCHANDISE OF ANY KIND, OR SERVICES ~~OF~~  
14 ~~ANY KIND~~ FROM A MOTOR VEHICLE ON CITY STREETS OR PRIVATE PROPERTY WITHIN THE  
15 CITY OF BALTIMORE.

16 ~~(2) EXCLUSION.~~

17 ~~“MOBILE VENDOR” DOES NOT INCLUDE AN ICE CREAM TRUCK.~~

18 (2) EXCLUSION.

19 “MOBILE VENDOR” DOES NOT INCLUDE A HORSE-DRAWN WAGON.

20 (F) ~~(G)~~ *MOBILE VENDING ZONE.*

21 “MOBILE VENDING ZONE” MEANS AN AREA DESIGNATED IN ACCORDANCE WITH § 17-5  
22 {“MOBILE VENDING ZONES”} OF THIS SUBTITLE FOR THE USE OF MOBILE VENDORS.

23 (G) MOTOR VEHICLE.

24 “MOTOR VEHICLE” HAS THE MEANING STATED IN ARTICLE 31, §1-2(C){“MOTOR VEHICLE”}.

25 (H) [(e)] *Person.*

26 (1) *In general.*

27 “Person” means:

28 (i) an individual;

29 (ii) A PARTNERSHIP, FIRM, ASSOCIATION, CORPORATION, OR OTHER ENTITY OF ANY  
30 KIND; OR

4 (2) *Exclusions.*

5 “Person” does not include a governmental entity or an instrumentality or unit of a  
6 governmental entity.

7 (I) [(f)] *Street.*

8 “Street” means any street, boulevard, road, highway, alley, lane, sidewalk, footway, mall,  
9 esplanade, or other way or place that is owned by the City or habitually used by the public.

10 (J) [(g)] *Street vendor.*

11 “Street vendor” means:

12 (1) A MOBILE VENDOR; OR

13 (2) any OTHER person who sells OR DISTRIBUTES, or offers to sell OR DISTRIBUTE food  
14 products or OTHER merchandise ~~of any kind~~ on any street.

15 (K) VENDOR TRUCK.

16 “VENDOR TRUCK” MEANS ANY MOTOR VEHICLE USED FOR THE PURPOSE OF SELLING ANY  
17 FOOD PRODUCT, OTHER MERCHANDISE, OR SERVICE BY A MOBILE VENDOR LICENSED UNDER  
18 THIS SUBTITLE.

19 (L) ~~(K)~~ [(h)] ~~Vehicle~~ VENDOR VEHICLE.

20 “~~Vehicle~~ VENDOR VEHICLE” means:

21 (1) any animal-drawn wagon;

22 (2) any motor vehicle; or

23 (3) any trailer, handcart, pushcart, or other vehicle.

25 (a) *Mandatory terms.*

26 “Must” and “shall” are each mandatory terms used to express a requirement or to impose a  
27 duty.

28 (b) *Prohibitory terms.*

29 “Must not” and “may not” are each mandatory negative terms used to establish a  
30 prohibition.

4 **§ 17-4. [§ 17-9.] Rules and regulations.**

5 (a) [Board] DEPARTMENT may adopt.

6 The [Board of Licenses for Street Vendors] DEPARTMENT may adopt rules and regulations  
7 to carry out this subtitle.

8 (B) PUBLIC NOTICE AND COMMENT.

9 THE DEPARTMENT MUST FIRST PUBLISH PROPOSED RULES AND REGULATIONS, AND PROVIDE  
10 ADEQUATE PUBLIC NOTICE AND OPPORTUNITY FOR PUBLIC COMMENT AT A HEARING ON THE  
11 PROPOSED RULES AND REGULATIONS, BEFORE ADOPTING ANY RULES AND REGULATIONS  
12 UNDER THIS SUBTITLE.

13 (C) ~~(b)~~ Filing with Legislative Reference.

14 A copy of all rules and regulations UNDER THIS SUBTITLE must be filed with the Department  
15 of Legislative Reference AT LEAST 30 DAYS before they take effect.

16 **§ 17-5. MOBILE VENDING ZONES.**

17 (A) *DESIGNATION.*

18 (1) *IN GENERAL.*

19 AT THE DEPARTMENT’S REQUEST, AND AFTER PUBLIC NOTICE HAS BEEN PROVIDED TO  
20 AREA BUSINESS AND NEIGHBORHOOD ORGANIZATIONS, THE DIRECTOR OF  
21 TRANSPORTATION MAY DESIGNATE SPACES ON CITY STREETS OR OTHER PUBLIC  
22 PROPERTY AS “MOBILE VENDING ZONES” FOR THE EXCLUSIVE USE OF MOBILE VENDORS  
23 DURING DESIGNATED HOURS.

24 (2) *REQUIRED CONSIDERATIONS.*

25 A DESIGNATION UNDER PARAGRAPH (1) OF THIS SUBSECTION MUST INCLUDE AN  
26 ASSESSMENT OF THE ZONE’S POTENTIAL IMPACT ON:

27 (I) VEHICULAR AND PEDESTRIAN TRAFFIC, INCLUDING ANY IMPEDIMENT TO INGRESS  
28 AND EGRESS FOR ESTABLISHED BUSINESSES;

29 (II) PUBLIC SAFETY AND HEALTH;

30 (III) PARKING IN THE AREA; AND

31 (IV) AREA RESIDENTS AND BUSINESSES.

1 (3) RESTRICTION ON ZONES NEAR SCHOOLS.

2 NO MOBILE VENDING ZONE MAY BE DESIGNATED WITHIN 2 BLOCKS OF THE GROUNDS OF  
3 ANY BUILDING USED AS A PUBLIC OR PRIVATE KINDERGARTEN, ELEMENTARY SCHOOL, OR  
4 SECONDARY SCHOOL.

5 (B) *TIME-LIMITED ZONES.*

6 THE MOBILE VENDING ZONES DESIGNATED UNDER THIS SECTION MAY BE SET ASIDE FOR THE  
7 USE OF MOBILE VENDORS AT ALL TIMES OR FOR ~~LIMITED~~ SPECIFIED TIMES, DATES, AND DAYS.

8 (C) TEMPORARY RELOCATION OR SUSPENSION.

9 THE DEPARTMENT, OR THE DEPARTMENT OF TRANSPORTATION, MAY TEMPORARILY  
10 RELOCATE OR SUSPEND MOBILE VENDING ZONES AT ANY TIME DUE TO EMERGENCIES OR TO  
11 FURTHER PUBLIC SAFETY, PUBLIC HEALTH INTERESTS, OR CITY OPERATIONS.

12 (D) ~~(E)~~ SIGNAGE.

13 MOBILE VENDING ZONES DESIGNATED UNDER THIS SECTION MUST BE MARKED BY CLEAR  
14 SIGNS SPECIFYING THE HOURS AND TIMES THAT THEY ARE RESERVED FOR THE EXCLUSIVE USE  
15 OF MOBILE VENDORS.

16 (E) ~~(D)~~ RULES AND REGULATIONS.

17 THE RULES AND REGULATIONS ADOPTED UNDER THIS SUBTITLE MUST:

18 (1) ESTABLISH A PROCESS AND TIMELINE FOR REQUESTING, ESTABLISHING, ASSIGNING,  
19 AND REMOVING MOBILE VENDING ZONES; AND

20 (2) REQUIRE A PUBLIC HEARING, AS WELL AS PROVIDE AN OPPORTUNITY FOR THE FILING  
21 OF WRITTEN PROTESTS, BEFORE A MOBILE VENDING ZONE IS DESIGNATED.

22 **§ 17-6. [§ 17-3. Scope] NEWSPAPER SALES EXCEPTED FROM SUBTITLE.**

23 This subtitle does not apply to the sale of newspapers.

**§ 17-15. [§ 17-11.] License required.**

No [person] STREET VENDOR may [sell or offer for sale in the streets of] OPERATE IN Baltimore City [any food products or other merchandise] without first having obtained a license to do so from the [Board of Licenses for Street Vendors] DEPARTMENT OF GENERAL SERVICES.

**§ 17-16. [§ 17-12.] Classes and scope of licenses.**

(a) *In general.*

In its rules and regulations, the [Board shall] DEPARTMENT MAY:

- (1) designate various classes of licenses to be issued; and
- (2) for each class of license, specify:
  - (i) the types of merchandise that may be sold under the license;
  - (ii) the locations or areas for which the license is effective;
  - (iii) the days and times for which the license is effective; [and]
  - (iv) the maximum number of licenses to be issued for a particular location or area or for a particular day or time of day;
  - (V) THE MAXIMUM NUMBER OF LICENSES OF EACH CLASS THAT MAY BE ISSUED IN TOTAL; AND
  - (VI) THE MAXIMUM NUMBER OF LICENSES THAT MAY BE ISSUED TO A SINGLE PERSON.

(b) *Required considerations.*

In designating classes and specifying limitations, the [Board] DEPARTMENT [shall] MUST consider:

1 (1) the volume and types of vehicular and pedestrian traffic in a proposed vending  
2 location or area;

3 (2) the proximity to a proposed vending location or area of schools, religious  
4 institutions, parks, and residences;

5 (3) the number of licenses issued to the same person; ~~and~~

6 (4) the impact of street vending activities on the health, safety, and general welfare of  
7 the public; AND

8 (5) COMMENTS AND FEEDBACK FROM AREA SCHOOLS, BUSINESSES, INSTITUTIONS, AND  
9 RESIDENTS.

10 **§ 17-17. [§ 17-13.] Limitations and conditions.**

11 (a) *In general.*

12 The [Board] DEPARTMENT OF GENERAL SERVICES may impose reasonable limitations and  
13 conditions on any license issued under this subtitle, as necessary or proper to carry out the  
14 purpose and intent of this subtitle.

15 (b) *Containers and VENDOR vehicles.*

16 (1) EXCEPT AS OTHERWISE DESIGNATED BY THIS SUBSECTION, [The Board] THE  
17 DEPARTMENT may determine the size, shape, design, and dimensions of any container,  
18 conveyance, SIGN, TABLE, CHAIR, OTHER APPURTENANCE, or VENDOR vehicle to be used  
19 in connection with [the sale of merchandise under] A LICENSE ISSUED UNDER this  
20 subtitle.

21 (2) THE DEPARTMENT MAY NOT ISSUE A NEW OR RENEWAL LICENSE FOR A MOBILE VENDOR  
22 TO OPERATE OUT OF ANY VEHICLE WITH A TOTAL OPERATING SPACE THAT IS LONGER  
23 THAN 25 FEET, INCLUDING ANY GENERATOR, HITCH, TRAILER, OR OTHER MOTOR VEHICLE  
24 ATTACHMENT.

25 **§ 17-18. [§ 17-14.] Applications.**

26 (a) *Form.*

27 An application for a license must be made in the form [the Board] THE DEPARTMENT OF  
28 GENERAL SERVICE requires.

29 [(b) *Application fee.*

30 The application must be accompanied by a non-refundable application fee of \$25 to cover  
31 the cost of investigating and processing the application.]

32 (B) [(c) *Contents.*

33 The application must contain:

- 2 (2) the applicant's age;
- 3 (3) the type of merchandise OR SERVICE for which the license is sought;
- 4 (4) the location or area for which the license is sought;
- 5 (5) for the sale of any food product, evidence that the applicant has obtained the
- 6 appropriate license from the Health Department; and
- 7 (6) any other information [the Board] THE DEPARTMENT requires.

8 (C) [(d)] *Verification.*

9 (1) The application must be SIGNED AND verified before a notary public or other officer  
10 authorized to administer oaths.

11 (2) IF THE APPLICATION IS BY A SOLE PROPRIETORSHIP, IT MUST BE SIGNED BY THE OWNER; IF  
12 BY A PARTNERSHIP, IT MUST BE SIGNED BY AN AUTHORIZED PARTNER; OR, IF BY A  
13 CORPORATION, LIMITED LIABILITY COMPANY, OR SIMILAR ENTITY, IT MUST BE SIGNED BY  
14 AN AUTHORIZED OFFICER.

15 **§ 17-19. TERM AND RENEWAL.**

16 (A) *TERM.*

17 EXCEPT AS PROVIDED IN § 17-20 {"TEMPORARY LICENSES"} OF THIS SUBTITLE, A LICENSE  
18 EXPIRES ON THE 1ST ANNIVERSARY OF ITS EFFECTIVE DATE.

19 (B) *RENEWAL.*

20 (1) BEFORE A LICENSE EXPIRES, THE STREET VENDOR MAY RENEW IT FOR AN ADDITIONAL 1-  
21 YEAR TERM.

22 (2) A RENEWAL APPLICATION MUST BE:

23 (I) IN THE FORM THE DEPARTMENT OF GENERAL SERVICES REQUIRES; AND

24 (II) SUBMITTED TO THE DEPARTMENT, WITH THE APPLICABLE ANNUAL FEE, AT LEAST  
25 30 DAYS BEFORE THE CURRENT LICENSE EXPIRES.
