## **Major Issues Discussed**

1. Chairman Costello went over the agency reports with agency representatives.

- 2. Andrew Chaveas from BOPA gave a powerpoint presentation highlighting the agency's accomplishments in FY24, including \$500k of grants and prizes distributed to the arts community.
- 3. The presentation focused on creating BOPA's Interim Board, including the members, their responsibilities, composition, size, goals, and commitments.
- 4. Councilman Stokes asked if artists must be on the Board, and if there is a city residency requirement for members. BOPA noted that there will be artists on the Board, but noted they aim for a balance of artists and community members. BOPA was unsure if members must live in the city, but Councilman Stokes asked for a follow up.
- 5. Councilman Dorsey asked"Who sits on the BOPA Board?". He noted that he doesn't want to vote on it until the Committee knows who is on the Board and mentioned that artists should be included.
- 6. BOPA is currently finalizing the Board members and will finalize it in 2 days. The agency will share a list with the Committee, which will be internal only.
- 7. Chairman Costello asked for a timeline of the Board confirmations. BOPA noted they have 10 commitments for the Board, but they need to confirm them. This will be done in 2 days or by Thursday of this week.
- 8. There are no plans as to how to publicly announce the Board yet.
- 9. Chairman Costello and Councilman Stokes thanked Todd Yuhanick for his collaboration and work in BOPA's progress, and welcomed Rachel Graham as BOPA's next CEO.
- 10. Hearing recessed. A voting session is scheduled for Monday, March 18<sup>th</sup>.
