Citizens have only the police to turn to aid a homeless or mentally ill person, respond to a domestic dispute, respond to a property crime, provide help to an addict, or any number of common issues our city faces. I hope you see that police officers are far from the most ideal people to respond to these cases. I think alternative means of public safety could see an increased reliance on community members, social workers, mental health professionals, and mediators to respond to the vast majority of calls. I think funding social programs and educational facilities to lift up our neighbors in underserved parts of the city could diminish the perceived need to send armed officers to every dispute or crime.

This need is even more apparent as we see our police department, and forces across the nation, militarize in tactics and technology. Are they receiving as much training in de-escalation and citizen protection as they are in assault and subduing? I know there are many who support the aerial surveillance program, but is that really solving any issues? If the problems you are solving are defined as people, then that is what the force will be trained to work against.

It is a huge undertaking, and may seem impossible to all of us who haven't seen substantial change in our lifetimes. We will need to look into provisions of affordable housing, our underfunded schools, the public transportation network, all of which are unfairly skewed to work against our Black and Brown neighbors. The police are not a part of any solution and are, from their inception in the role of slave-catchers, an inherently racist institution that should be looked at with a heavily critical eye as far as their needed role in our city and for that matter, our nation. I urge you to make substantive changes to the proposed Fiscal Year 2021 budget to defund the Baltimore City Police Department and reinvest in programs and services to address the root causes of crime and violence in our city in a sustainable way that values Black lives and dignity.

What are those programs? We have a few already: Affordable Housing Trust Fund, the Baltimore Children and Youth Fund, YouthWorks, the Mayor's Office of Employment Development, and Safe Streets Baltimore. Imagine what our city could be if they were looked at with the same, or hopefully greater, importance as the police department.
