AN ORDINANCE CONCERNING

1                    **Supplementary General Fund Operating Appropriation –**  
2                    **Mayoralty-Related: Office of the Inspector General – \$400,000**

3                    FOR the purpose of providing a Supplementary General Fund Operating Appropriation in the  
4                    amount of \$400,000 to M-R: Office of the Inspector General - Service 836 (Inspector  
5                    General), to provide funding for unbudgeted positions; and providing for a special effective  
6                    date.

7                    BY authority of  
8                    Article VI - Board of Estimates  
9                    Section 8(b)(3) and (c)

12                    **Recitals**

13                    The revenue appropriated by this Ordinance represents funds from the Recordation Tax in  
14                    excess of the revenue relied on by the Board of Estimates in determining the tax levy required to  
15                    balance the budget for Fiscal Year 2021.

16                    This additional revenue could not have been reasonably anticipated when the Ordinance of  
17                    Estimates for Fiscal Year 2021 was formulated.

18                    This appropriation is made necessary by a material change in circumstances since the  
19                    Ordinance of Estimates for Fiscal Year 2021 was formulated or is for a new program that could  
20                    not have been reasonably anticipated when that Ordinance of Estimates was formulated.

21                    On September 15, 2021, the Board of Estimates recommended this appropriation to the City  
22                    Council.


**Council Bill 21-0150**

1       **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That  
2 \$400,000 shall be made available to the M-R: Office of the Inspector General - Service 836  
3 (Inspector General) as a Supplementary General Fund Operating Appropriation for Fiscal Year  
4 2021, to provide funding for unbudgeted positions. The source of revenue for this appropriation  
5 is funds from the Recordation Tax in excess of the amount from this source that was relied on by  
6 the Board of Estimates in determining the tax levy required to balance the budget for Fiscal  
7 Year 2021.

8       **SECTION 2. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the date it is  
9 enacted.
