RECONVENING HEARING

Sponsor: President Mosby at the request of the Administration (Department of Housing and

Community Development)

Introduced: September 30, 2024

24-0594 - Purpose:

For the purpose of authorizing the issuance of special obligation bonds and the pledge, subject to appropriation, of Tax Increment Revenues (as such term is defined herein) to the payment of debt service thereon; providing that such bonds may be issued from time to time and in one or more issues or series in an aggregate principal amount not exceeding \$65,000,000 (to support, subject to additional Mayor and City Council approval, a borrowing program in the aggregate principal amount of \$150,000,000) for the purpose of financing costs associated with the rehabilitation of vacant units and the development of affordable housing, certain public infrastructure improvements, and other related costs, including, without limitation, the Project (defined herein), and other necessary improvements to, from, or within the development district, and certain other improvements permitted by the Tax Increment Act (defined herein); providing for the method and sources of payment for such special obligation bonds; authorizing the Board of Finance to specify, prescribe, determine, provide for and approve the details, forms, documents or procedures in connection with such special obligation bonds and any other matters necessary or desirable in connection with the authorization, issuance, sale, and payment of such special obligation bonds; authorizing the Board of Finance to specify, prescribe, determine, provide for, and approve the method and sources of such pledge, the details, forms, documents, or procedures in connection with such pledge, and any other matters necessary or desirable in connection with such pledge; providing for a special effective date; providing that the City, in each fiscal year in which any such bonds are outstanding, use its best efforts to obtain the appropriation of the Tax Increment Revenues in the amounts and at the times specified in a trust agreement or agreements between

the City and a bank or trust company appointed as trustee thereunder; and generally relating to the issuance and payment of special obligation bonds.

Effective: On the date it is enacted.

24-0595 - Purpose:

For the purpose of designating a "development district" to be known as the "City-Wide Affordable Housing Development District;" providing for and determining various matters in connection with the establishment of the development district; creating a special, tax increment fund for the development district; to provide for the financing of costs associated with the rehabilitation of vacant units and the development of affordable housing; allocating certain property taxes to that fund; making certain findings and determinations; providing for a special effective date; and generally providing for matters relating to the designation and operation of the development district, the establishment and use of the special tax increment fund to provide for the payment by or reimbursement to the City for debt service which the City is obligated to pay or has paid (whether such obligation is general or limited) on any special obligation bonds or notes issued by the City, the replenishment of any reserve fund established for any bonds, and the payment of certain expenses and administrative costs related to the operation of the development district; and providing for a special effective date.

Analysis

Current Law

Baltimore City Charter, Article II, Section 62 - outlines the rules, regulations, and mandates for TIF's.

§ (62) Tax increment financing (TIFs).

- (a) In general.
- (1) To borrow money by issuing and selling bonds, at any time and from time to time, for the purpose of financing and refinancing the development of an industrial, commercial, or residential area in Baltimore City. Such bonds shall be payable from and secured by a pledge of the special fund described in subsection (d)(3)(ii) of this section and the Mayor and City Council of Baltimore may also establish sinking funds, establish debt service reserve funds, or pledge other assets and revenues towards the payments of the principal and interest, including revenues received by the Mayor and City Council of Baltimore pursuant to a development agreement.

<u>Baltimore City Charter, Article II, Section 62 –</u> also outlines the rules and regulations for the Tax Increment Financing Act.

Background

On Tuesday, November 12, 2024 the Committee of the Whole held the first hearing for these companion bills. There were three (3) set of amendments introduced and/or proposed; two for Council Bill 24-0594 and one for 24-0595.

- 3. From the Department of Housing and Community Development.

On Monday, December 2, 2024 the hearing will reconvene. Following are <u>notes taken</u> during the November 12th hearing.

Major Issues Discussed

- 1. Both bills were heard simultaneously; 24-0594 and 24-0595.
- 2. A PowerPoint Presentation pertaining to both bills, was given (in conjunction) by representatives from the Department of Housing and Community Development and Finance Department. A copy is on file.
- 3. President/Chairman Mosby went over the agency reports with the agency representatives.
- 4. Committee/council members asked questions, stated concerns, and gave comments. Some highlighted topics of discussion and/or concern were:

Questions

- Is the City obligated to ensure that the bond holders are repaid?
- How will we know the new legislation is working?
- How can we be sure there will be a return on investment?
- Are there any plans and/or incentives to encourage these efforts?
- How is the selection of the properties made?
- Will all properties be available on day one? Answer: No
 - Is a map available for the first round of properties? Answer: No, not yet
- How can the community and small businesses take advantage of the TIFs?
- Will technical assistance be available to the public?
- What will future staffing for this initiative look like?
 - Will more capacity be needed to keep up with the processes needed?
- Will more grants become available?

Comments

• Pertaining to how TIF's districts are established and the background for same

Income Restriction

• How long does the restriction last; especially for those who may want to sell and who does the restriction apply to?

■ Concerns:

- Being able to afford renovations needed
- TIF's being in the marketplace
- Areas of the City that are and/or continue to be "disinvested in" is of concern
- 14TH District concerned that some properties in the neighborhood are not on the current list; will those properties eventually be added to the list?
- Tax Sale Reform
 - o A lot of these properties will go into tax sales
 - Comment: Don't think the City is moving fast enough for reform!
- Comments and concerns expressed regarding the payment/pay back of bonds

Increments

- Which tax credits will be included in the increments?
- Using Funds vs. using Tax Credits
 - Clarification needed
 - Will investors have to choose between the two?

Mortgages

- How will the mortgages work?
- Do you have enough banks to give mortgages?
