
I have just heard back from the Bureau of the Budget and Management Research (BBMR) and they provided me with the detail below to send to you. I hope this answer your questions.

- Unallocated appropriation: This line item acts as a place holder for anticipated grants for the agency—basically
  grants they haven't been awarded yet, but have applied for or are planning to apply for. By eliminating this
  funding, the agency will need to go to the City Council to get a supplemental appropriation for grants received in
  this service.
- Overtime: The City has been working to reduce overtime spending and track it better within the agency, which
  is why we've been budget for overtime. By eliminating this funding, the agency will likely need to get a
  supplemental appropriation from the City Council to cover overtime costs in FY21.
- The reductions to Service 622 Activity 026 and Service 115 Activity 018 eliminates funding for one of two proposed new Baltimore Community Intelligence Centers.

My name is Vianney Paul and I've been a Baltimore City résident for over 8 years. Given the current climate and calls for police reform in the wake of George Floyd's death, there has been much debate about the concept of defunding the police all over the United States.

Upon learning about the Baltimore city budget, it seems appropriate that we, at the very least, do NOT increase the BCPD budget from \$530 million to \$545 million, and instead reallocate those funds towards departments that would benefit your constituents directly, like homeless services (care and prevention), education, mental health services, and better food equality (i.e. funneling more funds for better food access in "food desert" areas).

Further, it would feel appropriate, especially in a time when there is so much emphasis on policy brutality and training, that more time and resources within the BCPD budget be allocated to de-escalating conflict and non-violent methods, and less time on weapons training and self defense. I realize those are very important aspects of the job, but it seems to take a disproportionately large portion of training and budget.

#### To all concerned:

My name is Will Holman, and I am a 14th District resident along with my wife Amanda and 2 year old, Annie. Our former nanny was robbed at gunpoint in broad daylight while walking Annie and her cousin home from the 29th Street Community Center in February. She had her phone taken, which was then used to steal money, order food, and order Uber rides. While at first solicitous in taking a report, the Baltimore Police detectives in charge of the case then told our nanny that the food orders went to known drug houses and to get her phone back she would have to testify in court and might get hurt in retaliation since the thief now knew where she lived. Further, they arrested a suspect who our nanny positively ID-ed as *not* the thief in a photo and proceeded to charge him anyway.

The bullying, threatening, and unprofessionalism of the BPD officers involved in this case is beyond unacceptable. It is but one small incident in the larger story of a department that has murdered Baltimoreans; stolen and re-sold seized guns and drugs; continues to steal overtime from taxpayers; and has repeatedly beaten and terrorized the citizens they are supposed to protect. On top of that, it is clear that they are outrageously ineffective, as violent crime and murders continue to rise year after year.

It is time to significantly defund the police. While I do not agree in abolishing the police, they currently consume 1/6th of the city's entire general fund, while we let schools, social services, and affordable housing wither on the vine. Adequate housing, education, and healthcare are human rights. Not only that, they are critical in reducing the incentives to enter criminal life in the first place.

While the BPD is a state agency, you control the \$509 million that is given to the department, as well as the IT and capital facilities support they get from other parts of the budget. This doesn't

even count hundreds of millions more in pension liabilities, civil rights lawsuits, and skyrocketing insurance costs that criminal cops incur. Every year we keep allocating more money, and every year we see more waste, fraud, abuse, and neglect in an already-damaged city.

Since 2010, we have spent \$4.74 billion in city funds on the Baltimore Police Department. This model is not working. Cut the BPD's budget so we can start a discussion about where we can allocate that money. Rolling the budget back to 2014 levels would give us another \$100 million to use towards education, healthcare, housing, jobs programs, and crisis-response teams for non-violent incidents.

For the previous several years the BPD budget from the general fund has eclipsed the amount of funding that is provided to other services that could help holistically and more effectively deal with issues in communities better than policing.
