A RESOLUTION ENTITLED

1 A COUNCIL RESOLUTION concerning

2 **Informational Hearing - 2022 Primary Election Irregularities**

3 FOR the purpose of inviting the Director of the Baltimore City Board of Elections and the  
4 Director of the State Board of Elections to come before the Council to detail the cause of  
5 voting irregularities during the 2022 primary election, potential impacts these irregularities  
6 had on election results, and solutions to ensure that such errors do not happen again.

7 **Recitals**

8 Voting is the pinnacle of our democracy. Voting during the 2022 primary election yielded the  
9 next Governor of Maryland, Comptroller, Attorney General, Baltimore City State's Attorney, and  
10 numerous delegates and senators who represent our communities.

11 Early voting and voting by mail have been very popular options that have substantially  
12 increased voter turnout in Baltimore City and allowed for voting to be much easier for residents  
13 with diverse schedules and circumstances.

14 During the 2 weeks before election day and on election day, voters experienced errors  
15 including:

- 16 • Receiving the correct mail-in ballot when they requested it, only to be told it was the  
17 incorrect ballot, and then the 2<sup>nd</sup> ballot being incorrect, causing a 3<sup>rd</sup> ballot to be mailed;
- 18 • Receiving new voter cards with incorrect information on them, causing voters to be confused  
19 as to which polling place they should attend;
- 20 • Being provided an incorrect ballot at the polls and then having to vote using a provisional  
21 ballot because the voter's district was incorrect in the pollbooks;
- 22 • Receiving no sample ballot or the incorrect sample ballot;
- 23 • Certain voters who received an incorrect mail-in ballot went to polling places to vote, causing  
24 the voter to have to vote by provisional ballot as the system indicated the voter had already  
25 received a ballot; and
- 26 • Being turned away at a polling place due to errors in the poll books.

EXPLANATION: CAPITALS indicate matter added to existing law.

**Council Bill 22-0121R**

1 Voting should be easy and the voters of Baltimore should be able to trust the City’s election  
2 system.

3 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE,** That the  
4 Baltimore City Council invites the Director of the Baltimore City Board of Elections and the  
5 Director of the State Board of Elections to come before the Council to detail the cause of voting  
6 irregularities during the 2022 primary election, potential impacts these irregularities had on  
7 election results, and solutions to ensure that such errors do not happen again.

8 **AND BE IT FURTHER RESOLVED,** That a copy of this Resolution be sent to the Director of the  
9 Baltimore City Board of Elections, the Director of the State Board of Elections, and the Mayor’s  
10 Legislative Liaison to the City Council.
