#### City Streets – Opening – Certain Streets and Alleys in the Area Bounded by Ensor Street, Monument Street, Aisquith Street, and Orleans Street

- FOR the purpose of condemning and opening certain streets and alleys in the area bounded by
  Ensor Street, Monument Street, Aisquith Street, and Orleans Street and lying within the
  Oldtown Urban Renewal Project, as shown on Plat 314-A-1D in the Office of the
  Department of General Services; and providing for a special effective date.

16 SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the 17 Department of Public Works shall proceed to condemn and open certain streets and alleys in the 18 area bounded by Ensor Street, Monument Street, Aisquith Street, and Orleans Street and lying 19 within the Oldtown Urban Renewal Project, and more particularly described as follows:

Beginning for Parcel No. 1 at the point formed by the intersection of the 20 southwest side of Forrest Street, 45 feet wide, and the east side of Ensor Street, 80 21 feet wide, and running thence binding on the east side of said Ensor Street 22 Northeasterly by a line curving to the left with a radius of 327.00 feet the distance 23 of 52.0 feet, more or less, to intersect the northeast side of said Forrest Street; 24 thence binding on the northeast side of said Forrest Street Southeasterly 158.3 25 26 feet, more or less, to the southeasternmost extremity of said Forrest Street, there situate; thence binding on the southeasternmost extremity of said Forrest Street 27 Southwesterly 45.0 feet to intersect the southwest side of said Forrest Street, and 28

thence binding on the southwest side of said Forrest Street Northwesterly 134.1 feet, more or less, to the place of beginning.

Beginning for Parcel No. 2 at the point formed by the intersection of the northeast side of East Street, 60 feet wide, and the northwest side of an alley, varying in width, laid out in the rear of the properties known as Nos. 426 through 450 Oldtown Mall, said point of beginning being distant Southeasterly 24.1 feet, more or less, measured along the northeast side of said East Street from the southeast side of Ensor Street, 80 feet wide, and running thence binding on the northwest and north sides of said varying in width alley the two following courses and distances; namely, Northeasterly 181.0 feet, more or less, and Northerly by a line curving to the left with a radius of 25.00 feet the distance of 35.1 feet, more or less, to intersect the southwest side of Forrest Street, 45 feet wide; thence binding on the southwest side of said Forrest Street Southeasterly 69.9 feet, more or less, to intersect the southeast side of said varying in width alley; thence binding on the southeast side of said varying in width alley the seven following courses and distances; namely, Southwesterly 43.2 feet, more or less, Northwesterly 22.8 feet, more or less, Southwesterly 52.4 feet, more or less, Southeasterly 4.4 feet, more or less, Southwesterly 61.8 feet, more or less, Southeasterly 9.7 feet, more or less, and Southwesterly 43.2 feet, more or less, to intersect the northeast side of said East Street, and thence binding on the northeast side of said East Street Northwesterly 26.8 feet, more or less, to the place of beginning.

Beginning for Parcel No. 3 at the point formed by the intersection of the 2.2 southwest side of East Street, 60 feet wide, and the southeast side of Ensor Street, 23 80 feet wide, and running thence binding on the southeast side of said Ensor 24 Street Northeasterly 65.5 feet, more or less, to intersect the northeast side of said 25 East Street; thence binding on the northeast side of said East Street Southeasterly 26 64.3 feet, more or less, to the southeasternmost extremity of said East Street; 27 thence binding on the southeasternmost extremity of said East Street 28 29 Southwesterly 60.8 feet, more or less, to intersect the southwest side of said East Street, and thence binding on the southwest side of said East Street Northwesterly 30 38.6 feet, more or less, to the place of beginning. 31

Beginning for Parcel No. 4 at the point formed by the intersection of the north 32 33 side of Orleans Street, varying in width, and the northwest side of Forrest Street, varying in width, and running thence binding on the northwest, west, south and 34 southwest sides of said Forrest Street the four following courses and distances; 35 namely, Northeasterly 14.2 feet, more or less, Northerly 37.6 feet, more or less, 36 Westerly 69.7 feet, more or less, and Northwesterly 231.9 feet, more or less, to 37 intersect the line of the northwest side of an alley, varying in width, laid out in the 38 rear of the properties known as Nos. 449/457 through 469 Oldtown Mall, if 39 projected northeasterly; thence binding on said line, so projected, Northeasterly 40 41 45.0 feet to intersect the northeast side of said Forrest Street; thence binding on the northeast and northwest sides of said Forrest Street, the three following 42 43 courses and distances; namely, Southeasterly 213.6 feet, more or less, Northeasterly 60.7 feet, more or less, and Northwesterly 172.4 feet, more or less, 44 to the northwesternmost extremity of said Forrest Street, there situate; thence 45 binding on the northwesternmost extremity of said Forrest Street Northeasterly 46 47 60.6 feet, more or less, to intersect the northeast side of said Forrest Street; thence binding on the northeast and east sides of said Forrest Street, the two following 48

courses and distances; namely, Southeasterly 198.6 feet, more or less, and Southerly 139.4 feet, more or less, to intersect the north side of said Orleans Street, and thence binding on the north side of said Orleans Street Westerly 71.2 feet, more or less, to the place of beginning.

Beginning for Parcel No. 5 at the point formed by the intersection of the northeast 5 side of East Street, 50 feet wide, and the northwest side of an alley, varying in 6 width, laid out in the rear of the properties known as Nos. 449/457 through 469 7 Oldtown Mall, said point of beginning being distant Southeasterly 114.0 feet, 8 more or less, measured along northeast side of said East Street from the southeast 9 side of Oldtown Mall, varying in width, and running thence binding on the 10 northeast and northwest sides of said varying in width alley the five following 11 courses and distances; namely, Northeasterly 89.8 feet, more or less, 12 Northwesterly 34.4 feet, more or less, Northeasterly 7.4 feet, more or less, 13 Northwesterly 5.7 feet, more or less, and Northeasterly 97.1 feet, more or less, to 14 intersect the southwest side of Forrest Street, 45 feet wide: thence binding on the 15 southwest side of said Forrest Street Southeasterly 92.7 feet, more or less, to 16 17 intersect the southeast side of said varying in width alley; thence binding on the southeast side of said varying in width alley the two following courses and 18 distances; namely, Westerly by a line curving to the left with a radius of 30.00 19 feet the distance of 51.3 feet, more or less, and Southwesterly 163.8 feet, more or 20 less, to intersect the northeast side of said East Street, and thence binding on the 21 northeast side of said East Street Northwesterly 21.6 feet, more or less, to the 2.2 place of beginning. 23

Beginning for Parcel No. 6 at the point formed by the intersection of the north 24 side of Orleans Street, varying in width, and the west side of East Street, 50 feet 25 wide, and running thence binding on the west and southwest sides of said East 26 Street the two following courses and distances; namely, Northerly 71.5 feet, more 27 or less, and Northwesterly 44.5 feet, more or less, to the northwesternmost 28 29 extremity of said East Street, there situate; thence binding on the northwesternmost extremity of said East Street Northeasterly 51.0 feet, more or 30 less, to intersect the northeast side of said East Street; thence binding on the 31 northeast and east sides of said East Street the four following courses and 32 distances; namely, Southeasterly 52.6 feet, more or less, Southeasterly 21.6 feet, 33 34 more or less, Southerly 60.2 feet, more or less, and Southeasterly 14.9 feet, more or less, to intersect the north side of said Orleans Street, and thence binding on the 35 north side of said Orleans Street the two following courses and distances; namely, 36 Westerly by a line curving to the left with a radius of 1341.25 feet the distance of 37 35.1 feet, more or less, and Westerly by a line curving to the left with a radius of 38 1321.25 feet the distance of 26.5 feet, more or less, to the place of beginning. 39

Beginning for Parcel No. 7 at the point formed by the intersection of the southeast 40 41 side of McElderry Street, 60 feet wide, and the northeast side of Forrest Street, 60 feet wide, and running thence binding on the northeast side of said Forrest Street 42 43 Northwesterly 60.6 feet, more or less, to intersect the northwest side of said McElderry Street; thence binding on the northwest side of said McElderry Street 44 Northeasterly 158.4 feet, more or less, to intersect the line of the northeast outline 45 of the property known as No. 515/517 Oldtown Mall, if projected southeasterly; 46 47 thence binding on said line, so projected, Southeasterly 60.0 feet to intersect the southeast side of said McElderry Street, and thence binding on the southeast side 48

1 of said McElderry Street Southwesterly 166.7 feet, more or less, to the place of 2 beginning.

Beginning for Parcel No. 8 at the point formed by the intersection of the north 3 side of Orleans Street, varying in width, and the west side of East Street, 50 feet 4 wide, and running thence by a straight line through the bed of said Orleans Street 5 Westerly 108.6 feet, more or less, to intersect the northwest side of said Orleans 6 Street; thence binding on the northwest side of said Orleans Street Northeasterly 7 141.2 feet, more or less, to intersect the southwest side of said East Street, and 8 thence binding on the southwest and west sides of said East Street the two 9 following courses and distances; namely, Southeasterly 5.5 feet, more or less, and 10 Southerly 71.5 feet, more or less, to the place of beginning. 11

- Beginning for Parcel No. 9 at the point formed by the intersection of the southeast 12 side of a 4-foot alley laid out through the property known as No. 449/457 13 Oldtown Mall and the southwest side of an alley, varying in width, laid out in the 14 rear of the properties known as Nos. 449/457 through 469 Oldtown Mall, said 15 point of beginning being distant northeasterly 89.8 feet, more or less, and 16 northwesterly 30.4 feet, more or less, measured along the northwest and 17 southwest sides of said varying in width alley from the northeast side of East 18 19 Street, 50 feet wide, to the place of beginning, and running thence binding on the southeast side of said 4-foot alley Southwesterly 28.5 feet, more or less, to the 20 southwesternmost extremity of said 4-foot alley, there situate; thence binding on 21 the southwesternmost extremity of said 4-foot alley Northwesterly 4.0 feet to 2.2 intersect the northwest side of said 4-foot alley; thence binding on the northwest 23 side of said 4-foot alley Northeasterly 29.1 feet, more or less, to intersect the 24 southwest side of said varying in width alley, and thence binding on the southwest 25 side of said varying in width alley Southeasterly 4.0 feet, more or less, to the 26 place of beginning. 27
- As delineated on Plat 314-A-1D, prepared by the Survey Control Section and filed on July 1,
   2011, in the Office of the Department of General Services.

SECTION 2. AND BE IT FURTHER ORDAINED, That the proceedings for the condemnation and opening of certain streets and alleys and the rights of all interested parties shall be regulated by and in accordance with all applicable provisions of state and local law and with all applicable rules and regulations adopted by the Director of General Services and filed with the Department of Legislative Reference.

#### 35 SECTION 3. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it 36 is enacted.
