16	This additional revenue could not have been reasonably anticipated when the Ordinance of		
17	Estimates for Fiscal Year 2008 was formulated.		
18	This appropriation is made necessary by a material change in circumstances since the		
19	Ordinance of Estimates for Fiscal Year 2008 was formulated or is for a new program that could		
20	not have been reasonably anticipated when that Ordinance of Estimates was formulated.		
21	On April 16, 2008, the Board of Estimates recommended this appropriation to the City		
22	Council.		
23	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That		
24	\$8,000,000 shall be made available to the Department of Housing and Community Development		
25	(Account #9911-600-858) as a Supplementary Special Fund Capital Appropriation for Fiscal
