**AN ORDINANCE CONCERNING**

**1 City Property – Renaming Lehigh and Gough Park to**  
**2 Gloria Hertzfelt Playground**

3 FOR the purpose of changing the name of Lehigh and Gough Park, located at 4500 Gough Street,  
4 to Gloria Hertzfelt Playground.

**10 Recitals**

11 Gloria Hertzfelt, a resident for many years of the Greektown Community, has  
12 been involved for a long time in efforts to improve the general living environment  
13 of her community. She has been an active member in her neighborhood  
14 association, the Greektown Community Neighborhood Association, and through  
15 her association with the Greektown Alliance, she was a strong partner and  
16 actively involved in the renovation of her neighborhood's playground for  
17 children. To this present day, she oversees the continued maintenance of this  
18 playground.

19 Among her other volunteer activities, she had a long term involvement in  
20 Baltimore City's Youth Summer Job Corp and was a long term member of the  
21 Community Advisory Board of Baltimore City's Community Action Center,  
22 located at 3411 Bank Street. She has also been a long term volunteer at the John  
23 Booth Senior Center of Baltimore City.

1 Gloria Hertzfelt has also worked to improve community relations in her  
2 neighborhood by participating in the monthly meetings of the Baltimore City  
3 Police Department’s Southeastern District’s Council of Community Relations  
4 and in the monthly meetings for the Hispanic community that are held at the  
5 Southeastern District. She also volunteers in her immediate neighborhood to  
6 provide assistance to nearby Hispanic residents who need information and referral  
7 help and who are faced with a language barrier.

8 It is fitting to name the playground, presently known as Lehigh and Gough Park,  
9 the Gloria Hertzfelt Playground, in honor of her many contributions to her  
10 community.

11 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That the  
12 name of Lehigh and Gough Park, located at 4500 Gough Street, is changed to Gloria Hertzfelt  
13 Playground.

14 **SECTION 2. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the 30<sup>th</sup> day  
15 after the date it is enacted.
