**A COUNCIL RESOLUTION CONCERNING**

**Corrective – Resolution 20-0233R**

FOR the purpose of approving a correction to Resolution 20-0233R, passed by the City Council on August 17, 2020, to reflect the correct name of the relevant business entity.

**Recitals**

A RESOLUTION concerning

Approval for the Exchange of a Class B-D-7 License to a  
Class A-7 License – 1300-1302 Laurens Street

FOR the purpose of providing the required approval under Md. Code Ann., Alc. Bev. § 12-902.1(d)(1) to allow the license holder holding a valid Class B-D-7 Beer, Wine, and Liquor License issued for use at 1300-1302 Laurens Street, Baltimore, Maryland 21217 to apply to the Board of Liquor License Commissioners for Baltimore City to exchange their Class B-D-7 Beer, Wine, and Liquor License for a Class A-7 Beer, Wine, and Liquor License.

Recitals

Under Md. Code Ann., Alc. Bev. § 12-902.1(d)(1), a City Council resolution is required to allow a current holder of a valid Class B-D-7 Beer, Wine, and Liquor License issued on or before July 1, 2018, to apply to the Board of Liquor License Commissioners for Baltimore City (the “Board”) to exchange their Class B-D-7 Beer, Wine, and Liquor License for a Class A-7 Beer, Wine, and Liquor License.

The Class A-7 License authorizes the license holder to sell beer, wine, and liquor at retail at the place described in the license for off-premise consumption. The holder of a Class A-7 License may sell beer, wine, and liquor on Monday through Sunday from 10:00 a.m. to midnight.

~~57 Liquors, Inc.~~ Kimsink Enterprises Inc., wishes to apply to the Board to exchange the Class B-D-7 License issued for use at 1300-1302 Laurens Street for a Class A-7 License. Accordingly, representatives of ~~57 Liquors, Inc.~~ Kimsink Enterprises Inc., have applied to the Baltimore City Council for approval of the exchange.

4           1302 Laurens Street, Baltimore, Maryland, 21217 may apply to exchange its Class  
5           B-D-7 License for a Class A-7 Beer, Wine, and Liquor License and may be  
6           afforded all the privileges and responsibilities of that license class and type under  
7           the Alcoholic Beverages Article for the State of Maryland.

9           Executive Secretary of the Board of Liquor License Commissioners for Baltimore
