**AN ORDINANCE CONCERNING**

**Charles Village Community Benefits District – Board Representation**

FOR the purpose of replacing representatives from the Waverly Merchants Association on the Charles Village Community Benefits District Board of Directors with representatives from Waverly Main Street.

BY repealing and reordaining, with amendments

Article 14 - Special Benefits Districts  
Section(s) 6-6(e)(4)  
Baltimore City Code

**SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That the Laws of Baltimore City read as follows:

**Baltimore City Code**

**Article 14. Special Benefits Districts**

**Subtitle 6. Charles Village Community Benefits District**

**§ 6-6. Board of Directors.**

(e) *Minimum representation.*

The following minimum representation shall be present on the full Board, except during periods of temporary vacancies:

(4) At least 6 voting Board members shall be from the following constituent organizations within the District:

(i) [the Waverly Merchants Association] WAVERLY MAIN STREET,
