# 23 SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the

Laws of Baltimore City read as follows:

3	Subtitle 1. Findings; Policy; Short Title
4	§ 1-2. Goals; purpose.
5 6 7	To guard against improper influence or even the appearance of improper influence, and to ensure public trust in the government, the Mayor and City Council of Baltimore enacts this article to:
8	(1) set minimum ethical standards of conduct for City officials and employees;
9	(2) require certain officials and employees to disclose their financial interests;
10 11	(3) require persons engaged in lobbying activities to register and disclose those activities; and
12	(4) generally protect the public welfare.
13	Subtitle 2. Definitions; General Provisions
14	§ 2-5. "Business with City".
15	(a) In general.
16 17	"Business with the City" means any 1 or combination of sales, purchases, leases, or contracts:

2	"Financial interest" means ownership of:
3	(1) more than 3% of a business entity;
4 5	<ul><li>(2) securities of any kind that represent or are convertible into ownership of more than 3% of a business entity; or</li></ul>

7	(i) received more than \$1,000 in any 1 of the preceding 3 calendar years; or

23 24 25	Except as otherwise provided in this Part II, a public servant may not participate in and must disqualify himself or herself from any matter if:

28 29	(A) the public servant has a [direct] financial interest of which the public servant might reasonably be expected to know; or

27 28 29 30	Except as permitted under subsection (b) of this section, a public servant may not solicit or facilitate the solicitation of a gift, whether on the public servant's own behalf or on behalf of another person, from any person who- <u>THAT THE PUBLIC SERVANT KNOWS OR HAS REASON TO KNOW</u> :
31	(1) does or seeks to do business of any kind, regardless of amount:
32	(i) with the public servant's agency; or

4 5	The statement must include a schedule of each significant gift that was, at any time during the reporting period:
6 7	(1) accepted by the public servant or by any other person at the direction of the public servant; and
8 9	(2) given by or on behalf of, directly or indirectly, any person that THE PUBLIC SERVANT KNOWS OR HAS REASON TO KNOW was:
10	(i) a lobbyist;
11	(ii) a person regulated by the City; or
12	(iii) a person doing business with the City.
13 14 15	<b>SECTION 2. AND BE IT FURTHER ORDAINED</b> , That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.
