A BILL ENTITLED

1 AN ORDINANCE concerning

2 **Supplementary General Fund Operating Appropriation –**  
3 **Police Department – \$2,125,000**

4 FOR the purpose of providing a Supplementary General Fund Operating Appropriation in the  
5 amount of \$2,125,000 to the Police Department – Program 202 (Investigations), to provide  
6 funds for additional operating expenses; and providing for a special effective date.

8 Article VI - Board of Estimates

12 **Recitals**

13 The revenue appropriated by this Ordinance represents funds from the Hotel Tax in excess of  
14 the revenue relied on by the Board of Estimates in determining the tax levy required to balance  
15 the budget for Fiscal Year 2006.

16 This additional revenue could not have been reasonably anticipated when the Ordinance of  
17 Estimates for Fiscal Year 2006 was formulated.

18 This appropriation is made necessary by a material change in circumstances since the  
19 Ordinance of Estimates for Fiscal Year 2006 was formulated or is for a new program that could  
20 not have been reasonably anticipated when that Ordinance of Estimates was formulated.

21 On May 10, 2006, the Board of Estimates recommended this appropriation to the City  
22 Council.

23 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That**  
24 **\$2,125,000 shall be made available to the Police Department – Program 202 (Investigations) as a**  
25 **Supplementary General Fund Operating Appropriation for Fiscal Year 2006, to provide funds for**

1 additional operating expenses. The source of revenue for this appropriation is funds from the  
2 Hotel Tax in excess of the amount from this source that was relied on by the Board of Estimates  
3 in determining the tax levy required to balance the budget for Fiscal Year 2006.

4 **SECTION 2. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the date it  
5 is enacted.
